AN ACT to amend the elder law and the social services law, in relation to authorizing county offices for the aging to accept and process supplemental nutrition assistance program (SNAP) and low-income home energy assistance program applications

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. The elder law is amended by adding a new section 224 to read as follows:

- S 224. SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM (SNAP) AND LOW-INCOME HOME ENERGY ASSISTANCE PROGRAM APPLICATIONS FOR THE ELDERLY. 1. CONSULTATION WITH THE COMMISSIONER OF TEMPORARY AND DISABILITY ASSIST-ANCE, THE OFFICE SHALL ESTABLISH GUIDELINES FOR AND ADMINISTER A PROGRAM 7 TO BE CARRIED OUT BY COUNTY OFFICES FOR THE AGING IN WHICH SUCH ACCEPT PROCESS APPLICATIONS FOR THE SUPPLEMENTAL SHALL AND 9 NUTRITION ASSISTANCE PROGRAM (SNAP) PURSUANT TO SECTION NINETY-FIVE SERVICES LAW AND THE LOW-INCOME HOME ENERGY ASSISTANCE 10 SOCIAL PROGRAM PURSUANT TO SECTION NINETY-SEVEN OF THE SOCIAL SERVICES LAW FROM 11 12 ELDERLY INDIVIDUALS SEEKING SERVICES FROM SUCH COUNTY OFFICES. OFFICES FOR THE AGING AND LOCAL SOCIAL SERVICES DISTRICTS SHALL HAVE THE 13 14 ABILITY TO DISCLOSE AND SHARE INFORMATION WITH RESPECT TO SUCH APPLICA-TIONS AND THE SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM (SNAP) 15 LOW-INCOME HOME ENERGY ASSISTANCE PROGRAM. FOR PURPOSES OF THIS SECTION, 16 17 "ELDERLY INDIVIDUAL" SHALL MEAN A PERSON SIXTY YEARS OF AGE OR OLDER.
- 18 2. THE PROVISIONS OF THIS SECTION SHALL NOT APPLY TO COUNTY OFFICES 19 FOR THE AGING THAT ARE ACCEPTING AND PROCESSING THE **APPLICATIONS** 20 REOUIRED IN SUBDIVISION ONE OF THIS SECTION PRIOR TO THE EFFECTIVE DATE OF THIS SECTION. 21
- 3. THE DIRECTOR SHALL PROMULGATE ANY RULES AND REGULATIONS 22 23 TO CARRY OUT THE PROVISIONS OF THIS SECTION.
- 24 2. Section 95 of the social services law is amended by adding a new 25 subdivision 11 to read as follows:

THE OFFICE FOR THE AGING IS AUTHORIZED AND REQUIRED, SUBJECT TO STATE AND FEDERAL LAWS AND REGULATIONS AND IN CONSULTATION WITH THE OFFICE, TO ACT ON BEHALF OF THE OFFICE AND ACCEPT AND PROCESS APPLICATIONS FOR THE SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM FROM ELDERLY INDIVIDUALS PURSUANT TO SECTION TWO HUNDRED TWENTY-FOUR OF THE ELDER LAW.

- S 3. Section 97 of the social services law is amended by adding a new subdivision 6 to read as follows:
- 9 6. THE OFFICE FOR THE AGING IS AUTHORIZED AND REQUIRED, SUBJECT TO STATE AND FEDERAL LAWS AND REGULATIONS AND IN CONSULTATION WITH THE 11 DEPARTMENT, TO ACT ON BEHALF OF THE DEPARTMENT AND ACCEPT AND PROCESS 12 APPLICATIONS FOR THE LOW-INCOME HOME ENERGY ASSISTANCE PROGRAM FROM 13 ELDERLY INDIVIDUALS PURSUANT TO SECTION TWO HUNDRED TWENTY-FOUR OF THE 14 ELDER LAW.
- 15 S 4. This act shall take effect on the one hundred eightieth day after 16 it shall have become a law; provided, however, effective immediately, 17 the addition, amendment and/or repeal of any rule or regulation neces-18 sary for the implementation of this act on its effective date is author-19 ized to be made on or before such date.
