Introduced by M. of A. MILLER -- read once and referred to the Committee on Ways and Means

AN ACT to amend the tax law, in relation to establishing business franchise and personal income tax gifts for state veterans' homes; and to amend the state finance law, in relation to establishing the veterans' home assistance fund

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

- Section 1. The tax law is amended by adding a new section 209-J to read as follows:
- 209-J. GIFT FOR NEW YORK STATE VETERANS' HOMES. EFFECTIVE FOR ANY TAX YEAR COMMENCING ON OR AFTER JANUARY FIRST, TWO THOUSAND IN ANY TAXABLE YEAR MAY ELECT TO CONTRIBUTE TO THE VETER-TAXPAYER ANS' HOME ASSISTANCE FUND. SUCH CONTRIBUTION SHALL BEINANY AMOUNT AND SHALL NOT REDUCE THE AMOUNT OF STATE TAX OWED BY SUCH DOLLAR TAXPAYER. THE COMMISSIONER SHALL INCLUDE SPACE ON THE CORPORATE INCOME RETURN TO ENABLE A TAXPAYER TO MAKE SUCH CONTRIBUTION. NOTWITH-STANDING ANY OTHER PROVISION OF LAW, ALL REVENUES COLLECTED PURSUANT 10 THIS SECTION SHALL BE CREDITED TO THE VETERANS' HOME ASSISTANCE FUND AND USED ONLY FOR THOSE PURPOSES ENUMERATED IN SECTION EIGHTY-ONE OF THE STATE FINANCE LAW.
- 14 S 2. The tax law is amended by adding a new section 627-c to read as 15 follows:
- 16 S 627-C. GIFT FOR NEW YORK STATE VETERANS' HOMES. EFFECTIVE FOR ANY 17 TAX YEAR COMMENCING ON OR AFTER JANUARY FIRST, TWO THOUSAND SEVENTEEN, INDIVIDUAL IN ANY TAXABLE YEAR MAY ELECT TO CONTRIBUTE TO THE VETER-18
- ANS' HOME ASSISTANCE FUND. SUCH CONTRIBUTION SHALL 19 $_{
 m BE}$ ΙN ANY WHOLE AMOUNT AND SHALL NOT REDUCE THE AMOUNT OF STATE TAX OWED BY SUCH
- 20 INDIVIDUAL. THE COMMISSIONER SHALL INCLUDE SPACE ON THE PERSONAL 21
- TAX RETURN TO ENABLE A TAXPAYER TO MAKE SUCH CONTRIBUTION. NOTWITHSTAND-22
- 23 ANY OTHER PROVISION OF LAW, ALL REVENUES COLLECTED PURSUANT TO THIS SECTION SHALL BE CREDITED TO THE VETERANS' HOME ASSISTANCE FUND AND USED
- 25 ONLY FOR THOSE PURPOSES ENUMERATED IN SECTION EIGHTY-ONE OF THE
- 26 FINANCE LAW.

1 S 3. The state finance law is amended by adding a new section 81 to 2 read as follows:

- S 81. VETERANS' HOME ASSISTANCE FUND. 1. THERE IS HEREBY ESTABLISHED IN THE JOINT CUSTODY OF THE COMMISSIONER OF TAXATION AND FINANCE AND THE COMPTROLLER, A SPECIAL FUND TO BE KNOWN AS THE "VETERANS' HOME ASSISTANCE FUND".
- 7 SUCH FUND SHALL CONSIST OF ALL REVENUES RECEIVED BY THE DEPARTMENT 8 OF TAXATION AND FINANCE, PURSUANT TO THE PROVISIONS OF SECTIONS HUNDRED NINE-J AND SIX HUNDRED TWENTY-SEVEN-C OF THE TAX LAW, AND ALL 9 10 OTHER MONEYS APPROPRIATED, CREDITED OR TRANSFERRED THERETO FROM ANY OTHER FUND OR SOURCE PURSUANT TO LAW. FOR EACH STATE FISCAL YEAR, THERE 11 SHALL BE APPROPRIATED TO THE FUND BY THE STATE, IN ADDITION TO ALL OTHER MONEYS REQUIRED TO BE DEPOSITED INTO SUCH FUND, AN AMOUNT EQUAL TO THE 12 13 14 AGGREGATE OF THE AMOUNTS OF MONEYS COLLECTED AND DEPOSITED INTO THE 15 VETERANS' HOME ASSISTANCE FUND PURSUANT TO SECTIONS TWO HUNDRED NINE-J 16 AND SIX HUNDRED TWENTY-SEVEN-C OF THE TAX LAW AND ALL OTHER MONEYS 17 RECEIVED AND DEPOSITED INTO SUCH FUND FROM GRANTS, GIFTS AND BEQUESTS DURING THE IMMEDIATELY PROCEEDING CALENDAR YEAR. NOTHING IN THIS SECTION 18 19 SHALL PREVENT THE STATE FROM SOLICITING AND RECEIVING GRANTS, GIFTS OR 20 BEQUESTS FOR THE PURPOSES OF THE FUND AS DEFINED IN THIS SECTION AND 21 DEPOSITING THEM INTO THE FUND ACCORDING TO LAW.
 - 3. ON OR BEFORE THE FIRST OF FEBRUARY EACH YEAR, THE COMPTROLLER SHALL CERTIFY TO THE GOVERNOR, THE TEMPORARY PRESIDENT OF THE SENATE, THE SPEAKER OF THE ASSEMBLY, THE CHAIR OF THE SENATE FINANCE COMMITTEE AND THE CHAIR OF THE ASSEMBLY WAYS AND MEANS COMMITTEE, THE AMOUNT OF MONIES DEPOSITED INTO THE VETERANS' HOME ASSISTANCE FUND DURING THE IMMEDIATELY PRECEDING CALENDAR YEAR AS THE RESULT OF REVENUES COLLECTED PURSUANT TO SECTIONS TWO HUNDRED NINE-J AND SIX HUNDRED TWENTY-SEVEN-C OF THE TAX LAW, AND FROM ALL GRANTS, GIFTS AND BEQUESTS TO SUCH FUND.
 - 4. MONEYS OF THE FUND SHALL BE EXPENDED ONLY FOR THE CARE AND MAINTENANCE OF VETERANS' HOMES OPERATED BY AGENCIES OF THE STATE, AND SHALL BE DISBURSED EQUALLY EACH STATE FISCAL YEAR TO EACH OF THE FOLLOWING FIVE VETERANS' HOMES: THE STATE HOME FOR VETERANS AND THEIR DEPENDENTS AT OXFORD, THE STATE HOME FOR VETERANS IN THE CITY OF NEW YORK, THE STATE HOME FOR VETERANS AT BATAVIA, THE STATE HOME FOR VETERANS AT MONTROSE AND THE LONG ISLAND STATE VETERANS HOME AT STONY BROOK UNIVERSITY.
 - 5. MONEYS SHALL BE PAYABLE FROM THE FUND ON THE AUDIT AND WARRANT OF THE COMPTROLLER ON VOUCHERS APPROVED AND CERTIFIED BY THE COMMISSIONER OF HEALTH, FOR VETERANS' HOMES OPERATED BY THE DEPARTMENT OF HEALTH, AND BY THE COMMISSIONER OF EDUCATION, FOR THE VETERANS' HOME OPERATED BY THE STATE UNIVERSITY OF NEW YORK.
- 42 6. MONEYS IN THE VETERANS' HOME ASSISTANCE FUND SHALL BE KEPT SEPARATE 43 AND SHALL NOT BE COMMINGLED WITH ANY OTHER MONEYS IN THE CUSTODY OF THE 44 COMMISSIONER OF TAXATION AND FINANCE AND/OR THE COMPTROLLER.
 - S 4. This act shall take effect immediately.
