AN ACT to amend the social services law, in relation to requiring medical assistance coverage for the cost of donor breast milk in certain circumstances

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. Subdivision 2 of section 365-a of the social services law  
2     is amended by adding a new paragraph (dd) to read as follows:  
3     (DD) THE COST OF DONOR BREAST MILK, FOR HOME AND INPATIENT USE, FOR  
4     WHICH A LICENSED MEDICAL PRACTITIONER HAS ISSUED AN ORDER FOR AN INFANT  
5     WHO IS MEDICALLY OR PHYSICALLY UNABLE TO RECEIVE MATERNAL BREAST MILK OR  
6     PARTICIPATE IN BREAST FEEDING OR WHOSE MOTHER IS MEDICALLY OR PHYSICALLY  
7     UNABLE TO PRODUCE MATERNAL BREAST MILK OR PARTICIPATE IN BREAST FEEDING.  
8     SUCH INFANT MUST: (I) HAVE A DOCUMENTED BIRTH WEIGHT OF ONE THOUSAND  
9     FIVE HUNDRED GRAMS OR LESS; (II) HAVE A CONGENITAL OR ACQUIRED INTESTI-  
10    NAL CONDITION, AND IS THEREFORE AT A HIGH RISK FOR DEVELOPMENT OF FEED-  
11    ING INTOLERANCE, NECROTIZING ENTEROCOLITIS AND/OR INFECTION; OR (III)  
12    OTHERWISE REQUIRE NOURISHMENT BY BREAST MILK. COVERAGE FOR DONOR BREAST
