AN ACT to authorize the town of Hyde Park to convey to the Greenfields Town Water District, a special district of the town of Hyde Park, an easement through land located in the town's Greenfields Park currently utilized as a public ground water supply with underground water mains, electrical lines and well heads as a part of the existing public water supply system

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The town of Hyde Park, acting by and through its town
2 board, is hereby authorized to convey by appropriate instruments to the
3 board of commissioners of the Greenfields Town Water District, a permanent easement in Greenfields Park described in section three of this
4 act, for the purpose of enabling such water district to own, construct,
5 and repair when necessary, public water supply wells, water mains, electrical lines and associated infrastructure as a part of the existing
6 public water supply system. Upon completion of any repairs or
7 construction, the Greenfields Town Water District shall restore the
8 surface of the lands and the lands shall continue to be used for park
9 purposes.

12 S 2. The authorization provided in section one of this act shall be
13 effective only upon the condition that the town of Hyde Park dedicate an
14 amount equal to or greater than the fair market value of the easement
15 interest being alienated pursuant to section one of this act to the
16 acquisition of new parklands and/or capital improvements to existing
17 park and recreational facilities.

18 S 3. The easements to be conveyed by the Greenfields Town Water
19 District pursuant to the provisions of this act are described as
20 follows:

21 Wellhead Access and Utility Easement No. 1:

22 ALL that plot piece or parcel of land, being an easement for the purpose
23 of ingress, egress, maintenance and repair, located in the Town of Hyde

22 185.26 feet, North 80°17'18" East 97.51 feet, North 67°52'46" East 98.11
23 feet and on a curve to the left having a radius of 30.00 feet and an arc
24 length of 40.49 feet; thence leaving said point of beginning and running
25 through the aforementioned lands of the Town of Hyde Park (recreation
26 parcel) the following courses and distances: South 76°14'45" West 39.04
27 feet, North 27°33'10" East 34.29 feet, North 11°48'01" East 179.43 feet

42 ALL that plot piece or parcel of land, being an easement for the purpose
43 of ingress, egress, maintenance and repair, located in the Town of Hyde
44 Park, County of Dutchess and State of New York, bounded and described as
45 follows:
46 Beginning at a point, said point being distant: On a curve to the left
47 having a radius of 25.00 feet and an arc length of 40.48 feet, North
48 80°52'48" East 54.73 feet and on a curve to the left having a radius of
49 100.00 feet and an arc length of 22.89 feet, from the intersection of
50 the easterly line of Cream Street (County Route 39) with the northerly
51 line of Windmill Road, said point of beginning being on the northerly
52 line of Windmill Road and said point being on the southerly line of
53 lands now or formerly Town of Hyde Park (recreation parcel), Liber 1558,
54 Page 568; thence leaving said northerly road line and running through
55 said lands of the Town of Hyde Park the following courses and distances:
56 North 01°43'18" West 33.06 feet, on a curve to the left having a radius

1 of 70.00 feet and an arc length of 36.08 feet, North 28°42'28" East
2 117.48 feet, North 45°50'44" West 111.25 feet, on a curve to the right
3 having a radius of 30.00 feet and an arc length of 75.27 feet, North
4 19°22'33" East 279.30 feet and North 40°20'33" West 41.56 feet to a
5 point being on the easterly line of said Town of Hyde Park (recreation
6 parcel), said point also being on the westerly line of lands now or
7 formerly Greenfields Sewer District, Liber 1493, Page 5109; thence
8 running along said division line, North 77°05'28" East 41.88 feet and
9 South 11°53'12" East 78.01 feet; thence leaving said division line and
10 running through the aforementioned lands of the Town of Hyde Park
11 (recreation parcel) the following courses and distances: South 19°22'33"
12 East 244.63 feet, on a curve to the right having a radius of 30.00 feet
13 and an arc length of 23.52 feet and South 45°50'44" East 131.32 feet to
14 a point being on the northerly line of the aforementioned Windmill Road;
15 thence running along said road line, South 28°42'28" West 150.69 feet
16 and on a curve to the right having a radius of 100.00 feet and an arc
17 length of 68.17 feet to the point of beginning containing 0.572± acres
18 of land.

19 S 4. In the event that the town of Hyde Park received any funding
20 support or assistance from the federal government for the purchase,
21 maintenance, or improvement of the parklands set forth in section three
22 of this act, the discontinuance and alienation of such parkland author-
23 ized by the provisions of section one of this act shall not occur until
24 the town of Hyde Park has complied with any federal requirements
25 pertaining to the alienation or conversion of such parklands, including
26 satisfying the secretary of the interior that the alienation or conver-
27 sion complies with all conditions which the secretary of the interior
28 deems necessary to assure the substitution of other lands shall be
29 equivalent in fair market value and usefulness to the lands being alien-
30 ated or converted.

31 S 5. This act shall take effect immediately.
