AN ACT in relation to authorizing the county of Westchester to alienate and convey certain parcels of land used as parkland

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Subject to the provisions of this act, the county of West-chester, acting by and through its governing body, is hereby authorized to discontinue as parklands and alienate the lands more particularly described in section three of this act, and to grant an access easement over such parklands at fair market value and upon such other terms and conditions as determined by the governing body of Westchester county to WP East Acquisitions, LLC.

- S 2. The authorization provided in section one of this act shall be effective only upon the condition that the county of Westchester dedicate an amount equal to or greater than the fair market value of the easement interest being alienated pursuant to section one of this act to the acquisition of new parklands and/or improvements to existing parklands.
- 14 S 3. The lands authorized by section one of this act to be discontin-15 ued as parklands and conveyed by the county of Westchester are described 16 as follows:

BEGINNING at the point on the southerly line of East Lincoln Avenue where it is met by the westerly most line of Plot No. 9 shown in that certain "Map Showing Lands ... East Hudson Parkway Authority ... Hutchinson River Parkway ... 10 S 4. In the event that the county of Westchester received any funding support or assistance from the federal government for the purchase, 11 12 maintenance or improvement of the parklands set forth in section three this act, the discontinuance and alienation of such parkland author-13 14 ized by the provisions of section three of this act shall not occur 15 until the county of Westchester has complied with any federal requirements pertaining to the alienation or conversion of such parklands, including satisfying the secretary of the interior that the alienation 16 17 or conversion complies with all conditions which the secretary of 18 19 interior deems necessary to assure the substitution of other lands shall be equivalent in fair market value and usefulness to the lands being 20 21 alienated or converted.

22 S 5. This act shall take effect immediately.
