AN ACT to amend the labor law, in relation to restrictions on consecutive hours of work for nurses in the office of children and family services

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

- Section 1. Paragraph a of subdivision 1 of section 167 of the labor law, as added by chapter 493 of the laws of 2008, is amended to read as follows:
- "Health care employer" shall mean any individual, partnership, association, corporation, limited liability company or any person or group of persons acting directly or indirectly on behalf of or in the interest of the employer, which provides health care services (i) in a facility licensed or operated pursuant to article twenty-eight of the public health law, including any facility operated by the state, a poli-9 tical subdivision or a public corporation as defined by section sixty-10 six of the general construction law, or (ii) in a facility operated by 11 the state, a political subdivision or a public corporation as defined by 12 section sixty-six of the general construction law, operated or licensed 13 pursuant to the mental hygiene law, the education law, ARTICLE NINE-14 TEEN-G OF THE EXECUTIVE LAW or the correction law. 15
