AN ACT to amend the general city law, the town law and the village law, in relation to requiring residential facilities of state agencies to maintain on file and make accessible a facility site plan

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. Section 27-a of the general city law is amended by adding a  
2     new subdivision 1-a to read as follows:  
3     1-A.     EVERY RESIDENTIAL FACILITY UNDER THE CONTROL OF A STATE AGENCY  
4     SHALL KEEP ON FILE AT SUCH RESIDENTIAL FACILITY AND HAVE ACCESSIBLE A  
5     FACILITY SITE PLAN. UPON REQUEST, THE RESIDENTIAL FACILITY SITE PLAN  
6     SHALL BE MADE AVAILABLE TO THE LOCAL MUNICIPAL GOVERNING BODY AND EMER-  
7     GENCY RESPONDERS. FOR THE PURPOSES OF THIS SUBDIVISION, "STATE AGENCY"  
8     MEANS ANY DEPARTMENT, BUREAU, COMMISSION, BOARD, PUBLIC AUTHORITY OR  
9     OTHER AGENCY OF THE STATE, INCLUDING ANY PUBLIC BENEFIT CORPORATION ANY  
10    MEMBER OF WHOSE BOARD IS APPOINTED BY THE GOVERNOR.  
11    S 2. Section 274-a of the town law is amended by adding a new subdivi-  
12    sion 1-a to read as follows:  
13    1-A.     EVERY RESIDENTIAL FACILITY UNDER THE CONTROL OF A STATE AGENCY  
14    SHALL KEEP ON FILE AT SUCH RESIDENTIAL FACILITY AND HAVE ACCESSIBLE A  
15    FACILITY SITE PLAN. UPON REQUEST, THE RESIDENTIAL FACILITY SITE PLAN  
16    SHALL BE MADE AVAILABLE TO THE LOCAL MUNICIPAL GOVERNING BODY AND EMER-

3 S 3. Section 7-725-a of the village law is amended by adding a new  
4 subdivision 1-a to read as follows:

5 1-A. EVERY RESIDENTIAL FACILITY UNDER THE CONTROL OF A STATE AGENCY  
6 SHALL KEEP ON FILE AT SUCH RESIDENTIAL FACILITY AND HAVE ACCESSIBLE A  
7 FACILITY SITE PLAN. UPON REQUEST, THE RESIDENTIAL FACILITY SITE PLAN  
8 SHALL BE MADE AVAILABLE TO THE LOCAL MUNICIPAL GOVERNING BODY AND EMER-  
9 GENCY RESPONDERS. FOR THE PURPOSES OF THIS SUBDIVISION, "STATE AGENCY"  
10 MEANS ANY DEPARTMENT, BUREAU, COMMISSION, BOARD, PUBLIC AUTHORITY OR

13 S 4. This act shall take effect on the thirtieth day after it shall
