AN ACT to amend the environmental conservation law, in relation to the powers and duties of the Historic Hudson-Hoosic Rivers Partnership

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- Section 1. Subdivisions 4 and 5 of section 42-0107 of the environmental conservation law, as added by chapter 737 of the laws of 2006, are amended to read as follows:
- 4. To appoint AND REMOVE an executive officer, officers, agents and employees, and prescribe their duties and qualifications and fix their compensation.
- 5. To contract for professional and technical assistance and advice, INCLUDING RETAINING OR EMPLOYING COUNSEL, PRIVATE CONSULTANTS AND INDEPENDENT CONTRACTORS.
- 10 S 2. Subdivision 13 of section 42-0107 of the environmental conserva-11 tion law is renumbered subdivision 15, and two new subdivisions 13 and 12 14 are added to read as follows:
 - 13. TO ADOPT AND USE A SEAL.
- 14 14. TO CONSTRUCT OR CAUSE TO HAVE CONSTRUCTED NECESSARY FACILITIES,
- 15 INCLUDING PATHS AND TRAILS, A VISITOR EDUCATION CENTER, AND RELATED
- 16 PARKING AREAS ON THE LAND DESCRIBED IN SECTION THREE OF THE CHAPTER OF THE LAWS OF TWO THOUSAND FIFTEEN THAT ADDED THIS SUBDIVISION.
