CONCURRENT RESOLUTION OF THE SENATE AND ASSEMBLY

proposing amendments to sections 5 and 6 of article 4 of the constitution, relating to the filling of vacancies in the office of lieutenant-governor and the powers and duties of such office

1 Section 1. Resolved (if the Assembly concur), That the third undesig-2 nated paragraph of section 5 of article 4 of the constitution be amended 3 to read as follows:

4 In case the governor is impeached[, is absent from the state or is 5 otherwise unable to discharge the powers and duties of the office of 6 governor], the lieutenant-governor shall act as governor until [the 7 inability shall cease or until] the term of the governor shall expire. 8 WHENEVER THE GOVERNOR TRANSMITS TO THE TEMPORARY PRESIDENT OF THE SENATE 9 AND SPEAKER OF THE ASSEMBLY HIS OR HER WRITTEN DECLARATION THAT HE OR IS UNABLE TO DISCHARGE THE POWERS AND DUTIES OF HIS OR HER OFFICE, 10 SHE 11 AND UNTIL HE OR SHE TRANSMITS TO THEM A WRITTEN DECLARATION TO THE SUCH POWERS AND DUTIES SHALL BE DISCHARGED BY THE LIEUTENANT-12 CONTRARY, 13 GOVERNOR AS ACTING GOVERNOR. WHENEVER THE LIEUTENANT-GOVERNOR AND A MAJORITY OF EITHER THE PRINCIPAL OFFICERS OF THE EXECUTIVE DEPARTMENT OR 14 15 OF SUCH OTHER BODY AS THE LEGISLATURE MAY BY LAW PROVIDE TRANSMIT TO THE 16 TEMPORARY PRESIDENT OF THE SENATE AND THE SPEAKER OF THE ASSEMBLY THEIR 17 WRITTEN DECLARATION THAT THE GOVERNOR IS UNABLE TO DISCHARGE THE POWERS 18 AND DUTIES OF HIS OR HER OFFICE, THE LIEUTENANT-GOVERNOR SHALL IMME-19 DIATELY ASSUME THE POWERS AND DUTIES OF THE OFFICE AS ACTING GOVERNOR. GOVERNOR TRANSMITS TO THE TEMPORARY PRESIDENT OF 20 THEREAFTER, WHEN THE THE SENATE AND THE SPEAKER OF THE ASSEMBLY HIS OR HER 21 WRITTEN DECLARA-22 TION NO INABILITY EXISTS, HE OR SHE SHALL RESUME THE POWERS AND THAT DUTIES OF HIS OR HER OFFICE UNLESS THE LIEUTENANT-GOVERNOR AND A MAJORI-23 24 TY OF EITHER THE PRINCIPAL OFFICERS OF THE EXECUTIVE DEPARTMENT OR OF BODY AS THE LEGISLATURE MAY BY LAW PROVIDE TRANSMIT WITHIN 25 SUCH OTHER

FOUR DAYS TO THE TEMPORARY PRESIDENT OF THE SENATE AND THE SPEAKER 1 OF 2 ASSEMBLY THEIR WRITTEN DECLARATION THAT THE GOVERNOR IS UNABLE TO THE 3 DISCHARGE THE POWERS AND DUTIES OF HIS OR HER OFFICE. THEREUPON THE 4 LEGISLATURE SHALL DECIDE THE ISSUE, ASSEMBLING WITHIN FORTY-EIGHT HOURS 5 THAT PURPOSE IF NOT IN SESSION. ΙF THE LEGISLATURE, FOR WITHIN 6 DAYS AFTER RECEIPT OF THE LATTER WRITTEN DECLARATION, OR, IF TWENTY-ONE 7 THE LEGISLATURE IS NOT IN SESSION, WITHIN TWENTY-ONE DAYS AFTER THE 8 IS REQUIRED TO ASSEMBLE, DETERMINES BY TWO-THIRDS VOTE OF LEGISLATURE BOTH HOUSES THAT THE GOVERNOR IS UNABLE TO DISCHARGE THE POWERS AND 9 10 OF HIS OR HER OFFICE, THE LIEUTENANT-GOVERNOR SHALL CONTINUE TO DUTIES 11 DISCHARGE THE SAME AS ACTING GOVERNOR; OTHERWISE, THE GOVERNOR SHALL 12 RESUME THE POWERS AND DUTIES OF HIS OR HER OFFICE.

13 S 2. Resolved (if the Assembly concur), That the third, fourth and 14 fifth undesignated paragraphs of section 6 of article 4 of the constitu-15 tion be amended to read as follows:

In case of vacancy in the offices of both governor and lieutenant-governor or if both of them shall be impeached[, absent from the state] or otherwise unable to discharge the powers and duties of the office of governor, the temporary president of the senate shall act as governor until the inability shall cease or until a governor shall be elected.

21 In case of vacancy in the office of lieutenant-governor alone, or if 22 the lieutenant-governor shall be [impeached, absent from the state or otherwise] unable to discharge the duties of office, the temporary pres-23 ident of the senate shall perform all the duties of lieutenant-governor 24 25 [during] UNTIL such vacancy BE FILLED or DURING THE SUCH PENDENCY OF 26 inability. IN CASE OF THE REMOVAL OF THE LIEUTENANT-GOVERNOR ALONE FROM OFFICE OR OF HIS OR HER DEATH, RESIGNATION, IMPEACHMENT OR ASCENSION TO 27 GOVERNOR, THE OFFICE OF LIEUTENANT-GOVERNOR SHALL BE FILLED 28 FOR THE REMAINDER OF THE TERM BY APPOINTMENT OF THE GOVERNOR, SUBJECT TO CONFIR-29 30 MATION OF SUCH APPOINTMENT BY MAJORITY VOTE OF EACH HOUSE OF THE LEGIS-31 LATURE.

If, when the duty of acting as governor devolves upon the temporary president of the senate, there be a vacancy in such office or the temporary president of the senate shall be [absent from the state or otherwise] unable to discharge the duties of governor, the speaker of the assembly shall act as governor during such vacancy or inability.

Resolved (if the Assembly concur), That the foregoing amendment 38 be referred to the first regular legislative session convening after the 39 next succeeding general election of members of the assembly, and, in 40 conformity with section 1 of article 19 of the constitution, be 41 published for 3 months previous to the time of such election.
