AN ACT to amend the environmental conservation law, in relation to the powers and duties of enforcement officers

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 4 of section 71-0907 of the environmental
2 conservation law, subparagraph 5 of paragraph f as added by chapter 366
3 of the laws of 1981, is amended to read as follows:
4 4. Officers named in subdivision 1 OF THIS SECTION shall have power:
5 a. To execute all warrants and search warrants issued for violation of
6 the Fish and Wildlife Law and to serve subpoenas issued for examination,
7 investigation or trial of offenses against any of its provisions;
8 b. To search without search warrant any boat or vehicle of any kind,
9 any box, locker, basket, creel, crate, game bag, package or any contain-
10 er of any nature and the contents of any building other than a dwelling
11 whenever they have PROBABLE cause to believe that any provision of this
12 article or of any law for the protection of fish, shellfish, crustacea,
13 wildlife, game or protected insects has been or is being violated, and
14 to use such force as may be necessary for the purpose of examination and
15 search;

1 c. To search any dwelling and its contents, provided they have a
2 search warrant to do so;

3 d. To arrest without warrant any person committing in their presence a
4 misdemeanor under the provisions of this chapter listed in section
5 71-0501 or under titles 5 through 15 inclusive and title 33 of this
6 article and to take such person immediately before a magistrate having
7 jurisdiction for trial;

8 e. To seize as evidence without warrant any fish, shellfish, crusta-
9 cea, wildlife, game, or parts thereof, protected insects or plumage [as
10 defined in section 11-1729], whenever they have PROBABLE cause to
11 believe it is possessed or transported in violation of law, or it bears
12 evidence of illegal taking, or it is possessed or transported under
13 circumstances making the possession or transportation presumptive
14 evidence of illegal taking;

15 f. To seize as evidence without warrant

16 (1) Any net, trap or other device constituting a nuisance as defined
17 in section 71-0915 OF THIS TITLE;

18 (2) Any net, trap or device other than a boat, a vehicle, or aircraft
19 or a firearm when they have PROBABLE cause to believe that its
20 possession or use is in violation of any provision of the Fish and Wild-
21 life Law or regulation pursuant thereto;

22 (3) Any firearm, when they have PROBABLE cause to believe that it has
23 been used in a violation of the Fish and Wildlife Law constituting a
24 misdemeanor involving the illegal taking or attempting to take wild
25 deer;

26 (4) Any rakes, tongs, dredges, or device other than a boat or vehicle
27 used, or in possession for purpose of use, for the taking of shellfish
28 WHEN THEY HAVE PROBABLE CAUSE TO BELIEVE THAT ITS POSSESSION OR USE IS
29 in violation of subdivisions 1 or 2 of section 13-0309 OF THIS CHAPTER.
30 For the purposes of this paragraph "device" includes a bird, dog, or
31 other animal used in or as an aid in taking fish or wildlife, any jack
32 light, spot light or other artificial light other than a headlight
33 attached in proper position to a motor vehicle, any hunting appliance or
34 apparatus and any fishing or netting gear or tackle. This paragraph
35 does not limit any power of seizure pursuant to warrant.

36 (5) Any boat or vehicle, when they have probable cause to believe it
37 has been used for the taking of shellfish in violation of subdivision 2
38 or 3 of section 13-0309 of this chapter by a person possessing, at the
39 time of such use, commercial shellfish harvesting gear or shellfish in
40 excess of two pecks. For the purposes of this subparagraph "commercial
41 shellfish harvesting gear" shall mean rakes, tongs, dredges and other
42 devices commonly used to harvest shellfish for commercial purposes.

43 G. WITHIN TWENTY-FOUR HOURS OF ANY SEARCH OR SEIZURE UNDERTAKEN WITH-
44 OUT A WARRANT PURSUANT TO THIS SUBDIVISION, THE OFFICER SHALL FILE WITH
45 A COURT OF COMPETENT JURISDICTION AN AFFIDAVIT OR SWORN STATEMENT
46 DESCRIBING WITH PARTICULARITY THE BASIS FOR PROBABLE CAUSE JUSTIFYING
47 THE PLACES THAT WERE SEARCHED AND THE ITEMS THAT WERE SEIZED. A COPY OF
48 THE AFFIDAVIT OR SWORN STATEMENT SHALL BE MAILED BY REGISTERED MAIL TO
49 ANY PERSON CHARGED WITH AN OFFENSE UNDER THIS CHAPTER PURSUANT TO THE
50 SEARCH OR SEIZURE WITHIN THREE DAYS OF ITS FILING WITH THE COURT.

51 S 2. This act shall take effect immediately.
