AN ACT to amend the social services law, in relation to investigation of illegally operating child day care services

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Subdivision 1 of section 390 of the social services law is amended by adding a new paragraph (g) to read as follows:

3 (G) "ADVERTISEMENT" SHALL MEAN ANY ADVERTISING OF CHILD DAY CARE 4 SERVICES THROUGH THE MEDIUM OF INTERNET, RADIO BROADCAST, TELEVISION 5 BROADCAST, NEWSPAPERS, PERIODICALS OR OTHER PUBLICATIONS, OUTDOOR ADVER-6 TISEMENT, OR ANY OTHER PRINTED OR GRAPHIC MATTER, INCLUDING BOOKLETS, 7 FLYERS OR CARDS.

8 S 2. Subdivisions 11, 12 and 13 of section 390 of the social services 9 law, paragraph (b) of subdivision 12 as relettered by chapter 117 of the 10 laws of 2010, are renumbered subdivisions 12, 13 and 14 and a new subdi-11 vision 11 is added to read as follows:

12 11. (A) THE OFFICE OF CHILDREN AND FAMILY SERVICES SHALL PERIODICALLY 13 REVIEW, NOT LESS THAN ONCE A MONTH, ADVERTISEMENTS OFFERING CHILD DAY 14 CARE SERVICES. SUCH REVIEW SHALL INCLUDE ADVERTISEMENTS FROM EACH COUNTY 15 IN THIS STATE.

(B) THE OFFICE OF CHILDREN AND FAMILY SERVICES SHALL, NO LATER THAN
NINETY DAYS AFTER THE EFFECTIVE DATE OF THIS SUBDIVISION, ADOPT A PROCEDURE FOR IMPLEMENTATION OF THIS SUBDIVISION, PROVIDED THAT SUCH PROCEDURE INCLUDES IDENTIFICATION AND FURTHER INVESTIGATION OF PROVIDERS WHO:
(I) ARE NOT REGISTERED OR LICENSED, AS REQUIRED BY THIS SECTION OR ANY
REGULATIONS PROMULGATED THEREUNDER; AND

22 (II) CANNOT PROVIDE THE CHILD DAY CARE SERVICES TO AN ADDITIONAL CHILD 23 WITHOUT VIOLATING THIS SECTION OR ANY REGULATIONS PROMULGATED THERE-24 UNDER.
