AN ACT to amend the executive law, in relation to establishing a legislative intelligence committee

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The executive law is amended by adding a new section 719 to 2 read as follows:

3 S 719. LEGISLATIVE INTELLIGENCE COMMITTEE. 1. THERE IS HEREBY ESTAB-4 LISHED A LEGISLATIVE INTELLIGENCE COMMITTEE. SUCH COMMITTEE SHALL 5 CONSIST OF TWELVE MEMBERS, THREE OF WHOM SHALL BE APPOINTED BY THE TEMPORARY PRESIDENT 6 OF THE SENATE, THREE OF WHOM SHALL BE APPOINTED BY 7 THE SPEAKER OF THE ASSEMBLY, THREE OF WHOM SHALL BE THE APPOINTED BY 8 MINORITY LEADER OF THE SENATE AND THREE OF WHOM SHALL BE APPOINTED BY THE MINORITY LEADER OF THE ASSEMBLY. 9 MEMBERS OF THE COMMITTEE SHALL THE APPOINTING AUTHORITY. VACANCIES ON THE 10 AT THE PLEASURE OF SERVE COMMITTEE SHALL BE FILLED IN THE SAME MANNER AS THE 11 ORIGINAL APPOINT-MEMBERS OF THE COMMITTEE SHALL RECEIVE NO COMPENSATION FOR THEIR 12 MENT. 13 SERVICES, BUT SHALL BE ALLOWED THEIR ACTUAL AND NECESSARY EXPENSES INCURRED IN THE PERFORMANCE OF THEIR DUTIES PURSUANT TO THIS SECTION. 14 15 2. FOR PURPOSES OF THIS SECTION, THE TERM "COUNTERTERRORISM AGENCY"

16 SHALL MEAN THE DIVISION OF HOMELAND SECURITY AND EMERGENCY SERVICES, THE 17 OFFICE OF COUNTERTERRORISM, THE NEW YORK CITY POLICE DEPARTMENT COUN-18 TER-TERRORISM FOUNDATION, INC., THE NEW YORK CITY POLICE DEPARTMENT FOUNDATION, ANY NOT-FOR-PROFIT CORPORATION OR ANY OTHER ENTITY UNDER THE 19 JURISDICTION OF ANY CITY, COUNTY, TOWN OR VILLAGE LOCATED 20 WITHIN THIS THAT IS ESTABLISHED FOR THE PURPOSE OF ENGAGING IN COUNTERTERROR-21 STATE 22 ISM ACTIVITIES.

23 3. THE LEGISLATIVE INTELLIGENCE COMMITTEE ESTABLISHED PURSUANT TO THIS 24 SECTION SHALL:

A. PROVIDE OVERSIGHT AND REVIEW OF ALL APPROPRIATIONS AND ALLOCATIONS 1 2 TO EVERY COUNTERTERRORISM AGENCY LOCATED WITHIN THE STATE FROM ANY 3 SOURCE; 4 B. APPROVE THE EXPENDITURE OF ANY FUNDS MADE BY EVERY COUNTERTERRORISM 5 AGENCY LOCATED WITHIN THE STATE PRIOR TO THE EXPENDITURE OF SUCH FUNDS; 6 C. CONDUCT AUDITS REGARDING THE APPROPRIATION, ALLOCATION AND EXPENDI-7 TURE OF ALL FUNDS OF EVERY COUNTERTERRORISM AGENCY LOCATED WITHIN THE 8 STATE; AND 9 D. REOUIRE AND RECEIVE REPORTS FROM THE DIVISION OF HOMELAND SECURITY 10 AND EMERGENCY SERVICES IN A MANNER AND FREQUENCY TO BE DETERMINED BY THE SUCH REPORTS SHALL INCLUDE, BUT NOT BE LIMITED TO, INFORMA-11 COMMITTEE. TION REGARDING THE APPROPRIATION, ALLOCATION AND EXPENDITURE OF ALL 12 FUNDS OF EVERY COUNTERTERRORISM AGENCY LOCATED WITHIN THE STATE, AND ANY 13 14 OTHER INFORMATION THE COMMITTEE SHALL DEEM NECESSARY. 15 4. THE LEGISLATIVE INTELLIGENCE COMMITTEE SHALL HAVE THE POWER TO 16 SUBPOENA AND TO TAKE TESTIMONY BY DEPOSITION AND THE POWER TO COMPEL THE ATTENDANCE OF WITNESSES AND THE PRODUCTION OF RECORDS, 17 IN THE SAME MANNER AS PRESCRIBED BY LAW IN JUDICIAL PROCEEDINGS IN THE COURTS OF 18 19 THIS STATE. 5. THE LEGISLATIVE INTELLIGENCE COMMITTEE IS AUTHORIZED TO EMPLOY, 20 21 CONTRACT FOR OR UTILIZE THE SERVICES OF ANY PERSON, FIRM, PARTNERSHIP, ASSOCIATION, CORPORATION, GOVERNMENTAL AGENCY, OR AUTHORITY TO CARRY OUT 22 23 ITS POWERS AND DUTIES AUTHORIZED OR MANDATED PURSUANT TO THE PROVISIONS 24 OF THIS SECTION. 25 6. MEMBERS OF THE LEGISLATIVE INTELLIGENCE COMMITTEE SHALL BE SUBJECT 26 TO THE CONFIDENTIALITY PROTOCOL RELATED TO SENSITIVE INFORMATION AND BE 27 SUBJECT TO REQUISITE SECURITY CLEARANCES AS ESTABLISHED BY THE FEDERAL 28 GOVERNMENT. 29 S 2. This act shall take effect immediately.
