AN ACT to amend the education law, in relation to the volunteer firefighters of New York higher education learning plan

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. The education law is amended by adding a new section 669-h to read as follows:

- S 669-H. VOLUNTEER FIREFIGHTERS OF NEW YORK HIGHER EDUCATION LEARNING PLAN. 1. ELIGIBILITY. UNDERGRADUATE STUDENTS WHO ARE MATRICULATED IN AN APPROVED UNDERGRADUATE PROGRAM AT THE STATE UNIVERSITY OF NEW YORK AND ARE MEMBERS IN GOOD STANDING IN ONE OF NEW YORK'S VOLUNTEER FIRE COMPANIES SHALL BE ELIGIBLE FOR AN AWARD UNDER THIS SECTION, PROVIDED THE APPLICANT: (A) SIGNS A CONTRACT WITH THE CORPORATION AGREEING TO WORK FOR A NEW YORK VOLUNTEER FIRE COMPANY ON A FULL-TIME BASIS FOR FIVE YEARS; AND (B) COMPLIES WITH THE APPLICABLE PROVISIONS OF THIS ARTICLE AND ALL REQUIREMENTS PROMULGATED BY THE CORPORATION FOR THE ADMINISTRATION OF THE PROGRAM.
- 2. WITHIN THE AMOUNTS APPROPRIATED THEREFOR, AWARDS SHALL BE GRANTED TO APPLICANTS THAT THE CORPORATION HAS CERTIFIED ARE ELIGIBLE TO RECEIVE SUCH AWARDS. SUCH AWARDS SHALL BE MADE TO RECIPIENTS AFTER THE SUCCESSFUL COMPLETION OF EACH ACADEMIC YEAR, AS DEFINED BY THE CORPORATION.
- 3. AN AWARD SHALL ENTITLE THE RECIPIENT TO ANNUAL PAYMENTS FOR NOT MORE THAN FOUR ACADEMIC YEARS OF FULL-TIME UNDERGRADUATE STUDY.
- 4. RECIPIENTS SHALL RECEIVE AN ANNUAL PAYMENT FOR THE SUCCESSFUL COMPLETION OF AN ACADEMIC YEAR, EQUAL TO UP TO ONE HUNDRED PERCENT OF THE ANNUAL TUITION CHARGED TO STATE RESIDENT STUDENTS ATTENDING AN

1 UNDERGRADUATE PROGRAM FULL-TIME AT THE STATE UNIVERSITY OF NEW YORK, OR 2 ACTUAL TUITION CHARGED, WHICHEVER IS LESS.

5. THE CORPORATION SHALL CONVERT TO A STUDENT LOAN THE FULL AMOUNT OF 3 THE AWARD GIVEN PURSUANT TO THIS SECTION PLUS INTEREST, ACCORDING TO A 5 SCHEDULE TO BE DETERMINED BY THE CORPORATION IF: (A) A RECIPIENT FAILS 6 TO COMPLETE THEIR COURSE OF STUDIES AS AGREED TO WITH THE CORPORATION OR IS NOT A MEMBER IN GOOD STANDING IN A NEW YORK VOLUNTEER FIRE COMPANY 7 WHILE OBTAINING HIS OR HER DEGREE; OR (B) TWO YEARS AFTER THE COMPLETION 8 9 OF THEIR COURSE OF STUDIES AS AGREED TO WITH THE CORPORATION IT IS FOUND 10 THAT THE RECIPIENT IS NOT WORKING FOR A NEW YORK VOLUNTEER FIRE COMPANY; OR (C) A RECIPIENT HAS NOT WORKED FOR A NEW YORK VOLUNTEER FIRE COMPANY 11 FOR FIVE OF THE SEVEN YEARS AFTER THE COMPLETION OF 12 THEIR COURSE OF AGREED TO WITH THE CORPORATION; OR (D) A RECIPIENT FAILS TO 13 STUDIES AS 14 RESPOND TO REQUESTS BY THE FIREMAN'S ASSOCIATION OF THE STATE OF NEW 15 YORK FOR THE STATUS OF HIS OR HER ACADEMIC OR PROFESSIONAL PROGRESS.

S 2. This act shall take effect immediately.
