AN ACT to amend the insurance law, in relation to including post traumatic stress disorder in the definition of biologically based mental illness for purposes of Timothy's Law

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Item (ii) of subparagraph (B) of paragraph 5 of subsection 2 (1) of section 3221 of the insurance law, as amended by chapter 502 of 3 the laws of 2007, is amended to read as follows:

4 (ii) For purposes of this paragraph, the term "biologically based 5 mental illness" means a mental, nervous, or emotional condition that is 6 caused by a biological disorder of the brain and results in a clinically 7 significant, psychological syndrome or pattern that substantially limits 8 the functioning of the person with the illness. Such biologically based mental illnesses are defined as schizophrenia/psychotic disorders, major 9 depression, bipolar disorder, delusional disorders, panic disorder, 10 11 obsessive compulsive disorders, POST TRAUMATIC STRESS DISORDER, bulimia, 12 and anorexia.

13 S 2. Subparagraph (B) of paragraph 2 of subsection (g) of section 4303 14 of the insurance law, as amended by chapter 502 of the laws of 2007, is 15 amended to read as follows:

(B) For purposes of this subsection, the term "biologically based mental illness" means a mental, nervous, or emotional condition that is 16 17 caused by a biological disorder of the brain and results in a clinically 18 significant, psychological syndrome or pattern that substantially limits 19 the functioning of the person with the illness. Such biologically based 20 mental illnesses are defined as schizophrenia/psychotic disorders, major 21 22 depression, bipolar disorder, delusional disorders, panic disorder, 23 obsessive compulsive disorders, POST TRAUMATIC STRESS DISORDER, anore-24 xia, and bulimia.

4 (B) For purposes of this subsection, the term "biologically based mental illness" means a mental, nervous, or emotional condition that is caused by a biological disorder of the brain and results in a clinically 5 б 7 significant, psychological syndrome or pattern that substantially limits 8 the functioning of the person with the illness. Such biologically based mental illnesses are defined as schizophrenia/psychotic disorders, major 9 depression, bipolar disorder, delusional disorders, panic disorder, obsessive compulsive disorder, POST TRAUMATIC STRESS DISORDER, anorexia, 10 11 12 and bulimia.
