AN ACT to amend the education law, in relation to clarifying the authorization to practice for mental health practitioners

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Subdivision 1 of section 8402 of the education law, as added by chapter 676 of the laws of 2002, is amended to read as follows: 1. Definition of the practice of mental health counseling. The practice of the profession of mental health counseling is defined as:
