AN ACT to amend the education law, in relation to budgets of boards of cooperative educational services

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subparagraph 1 of paragraph b of subdivision 4 of section 2 1950 of the education law, as amended by chapter 474 of the laws of 3 1996, is amended to read as follows:

4 (1) Prepare, prior to the annual meeting of members of the boards of 5 education and school trustees, held as provided in paragraph o of this б subdivision, a tentative budget of expenditures for the program costs, a tentative budget for capital costs, and a tentative budget for the 7 administration costs of the board of cooperative educational services. 8 9 EXCEPT AS PROVIDED IN PARAGRAPH C-1 OF THIS SUBDIVISION, [Such] SUCH budgets shall include the proposed budget for the upcoming school year, 10 the previous school year's actual costs and the current school year's 11 12 projected costs for each object of expenditure. Such program, capital and administrative budgets shall be separately delineated in accordance 13 14 with the definition of program, capital and administrative costs which shall be promulgated by the commissioner after consultation with school 15 district officials and the director of the budget. Personal service 16 17 costs for each budget shall include the number of full-time equivalent positions funded and total salary and, except as noted herein, fringe 18 19 benefit costs for such positions by program. Each program budget shall 20 include the local and statewide unit costs of such programs and also services proposed for the upcoming school year, such actual unit costs 21 22 for the previous school year, and the current school year's projected 23 unit costs, all established in accordance with paragraph d of this 24 subdivision. The capital budget shall include facility construction and 25 lease expenditures authorized pursuant to paragraphs p, t and u of this

subdivision, payments for the repayment of indebtedness related to capi-1 tal projects, payments for the acquisition or construction of facili-2 3 ties, sites or additions, provided that such budget shall contain a 4 rental, operations and maintenance section that will include base rent 5 costs, total rent costs, operations and maintenance charges, cost per 6 square foot for each facility rented or leased by such board of cooper-7 ative educational services, and any and all expenditures associated with 8 custodial salaries and benefits, service contracts, supplies, utilities, maintenance and repairs for such facilities, and that such budget shall 9 10 include the annual debt service and total debt for all facilities 11 financed by bonds or notes of the component districts, annual rental and 12 lease payments and total rental and lease costs for all facilities rent-13 ed by such board; such capital budget shall also include expenditures 14 resulting from court judgments and orders from administrative bodies or 15 officers, and, to the extent a board's administrative budget has been adopted, one-time costs incurred in the first year in which an employee retires. The administrative budget shall include, but need not be limit-16 17 ed to, office and central administrative expenses, traveling 18 expenses 19 and salaries and benefits of supervisors and administrative personnel necessary to carry out the central administrative duties of the supervi-20 21 sory district, any and all expenditures associated with the board, the 22 district superintendent, general administration, office of central support services, planning, and all other administrative activities. 23 Such administrative budget shall also specify the amount of supplementa-24 25 salary and benefits, if any, which the board determines should be ry 26 paid to the district superintendent of schools and the board shall append to such budget a detailed statement of the total compensation to 27 be paid the district superintendent of schools by the board, including a 28 29 delineation of the salary, annualized cost of benefits and any in-kind 30 other form of remuneration to be paid, plus, commencing with the or presentation of the budget for the nineteen hundred ninety-seven--nine-31 32 ty-eight school year, a list of items of expense eligible for reimburse-33 ment on expense accounts in the ensuing school year and a statement of 34 the amount of expenses paid to the district superintendent of schools in the prior year for purposes of carrying out his or her official duties. 35 36 S 2. Subdivision 4 of section 1950 of the education law is amended by 37 adding a new paragraph c-1 to read as follows:

38 C-1. THE COMMISSIONER MAY, PURSUANT TO RULES AND REGULATIONS, AUTHOR-39 A BOCES, TO OPERATE ON A MULTI-YEAR BUDGET FOR PROGRAM, CAPITAL IZE 40 AND/OR ADMINISTRATIVE EXPENDITURES IF IT IS DETERMINED ΒY THE COMMIS-THAT A MULTI-YEAR BUDGET WILL RESULT IN GREATER EFFICIENCIES TO 41 SIONER THE COMPONENT DISTRICT. SUCH MULTI-YEAR BUDGET SHALL BE DEVELOPED IN THE 42 SAME MANNER AS REQUIRED PURSUANT TO SUBPARAGRAPHS ONE, TWO, THREE, FOUR, 43 44 FIVE, SIX AND SEVEN OF PARAGRAPH B OF THIS SUBDIVISION EXCEPT THAT IΤ 45 SHALL BE DONE BASED ON A MULTI-YEAR BASIS.

46 S 3. Subdivision 1 of section 1951 of the education law, as amended by 47 chapter 474 of the laws of 1996, is amended to read as follows:

48 1. The final administrative and capital budgets of the board of cooperative educational services as adopted INCLUDING, BUT NOT LIMITED 49 ΤO 50 MULTI-YEAR BUDGETS THAT ARE AUTHORIZED PURSUANT TO PARAGRAPH C-1 OF 51 SUBDIVISION FOUR OF SECTION NINETEEN HUNDRED FIFTY OF THIS ARTICLE, shall be a charge against all of the school districts contained in the 52 53 board of cooperative educational services, provided, however, that any 54 component school district which does not elect to participate in any 55 specific educational service authorized to be furnished by the board of 56 cooperative educational services shall not be required to pay any share

of the moneys provided in the program budget as salaries of teachers or 1 2 other personnel employed in providing such service, for equipment and 3 supplies for such service or for transportation of pupils to and from 4 the place where such service is maintained, provided, however, expendi-5 tures for the board of cooperative educational services program, includ-6 ing office and central administrative expenses, traveling expenses and 7 salaries and benefits of supervisors and all other central administra-8 tive personnel necessary to carry out its program shall be deemed administrative expenses which shall be a charge upon all component school 9 10 districts notwithstanding the fact that such a component school district elects to not participate in any specific program offered by the board 11 12 of cooperative educational services. Each school district's propor-13 tionate share of administrative and capital expenses shall be determined 14 in accordance with subparagraph seven of paragraph b of subdivision four 15 of section nineteen hundred fifty of this article. The board shall alloother services to participating component school 16 cate the cost of districts in accordance with terms agreed upon between such board 17 and the boards of education and trustees of each component school district 18 19 using the local uniform unit cost of each such service, based on (i) anticipated participation in the ensuing school year, or (ii) partic-20 21 ipation in the current year, or (iii) a two or three year average 22 including participation in the current year, which unit cost shall be the same for all participating component school districts and shall be 23 computed in accordance with a uniform methodology approved annually by 24 25 at least three-quarters of the participating component school districts 26 after consultation by local school officials with their respective boards; provided, however, such unit cost shall be subject to final 27 adjustment for programs for students with disabilities based on actual 28 29 participation in accordance with regulations of the commissioner. The school authorities of each school district in the board of cooperative 30 educational services shall add such amount to the budget of such school 31 32 district and shall pay such amount to the treasurer of the board of 33 cooperative educational services, and shall be paid out by the treasurer 34 upon orders of the board issued and executed pursuant to the resolution 35 of said board.

36 S 4. This act shall take effect on the first of July next succeeding 37 the date on which it shall have become a law.
