AN ACT to amend the real property law, in relation to allowing an assignment of mortgage in lieu of a certificate of discharge

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 2 of section 275 of the real property law is 2 amended by adding a new closing paragraph to read as follows:

NOTE WAS MISPLACED OR LOST.

THE SITUATION PROVIDED FOR IN PARAGRAPH (C) OF THIS SUBDIVISION, THE MORTGAGOR, AT HIS OR HER OPTION MAY DEMAND AN ASSIGNMENT AND MORTGAGE SECURING ITS PAYMENT TO ANOTHER LENDER. MORTGAGOR'S NOTE ASSIGN THE ORIGINAL LENDER SHALL THE MORTGAGOR'S NOTE AND MORTGAGE SECURING ITS PAYMENT TO ANOTHER LENDER UPON SUCH DEMAND. THE DEMAND FOR THE ASSIGNMENT OF MORTGAGE SHALL BE MADE BY THE MORTGAGOR TO THE MORTGA-GEE IN WRITING WITHIN TWENTY DAYS OF CLOSING ON THE REFINANCING AND THE PURPOSE FOR SUCH ASSIGNMENT IS TO EFFECTUATE THE THATSHALL STATE REFINANCING OF THE EXISTING LOAN WITH A NEW LENDER. THE PERSON THE ASSIGNMENT SHALL DELIVER THE ASSIGNMENT AND ANY NECESSARY ACCOMPANY-ING PAPERS OR AFFIDAVITS AT LEAST TWO DAYS PRIOR TO SUCH CLOSING, TO THE ESCROW AGENT DESIGNATED BY THE MORTGAGOR AND THE MORTGAGEE OR ORIGINAL LENDER. UPON CLOSING, THE ESCROW AGENT SHALL TRANSMIT THE ASSIGNMENT AND ANY NECESSARY ACCOMPANYING PAPERS OR AFFIDAVITS TO THE NEW LENDER OR MORTGAGEE. THE PROVISIONS OF THIS PARAGRAPH SHALL NEITHER EXPAND NOR DIMINISH THE LIABILITY AGAINST A MORTGAGEE WHO, AFTER A GOOD UNABLE TO DELIVER THE NOTE TO THE ESCROW AGENT BECAUSE THE EFFORT, IS
