AN ACT to amend the vehicle and traffic law, in relation to establishing distinctive "Pink Ribbon" plates; and to amend the state finance law, in relation to establishing the "breast cancer education and support fund"

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The vehicle and traffic law is amended by adding a new 2 section 404-x to read as follows:

- S 404-X. DISTINCTIVE "PINK RIBBON" LICENSE PLATES. 1. ANY PERSON RESIDING IN THIS STATE SHALL, UPON REQUEST, BE ISSUED A DISTINCTIVE "PINK RIBBON" LICENSE PLATE OF A DESIGN APPROVED BY THE COMMISSIONER. APPLICATION FOR SAID LICENSE PLATE SHALL BE FILED WITH THE FORM AND DETAIL AS THE COMMISSIONER SHALL PRESCRIBE.
- 2. A DISTINCTIVE PLATE ISSUED PURSUANT TO THIS SECTION SHALL BE ISSUED IN THE SAME MANNER AS OTHER NUMBER PLATES UPON THE PAYMENT OF THE REGULAR REGISTRATION FEE PRESCRIBED BY SECTION FOUR HUNDRED ONE OF THIS ARTICLE, PROVIDED, HOWEVER, THAT AN ADDITIONAL ANNUAL SERVICE CHARGE OF TWENTY-FIVE DOLLARS SHALL BE CHARGED FOR SUCH PLATE. SUCH ADDITIONAL SERVICE CHARGE SHALL BE DEPOSITED PURSUANT TO SECTION FOUR HUNDRED FOUR-OO OF THIS ARTICLE TO THE CREDIT OF THE DEPARTMENT OF MOTOR VEHICLES DISTINCTIVE PLATE DEVELOPMENT FUND, ESTABLISHED BY SECTION NINETY-
- 15 CLES DISTINCTIVE PLATE DEVELOPMENT FUND, ESTABLISHED BY SECTION NINETY-16 FIVE-G OF THE STATE FINANCE LAW, AND SHALL BE USED FOR THE PRODUCTION,
- 17 DESIGN, ADVERTISING AND MARKETING OF DISTINCTIVE NUMBER PLATES;
- 18 PROVIDED, HOWEVER, THAT ADDITIONAL ANNUAL SERVICE CHARGES COLLECTED IN

BREAST CANCER EDUCATION AND SUPPORT FUND ESTABLISHED PURSUANT TO SECTION NINETY-FIVE-I OF THE STATE FINANCE LAW.

- 3 S 2. The state finance law is amended by adding a new section 95-i to 4 read as follows:
- S 95-I. BREAST CANCER EDUCATION AND SUPPORT FUND. 1. THERE IS HEREBY ESTABLISHED IN THE JOINT CUSTODY OF THE COMMISSIONER OF TAXATION AND FINANCE AND THE COMPTROLLER, A SPECIAL FUND TO BE KNOWN AS THE "BREAST CANCER EDUCATION AND SUPPORT FUND".
- 9 2. SUCH FUND SHALL CONSIST OF ALL MONEYS COLLECTED PURSUANT TO SECTION 10 FOUR HUNDRED FOUR-X OF THE VEHICLE AND TRAFFIC LAW, AND ALL OTHER MONEYS 11 APPROPRIATED, CREDITED OR TRANSFERRED THERETO FROM ANY OTHER FUND OR 12 SOURCE PURSUANT TO LAW.
- 3. MONEYS OF THE FUND SHALL BE EXPENDED BY THE DEPARTMENT FOR BREAST CANCER EDUCATION AND SUPPORT PROJECTS AND GRANTS TO COMMUNITY-BASED ORGANIZATIONS PURSUANT TO SECTION TWENTY-FOUR HUNDRED SIX-A OF THE PUBLIC HEALTH LAW.
- 17 S 3. This act shall take effect immediately.
