GIANARIS, ADDABBO, AVELLA, BRESLIN, HOYLMAN, KRUEG-ER, LATIMER, PARKER, STAVISKY -- read twice and ordered printed, and when printed to be committed to the Committee on Transportation -committee discharged, bill amended, ordered reprinted as amended and recommitted to said committee
- AN ACT to amend the vehicle and traffic law, in relation to the surrender of certificates of registration and number plates of all motor vehicles which a person has registered where such person has a suspended or revoked license

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The vehicle and traffic law is amended by adding a new 2 section 403-c to read as follows:

3 S 403-C. SURRENDER OF REGISTRATION AND NUMBER PLATES. 1. ANY PERSON 4 HAS HAD THEIR LICENSE SUSPENDED OR REVOKED PURSUANT TO SECTION FIVE WHO 5 HUNDRED TEN OR FIVE HUNDRED TEN-A OF THIS CHAPTER SHALL SURRENDER THE CERTIFICATES OF REGISTRATION AND NUMBER PLATES OF ALL MOTOR VEHICLES 6 7 WHICH SUCH PERSON HAS REGISTERED PURSUANT TO THIS ARTICLE, ТО THE 8 SUCH SURRENDER OF REGISTRATION AND NUMBER PLATES SHALL DEPARTMENT. 9 REMAIN IN EFFECT AS LONG AS THE SUSPENSION OR REVOCATION OF SUCH DRIV-10 ER'S LICENSE.

12 2. ALL MOTOR VEHICLES REGISTERED TO SUCH PERSON SHALL NOT BE REGIS-12 TERED OR REREGISTERED IN THE NAME OF SUCH PERSON, OR IN ANY OTHER NAME 13 WHERE THE COMMISSIONER HAS REASONABLE GROUNDS TO BELIEVE THAT SUCH 14 REGISTRATION OR REREGISTRATION WILL HAVE THE EFFECT OF DEFEATING THE 15 PURPOSES OF THIS SECTION, AND NO OTHER MOTOR VEHICLE SHALL BE REGISTERED 16 IN THE NAME OF SUCH PERSON DURING THE PERIOD OF SUCH SUSPENSION.

EXCEPT AS PROVIDED IN SUBDIVISION FIVE OF SECTION FOUR HUNDRED
 TWENTY-EIGHT OF THIS TITLE, REFUNDS OF FEES ASSESSED PURSUANT TO THIS
 ARTICLE AND ARTICLE FOURTEEN-A OF THIS TITLE SHALL NOT BE PROVIDED WHEN
 SURRENDER IS MANDATED PURSUANT TO SUBDIVISION ONE OF THIS SECTION.

4. A. THE COMMISSIONER OR HIS OR HER DULY AUTHORIZED AGENT SHALL NOTI-FY EACH PERSON WHOSE LICENSE HAS BEEN SUSPENDED OR REVOKED OF HIS OR HER OBLIGATION TO SURRENDER THE CERTIFICATE OF REGISTRATION AND NUMBER PLATES OF ANY MOTOR VEHICLES WHICH SUCH PERSON HAS REGISTERED PURSUANT TO THIS ARTICLE.

6 B. SUCH NOTICE SHALL INCLUDE THE NAME AND ADDRESS OF THE PERSON WHOSE 7 LICENSE HAS BEEN SUSPENDED OR REVOKED, THE REGISTRATION NUMBER AND 8 NUMBER PLATES OF THE VEHICLE OR VEHICLES WHICH MUST BE SURRENDERED, THE 9 INFRACTION, INFRACTIONS, OFFENSE AND/OR OFFENSES FOR WHICH THE REGISTRA-10 TION AND NUMBER PLATES MUST BE SURRENDERED, AND THE DATES AND TIMES OF 11 THE CONVICTIONS OF SUCH INFRACTIONS AND/OR OFFENSES.

12 C. THE NOTICE SHALL ALSO CONTAIN A WARNING ADVISING THE PERSON OF THE 13 CONSEQUENCES OF FAILURE TO SURRENDER CERTIFICATE OF REGISTRATION AND 14 NUMBER PLATES.

15 D. THE NOTICE REQUIRED BY THIS SUBDIVISION SHALL BE PROVIDED BY FIRST 16 CLASS MAIL TO THE REGISTRANT OF THE MOTOR VEHICLE WITHIN THIRTY DAYS OF 17 THE LICENSE SUSPENSION OR REVOCATION.

E. SUCH PERSON SHALL SURRENDER ANY CERTIFICATE OF REGISTRATION AND ANY 18 19 NUMBER PLATES FOR ANY VEHICLE WHICH THE PERSON IS THE REGISTRANT WITHIN FOURTEEN DAYS OF RECEIVING NOTICE FROM THE DEPARTMENT. FAILURE 20 ΤO SURRENDER THE CERTIFICATE OF REGISTRATION AND NUMBER PLATES UPON NOTICE 21 SHALL CONSTITUTE AN INFRACTION, PUNISHABLE UPON CONVICTION BY A FINE NOT 22 LESS THAN ONE HUNDRED FIFTY DOLLARS NOR MORE THAN FIVE HUNDRED DOLLARS 23 OR IMPRISONMENT FOR NOT MORE THAN FIFTEEN DAYS OR BOTH SUCH FINE AND 24 25 IMPRISONMENT.

5. A WAIVER OF THE PROVISIONS OF SUBDIVISION ONE OF THIS SECTION SHALL 26 27 APPLY TO MOTOR VEHICLES WHICH ARE JOINTLY USED BY SPOUSES OR OTHER IMME-DIATE FAMILY MEMBERS IF THE IMPLEMENTATION OF SUCH SUBDIVISION WOULD 28 RESULT IN AN EXTREME HARDSHIP FOR THE SPOUSE OR FAMILY MEMBER WHOSE 29 LICENSE HAS NOT BEEN SUSPENDED OR REVOKED. TO BE ELIGIBLE FOR AN 30 EXTREME HARDSHIP EXCEPTION, A DULY LICENSED SPOUSE OR IMMEDIATE FAMILY 31 MEMBER MUST FURNISH PROOF ACCEPTABLE TO THE COMMISSIONER OR HIS OR HER 32 DULY AUTHORIZED AGENT THAT HE OR SHE JOINTLY USES A MOTOR VEHICLE WHOSE 33 REGISTRATION AND NUMBER PLATES WOULD OTHERWISE BE SUBJECT TO SURRENDER 34 35 PURSUANT TO SUBDIVISION ONE OF THIS SECTION. ACCEPTABLE PROOF SHALL INCLUDE WITHOUT LIMITATION THE SPOUSE OR IMMEDIATE FAMILY MEMBER BEING 36 NAMED IN A POLICY OF LIABILITY INSURANCE FOR THE MOTOR VEHICLE PURSUANT 37 TO ARTICLE SEVEN OF THIS CHAPTER BEFORE THE DATE OF CONVICTION, AND ANY ADDITIONAL FACTORS THAT THE COMMISSIONER OR HIS OR HER DULY AUTHORIZED 38 39 40 AGENT DEEMS NECESSARY TO ESTABLISH JOINT USE. THE COMMISSIONER OR HIS OR HER DULY AUTHORIZED AGENT SHALL DETERMINE WHETHER AN INDIVIDUAL QUALI-41 FIES AS AN IMMEDIATE FAMILY MEMBER, PROVIDED THAT SUCH DEFINITION OF IMMEDIATE FAMILY MEMBERS SHALL INCLUDE WITHOUT LIMITATION DOMESTIC PART-42 43 NERS AS DEFINED IN SECTION FOUR OF THE WORKERS' COMPENSATION LAW AND ANY 44 45 CHILDREN OF THE REGISTRANT.

46 S 2. This act shall take effect on the one hundred eightieth day after 47 it shall have become a law.
