- AN ACT to amend the executive law, in relation to the criminal enforcement of violations of the state's uniform fire prevention and building code

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 2 of section 382 of the executive law, as 2 amended by chapter 135 of the laws of 1997, is amended to read as 3 follows:

4 2. [Any person, having been served, either personally or by registered 5 or certified mail, with an order to remedy any condition found to exist 6 in, on, or about any building in violation of the uniform fire 7 prevention and building code, who shall fail to comply with such order 8 within the time fixed by the regulations promulgated by the secretary 9 pursuant to subdivision one of section three hundred eighty-one of this 10 article, such time period to be stated in the order, and]

(A) ANY PERSON, LIMITED LIABILITY COMPANY, LIMITED LIABILITY 11 PARTNER-12 SHIP, OR CORPORATION OWNING, IN CONTROL OF, AGENT FOR, TENANT OF, OR OTHERWISE RESPONSIBLE FOR A PROPERTY OR BUILDING, 13 HAVING BEEN SERVED, PURSUANT 14 EITHER PERSONALLY OR TO SUBDIVISION FOUR OF SECTION THREE HUNDRED EIGHT OF THE CIVIL PRACTICE LAW AND RULES, 15 WITH AN ORDER TO 16 REMEDY ANY CONDITION FOUND TO EXIST IN, ON, OR ABOUT THE PROPERTY OR ANY 17 BUILDING ON THE PROPERTY IN VIOLATION OF THE UNIFORM FIRE PREVENTION AND BUILDING CODE, WHO FAILS TO COMPLY WITH SUCH ORDER WITHIN THE TIME STAT-18 19 ED THEREIN OR any owner, builder, PROPERTY MANAGER, PROPERTY AGENT,

33 S 2. This act shall take effect on the ninetieth day after it shall 34 have become a law.
