- AN ACT to amend the executive law, in relation to the establishment of the New York state veterans cemetery act

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

1 Section 1. Short title. This act shall be known and may be cited as 2 the "New York state veterans cemetery act".

3 S 2. The executive law is amended by adding a new section 368-a to 4 read as follows:

5 368-A. VETERANS CEMETERY FUNDING PROMOTION PROGRAM. THE DIVISION IS S 6 HEREBY DIRECTED TO ESTABLISH, PRODUCE AND CONDUCT A NEW YORK STATE 7 VETERANS CEMETERY FUNDING PROMOTION PROGRAM. THE PURPOSE OF THE NEW YORK STATE VETERANS CEMETERY FUNDING PROGRAM WOULD BE TO ENCOURAGE THE GIVING 8 FINANCIAL CONTRIBUTIONS, BY INDIVIDUALS, GROUPS AND CORPORATIONS, TO 9 OF 10 THE VETERANS REMEMBRANCE AND CEMETERY MAINTENANCE AND OPERATION FUND, PURSUANT TO SECTION NINETY-SEVEN-MMMM OF THE STATE FINANCE LAW, 11 CREATED 12 WHICH WAS ESTABLISHED TO PROVIDE FUNDING FOR VETERANS CEMETERIES PURSU-13 TO THE NEW YORK STATE VETERANS CEMETERY PROGRAM CREATED UNDER ANT 14 SECTION THREE HUNDRED SIXTY-FIVE OF THIS CHAPTER. INESTABLISHING THE 15 NEW YORK STATE VETERANS CEMETERY FUNDING PROMOTION PROGRAM, THE DIVISION SHALL ESTABLISH, PRODUCE AND CONDUCT PROGRAMS, PROJECTS, AND MATERIALS 16 17 DESIGNED TO ENCOURAGE THE GIVING OF FINANCIAL CONTRIBUTIONS, BY INDIVID-UALS, GROUPS AND CORPORATIONS, TO THE VETERANS REMEMBRANCE AND CEMETERY 18 MAINTENANCE AND OPERATION FUND. THE DIVISION SHALL FURTHER SEEK, AND MAY 19 APPLY ON BEHALF OF THE STATE OF NEW YORK, FOR GRANTS AND CONTRIBUTIONS, 20 21 FROM GOVERNMENTS AND/OR OTHER INSTITUTIONAL FUNDING SOURCES, FOR DEPOSIT 22 IN, AND USE BY, THE VETERANS REMEMBRANCE AND CEMETERY MAINTENANCE AND 23 OPERATION FUND, FOR THE PURPOSE OF CONSTRUCTING, OPERATING AND FINANCING

NEW YORK STATE VETERANS CEMETERIES. EVERY YEAR, NOT LATER THAN THE 1 FIFTEENTH OF DECEMBER, THE DIVISION SHALL PRODUCE A REPORT OF THE ACTIV-2 ITIES AND OPERATION OF THE NEW YORK STATE VETERANS CEMETERY 3 FUNDING 4 PROMOTION PROGRAM, AND SHALL DELIVER A COPY OF SUCH REPORT TO THE GOVER-5 NOR, THE TEMPORARY PRESIDENT OF THE SENATE, THE SPEAKER OF THE ASSEMBLY, THE CHAIR OF THE SENATE STANDING COMMITTEE ON VETERANS, HOMELAND SECURI-6 7 TY AND MILITARY AFFAIRS AND THE CHAIR OF THE ASSEMBLY STANDING COMMITTEE 8 ON VETERANS' AFFAIRS. SUCH REPORT SHALL CONTAIN INFORMATION ON THE OPER-ATIONS AND PROGRESS OF THE NEW YORK STATE VETERANS CEMETERY FUNDING 9 10 PROMOTION PROGRAM, AS WELL AS RECOMMENDATIONS TO THE LEGISLATURE ON THE NEW YORK STATE VETERANS CEMETERY FUNDING PROMOTION PROGRAM, AND ESTAB-11 LISHING, MAINTAINING AND OPERATING STATE VETERANS CEMETERIES IN ACCORD-12 ANCE WITH THE NEW YORK STATE VETERANS CEMETERY PROGRAM. 13 14 S 3. This act shall take effect immediately.
