AN ACT to amend the criminal procedure law, in relation to requiring court review of domestic violence bail applications

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- Section 1. This act shall be known and may be cited as the "Isol Cotto Act".
- S 2. The criminal procedure law is amended by adding a new section 510.25 to read as follows:
- S 510.25 APPLICATION FOR RECOGNIZANCE OR BAIL; WHERE DEFENDANT IS ACCUSED OF DOMESTIC VIOLENCE OR VIOLATING AN EXISTING ORDER OF PROTECTION.
- ARRESTED FOR AN OFFENSE RELATING TO: (A) DOMESTIC ANY INDIVIDUAL VIOLENCE, AS DEFINED IN SECTION FOUR HUNDRED FIFTY-NINE-A OF THE SERVICES LAW; (B) VIOLATING AN EXISTING ORDER OF PROTECTION ISSUED PURSUANT TO THE FOLLOWING PROVISIONS OF LAW: SUBDIVISION ONE OF SECTION 530.11, SUBPARAGRAPH (I) OR (II) OF PARAGRAPH (O) OF SUBDIVISION ONE OF SECTION 530.12 OF THIS CHAPTER, ORDERS ISSUED PURSUANT SECTION 330.20, TO SECTIONS TWO HUNDRED FORTY AND TWO HUNDRED FIFTY-TWO OF THE DOMESTIC ARTICLES FOUR, FIVE, SIX AND EIGHT OF THE FAMILY COURT RELATIONS LAW, ACT, AND AN ORDER OF PROTECTION ISSUED BY COURTS OF COMPETENT JURISDIC-ANOTHER STATE, TERRITORIAL OR TRIBAL JURISDICTION; OR (C) COMMITTING A FAMILY OFFENSE AS DEFINED IN SUBDIVISION ONE OF SECTION EIGHT HUNDRED TWELVE OF THE FAMILY COURT ACT SHALL NOT BE RELEASED ON BAIL UNTIL THEY HAVE APPEARED BEFORE A JUDGE OF THE COURT.
- 2. THE COURT'S REVIEW OF BAIL, AS PROVIDED FOR IN THIS SECTION, SHALL INCLUDE BUT NOT BE LIMITED TO: (A) A REVIEW OF THE CIRCUMSTANCES OF THE ARREST; (B) ANY PRIOR VIOLENT OFFENSES; AND (C) THE RISK THAT THE ACCUSED POSES TO THE VICTIM IF RELEASED. SUCH APPEARANCE SHALL OCCUR WITHIN TWELVE HOURS OF ARREST AND IN NO INSTANCE MAY THE ACCUSED BE HELD UNDER THE PROVISIONS OF THIS SECTION FOR MORE THAN TWELVE HOURS.
- S 3. This act shall take effect immediately.
