Introduced by Sens. SERINO, MARCHIONE -- read twice and ordered printed, and when printed to be committed to the Committee on Codes -- reported favorably from said committee, ordered to first and second report, amended on second report, ordered to a third reading, and to be reprinted as amended, retaining its place in the order of third reading

AN ACT to amend the penal law, in relation to public lewdness; to amend the vehicle and traffic law, in relation to designating public lewdness in the first degree as an offense which results in permanent disqualification as a bus driver; and to amend the correction law, in relation to designating public lewdness in the first degree as a sex offense for purposes of the sex offender registration

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. Paragraph (c) of subdivision 3 of section 65.00 of the  
2     penal law, as amended by chapter 568 of the laws of 2004, is amended to  
3     read as follows:  
4     (c) For a class B misdemeanor, the period of probation shall be one  
5     year, except the period of probation shall be no less than one year and  
6     no more than three years for the class B misdemeanor of public lewdness  
7     IN THE FOURTH DEGREE as defined in section 245.00 of this chapter;  
8     S 2. Section 245.00 of the penal law, as amended by chapter 748 of the  
9     laws of 1968, is amended to read as follows:  
10    S 245.00 Public lewdness IN THE FOURTH DEGREE.  
11    A person is guilty of public lewdness IN THE FOURTH DEGREE when he OR  
12    SHE intentionally exposes the private or intimate parts of his OR HER  
13    body in a lewd manner or commits any other lewd act (a) in a public  
14    place, or (b) in private premises under circumstances in which he OR SHE  
15    may readily be observed from either a public place or from other private  
16    premises, and with intent that he OR SHE be so observed.  
17    Public lewdness IN THE FOURTH DEGREE is a class B misdemeanor.

1 S 3. The penal law is amended by adding a new section 245.04 to read  
2 as follows:

3 S 245.04 PUBLIC LEWDNESS IN THE THIRD DEGREE.

4 A PERSON IS GUILTY OF PUBLIC LEWDNESS IN THE THIRD DEGREE WHEN HE OR  
5 SHE INTENTIONALLY EXPOSES THE PRIVATE OR INTIMATE PARTS OF HIS OR HER  
6 BODY IN A LEWD MANNER OR COMMITS ANY OTHER LEWD ACT (A) IN A PUBLIC  
7 PLACE, OR (B) IN A PRIVATE PREMISES UNDER CIRCUMSTANCES IN WHICH HE OR  
8 SHE MAY READILY BE OBSERVED FROM EITHER A PUBLIC PLACE OR FROM OTHER  
9 PRIVATE PREMISES, AND WITH THE INTENT THAT HE OR SHE BE OBSERVED WHEN  
10 THE OFFENSE IS COMMITTED FOR THE PURPOSE, IN WHOLE OR SUBSTANTIAL PART,  
11 OF HIS OR HER OWN SEXUAL GRATIFICATION.

12 PUBLIC LEWDNESS IN THE THIRD DEGREE IS A CLASS A MISDEMEANOR.

13 S 4. The penal law is amended by adding two new sections 245.06 and  
14 245.09 to read as follows:

15 S 245.06 PUBLIC LEWDNESS IN THE SECOND DEGREE.

16 A PERSON IS GUILTY OF PUBLIC LEWDNESS IN THE SECOND DEGREE WHEN HE OR  
17 SHE COMMITS THE CRIME OF PUBLIC LEWDNESS IN THE THIRD DEGREE, AS DEFINED  
18 IN SECTION 245.04 OF THIS ARTICLE, AND HAS PREVIOUSLY BEEN CONVICTED OF  
19 SUCH CRIME WITHIN THE PRECEDING TEN YEARS.

20 PUBLIC LEWDNESS IN THE SECOND DEGREE IS A CLASS E FELONY.

21 S 245.09 PUBLIC LEWDNESS IN THE FIRST DEGREE.

22 A PERSON IS GUILTY OF PUBLIC LEWDNESS IN THE FIRST DEGREE WHEN HE OR  
23 SHE COMMITS THE CRIME OF PUBLIC LEWDNESS IN THE THIRD DEGREE, AS DEFINED  
24 IN SECTION 245.04 OF THIS ARTICLE, AND SUCH CRIME IS COMMITTED AT A TIME  
25 OR PLACE WHERE A CHILD UNDER THE AGE OF FOURTEEN IS PRESENT.

26 PUBLIC LEWDNESS IN THE FIRST DEGREE IS A CLASS D FELONY.

27 S 5. Paragraph (b) of subdivision 4 of section 509-cc of the vehicle  
28 and traffic law, as amended by chapter 400 of the laws of 2011, is  
29 amended to read as follows:

30 (b) The offenses referred to in subparagraph (ii) of paragraph (a) of  
31 subdivision one and paragraph (b) of subdivision two of this section  
32 that result in permanent disqualification shall include a conviction  
33 under sections 100.13, 105.15, 105.17, 115.08, 120.12, 120.70, 125.10,  
34 125.11, 130.40, 130.53, 130.60, 130.65-a, 135.20, 160.15, 220.18,  
35 220.21, 220.39, 220.41, 220.43, 220.44, 230.25, 245.04, 245.06, 245.09,  
36 260.00, 265.04 of the penal law or an attempt to commit any of the aforesaid offenses under section 110.00 of the penal law, or any offenses committed under a former section of the penal law which would constitute violations of the aforesaid sections of the penal law, or any offenses committed outside this state which would constitute violations of the aforesaid sections of the penal law.

42 S 6. Subparagraph (i) of paragraph (a) of subdivision 2 of section  
43 168-a of the correction law, as amended by chapter 405 of the laws of  
44 2008, is amended to read as follows:

45 (i) a conviction of or a conviction for an attempt to commit any of  
46 the provisions of sections 120.70, 130.20, 130.25, 130.30, 130.40,  
47 130.45, 130.60, 230.34, 245.09, 250.50, 255.25, 255.26 and 255.27 or  
48 article two hundred sixty-three of the penal law, or section 135.05,  
49 135.10, 135.20 or 135.25 of such law relating to kidnapping offenses,  
50 provided the victim of such kidnapping or related offense is less than  
51 seventeen years old and the offender is not the parent of the victim, or
