AN ACT to amend the vehicle and traffic law, in relation to the provision of notice to owners whose motor vehicles are subject to safety recalls

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. The vehicle and traffic law is amended by adding a new section 210-a to read as follows:

- S 210-A. MOTOR VEHICLE SAFETY RECALL INFORMATION. 1. THE DEPARTMENT AVAILABLE ITS INTERNET SHALL MAKE ONWEBSITE, Α LINK TO "HTTP://WWW.SAFERCAR.GOV" OPERATED BY THE NATIONAL HIGHWAY TRAFFIC SAFE-TY ADMINISTRATION AND PROVIDING ALL MOTOR VEHICLE SAFETY RECALLS, MOTOR VEHICLE MAKE, MODEL, YEAR AND VEHICLE IDENTIFICATION NUMBER, ISSUED BY SUCH ADMINISTRATION IN ACCORDANCE WITH THE NATIONAL AND MOTOR VEHICLE SAFETY ACT.
- 2. THE DEPARTMENT SHALL ENSURE THAT THE LINK ESTABLISHED PURSUANT TO SUBDIVISION ONE OF THIS SECTION IS MADE DIRECTLY AVAILABLE TO EVERY OFFICIAL INSPECTION STATION.
 - 3. THEDEPARTMENT SHALL PROMOTE AND PROVIDE PUBLIC NOTICE OF THE SAFETY AVAILABILITY OF INFORMATION ON MOTOR VEHICLE RECALLS DEPARTMENT'S WEBSITE AND THE NATIONAL HIGHWAY TRAFFIC SAFETY ADMINIS-TRATION AT ITS WEBSITE: "HTTP://WWW.SAFERCAR.GOV". SUCH PROMOTION SHALL BE PROVIDED ON THE DEPARTMENT'S INTERNET WEBSITE AND ON A NOTICE SEPARATE INSERT PROVIDED TO MOTOR VEHICLE OWNERS UPON $_{
 m THE}$ ISSUANCE OR RENEWAL OF A REGISTRATION PURSUANT TO ARTICLE FOURTEEN OF THIS CHAPTER.
- 20 S 2. Subdivision (a) of section 304 of the vehicle and traffic law, as 21 amended by chapter 608 of the laws of 1993, is amended and a new subdi-22 vision (b-1) is added to read as follows:
- 23 (a) No certificate or certificates of inspection shall be issued by an 24 official inspection station until the mechanisms and other equipment, as

specified in SUBDIVISION (C) OF section three hundred one [(c)] of this [chapter] ARTICLE, of the motor vehicle inspected are in proper and safe condition and comply with the rules and regulations of the commissioner and with the laws of this state, and the emissions of such motor vehicle conform with subdivision (d) of section three hundred one of this article and regulations promulgated pursuant thereto at the time the certificate is issued, AND THE OFFICIAL INSPECTION STATION SHALL MAKE OR CAUSE TO BE MADE AN INQUIRY, BASED ON THE VEHICLE IDENTIFICATION NUMBER OF THE MOTOR VEHICLE, OF THE DEPARTMENT'S MOTOR VEHICLE SAFETY RECALL INTERNET LINK TO DETERMINE THE SAFETY RECALLS WHICH EXIST ON THE VEHICLE.

- (B-1) IF AFTER INQUIRY OF THE DEPARTMENT'S MOTOR VEHICLE SAFETY RECALL INTERNET LINK, ESTABLISHED PURSUANT TO SUBDIVISION ONE OF SECTION TWO HUNDRED TEN-A OF THIS CHAPTER, THE OFFICIAL INSPECTION STATION FINDS THAT THE INSPECTED MOTOR VEHICLE IS THE SUBJECT OF SAFETY RECALLS, SUCH STATION SHALL NOTIFY THE OWNER, IN WRITING, OF THE MOTOR VEHICLE SAFETY RECALLS THAT THE MOTOR VEHICLE IS SUBJECT TO, THAT SUCH RECALLS MAY BE REPAIRED AT A MOTOR VEHICLE DEALER APPROVED BY THE MANUFACTURER OF THE VEHICLE, AND THAT FURTHER INFORMATION ON THE RECALLS MAY BE OBTAINED FROM THE NATIONAL HIGHWAY TRAFFIC SAFETY ADMINISTRATION ON ITS WEBSITE: "HTTP://WWW.SAFERCAR.GOV".
- 21 S 3. This act shall take effect on the first of January next succeed22 ing the date on which it shall have become a law; provided, however,
 23 that effective immediately any and all actions necessary to implement
 24 the provisions of this act on its effective date are authorized and
 25 directed to be completed by the department of motor vehicles on or
 26 before such effective date.
