AN ACT to amend the vehicle and traffic law, in relation to the
provision of notice to owners whose motor vehicles are subject to
safety recalls

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-
BLY, DO ENACT AS FOLLOWS:

- 1 Section 1. The vehicle and traffic law is amended by adding a new
2 section 210-a to read as follows:
3 S 210-A. MOTOR VEHICLE SAFETY RECALL INFORMATION. 1. THE DEPARTMENT
4 SHALL MAKE AVAILABLE ON ITS INTERNET WEBSITE, A LINK TO
5 "HTTP://WWW.SAFERCAR.GOV" OPERATED BY THE NATIONAL HIGHWAY TRAFFIC SAFE-
6 TY ADMINISTRATION AND PROVIDING ALL MOTOR VEHICLE SAFETY RECALLS, BASED
7 ON MOTOR VEHICLE MAKE, MODEL, YEAR AND VEHICLE IDENTIFICATION NUMBER,
8 ISSUED BY SUCH ADMINISTRATION IN ACCORDANCE WITH THE NATIONAL TRAFFIC
9 AND MOTOR VEHICLE SAFETY ACT.
10 2. THE DEPARTMENT SHALL ENSURE THAT THE LINK ESTABLISHED PURSUANT TO
11 SUBDIVISION ONE OF THIS SECTION IS MADE DIRECTLY AVAILABLE TO EVERY
12 OFFICIAL INSPECTION STATION.
13 3. THE DEPARTMENT SHALL PROMOTE AND PROVIDE PUBLIC NOTICE OF THE
14 AVAILABILITY OF INFORMATION ON MOTOR VEHICLE SAFETY RECALLS FROM THE
15 DEPARTMENT'S WEBSITE AND THE NATIONAL HIGHWAY TRAFFIC SAFETY ADMINIS-
16 TRATION AT ITS WEBSITE: "HTTP://WWW.SAFERCAR.GOV". SUCH PROMOTION AND
17 NOTICE SHALL BE PROVIDED ON THE DEPARTMENT'S INTERNET WEBSITE AND ON A
18 SEPARATE INSERT PROVIDED TO MOTOR VEHICLE OWNERS UPON THE ISSUANCE OR
19 RENEWAL OF A REGISTRATION PURSUANT TO ARTICLE FOURTEEN OF THIS CHAPTER.
20 S 2. Subdivision (a) of section 304 of the vehicle and traffic law, as
21 amended by chapter 608 of the laws of 1993, is amended and a new subdi-
22 vision (b-1) is added to read as follows:
23 (a) No certificate or certificates of inspection shall be issued by an
24 official inspection station until the mechanisms and other equipment, as

1 specified in SUBDIVISION (C) OF section three hundred one [(c)] of this
2 [chapter] ARTICLE, of the motor vehicle inspected are in proper and safe
3 condition and comply with the rules and regulations of the commissioner
4 and with the laws of this state, and the emissions of such motor vehicle
5 conform with subdivision (d) of section three hundred one of this arti-
6 cle and regulations promulgated pursuant thereto at the time the certifi-
7 cate is issued, AND THE OFFICIAL INSPECTION STATION SHALL MAKE OR CAUSE
8 TO BE MADE AN INQUIRY, BASED ON THE VEHICLE IDENTIFICATION NUMBER OF THE
9 MOTOR VEHICLE, OF THE DEPARTMENT'S MOTOR VEHICLE SAFETY RECALL INTERNET
10 LINK TO DETERMINE THE SAFETY RECALLS WHICH EXIST ON THE VEHICLE.

11 (B-1) IF AFTER INQUIRY OF THE DEPARTMENT'S MOTOR VEHICLE SAFETY RECALL
12 INTERNET LINK, ESTABLISHED PURSUANT TO SUBDIVISION ONE OF SECTION TWO
13 HUNDRED TEN-A OF THIS CHAPTER, THE OFFICIAL INSPECTION STATION FINDS
14 THAT THE INSPECTED MOTOR VEHICLE IS THE SUBJECT OF SAFETY RECALLS, SUCH
15 STATION SHALL NOTIFY THE OWNER, IN WRITING, OF THE MOTOR VEHICLE SAFETY
16 RECALLS THAT THE MOTOR VEHICLE IS SUBJECT TO, THAT SUCH RECALLS MAY BE
17 REPAIRED AT A MOTOR VEHICLE DEALER APPROVED BY THE MANUFACTURER OF THE
18 VEHICLE, AND THAT FURTHER INFORMATION ON THE RECALLS MAY BE OBTAINED
19 FROM THE NATIONAL HIGHWAY TRAFFIC SAFETY ADMINISTRATION ON ITS WEBSITE:
20 "HTTP://WWW.SAFERCAR.GOV".

21 S 3. This act shall take effect on the first of January next succeed-
22 ing the date on which it shall have become a law; provided, however,
23 that effective immediately any and all actions necessary to implement
24 the provisions of this act on its effective date are authorized and
25 directed to be completed by the department of motor vehicles on or
26 before such effective date.
