AN ACT to amend the vehicle and traffic law, in relation to issuance of distinctive plates for Catholic War Veterans of America

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- Section 1. The vehicle and traffic law is amended by adding a new section 404-aa to read as follows:
 - S 404-AA. DISTINCTIVE PLATES FOR MEMBERS OF THE CATHOLIC WAR VETERANS OF AMERICA. 1. ANY MEMBER OF THE CATHOLIC WAR VETERANS OF AMERICA RESIDING IN THIS STATE SHALL, UPON REQUEST, BE ISSUED A LICENSE PLATE BEARING THE WORDS "CATHOLIC WAR VETERANS OF AMERICA". APPLICATION FOR SAID LICENSE PLATE SHALL BE FILED WITH THE COMMISSIONER IN SUCH FORM AND DETAIL AS THE COMMISSIONER SHALL PRESCRIBE.
- 2. THE DISTINCTIVE PLATE AUTHORIZED IN THIS SECTION SHALL BE ISSUED UPON PROOF, SATISFACTORY TO THE COMMISSIONER, THAT THE APPLICANT IS A MEMBER OF THE CATHOLIC WAR VETERANS OF AMERICA.
- 3. A DISTINCTIVE PLATE ISSUED PURSUANT TO THIS SECTION SHALL BE ISSUED IN THE SAME MANNER AS OTHER NUMBER PLATES UPON PAYMENT OF THE REGULAR REGISTRATION FEE PRESCRIBED BY SECTION FOUR HUNDRED ONE OF THIS ARTICLE; PROVIDED, HOWEVER, THAT AN ADDITIONAL ONE-TIME SERVICE CHARGE OF TEN DOLLARS SHALL BE CHARGED FOR SUCH PLATE.
- S 2. Subdivision 1-a of section 404 of the vehicle and traffic law, as added by chapter 415 of the laws of 2001, is amended to read as follows:

 1-a. The commissioner may issue special number plates to applicants who are members of veterans organizations in the same manner as other

number plates are issued pursuant to this article. Such special number plates shall be issued only upon (a) payment of a one-time service 3 in addition to the regular charge of ten dollars registration prescribed by section four hundred one of this article, and (b) 5 submission of proof, satisfactory to the commissioner, that the appli-6 cant is presently a member of the veterans organization for which such 7 plate is requested. Such membership shall be verified annually by the 8 applicant. Application for such plates shall be made in accordance with regulations promulgated by the commissioner with respect to the issuance 9 10 of such plates. Provided, however, that nothing contained herein shall 11 deemed to supersede the provisions of section four hundred four-d, four hundred four-e, four hundred four-h, four hundred four-i, four hundred four-j, four hundred four-k [or], four hundred four-p OR FOUR 12 13 HUNDRED FOUR-AA of this article. 14

- S 3. 1. A distinctive plate established pursuant to section 404-aa of vehicle and traffic law as added by section one of this act shall only be designed, produced and issued upon the delivery to the departof motor vehicles of a surety bond in the amount of six thousand dollars, which shall be executed by a surety company authorized by the department of financial services to transact business in this state. Provided, however, that if the commissioner of motor vehicles shall have received prior to plate design, production and issuance at least hundred orders for such distinctive plate together with the additional one-time service charge applicable to each such order, which shall be such surety bond shall be required. All service non-refundable, no charges collected pursuant to this section shall be deposited pursuant the provisions of section 404-oo of the vehicle and traffic law to the credit of the department of motor vehicles distinctive plate development fund established by section 95-g of the state finance law and shall be used for the design, production, advertising and distribution of distinctive license plates in accordance with such section 95-g.
- 2. If, upon the expiration of two years following the date upon which distinctive plates in the series are first available for sale two hundred or more sets of such plates are sold, a bond delivered pursuant to this section shall be discontinued. If fewer than two hundred sets of such plates are sold by such time, such department shall be entitled to recover against the bond in an amount proportionate to such shortfall.
- S 4. This act shall take effect on the one hundred eightieth day after it shall have become a law; provided, however, that section three of this act shall take effect immediately; provided further, however, that effective immediately, the addition, amendment and/or repeal of any rule or regulation necessary for the implementation of this act on its effective date are authorized and directed to be made and completed on or before such effective date.
