AN ACT to amend the penal law, in relation to assault on a member of the military or reserves

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 10.00 of the penal law is amended by adding a new
2 subdivision 22 to read as follows:

3 22. "MEMBER OF THE MILITARY OR RESERVES" MEANS (A) A MEMBER OF THE
4 UNITED STATES ARMY, NAVY, AIR FORCE, MARINES, COAST GUARD, ARMY NATIONAL
5 GUARD, AIR NATIONAL GUARD AND/OR RESERVES THEREOF OR (B) A MEMBER OF THE
6 NEW YORK GUARD OR THE NEW YORK NAVAL MILITIA AND/OR THE RESERVES THERE-
7 OF.

8 S 2. Section 120.08 of the penal law, as added by chapter 632 of the
9 laws of 1996, is amended to read as follows:

10 S 120.08 Assault on a peace officer, police officer, fireman, [or] emer-
11 gency medical services professional OR A MEMBER OF THE MILI-
12 TARY OR RESERVES.

13 A person is guilty of assault on a peace officer, police officer,
14 fireman, [or] emergency medical services professional OR A MEMBER OF THE
15 MILITARY OR RESERVES when, with intent to prevent a peace officer,
16 police officer, a fireman, including a fireman acting as a paramedic or
17 emergency medical technician administering first aid in the course of
18 performance of duty as such fireman, [or] an emergency medical service
19 paramedic or emergency medical service technician, OR A MEMBER OF THE
20 MILITARY OR RESERVES, from performing a lawful duty, he causes serious
21 physical injury to such peace officer, police officer, fireman, paramed-
22 ic, [or] technician OR A MEMBER OF THE MILITARY OR RESERVES.
