DeFRANCISCO -- read twice and ordered printed, and when printed to be committed to the Committee on Health -- reported favorably from said committee and committed to the Committee on Finance -- committee discharged, bill amended, ordered reprinted as amended and recommitted to said committee

AN ACT to amend the public health law, in relation to the reimbursement of tuition, fees and hospital charges to state university health care facilities

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. The public health law is amended by adding a new section  
2     2807-aa to read as follows:  
3     S 2807-AA. STATE UNIVERSITY HEALTH CARE FACILITIES; REIMBURSEMENT OF  
4     TUITION, FEES AND HOSPITAL CHARGES. NOTWITHSTANDING ANY OTHER PROVISION  
5     OF LAW, ANY FUNDS COLLECTED AND RECEIVED BY THE STATE COMPTROLLER OR THE  
6     ATTORNEY GENERAL FOR PAST DUE AND UNCOLLECTED TUITION, FEES OR HOSPITAL  
7     CHARGES DUE AND OWED TO A STATE UNIVERSITY HEALTH CARE FACILITY SHALL BE  
8     REIMBURSED AND PAID TO THE STATE UNIVERSITY HEALTH CARE FACILITY FOR  
9     WHICH SUCH UNCOLLECTED TUITION, FEES OR HOSPITAL CHARGES WERE PAST DUE  
10    AND UNCOLLECTED. SUCH FUNDS, WHEN RECEIVED BY THE STATE COMPTROLLER OR  
11    THE ATTORNEY GENERAL, SHALL BE PAID TO SUCH UNIVERSITY HEALTH CARE  
12    FACILITY WITHIN THIRTY DAYS OF RECEIPT. FOR PURPOSES OF THIS SECTION THE  
13    TERM "STATE UNIVERSITY HEALTH CARE FACILITY" SHALL MEAN A HOSPITAL, AS  
14    DEFINED IN SECTION TWENTY-EIGHT HUNDRED ONE OF THIS ARTICLE, OPERATED BY  
15    THE STATE UNIVERSITY.  
16    S 2. This act shall take effect immediately and shall apply to past  
17    due and uncollected tuition, fees and hospital charges collected on or  
18    after such date.
