AN ACT to amend the administrative code of the city of New York, in relation to abandoned buildings and stalled construction sites

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. The administrative code of the city of New York is amended
2 by adding a new section 28-118.22 to read as follows:
3 S 28-118.22 ABANDONED BUILDINGS AND/OR STALLED CONSTRUCTION SITES. ALL
4 NEW BUILDING CONSTRUCTION OR ALTERATIONS OF CURRENT BUILDINGS IN AN R1,
5 2, 3 OR 4 ZONING AREA SHALL COMPLETE CONSTRUCTION AND/OR ALTERATIONS AND
6 OBTAIN A CERTIFICATE OF OCCUPANCY WITHIN FOUR YEARS OF THE INITIAL
7 PERMIT FOR SUCH CONSTRUCTION AND/OR ALTERATION. IF SUCH CONSTRUCTION IS
8 NOT COMPLETE AND A CERTIFICATE OF OCCUPANCY PURSUANT TO THIS ARTICLE IS
9 NOT OBTAINED WITHIN FOUR YEARS, THE DEPARTMENT MAY DEMOLISH THE STRUC-
10 TURE AND RETURN THE SITE TO A CLEAN AND SAFE CONDITION AT THE PROPERTY
11 OWNER'S EXPENSE.
12 S 2. Section 28-214.1 of the administrative code of the city of New
13 York, as amended by section 54 of part A of local law 141 of the city of
14 New York for the year 2013, is amended to read as follows:
15 S 28-214.1 Order to seal, secure, and close. 1. If the commissioner
16 determines such action is necessary to the preservation of life and
17 safety the commissioner may order a building subject to a vacate order
18 to be sealed, secured and closed.
19 2. AFTER A PERIOD OF TWO YEARS, IF NO ATTEMPT IS MADE TO REHABILITATE
20 THE "SEALED" STATUS OF SUCH BUILDING PURSUANT TO SUBDIVISION ONE OF THIS
21 SECTION, SUCH BUILDING MAY BE DEMOLISHED AT THE PROPERTY OWNER'S EXPENSE
22 PURSUANT TO SECTION 28-214.1.5 OF THIS ARTICLE.
23 S 3. This act shall take effect immediately.
