- AN ACT to amend the education law, in relation to long range financial planning for school districts

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The education law is amended by adding a new section 3817 2 to read as follows:

3 S 3817. LONG RANGE FINANCIAL PLAN. 1. EACH YEAR, COMMENCING WITH THE 4 PROPOSED BUDGET FOR THE TWO THOUSAND SIXTEEN--TWO THOUSAND SEVENTEEN 5 SCHOOL YEAR, THE SUPERINTENDENT OF SCHOOLS IN CONSULTATION WITH THE CHIEF FINANCIAL OFFICER OF EACH SCHOOL DISTRICT, AND THE BOARD OF TRUSб 7 TEES, SHALL PREPARE FOR APPROVAL BY THE BOARD OF TRUSTEES A LONG RANGE SUCH DISTRICTS IN ESTABLISHING AND PLANNING 8 FINANCIAL PLAN TO ASSIST 9 FINANCIAL GOALS AND PROJECTIONS.

10 2. A LONG RANGE FINANCIAL PLAN SHALL MEAN A PLAN THAT INCLUDES INFOR-11 MATION FOR THE CURRENT SCHOOL YEAR AND PROJECTIONS FOR AT LEAST THE SUBSEQUENT TWO YEARS OF THE SCHOOL DISTRICT THAT COVERS: 12 (A) REVENUES; 13 (B) EXPENDITURES; (C) UNASSIGNED FUND BALANCE; (D) RESTRICTED FUND BALANCE; (E) GRANT AWARDS; AND (F) CAPITAL CONSTRUCTION PROJECT 14 PLAN-15 NING.

3. A SCHOOL DISTRICT MUST POST ON ITS WEBSITE, IF AVAILABLE, AND IN
FIVE PUBLIC PLACES IN SAID DISTRICT, THE DISTRICT'S LONG RANGE FINANCIAL
PLAN, ANNUAL AUDITED FINANCIAL STATEMENT, INCLUDING ANY CORRECTIVE
ACTION PLAN AS REQUIRED BY SECTION TWENTY-ONE HUNDRED SIXTEEN-A OF THIS
CHAPTER, AND ADOPTED ANNUAL BUDGET.

4. A DISTRICT MAY APPLY TO THE COMMISSIONER FOR A WAIVER OF THE REQUIREMENT TO PREPARE A LONG TERM FINANCIAL PLAN UNDER SUBDIVISION ONE OF THIS SECTION, WHICH MAY BE GRANTED AT THE DISCRETION OF THE COMMIS-
