AN ACT to amend the real property actions and proceedings law, in relation to the failure to raise the defense of lack of standing in a mortgage foreclosure action

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. The real property actions and proceedings law is amended by 2 adding a new section 1302-a to read as follows:
- 3 S 1302-A. DEFENSE OF LACK OF STANDING; NOT WAIVED. NOTWITHSTANDING THE 4 PROVISIONS OF SUBDIVISION (E) OF RULE THIRTY-TWO HUNDRED ELEVEN OF THE
- 5 CIVIL PRACTICE LAW AND RULES, ANY OBJECTION OR DEFENSE BASED ON THE 6 PLAINTIFF'S LACK OF STANDING IN A FORECLOSURE PROCEEDING RELATED TO A
- 7 HOME LOAN, AS DEFINED IN PARAGRAPH (A) OF SUBDIVISION FIVE OF SECTION
- 8 THIRTEEN HUNDRED FOUR OF THIS ARTICLE, SHALL NOT BE WAIVED IF A DEFEND-
- 9 ANT FAILS TO RAISE THE OBJECTION OR DEFENSE IN A RESPONSIVE PLEADING OR 10 PRE-ANSWER MOTION TO DISMISS. A DEFENDANT MAY NOT RAISE AN OBJECTION OR
- 10 PRE-ANSWER MOTION TO DISMISS. A DEFENDANT MAY NOT RAISE AN OBJECTION OR 11 DEFENSE OF LACK OF STANDING FOLLOWING A FORECLOSURE SALE, HOWEVER,
- 12 UNLESS THE JUDGMENT OF FORECLOSURE AND SALE WAS ISSUED UPON DEFENDANT'S
- 13 DEFAULT.
- 14 S 2. This act shall take effect immediately.
