AN ACT to amend the banking law, in relation to community reinvestment evaluations

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 Section 1. The banking law is amended by adding a new section 46 to 2 read as follows:
- 46. COMMUNITY REINVESTMENT EVALUATION EXEMPTIONS. NOTWITHSTANDING ANY LAW, RULE OR REGULATION TO THE CONTRARY, A BANKING ORGANIZATION 5 TOTAL LESS ONE BILLION DOLLARS AND WHICH WHICH HAS ASSETS OF THAN THE RECEIVED A RATING OF SATISFACTORY OR OUTSTANDING INMOST COMMUNITY REINVESTMENT ACT EXAMINATION CONDUCTED BY SUCH BANKING ORGAN-7 8 IZATION'S PRIMARY FEDERAL REGULATOR SHALL BE EXEMPT FROM THE CONDUCT THE DEPARTMENT OF FINANCIAL SERVICES OF A COMMUNITY REINVESTMENT EVALU-9 10 ATION.
- 11 S 2. This act shall take effect on the sixtieth day after it shall 12 have become a law.
