AN ACT to amend the vehicle and traffic law, in relation to authorizing a pilot residential parking permit system in the city of Buffalo and providing for the repeal of such provisions upon expiration thereof

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEM-BLY, DO ENACT AS FOLLOWS:

Section 1. Legislative findings and intent. The legislature finds that a lack of parking for residents in the city of Buffalo in the area in and around Buffalo General Medical Park has resulted in traffic hazards, congestion and air and noise pollution. In addition, such lack of parking poses a hazard to residents and other pedestrians in such area.

The legislature further finds that a residential parking system within such area will reduce such hazards and will reduce pollution levels as well. The legislature, therefore, hereby declares the necessity of this act to authorize the city of Buffalo to adopt a residential parking system in accordance with the provisions of this act.

- 2. The vehicle and traffic law is amended by adding a new section 1640-o to read as follows:
- S 1640-O. PILOT RESIDENTIAL PARKING PERMIT SYSTEM IN THECITY OF 14 NOTWITHSTANDING THE PROVISIONS OF ANY LAW TO THE CONTRARY, 1. 15 THE CITY OF BUFFALO MAY, BY ADOPTION OF A LOCAL LAW OR ORDINANCE,
- PROVIDE FOR A RESIDENTIAL PARKING PERMIT SYSTEM AND FIX AND REQUIRE THE 17 PAYMENT OF FEES APPLICABLE TO PARKING WITHIN THE AREA INWHICH

PARKING SYSTEM IS IN EFFECT IN ACCORDANCE WITH THE PROVISIONS OF THIS 2 SECTION.

- SUCH RESIDENTIAL PARKING PERMIT SYSTEM MAY ONLY BE ESTABLISHED WITHIN THE AREA OF THE CITY OF BUFFALO CONSISTING OF THE FOLLOWING ROAD-WAYS:
 - (A) MAPLE STREET, FROM VIRGINIA STREET TO NORTH STREET;
 - (B) MULBERRY STREET, FROM VIRGINIA STREET TO NORTH STREET;
 - (C) LOCUST STREET, FROM VIRGINIA STREET TO NORTH STREET;
 - (D) LEMON STREET, FROM VIRGINIA STREET TO NORTH STREET;
 - (E) ORANGE STREET, FROM VIRGINIA STREET TO NORTH STREET;
 - (F) PEACH STREET, FROM VIRGINIA STREET TO NORTH STREET;
- (G) GRAPE STREET, FROM VIRGINIA STREET TO NORTH STREET;
 - (H) ROSE STREET, FROM BFNC DRIVE TO NORTH STREET;
 - (I) HIGH STREET, FROM MAPLE STREET TO ROSE STREET;
 - (J) CARLTON STREET, FROM MAPLE STREET TO ROSE STREET;
 - (K) VIRGINIA STREET, FROM MAPLE STREET TO BFNC DRIVE; AND
 - (L) NORTH STREET, FROM MAPLE STREET TO ROSE STREET.
- 3. NOTWITHSTANDING THE FOREGOING, NO PERMIT SHALL STREETS WHERE THE ADJACENT PROPERTIES ARE ZONED FOR COMMERCIAL, OFFICE AND/OR RETAIL USE.
- 4. THE LOCAL LAW OR ORDINANCE PROVIDING FOR SUCH RESIDENTIAL PARKING PERMIT SYSTEM SHALL:
- FORTH FACTORS NECESSITATING THE ENACTMENT OF SUCH PARKING (A) SET SYSTEM;
- (B) PROVIDE THAT MOTOR VEHICLES REGISTERED PURSUANT TO SECTION HUNDRED FOUR-A OF THIS CHAPTER SHALL BE EXEMPT FROM ANY PERMIT REQUIRE-MENT;
- (C) PROVIDE THE TIMES OF THE DAY AND THE DAYS OF THE WEEK DURING WHICH PERMIT REQUIREMENTS SHALL BE IN EFFECT;
- (D) MAKE NOT LESS THAN TWENTY PERCENT OF ALL SPACES WITHIN THE PERMIT AREA AVAILABLE TO NONRESIDENTS AND SHALL PROVIDE SHORT-TERM PARKING OF NOT LESS THAN NINETY MINUTES IN DURATION IN SUCH AREA;
 - (E) PROVIDE THE SCHEDULE OF FEES TO BE PAID FOR SUCH PERMITS; AND
- (F) PROVIDE THAT SUCH FEES SHALL BE CREDITED TO THE GENERAL FUND OF THE CITY OF BUFFALO.
- SHALL BE ADOPTED PURSUANT TO THIS SECTION UNTIL A 5. NO ORDINANCE PUBLIC HEARING THEREON HAS BEEN HAD IN THE SAME MANNER AS REQUIRED FOR PUBLIC HEARINGS ON A LOCAL LAW PURSUANT TO THE MUNICIPAL HOME RULE LAW.
- This act shall take effect immediately and shall remain in full force and effect for a period of 730 days after the implementation of local law or ordinance adopted by the city of Buffalo pursuant to section 1640-o of the vehicle and traffic law as added by section two of this act at which time this act shall expire and be deemed repealed. The city of Buffalo shall notify the legislative bill drafting commission upon the occurrence of such implementation or adoption in order that the commission may maintain an accurate and timely effective data base of the official text of the laws of the state of New York in furtherance of 48 effectuating the provisions of section 44 of the legislative section 70-b of the public officers law.
