AN ACT to amend the insurance law, in relation to mandatory health insurance coverage for prosthetic devices

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subsection (i) of section 3216 of the insurance law is 2 amended by adding a new paragraph 32 to read as follows:

3 (32) EVERY POLICY WHICH PROVIDES MEDICAL, MAJOR MEDICAL, OR COMPREHENSIVE TYPE COVERAGE SHALL PROVIDE COVERAGE FOR PROSTHETIC 5 DEVICES THAT ARE INTENDED FOR MEDICALLY NECESSARY REHABILITATIVE AND 6 HABILITATIVE PURPOSES AS REQUIRED BY 42 U.S.C. S 18022. COVERAGE SHALL 7 NOT BE DENIED IF THE POLICY HOLDER'S PHYSICIAN DETERMINES THE PROSTHETIC 8 DEVICE ADEQUATELY MEETS THE MEDICAL NEEDS OF THEPOLICY HOLDER 9 WITH THE AGE, DISABILITY AND EXPECTED LENGTH OF LIFE COMPLIANCE 10 ANTI-DISCRIMINATION REQUIREMENTS OF 42 U.S.C. S 18022 (B)(4)(B) AND REQUIREMENT TO CONSIDER THE HEALTH CARE NEEDS OF DIVERSE SEGMENTS OF THE 11 12 POPULATION, INCLUDING PERSONS WITH DISABILITIES, PURSUANT TO 42 U.S.C. S 18022 (B)(4)(C). THE TERM "PROSTHETIC DEVICE" AS USED IN 13 THIS ARTIFICIAL LIMB BUT SHALL NOT INCLUDE SHOES OR ANY 14 GRAPH INCLUDES AN 15 OTHER ARTICLE CONSIDERED AS ORDINARY WEARING APPAREL, WHETHER OR SPECIALLY CONSTRUCTED. SUCH COVERAGE SHALL BE SUBJECT TO ANNUAL DEDUCT-16 17 IBLES AND COINSURANCE AS DEEMED APPROPRIATE BY THE SUPERINTENDENT. THE COVERAGE REOUIRED BY THIS PARAGRAPH SHALL BE IDENTICAL TO, AND SHALL NOT 18 ENHANCE OR INCREASE THE COVERAGE REQUIRED AS PART OF ESSENTIAL HEALTH 19 BENEFITS AS REQUIRED PURSUANT TO SECTION 2707(A) OF 20 THE PUBLIC 42 U.S.C. S 300 GG-6(A). THE TERM "POLICY HOLDER" AS USED 21 ACT SERVICES 22 IN THIS PARAGRAPH SHALL MEAN A VETERAN OF THE ARMED FORCES

- 30 (PP) EVERY POLICY WHICH PROVIDES MEDICAL, MAJOR MEDICAL, OR SIMILAR TYPE COVERAGE SHALL PROVIDE COVERAGE FOR PROSTHETIC 31 COMPREHENSIVE 32 DEVICES THAT ARE INTENDED FOR MEDICALLY NECESSARY REHABILITATIVE AND HABILITATIVE PURPOSES AS REQUIRED BY 42 U.S.C. S 18022. COVERAGE 33 NOT BE DENIED IF THE POLICY HOLDER'S PHYSICIAN DETERMINES THE PROSTHETIC 34 35 DEVICE ADEOUATELY MEETS THE MEDICAL NEEDS OF THE POLICY HOLDER IN WITH THE AGE, DISABILITY AND EXPECTED LENGTH OF LIFE 36 COMPLIANCE ANTI-DISCRIMINATION REQUIREMENTS OF 42 U.S.C. SUCH COVERAGE SHALL BE SUBJECT TO ANNUAL DEDUCTIBLES 44 COINSURANCE AS DEEMED APPROPRIATE BY THE SUPERINTENDENT. THE COVERAGE 45 REQUIRED BY THIS SUBSECTION SHALL BE IDENTICAL TO, AND SHALL NOT ENHANCE OR INCREASE THE COVERAGE REQUIRED AS PART OF ESSENTIAL HEALTH BENEFITS 46 47 REQUIRED PURSUANT TO SECTION 2707(A) OF THE PUBLIC HEALTH SERVICES ACT 42 U.S.C. S 300 GG-6(A). THE TERM "POLICY HOLDER" AS USED 48 49 SUBSECTION SHALL MEAN A VETERAN OF THE ARMED FORCES WHO RESIDES IN THE 50 STATE OF NEW YORK AND WHOSE MEDICAL NEED FOR SUCH PROSTHETIC DEVICE RESULTED FROM AN INJURY SUFFERED IN THE LINE OF DUTY WHILE SERVING IN 51 52 THE ARMED FORCES.
  - S 4. This act shall take effect May 25, 2016 and shall apply to all policies and contracts issued, renewed, altered, or amended on or after such effective date.
