AN ACT to amend the insurance law, in relation to prescription drug formulary changes during a contract year

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The insurance law is amended by adding a new section 4909 2 to read as follows:

3 S 4909. PRESCRIPTION DRUG FORMULARY CHANGES. (A) A HEALTH CARE PLAN 4 REQUIRED TO PROVIDE ESSENTIAL HEALTH BENEFITS SHALL NOT, EXCEPT AS 5 OTHERWISE PROVIDED IN SUBSECTION (B) OF THIS SECTION, REMOVE A 6 PRESCRIPTION DRUG FROM A FORMULARY:

7 (I) IF THE FORMULARY INCLUDES TWO OR MORE TIERS OF BENEFITS PROVIDING
8 FOR DIFFERENT DEDUCTIBLES, COPAYMENTS OR COINSURANCE APPLICABLE TO THE
9 PRESCRIPTION DRUGS IN EACH TIER, MOVE A DRUG TO A TIER WITH A LARGER
10 DEDUCTIBLE, COPAYMENT OR COINSURANCE, OR;

(II) ADD UTILIZATION MANAGEMENT RESTRICTIONS TO A FORMULARY DRUG, 11 12 UNLESS SUCH CHANGES OCCUR AT THE TIME OF ENROLLMENT OR ISSUANCE OF SUCH PROHIBITION SHALL APPLY BEGINNING ON THE DATE ON WHICH 13 COVERAGE. 14 OPEN ENROLLMENT BEGINS FOR A PLAN YEAR AND THROUGH THE END OF THE PLAN YEAR TO WHICH SUCH OPEN ENROLLMENT PERIOD APPLIES. 15

A HEALTH CARE PLAN WITH A FORMULARY THAT INCLUDES TWO OR MORE 16 (B) 17 TIERS OF BENEFITS PROVIDING FOR DIFFERENT DEDUCTIBLES, COPAYMENTS OR APPLICABLE TO PRESCRIPTION DRUGS IN EACH TIER MAY MOVE A 18 COINSURANCE PRESCRIPTION DRUG TO A TIER WITH A LARGER DEDUCIBLE, COPAYMENT OR COIN-19 20 IF AN AB-RATED GENERIC DRUG FOR SUCH PRESCRIPTION DRUG IS ADDED SURANCE TO THE FORMULARY AT THE SAME TIME. 21

22 S 2. This act shall take effect on the sixtieth day after it shall 23 become a law; provided, however, that effective immediately, the addi-24 tion, amendment and/or repeal of any rule or regulation necessary for 25 the implementation of this act on its effective date is authorized to be 26 made and completed by the superintendent of financial services on or 27 before such date.
