AN ACT to amend the alcoholic beverage control law, in relation to purchasing by two or more licensed retailers

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. Subdivision 3 of section 101-b of the alcoholic beverage  
2 control law is amended by adding a new paragraph (e) to read as follows:  
3     (E) FOR THE PURPOSES OF PURCHASING ONLY, ANY TWO OR MORE RETAILERS  
4 LICENSED PURSUANT TO SECTION SIXTY-THREE OR SEVENTY-NINE OF THIS CHAPTER  
5 MAY JOIN IN AN AGREEMENT TO MAKE JOINT PURCHASES OF LIQUOR OR WINE,  
6 PROVIDED, HOWEVER, THAT ALL SUCH ALCOHOLIC BEVERAGES PURCHASED PURSUANT  
7 TO ANY SUCH AGREEMENT SHALL BE DISTRIBUTED TO NONE OTHER THAN A LICENSEE  
8 WHO IS A PARTY TO SUCH AGREEMENT. THE COOPERATIVE AGREEMENTS, AS AUTHOR-  
9 IZED UNDER THIS SUBDIVISION, SHALL BE VOID IF, WITHIN A CITY WITH A  
10 POPULATION OF ONE MILLION OR MORE, THE PREMISES OPERATING UNDER THE  
11 COOPERATIVE AGREEMENTS AUTHORIZED IN THIS SUBDIVISION ARE LOCATED MORE  
12 THAN ONE MILE FROM ONE ANOTHER. THE COOPERATIVE AGREEMENTS, AS AUTHOR-  
13 IZED UNDER THIS SUBDIVISION, SHALL BE VOID IF, OUTSIDE OF A CITY WITH A  
14 POPULATION OF ONE MILLION OR MORE, THE PREMISES OPERATING UNDER AGREE-  
15 MENTS AUTHORIZED IN THIS SUBDIVISION ARE LOCATED MORE THAN FIFTY MILES  
16 FROM ONE ANOTHER. THE AUTHORITY MAY PROMULGATE SUCH RULES AND REGU-  
17 LATIONS AS MAY BE NECESSARY TO CARRY OUT THE PROVISIONS OF THIS SUBDIVI-  
18 SION.  
19     S 2. This act shall take effect immediately.
