AN ACT to amend chapter 97 of the laws of 2011, amending the general municipal law and the education law relating to establishing limits upon school district and local government tax levies, in relation to eliminating the expiration of and making permanent certain provisions thereof

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 13 of part A of chapter 97 of the laws of 2011, 2 amending the general municipal law and the education law relating to 3 establishing limits upon school district and local government tax 4 levies, is amended to read as follows:

5 S 13. This act shall take effect immediately; provided, however, that б sections two through eleven of this act shall take effect July 1, 2011 7 and shall first apply to school district budgets and the budget adoption process for the 2012-13 school year; and shall continue to apply to 8 9 school district budgets and the budget adoption process for any school 10 year beginning in any calendar year during which this act is in effect; provided further, that if section 26 of part A of chapter 58 of the laws 11 2011 shall not have taken effect on or before such date then section 12 of ten of this act shall take effect on the same date and in 13 the same 14 manner as such chapter of the laws of 2011, takes effect; provided further, that section one of this act shall first apply to the 15 levy of 16 taxes by local governments for the fiscal year that begins in 2012 and shall continue to apply to the levy of taxes by local governments 17 for any fiscal year beginning in any calendar year during which this act is 18 in effect[; provided, further, that this act shall remain in full force 19 20 and effect at a minimum until and including June 15, 2016 and shall 21 remain in effect thereafter only so long as the public emergency requir-22 ing the regulation and control of residential rents and evictions and

all such laws providing for such regulation and control continue as 1 provided in subdivision 3 of section 1 of the local emergency rent 2 control act, sections 26-501, 26-502 and 26-520 of the administrative 3 4 code of the city of New York, section 17 of chapter 576 of the laws of 5 1974 and subdivision 2 of section 1 of chapter 274 of the laws of 1946 constituting the emergency housing rent control law, and section 10 of chapter 555 of the laws of 1982, amending the general business law and б 7 8 the administrative code of the city of New York relating to conversions of residential property to cooperative or condominium ownership in the 9 10 city of New York as such laws are continued by chapter 93 of the laws of 2011 and as such sections are amended from time to time]. 11 S 2.
