AN ACT permitting the town of Thompson to diminish the Kiamesha Lake sewer district

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     Section 1. If the town board of the town of Thompson, Sullivan county  
2     shall determine it to be in the public interest, said town board may,  
3     upon petition, and after a public hearing held in the manner and upon  
4     the notice specified in section 202-c of the town law, diminish the  
5     Kiamesha Lake sewer district by deleting therefrom the parcels listed in  
6     section two of this act located in the town of Thompson and presently  
7     included in said district; provided that a new district encompassing  
8     such parcels is established that will assume any indebtedness attribut-  
9     able to parcels located within the district incurred by the Kiamesha  
10    Lake sewer district prior to its creation.

11    S 2. The tax lot numbers of the parcels authorized to be deleted from  
12    the Kiamesha Lake sewer district are listed as follows:
