- AN ACT to amend the public health law, in relation to requiring hospitals and physicians to include certain information regarding military service of patients or persons close to patients on admission forms

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 5 of section 2805-b of the public health law, 2 as added by chapter 694 of the laws of 1986, is amended to read as 3 follows:

4 5. The staff of a general hospital shall inquire whether or not the 5 person admitted is a veteran, as defined in section eighty-five of the б civil service law. [Such information shall be listed on the] THE admis-7 sions form SHALL INCLUDE INFORMATION INCLUDING, BUT NOT LIMITED TO, WHETHER THE PATIENT OR SOMEONE CLOSE TO THE PATIENT HAS EVER SERVED 8 IN 9 MILITARY, WHO SERVED IN THE MILITARY, WHEN AND WHERE DID THE PERSON THE SERVE, WHAT WAS THE PERSON IN THE MILITARY'S JOB 10 DESCRIPTION, WHETHER 11 THE PATIENT IS CURRENTLY REGISTERED WITH THE VETERANS ADMINISTRATION, AND WHETHER THE PATIENT IS CURRENTLY RECEIVING ANY 12 BENEFITS FROM THE The staff shall notify any admittee who is a 13 VETERANS ADMINISTRATION. 14 veteran of the possible availability of services at a hospital operated the veterans administration, and, upon request by the admittee, such 15 by 16 staff shall make arrangements for the individual's transfer to a veterans administration operated hospital. Transfers shall be authorized only 17 after it has been determined, according to accepted clinical and medical 18 standards, that the patient's condition has stabilized and transfer can 19 20 be accomplished safely and without complication. The commissioner shall 21 promulgate rules and regulations for notifying such admittees of possi-22 ble available services and for arranging a requested transfer.

The public health law is amended by adding a new article 26-B to 1 S 2. 2 read as follows: 3

ARTICLE 26-B

MILITARY SERVICE INQUIRY

SECTION 2640. MILITARY SERVICE; DUTY TO INQUIRE AND RECORD.

2640. MILITARY SERVICE; DUTY TO INQUIRE AND RECORD. 1. EVERY PHYSI-6 S 7 CIAN SHALL INOUIRE OF EVERY RESIDENT OF THE STATE OF NEW YORK COMING TO SUCH PHYSICIAN FOR SERVICES OR TREATMENT WHETHER THE PERSON IS A VETER-8 9 AN, AS DEFINED IN SECTION EIGHTY-FIVE OF THE CIVIL SERVICE LAW, AND 10 SHALL RECORD THE ANSWERS TO SUCH INQUIRY IN THE PATIENT'S MEDICAL RECORD. THE PHYSICIAN SHALL RECORD, AT A MINIMUM, THE FOLLOWING INFORMA-11 TION: WHETHER THE PATIENT OR SOMEONE CLOSE TO THE PATIENT 12 HAS EVER SERVED IN THE MILITARY, WHO SERVED IN THE MILITARY, WHEN AND WHERE DID 13 14 THE PERSON SERVE, WHAT WAS THE PERSON IN THE MILITARY'S JOB DESCRIPTION, 15 WHETHER THE PATIENT IS CURRENTLY REGISTERED WITH THE VETERANS ADMINIS-TRATION, AND WHETHER THE PATIENT IS CURRENTLY RECEIVING ANY BENEFITS 16 17 FROM THE VETERANS ADMINISTRATION.

EACH PHYSICIAN PROVIDING SERVICES OR TREATMENT TO A VETERAN OR 18 19 SOMEONE CLOSE TO A VETERAN SHALL NOTIFY SUCH PATIENT OF THE POSSIBLE AVAILABILITY OF SERVICES AT A HOSPITAL OPERATED BY THE VETERANS ADMINIS-20 21 TRATION AND, UPON REQUEST BY THE PATIENT, SUCH PHYSICIAN SHALL TRANSFER PATIENT'S MEDICAL RECORDS TO SUCH HOSPITAL. THE COMMISSIONER SHALL 22 THE PROMULGATE RULES AND REGULATIONS FOR NOTIFYING SUCH PATIENT OF POSSIBLE 23 24 AVAILABLE SERVICES AND FOR ARRANGING FOR A TRANSFER OF MEDICAL RECORDS. 25 S 3. This act shall take effect immediately.
