AN ACT to amend the criminal procedure law, in relation to designating members of the security force at Saratoga Hospital as peace officers

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Subdivision 83 of section 2.10 of the criminal procedure
2 law, as added by chapter 504 of the laws of 2012, is renumbered subdivi-
3 sion 84 and a new subdivision 85 is added to read as follows:
4 85. MEMBERS OF THE SECURITY FORCE EMPLOYED BY SARATOGA HOSPITAL WITHIN
5 AND DIRECTLY ADJACENT TO THE HOSPITAL BUILDINGS ON THE MEDICAL CAMPUS
6 LOCATED AT 211 CHURCH STREET, SARATOGA SPRINGS, NEW YORK OWNED AND OPER-
7 ATED BY SARATOGA HOSPITAL. THESE OFFICERS SHALL ONLY HAVE THE POWERS IN
8 SECTION 9.41 OF THE MENTAL HYGIENE LAW AND THE POWERS LISTED IN PARA-
9 GRAPHS (A), (B), (C), (D), (H) AND (I) OF SUBDIVISION ONE OF SECTION
10 2.20 OF THIS ARTICLE. PROVIDED THAT IN ORDER TO EXERCISE THE POWERS SET
11 FORTH IN PARAGRAPHS (A), (B) AND (D) OF SUBDIVISION ONE OF SECTION 2.20
12 OF THIS ARTICLE, THE OFFICER HAS ACTUAL KNOWLEDGE, OR PROBABLE CAUSE TO
13 BELIEVE, THAT SUCH INDIVIDUAL HAS COMMITTED AN OFFENSE; PROVIDED HOWEV-
14 ER, THAT NOTHING IN THIS SUBDIVISION SHALL BE DEEMED TO AUTHORIZE SUCH
15 OFFICER TO CARRY, POSSESS, REPAIR OR DISPOSE OF A FIREARM UNLESS THE
16 APPROPRIATE LICENSE THEREFOR HAS BEEN ISSUED PURSUANT TO SECTION 400.00
17 OF THE PENAL LAW.
18 S 2. This act shall take effect immediately.
