THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. This act enacts into law major components of legislation

17 Section 1. Paragraph (b) of subdivision 6 of section 186-f of the tax
18 law, as amended by section 1 of part D of chapter 55 of the laws of
19 2014, is amended to read as follows:

20 (b) The sum of one million five hundred thousand dollars must be
21 deposited into the New York state emergency services revolving loan fund
22 annually; provided, however, that such sums shall not be deposited for
23 state fiscal years two thousand eleven--two thousand twelve, two thou-
24 sand twelve--two thousand thirteen, two thousand fourteen--two thousand

29 PART D

30 Section 1. This act enacts into law major components of legislation in
31 relation to homeland security. Each component is wholly contained within
32 a Subpart identified as Subparts A through J. The effective date for
33 each particular provision contained within such Subpart is set forth in

the last section of such Subpart. Any provision in any section contained within a Subpart, including the effective date of the Subpart, which makes a reference to a section "of this act", when used in connection with that particular component, shall be deemed to mean and refer to the corresponding section of the Subpart in which it is found. Section three of this act sets forth the general effective date of this act.

SUBPART A

Section 1. Section 210 of the executive law is amended by adding a new closing paragraph to read as follows:

IN ADDITION TO ALL OTHER OPERATIONS AND FUNCTIONS OF THE DIVISION OF STATE POLICE, IT SHALL ALSO CONTAIN THREE BUREAUS TO ADDRESS SPECIFIC OPERATIONS AND FUNCTIONS WITHIN THE STATE OF NEW YORK. SUCH BUREAUS SHALL INCLUDE, THE BUREAU OF CRIMINAL INVESTIGATION (BCI), THE BUREAU OF COUNTERTERRORISM AND INTELLIGENCE (BCTI), AND THE BUREAU OF CYBER SECURITY (BCS).

S 2. Subparagraphs 6, 7 and 9 of paragraph a of subdivision 1 of section 215 of the executive law, as amended by chapter 21 of the laws of 1996, are amended to read as follows:

(6) [one counsel] THREE DEPUTY SUPERINTENDENT BUREAU COMMANDERS, ONE OF WHOM SHALL BE ASSIGNED TO THE BUREAU OF CRIMINAL INVESTIGATION, ONE OF WHOM SHALL BE ASSIGNED TO THE BUREAU OF COUNTERTERRORISM AND INTELLIGENCE, AND ONE OF WHOM SHALL BE ASSIGNED TO THE BUREAU OF CYBER SECURITY;

(7) [seven] SIX assistant deputy superintendents, one of whom shall be assigned to the uniform force, [one to the bureau of criminal investigation,] two for administrative services, one for employee relations, training and human resources, and two who shall serve as deputy chief inspectors;

(9) ONE COUNSEL, AND one first assistant counsel and such assistant counsels and staff attorneys as the [superintendent] SUPERINTENDENT may appoint;

S 3. Subparagraph 1 of paragraph b of subdivision 1 of section 215 of the executive law, as amended by chapter 21 of the laws of 1996, is amended to read as follows:

(1) [one major] FOUR MAJORS, NOT LESS THAN ONE OF EACH SHALL BE ASSIGNED TO EACH OF THE BUREAUS OF THE STATE POLICE;

S 4. The opening paragraph of paragraph a of subdivision 2 of section 215 of the executive law, as added by chapter 69 of the laws of 2009, is amended to read as follows:

S 5. Subparagraphs 7 and 8 of paragraph a of subdivision 2 of section 215 of the executive law, as added by chapter 235 of the laws of 2015, are amended to read as follows:

(7) Effective April first, two thousand sixteen, members of the collective negotiating unit consisting of commissioned and non-commissioned officers in the division of state police shall receive a basic annual salary pursuant to the following schedule:

19 S 6. Subdivision 3 of section 215 of the executive law, as amended by
 20 chapter 478 of the laws of 2004, is amended to read as follows:

21 3. The sworn members of the New York state police shall be appointed
 22 by the superintendent and permanent appointees may be removed by the
 23 superintendent only after a hearing. No person shall be appointed to the
 24 New York state police force as a sworn member unless he or she shall be
 25 a citizen of the United States, between the ages of twenty-one and twen-
 26 ty-nine years except that in the superintendent's discretion, the maxi-
 27 mum age may be extended to thirty-five years. Notwithstanding any other
 28 provision of law or any general or special law to the contrary the time
 29 spent on military duty, not exceeding a total of six years, shall be
 30 subtracted from the age of any applicant who has passed his or her twen-
 31 ty-ninth birthday, solely for the purpose of permitting qualification as
 32 to age and for no other purpose. Such limitations as to age however
 33 shall not apply to persons appointed to the positions of counsel, first
 34 assistant counsel, assistant counsel, and assistant deputy superinten-
 35 dent for employee relations nor to any person appointed to the bureau of
 36 criminal investigation, THE BUREAU OF COUNTERTERRORISM AND INTELLIGENCE,
 37 OR THE BUREAU OF CYBER SECURITY, pursuant to section two hundred sixteen
 38 of this article nor shall any person be appointed unless he or she has
 39 fitness and good moral character and shall have passed a physical and
 40 mental examination based upon standards provided by the rules and regu-
 41 lations of the superintendent. Appointments shall be made for a proba-
 42 tionary period which, in the case of appointees required to attend and
 43 complete a basic training program at the state police academy, shall
 44 include such time spent attending the basic school and terminate one
 45 year after successful completion thereof. All other sworn members shall
 46 be subject to a probationary period of one year from the date of
 47 appointment. Following satisfactory completion of the probationary peri-
 48 od the member shall be a permanent appointee. Voluntary resignation or
 49 withdrawal from the New York state police during such appointment shall
 50 be submitted to the superintendent for approval. Reasonable time shall
 51 be required to account for all equipment issued or for debts or obli-
 52 gations to the state to be satisfied. Resignation or withdrawal from the
 53 division during a time of emergency, so declared by the governor, shall
 54 not be approved if contrary to the best interest of the state and shall
 55 be a misdemeanor. No sworn member removed from the New York state police
 56 shall be eligible for reappointment. The superintendent shall make rules

1 and regulations subject to approval by the governor for the discipline
2 and control of the New York state police and for the examination and
3 qualifications of applicants for appointment as members thereto and such
4 examinations shall be held and conducted by the superintendent subject
5 to such rules and regulations. The superintendent is authorized to
6 charge a fee of twenty dollars as an application fee for any person
7 applying to take a competitive examination for the position of trooper,
8 and a fee of five dollars for any competitive examination for a civilian
9 position. The superintendent shall promulgate regulations subject to the
10 approval of the director of the budget, to provide for a waiver of the
11 application fee when the fee would cause an unreasonable hardship on the
12 applicant and to establish a fee schedule and charge fees for the use of
13 state police facilities.

14 S 7. Section 216 of the executive law, as amended by chapter 128 of
15 the laws of 1968, subdivision 2 as added by chapter 335 of the laws of
16 1969 and paragraph (a) of subdivision 2 as added by chapter 70 of the
17 laws of 2009, is amended to read as follows:

18 S 216. [Bureau of criminal investigation] BUREAUS OF THE STATE POLICE.
19 1. THE DIVISION OF STATE POLICE SHALL CONTAIN THREE BUREAUS TO ADDRESS
20 SPECIFIC OPERATIONS AND FUNCTIONS WITHIN THE STATE OF NEW YORK. SUCH
21 BUREAUS SHALL INCLUDE, THE BUREAU OF CRIMINAL INVESTIGATION (BCI), THE
22 BUREAU OF COUNTERTERRORISM AND INTELLIGENCE (BCTI), AND THE BUREAU OF
23 CYBER SECURITY (BCS).

24 2. BUREAU OF CRIMINAL INVESTIGATION. A. ESTABLISHMENT. The superinten-
25 dent [may] SHALL ESTABLISH AND continue, within the New York state
26 police, a bureau of criminal investigation and assign to it members of
27 the New York state police in such numbers and appoint to it such inves-
28 tigative specialists, AND SUCH OTHER EMPLOYEES in such numbers as may be
29 required for the purpose of [preventing, investigating and detecting]
30 SUCH BUREAU.

31 B. PURPOSE. IT SHALL BE THE PURPOSE OF THE BUREAU OF CRIMINAL INVESTI-
32 GATION TO PREVENT, INVESTIGATE AND DETECT violations of the criminal
33 laws of the state, and [conducting] TO CONDUCT such other investigations
34 as may be DIRECTED BY THE SUPERINTENDENT, OR AS MAY BE provided for by
35 law.

36 C. CLASSIFICATION AND APPOINTMENT. Members of the New York state
37 police assigned to the bureau of criminal investigation and investi-
38 gative specialists appointed to the bureau by the superintendent shall
39 be classified as [(a)] (I) investigators; [(b)] (II) senior investi-
40 gators; [(c)] (III) lieutenants; [(d)] (IV) captains; (V) MAJORS;
41 provided, however, that investigative specialists appointed to the
42 bureau of criminal investigation may be appointed as investigators or
43 senior investigators at salaries to be determined by the superintendent
44 with the approval of the director of the budget within the range from
45 minimum to maximum provided for in this section for the positions to
46 which appointments are made. Investigative specialists appointed to the
47 bureau of criminal investigation shall be deemed to be members of the
48 New York state police upon the filing by them of the constitutional oath
49 of office, but shall not be eligible for transfer to the uniform force
50 unless otherwise qualified under section two hundred fifteen of this
51 article.

52 D. CIVILIAN APPOINTMENTS. The superintendent may employ, from time to
53 time, within the appropriation, such skilled experts, scientists, tech-
54 nicians or other specially qualified persons as he deems necessary to
55 aid the bureau OF CRIMINAL INVESTIGATION and the New York state police
56 TO FULFILL THE PURPOSE OF THIS SUBDIVISION, AND/OR in preventing or

detecting crime, apprehending criminals, or preparing and presenting evidence of violations of the criminal laws of the state.

E. ASSIGNMENT OF BUREAU PERSONNEL. Upon request of the head of any state department, or of any police agency or of any district attorney within the state, the superintendent may assign to such requesting authority members of the state police, OR CIVILIAN APPOINTMENTS, attached to the bureau of criminal investigation in such numbers and for such periods of time as he may deem necessary for the purpose of investigating and detecting felonies committed within the state. Members of the state police, OR CIVILIAN APPOINTMENTS, assigned or appointed to the bureau of criminal investigation are empowered to cooperate with departments of the United States government in the investigation of violations of the federal laws of the grade of felony within this state.

F. OFFICES OF THE BUREAU OF CRIMINAL INVESTIGATION. The superintendent may, from time to time, establish headquarters or stations in such localities of the state as he shall deem most suitable for the efficient operation of the bureau of criminal investigation.

14 3. BUREAU OF COUNTERTERRORISM AND INTELLIGENCE. A. ESTABLISHMENT. THE
 15 SUPERINTENDENT SHALL ESTABLISH AND CONTINUE, WITHIN THE NEW YORK STATE
 16 POLICE, A BUREAU OF COUNTERTERRORISM AND INTELLIGENCE AND ASSIGN TO IT
 17 MEMBERS OF THE NEW YORK STATE POLICE IN SUCH NUMBERS AND APPOINT TO IT
 18 SUCH COUNTERTERRORISM AND INTELLIGENCE SPECIALISTS, AND OTHER EMPLOYEES
 19 IN SUCH NUMBERS AS MAY BE REQUIRED FOR THE PURPOSE OF SUCH BUREAU.

20 B. PURPOSE. IT SHALL BE THE PURPOSE OF THE BUREAU OF COUNTERTERRORISM
 21 AND INTELLIGENCE TO COLLECT, ANALYZE AND SHARE INFORMATION RELATING TO
 22 TERRORIST THREATS, TERRORIST ACTIVITIES, AND TERRORIST ATTACKS THROUGH-
 23 OUT THE STATE, AND TO CONDUCT INVESTIGATIONS NECESSARY TO PREVENT,
 24 INVESTIGATE, DETECT AND RESPOND TO TERRORIST THREATS, TERRORIST ACTIV-
 25 ITIES, AND TERRORIST ATTACKS THROUGHOUT THE STATE, TOGETHER WITH THE
 26 CONDUCT OF SUCH OTHER INVESTIGATIONS AS MAY BE DIRECTED BY THE SUPER-
 27 INTENDENT, OR AS MAY BE PROVIDED FOR BY LAW.

28 C. CLASSIFICATION AND APPOINTMENT. MEMBERS OF THE NEW YORK STATE

 33 (V) MAJORS; PROVIDED, HOWEVER, THAT INTELLIGENCE SPECIALISTS APPOINTED
 34 TO THE BUREAU OF COUNTERTERRORISM AND INTELLIGENCE MAY BE APPOINTED AS
 35 INTELLIGENCE SPECIALISTS OR SENIOR INTELLIGENCE SPECIALISTS AT SALARIES
 36 TO BE DETERMINED BY THE SUPERINTENDENT WITH THE APPROVAL OF THE DIRECTOR
 37 OF THE BUDGET WITHIN THE RANGE FROM MINIMUM TO MAXIMUM PROVIDED FOR IN
 38 THIS SECTION FOR THE POSITIONS TO WHICH APPOINTMENTS ARE MADE. INTELLI-
 39 GENCE SPECIALISTS APPOINTED TO THE BUREAU OF COUNTERTERRORISM AND INTEL-
 40 LIGENCE SHALL BE DEEMED TO BE MEMBERS OF THE NEW YORK STATE POLICE UPON

1 E. ASSIGNMENT OF BUREAU PERSONNEL. UPON REQUEST OF THE HEAD OF ANY
 2 STATE DEPARTMENT, OR OF ANY POLICE AGENCY, OR OF ANY DISTRICT ATTORNEY
 3 WITHIN THE STATE, OR UPON REQUEST OF THE SECRETARY OF THE UNITED STATES
 4 DEPARTMENT OF HOMELAND SECURITY, THE ATTORNEY GENERAL OF THE UNITED
 5 STATES, THE DIRECTOR OF THE FEDERAL BUREAU OF INVESTIGATION, THE OFFICE
 6 OF THE DIRECTOR OF NATIONAL INTELLIGENCE, THE DIRECTOR OF THE CENTRAL
 7 INTELLIGENCE AGENCY, OR THE SECRETARY OF THE DEPARTMENT OF DEFENSE, THE
 8 SUPERINTENDENT MAY ASSIGN TO SUCH REQUESTING AUTHORITY MEMBERS OF THE

19 F. SHARING OF INTELLIGENCE INFORMATION. THE BUREAU OF COUNTERTERRORISM
 20 AND INTELLIGENCE SHALL SHARE COUNTERTERRORISM, INTELLIGENCE AND INVESTI-
 21 GATION INFORMATION WITH, AND MAY RECEIVE COUNTERTERRORISM, INTELLIGENCE,
 22 AND INVESTIGATION INFORMATION FROM, THE DIVISION OF HOMELAND SECURITY
 23 AND EMERGENCY SERVICES, LOCAL LAW ENFORCEMENT ENTITIES, THE UNITED
 24 STATES DEPARTMENT OF HOMELAND SECURITY, THE UNITED STATES DEPARTMENT OF
 25 JUSTICE, THE FEDERAL BUREAU OF INVESTIGATION, THE CENTRAL INTELLIGENCE
 26 AGENCY, THE OFFICE OF THE DIRECTOR OF NATIONAL INTELLIGENCE, THE UNITED
 27 STATES DEPARTMENT OF DEFENSE, AND ANY OTHER FEDERAL, STATE OR LOCAL
 28 ENTITY THAT THE SUPERINTENDENT DEEMS PRUDENT FOR THE PURPOSE OF FULFILL-
 29 ING THE PURPOSE OF THE BUREAU. SUCH INTELLIGENCE AND COUNTERTERRORISM
 30 INFORMATION AND INVESTIGATIONS SHALL BE SHARED, AND MAY BE RECEIVED,
 31 PURSUANT TO SECURITY PROTOCOLS DEVELOPED BETWEEN THE BUREAU AND THE
 32 ENTITY WITH WHICH SUCH INFORMATION AND/OR INVESTIGATIONS ARE SHARED OR
 33 FROM WHICH SUCH INFORMATION AND/OR INVESTIGATIONS ARE RECEIVED.

34 G. OPERATION OF THE NEW YORK STATE INTELLIGENCE CENTER. THE BUREAU OF
 35 COUNTERTERRORISM AND INTELLIGENCE SHALL BE RESPONSIBLE FOR THE MANAGE-
 36 MENT AND OPERATION OF THE NEW YORK STATE INTELLIGENCE CENTER (NYSIC).
 37 SUCH NEW YORK STATE INTELLIGENCE CENTER SHALL SERVE AS THE NEW YORK
 38 STATE FUSION CENTER, AND SHALL BRING TOGETHER FEDERAL, STATE AND LOCAL
 39 AGENCIES TO ANALYZE AND SHARE INFORMATION RELATED TO TERRORISM AND OTHER
 40 CRIMES.

41 H. OFFICES OF THE BUREAU OF COUNTERTERRORISM AND INTELLIGENCE. THE
 42 SUPERINTENDENT MAY, FROM TIME TO TIME, ESTABLISH HEADQUARTERS OR
 43 STATIONS IN SUCH LOCALITIES OF THE STATE AS HE SHALL DEEM MOST SUITABLE

46 I. SALARY SCHEDULES FOR INTELLIGENCE SPECIALISTS AND SENIOR INTELLI-

51 AUTHORITY MEMBERS OF THE STATE POLICE, OR CIVILIAN APPOINTMENTS,
52 ATTACHED TO THE BUREAU OF CYBER SECURITY IN SUCH NUMBERS AND FOR SUCH
53 PERIODS OF TIME AS HE MAY DEEM NECESSARY TO FACILITATE THE PURPOSE OF
54 THE BUREAU OF CYBER SECURITY. MEMBERS OF THE STATE POLICE, OR CIVILIAN
55 APPOINTMENTS, ASSIGNED OR APPOINTED TO THE BUREAU OF CYBER SECURITY ARE
56 EMPOWERED TO COOPERATE WITH DEPARTMENTS, DIVISIONS, AGENCIES AND OFFICES

OF THE STATE OF NEW YORK, AND/OR OF ITS LOCAL SUBDIVISIONS THEREOF, AND/OR THE GOVERNMENT OF THE UNITED STATES TO FACILITATE THE PURPOSE OF THE BUREAU OF COUNTERTERRORISM AND INTELLIGENCE.

F. SHARING OF INTELLIGENCE INFORMATION. THE BUREAU OF CYBER SECURITY SHALL SHARE CYBER SECURITY, INTELLIGENCE, AND INVESTIGATION INFORMATION WITH, AND MAY RECEIVE CYBER SECURITY, INTELLIGENCE, AND INVESTIGATION INFORMATION FROM, THE DIVISION OF HOMELAND SECURITY AND EMERGENCY SERVICES, THE STATE OFFICE OF INFORMATION TECHNOLOGY SERVICES, LOCAL LAW ENFORCEMENT ENTITIES, THE UNITED STATES DEPARTMENT OF HOMELAND SECURITY, THE UNITED STATES DEPARTMENT OF JUSTICE, THE FEDERAL BUREAU OF INVESTIGATION, THE CENTRAL INTELLIGENCE AGENCY, THE OFFICE OF THE DIRECTOR OF NATIONAL INTELLIGENCE, THE UNITED STATES DEPARTMENT OF DEFENSE, AND ANY OTHER FEDERAL, STATE OR LOCAL ENTITY THAT THE SUPERINTENDENT DEEMS PRUDENT FOR THE PURPOSE OF FULFILLING THE PURPOSE OF THE BUREAU. SUCH CYBER SECURITY, INTELLIGENCE, AND INVESTIGATIONS INFORMATION SHALL BE SHARED, AND MAY BE RECEIVED, PURSUANT TO SECURITY PROTOCOLS DEVELOPED BETWEEN THE BUREAU AND THE ENTITY WITH WHICH SUCH INFORMATION AND/OR INVESTIGATIONS ARE SHARED OR FROM WHICH SUCH INFORMATION AND/OR INVESTIGATIONS ARE RECEIVED.

G. OFFICES OF THE BUREAU OF CYBER SECURITY. THE SUPERINTENDENT MAY, FROM TIME TO TIME, ESTABLISH HEADQUARTERS OR STATIONS IN SUCH LOCALITIES OF THE STATE AS HE SHALL DEEM MOST SUITABLE FOR THE EFFICIENT OPERATION OF THE BUREAU OF CYBER SECURITY.

H. SALARY SCHEDULES FOR CYBER SECURITY SPECIALISTS AND SENIOR CYBER SECURITY SPECIALISTS IN THE DIVISION OF STATE POLICE. EFFECTIVE APRIL FIRST, TWO THOUSAND SIXTEEN, MEMBERS ASSIGNED TO THE BUREAU OF CYBER SECURITY AND CYBER SECURITY SPECIALISTS APPOINTED TO THE BUREAU BY THE SUPERINTENDENT, SHALL RECEIVE A BASIC ANNUAL SALARY PURSUANT TO THE FOLLOWING SCHEDULE:

S 8. This act shall take effect immediately.

SUBPART B

Section 1. Section 709-a of the executive law, as added by section 15-a of part B of chapter 56 of the laws of 2010, is amended to read as follows:

S 709-a. Office of counterterrorism, INTELLIGENCE AND CYBER SECURITY. THERE SHALL BE ESTABLISHED AND MAINTAINED WITHIN THE DIVISION, AN OFFICE OF COUNTERTERRORISM, INTELLIGENCE AND CYBER SECURITY. THE OFFICE OF COUNTERTERRORISM, INTELLIGENCE AND CYBER SECURITY SHALL BE THE ENTITY OF STATE GOVERNMENT RESPONSIBLE FOR ESTABLISHING AND MAINTAINING THE STATE'S POLICIES, PROTOCOLS AND STRATEGIES, RELATING TO THE PREVENTION OF, RESPONSE TO, AND RECOVERY FROM, TERRORIST ATTACKS AND CYBER ATTACKS.

1. PURPOSE. The office of counterterrorism, INTELLIGENCE AND CYBER SECURITY shall develop, ESTABLISH, MAINTAIN and analyze the state's policies, protocols and strategies relating to the prevention and detection of terrorist acts [and], terrorist threats, CYBER ACTS AND CYBER THREATS.

1 2. COUNTERTERRORISM AND INTELLIGENCE. The office shall also [be
2 responsible] MAINTAIN POLICY, PROTOCOL AND STRATEGIC OVERSIGHT RESPONSI-
3 BILITY OF, AND WORK COOPERATIVELY WITH, THE BUREAU OF COUNTERTERRORISM
4 AND INTELLIGENCE OF THE STATE POLICE, for:

5 (A) THE ESTABLISHMENT AND MAINTENANCE OF THE STATE'S POLICIES, PROTO-
6 COLS AND STRATEGIES RELATING TO THE PREVENTION AND DETECTION OF TERROR-
7 IST THREATS OR TERRORIST ATTACKS THAT WOULD ENDANGER THE PEOPLE, BUSI-
8 NESSES OR PROPERTY OF THE STATE OF NEW YORK;

9 (B) the collection, analysis and sharing of information relating to
10 terrorist threats [and], terrorist activities, AND TERRORIST ATTACKS
11 throughout the state; [coordinating]

12 (C) THE COORDINATION, DEVELOPMENT AND MAINTENANCE OF strategies,
13 protocols and first responder equipment needs NECESSARY to detect,
14 PREVENT AND/OR RESPOND TO a biological, chemical [or], radiological, OR
15 OTHER TYPE OF terrorist act or threat; [working]

16 (D) THE CONDUCT OF ASSESSMENTS, IN COOPERATION with private entities
17 and local, state and federal agencies [to conduct assessments], of the
18 vulnerability of critical infrastructure to terrorist attack; and
19 [consulting]

20 (E) THE CONSULTATION with appropriate state and local governments and
21 private entities, AND THE GOVERNMENT OF THE UNITED STATES to facilitate
22 and foster cooperation to better prepare the state to prevent and detect
23 threats and acts of terrorism.

24 3. CYBER SECURITY. THE OFFICE SHALL ALSO MAINTAIN POLICY, PROTOCOL AND
25 STRATEGIC OVERSIGHT RESPONSIBILITY OF, AND WORK COOPERATIVELY WITH, THE
26 BUREAU OF CYBER SECURITY OF THE STATE POLICE, AND THE STATE OFFICE OF
27 INFORMATION TECHNOLOGY SERVICES, FOR:

28 (A) THE ESTABLISHMENT AND MAINTENANCE OF THE STATE'S POLICIES, PROTO-
29 COLS AND STRATEGIES RELATING TO THE PREVENTION AND DETECTION OF CYBER
30 THREATS OR CYBER ATTACKS THAT WOULD ENDANGER THE PEOPLE, BUSINESSES OR
31 PROPERTY OF THE STATE OF NEW YORK;

32 (B) THE COLLECTION, ANALYSIS AND SHARING OF INFORMATION RELATING TO
33 CYBER THREATS, CYBER ACTIVITIES AND CYBER ATTACKS THROUGHOUT THE STATE;

34 (C) THE DEVELOPMENT AND IMPLEMENTATION OF INFORMATION SHARING PROGRAMS
35 AND CYBER DEFENSE MEASURES TO PROTECT COMPUTERS, SYSTEMS AND NETWORKS;

36 (D) THE COORDINATION, DEVELOPMENT AND MAINTENANCE OF STRATEGIES,
37 PROTOCOLS AND RESPONSE NEEDS TO DETECT, PREVENT AND/OR RESPOND TO A
38 CYBER ATTACK OR CYBER THREAT;

39 (E) THE CONDUCT OF ASSESSMENTS, IN COOPERATION WITH PRIVATE ENTITIES
40 AND LOCAL, STATE AND FEDERAL AGENCIES, OF THE VULNERABILITY OF CRITICAL
41 INFRASTRUCTURE TO CYBER ATTACK;

42 (F) THE CONDUCT OF ASSESSMENTS, IN COOPERATION WITH PRIVATE ENTITIES
43 AND LOCAL, STATE AND FEDERAL AGENCIES TO PROVIDE STATE-WIDE COORDINATION
44 OF GEOGRAPHICALLY REFERENCED CRITICAL INFRASTRUCTURE, AND THE PROMOTION
45 AND DEVELOPMENT OF PROGRAMS TO PREVENT SUCH INFRASTRUCTURE FROM CYBER
46 ATTACK; AND

47 (G) THE CONSULTATION WITH APPROPRIATE STATE AND LOCAL GOVERNMENTS AND
48 PRIVATE ENTITIES, AND THE GOVERNMENT OF THE UNITED STATES, TO FACILITATE
49 AND FOSTER COOPERATION TO BETTER PREPARE THE STATE TO PREVENT, DETECT
50 AND RESPOND TO CYBER THREATS AND CYBER ATTACKS.

51 4. INFORMATION SHARING. THE OFFICE OF COUNTERTERRORISM, INTELLIGENCE
52 AND CYBER SECURITY SHALL ENGAGE IN THE SHARING OF INFORMATION TO FACILI-
53 TATE THE PURPOSES OF THIS SECTION.

13 (B) THE OFFICE SHALL SHARE CYBER SECURITY, INTELLIGENCE AND INVESTI-
14 GATION INFORMATION WITH, AND MAY RECEIVE CYBER SECURITY, INTELLIGENCE,
15 AND INVESTIGATION INFORMATION FROM, THE BUREAU OF CYBER SECURITY OF THE

51 THAT TERRORISM IS A SERIOUS THREAT TO THE PUBLIC SAFETY OF THE PEOPLE OF
52 THE STATE OF NEW YORK.

53 THE LEGISLATURE ADDITIONALLY FINDS AND DETERMINES, THAT IT IS THE
54 FIRST RESPONSIBILITY OF ANY GOVERNMENT TO PROVIDE FOR THE PUBLIC
55 PROTECTION AND SAFETY OF ITS CITIZENS, AND THAT IN ORDER TO ASSURE SUCH
56 PUBLIC PROTECTION AND SAFETY, NEW YORK MUST TAKE ACTIVE STEPS TO ADVANCE

1 A PROGRAM OF PREVENTION OF, RESPONSE TO, AND RECOVERY FROM, TERRORIST
2 ATTACKS.

3 THE LEGISLATURE ALSO FINDS AND DETERMINES, THAT IN ORDER TO ADVANCE A
4 PROGRAM TO PREVENT TERRORIST ATTACKS, WHILE STILL PRESERVING THE ESSEN-
5 TIAL CIVIL LIBERTIES AND FREEDOMS THAT NEW YORK'S CITIZENS HOLD DEAR AS
6 AN IRREPLACEABLE, FOUNDATIONAL ELEMENT OF SOCIETY, THE STATE MUST TAKE
7 RESPONSIBLE ACTION TO REGISTER THOSE INDIVIDUALS, WHO HAVE DEMONSTRATED

29 1751, 1992, 1993, 2155, 2280, 2281, 2332, 2332A, 2332B, 2332C, 2332D,
30 2332E, 2332F, 2332G, 2332H, 2339, 2339A, 2339B, 2339C, AND/OR 2339D OF
31 TITLE 18 OF THE UNITED STATES CODE;

32 (D) SET FORTH IN SECTION 2284 OF TITLE 42 OF THE UNITED STATES CODE;

33 (E) SET FORTH IN SECTION 46504, 46505 (B) (3), 46506, AND/OR 60123 (B)
34 OF TITLE 49 OF THE UNITED STATES CODE; AND/OR

35 (F) IN ANY OTHER JURISDICTION, WHETHER WITHIN THE UNITED STATES OR A
36 FOREIGN COUNTRY, OF ANY OFFENSE WHICH INCLUDES ALL OF THE ESSENTIAL
37 ELEMENTS OF ANY OFFENSE SET FORTH WITHIN PARAGRAPHS (C), (D) OR (E) OF
38 THIS SUBDIVISION.

39 3. "VERIFIABLE ACT OF TERRORISM" MEANS ANY ACT COMMITTED BY A PERSON
40 OR PERSONS THAT HAS RESULTED IN SUCH PERSON OR PERSONS BEING:

41 (A) CONVICTED BY A COMBAT STATUS REVIEW TRIBUNAL OR MILITARY COMMIS-
42 SION OF ANY ACT OF TERRORISM, TERRORIST ACTIVITIES, OR THE HARBORING,
43 SUPPORT AND/OR PROMOTION OF TERRORISTS OF TERRORIST ACTIVITIES;

44 (B) CONVICTED BY A MILITARY OR CIVILIAN COURT OF COMPETENT JURISDIC-
45 TION OF ANY ACT OF TERRORISM, TERRORIST ACTIVITIES, OR THE HARBORING,
46 SUPPORT AND/OR PROMOTION OF TERRORISTS OR TERRORIST ACTIVITIES IN
47 VIOLATION OF THE UNIFORM CODE OF MILITARY JUSTICE;

48 (C) SUBJECT TO AN ORDER OF DETENTION BY THE ARMED FORCES OF THE UNITED
49 STATES, ANY OTHER GOVERNMENT AGENCY OF THE UNITED STATES, OR ANY
50 CONTRACTOR OF THE GOVERNMENT OF THE UNITED STATES THAT IS AUTHORIZED BY
51 THE GOVERNMENT OF THE UNITED STATES TO MAKE SUCH DETENTIONS, UPON A
52 DETERMINATION THAT SUCH PERSON WAS AT ANY TIME, A FOREIGN ENEMY COMBA-
53 TANT OR AN ILLEGAL ENEMY COMBATANT;

54 (D) DEPORTED OR TRANSPORTED, TO A COUNTRY, OTHER THAN THE UNITED
55 STATES, BY THE GOVERNMENT OF THE UNITED STATES, OR ANY DEPARTMENT OR
56 AGENCY THEREOF, UPON A DETERMINATION OF INVOLVEMENT IN TERRORIST ACTIV-

ITIES, OR THE HARBORING, SUPPORT AND/OR PROMOTION OF TERRORISTS OR TERRORIST ACTIVITIES; OR

(E) DESIGNATED BY THE UNITED STATES DEPARTMENT OF HOMELAND SECURITY, THE UNITED STATES DEPARTMENT OF STATE, THE UNITED STATES DEPARTMENT OF JUSTICE, THE UNITED STATES DEPARTMENT OF DEFENSE OR ANY OF ITS ARMED SERVICES, THE UNITED STATES CENTRAL INTELLIGENCE AGENCY, AND/OR THE OFFICE OF THE DIRECTOR OF NATIONAL INTELLIGENCE, AS A PERSON WHO HAS COMMITTED A TERRORIST ACT AGAINST THE UNITED STATES OR ANY OF ITS CITIZENS, AND/OR WHO IS A MEMBER OF A DESIGNATED TERRORIST ORGANIZATION PURSUANT TO SECTION 1189 OF TITLE 8 OF THE UNITED STATES CODE.

4. "TERRORIST INCIDENT" MEANS ANY INCIDENT WHICH WAS THE BASIS OF A CONVICTION FOR ANY TERRORIST OFFENSE, AS DEFINED BY SUBDIVISION TWO OF THIS SECTION, OR ANY INCIDENT WHICH WAS THE BASIS FOR A VERIFIABLE ACT OF TERRORISM, AS DEFINED BY SUBDIVISION THREE OF THIS SECTION.

5. "LAW ENFORCEMENT AGENCY HAVING JURISDICTION" MEANS:

(A) THE CHIEF LAW ENFORCEMENT OFFICER IN THE VILLAGE, TOWN OR CITY IN WHICH THE TERRORIST EXPECTS TO RESIDE, OR ACTUALLY RESIDES, UPON HIS OR HER DISCHARGE, PROBATION, PAROLE, RELEASE TO POST-RELEASE SUPERVISION, OR UPON ANY OTHER FORM OF FEDERAL, STATE OR LOCAL CONDITIONAL RELEASE; OR

(B) IF THE TERRORIST DOES NOT RECEIVE DISCHARGE, PROBATION, PAROLE, RELEASE TO POST-RELEASE SUPERVISION, OR ANY OTHER FORM OF FEDERAL, STATE OR LOCAL CONDITIONAL RELEASE, THEN THE CHIEF LAW ENFORCEMENT OFFICER IN THE VILLAGE, TOWN OR CITY IN WHICH THE TERRORIST ACTUALLY RESIDES; OR

(C) IF THERE IS NO CHIEF LAW ENFORCEMENT OFFICER IN SUCH VILLAGE, TOWN OR CITY, THE CHIEF LAW ENFORCEMENT OFFICER OF THE COUNTY; OR

(D) IF THERE IS NO CHIEF ENFORCEMENT OFFICER IN SUCH VILLAGE, TOWN, CITY OR COUNTY, THE DIVISION OF STATE POLICE.

6. "DIVISION" MEANS THE DIVISION OF CRIMINAL JUSTICE SERVICES AS DEFINED BY SECTION EIGHT HUNDRED THIRTY-SEVEN OF THE EXECUTIVE LAW.

7. "DEPARTMENT" MEANS THE DEPARTMENT OF CORRECTIONS AND COMMUNITY SUPERVISION, AS DEFINED IN SUBDIVISION ONE OF SECTION TWO, AND SECTION FIVE, OF THIS CHAPTER.

8. "OFFICE OF PROBATION AND CORRECTIONAL ALTERNATIVES" MEANS THE OFFICE OF PROBATION AND CORRECTIONAL ALTERNATIVES AS DESCRIBED IN SECTION TWO HUNDRED FORTY OF THE EXECUTIVE LAW.

9. "HOSPITAL" MEANS A HOSPITAL AS DEFINED IN SUBDIVISION TWO OF SECTION FOUR HUNDRED OF THIS CHAPTER AND APPLIES TO PERSONS COMMITTED TO SUCH HOSPITAL BY ORDER OF COMMITMENT MADE PURSUANT TO ARTICLE SIXTEEN OF THIS CHAPTER.

10. "LOCAL CORRECTIONAL FACILITY" MEANS THE LOCAL CORRECTIONAL FACILITY AS THAT TERM IS DEFINED IN SUBDIVISION SIXTEEN OF SECTION TWO OF THIS CHAPTER.

11. "PROBATION" MEANS A SENTENCE OF PROBATION IMPOSED PURSUANT TO ARTICLE SIXTY-FIVE OF THE PENAL LAW AND SHALL INCLUDE A SENTENCE OF IMPRISONMENT IMPOSED IN CONJUNCTION WITH A SENTENCE OF PROBATION.

12. "INTERNET ACCESS PROVIDER" MEANS ANY BUSINESS, ORGANIZATION OR OTHER ENTITY ENGAGED IN THE BUSINESS OF PROVIDING A COMPUTER AND COMMUNICATIONS FACILITY THROUGH WHICH A CUSTOMER MAY OBTAIN ACCESS TO THE INTERNET.

13. "INTERNET SERVICE PROVIDER" MEANS ANY BUSINESS, ORGANIZATION OR OTHER ENTITY ENGAGED IN THE BUSINESS OF PROVIDING TELECOMMUNICATION, CABLE AND/OR BROADBAND SERVICES TO CONNECT TO, AND COMMUNICATE ON, THE INTERNET, OR ANY OTHER BROAD MULTI-USER COMPUTER SYSTEM.

1 14. "INTERNET IDENTIFIERS" MEANS ANY ELECTRONIC MAIL ADDRESSES AND
2 DESIGNATIONS USED FOR THE PURPOSES OF CHAT, INSTANT MESSAGING, SOCIAL
3 NETWORKING OR OTHER SIMILAR INTERNET COMMUNICATION.

4 15. "CELLULAR SERVICE PROVIDER" MEANS ANY BUSINESS, ORGANIZATION OR
5 OTHER ENTITY ENGAGED IN THE BUSINESS OF PROVIDING CELLULAR TELEPHONE OR
6 DEVICE SERVICE THROUGH WHICH A CUSTOMER MAY MAKE CELLULAR TELEPHONE
7 CALLS OR OBTAIN ACCESS TO THE INTERNET, BUT DOES NOT INCLUDE A BUSINESS,
8 ORGANIZATION OR OTHER ENTITY TO THE EXTENT THAT IT PROVIDES ONLY LAND
9 LINE OR CABLE TELECOMMUNICATIONS SERVICES.

10 16. "REGISTRY" MEANS THE NEW YORK STATE TERRORIST REGISTRY ESTABLISHED
11 AND MAINTAINED BY THE DIVISION OF CRIMINAL JUSTICE SERVICES PURSUANT TO
12 THIS ARTICLE.

13 17. "REGISTRANT" MEANS A TERRORIST, THAT UPON EXAMINATION, PURSUANT TO
14 SECTION ONE HUNDRED SIXTY-NINE-F OF THIS ARTICLE, THE DIVISION HAS
15 DETERMINED SHALL BE REQUIRED TO REGISTER WITH, AND BE ADDED TO, THE NEW
16 YORK STATE TERRORIST REGISTRY.

17 18. "CONFINEMENT ENTITY" MEANS THE DEPARTMENT, OR ANY OTHER OFFICE,
18 AGENCY, GOVERNMENT, CORPORATION OR OTHER INSTITUTION WHICH MAINTAINS THE
19 CORRECTIONAL FACILITY, HOSPITAL, LOCAL CORRECTIONAL FACILITY, OR ANY
20 OTHER SIMILAR TYPE OF SECURE FACILITY, AT WHICH A TERRORIST, AS DEFINED
21 IN SUBDIVISION ONE OF THIS SECTION, IS CONFINED.

22 S 169-C. DUTIES OF THE DIVISION. 1. TERRORIST REGISTRY. THE DIVISION
23 SHALL ESTABLISH AND MAINTAIN AN INFORMATION FILE ON ALL TERRORISTS
24 REQUIRED TO REGISTER PURSUANT TO THE PROVISIONS OF THIS ARTICLE, WHICH
25 SHALL INCLUDE ALL THE INFORMATION SET FORTH IN SECTION ONE HUNDRED
26 SIXTY-NINE-D OF THIS ARTICLE, AND WHICH SHALL BE KNOWN AS THE NEW YORK
27 STATE TERRORIST REGISTRY.

28 2. REGISTRANT NOTIFICATION. THE DIVISION SHALL NOTIFY EVERY TERRORIST
29 REQUIRED TO BE REGISTERED UNDER THIS ARTICLE, PURSUANT TO THE PROVISIONS
30 OF SECTION ONE HUNDRED SIXTY-NINE-E OF THIS ARTICLE, BUT IN NO EVENT

PURPOSE OF COLLECTING THE QUARTERLY SUPPLEMENTAL AND VERIFICATION INFORMATION IDENTIFIED IN SECTION ONE HUNDRED SIXTY-NINE-D OF THIS ARTICLE, FROM EVERY TERRORIST REQUIRED TO REGISTER WITH THE NEW YORK STATE TERRORIST REGISTRY.

9. AVAILABILITY OF INFORMATION AND FORMS. IN ADDITION TO THE OTHER PROVISIONS OF THIS SECTION, THE DIVISION SHALL FURTHER MAKE INFORMATION AND FORMS AVAILABLE AS FOLLOWS:

(A) THE DIVISION SHALL MAKE PAPER COPIES OF THE STANDARDIZED REGISTRATION INFORMATION FORM, THE STANDARDIZED REGISTRATION FORM, THE STANDARDIZED VERIFICATION INFORMATION FORM AND THE STANDARDIZED VERIFICATION FORM AVAILABLE TO REGISTRANTS, ATTORNEYS REPRESENTING REGISTRANTS, THE UNIFIED COURT SYSTEM, THE DEPARTMENT, FEDERAL, STATE AND LOCAL LAW ENFORCEMENT, AND SUCH OTHER AND FURTHER INDIVIDUALS AND ENTITIES AS THE DIVISION DEEMS APPROPRIATE;

(B) THE DIVISION SHALL FURTHER POST ELECTRONIC COPIES OF THE STANDARDIZED REGISTRATION INFORMATION FORM, THE STANDARDIZED REGISTRATION FORM, THE STANDARDIZED VERIFICATION INFORMATION FORM AND THE STANDARDIZED VERIFICATION FORM, PRODUCED IN ACCORDANCE WITH THIS SECTION, ON THE OFFICIAL WEBSITE OF THE DIVISION, AND SUCH ELECTRONIC FORMS SHALL ALL BE IN A DOWNLOADABLE FORMAT, TO ALLOW FOR THE SUBMISSION OF A COMPLETED COPY OF SUCH FORM OR FORMS TO THE DIVISION, REGARDLESS OF WHETHER ANY SUCH FORM OR FORMS HAVE BEEN PROVIDED TO, OR RECEIVED BY, THE REGISTRANT, OR REGARDLESS OF WHETHER SUCH REGISTRANT HAS IN FACT RECEIVED NOTICE OF HIS OR HER DUTY AND OBLIGATION TO REGISTER AS REQUIRED BY THIS ARTICLE; AND

(C) THE DIVISION SHALL ALSO MAINTAIN A TOLL FREE TELEPHONE NUMBER, WHICH SHALL BE DISPLAYED ON THE OFFICIAL WEBSITE OF THE DIVISION, TO PROVIDE, UPON REQUEST OF ANY PERSON REQUIRED TO REGISTER WITH THE NEW YORK STATE TERRORIST REGISTRY, OR THEIR REPRESENTATIVE, ALL INFORMATION THAT IS NECESSARY FOR A REGISTRANT TO COMPLETE THEIR REGISTRATION WITH THE NEW YORK STATE TERRORIST REGISTRY, OR FOR A REGISTRANT TO COMPLETE THEIR VERIFICATION, INCLUDING INFORMATION THAT WOULD BE PROVIDED IN A PERSONALIZED REGISTRATION INFORMATION FORM OR A PERSONALIZED VERIFICATION INFORMATION FORM.

10. ADVERTISEMENT. THE DIVISION SHALL ADVERTISE ON ITS OFFICIAL WEBSITE THAT ALL TERRORISTS ADDED TO THE NEW YORK STATE TERRORIST REGISTRY SHALL BE REQUIRED TO REGISTER AND PROVIDE VERIFICATION UNDER PENALTY OF LAW, AND THAT THE INFORMATION AND FORMS NECESSARY TO COMPLETE SUCH REGISTRATION AND PROVIDE SUCH VERIFICATION ARE AVAILABLE FOR DOWNLOAD ON THE DIVISION'S WEBSITE AND THAT FURTHER INFORMATION CAN BE OBTAINED FROM THE TOLL FREE TELEPHONE NUMBER ESTABLISHED IN ACCORDANCE WITH PARAGRAPH (C) OF SUBDIVISION NINE OF THIS SECTION.

11. PURPOSE OF THE REGISTRATION PACKET. THE PURPOSE OF THE NON-FORWARDABLE REGISTRATION PACKET CREATED IN ACCORDANCE WITH SUBDIVISION ONE OF THIS SECTION, SHALL BE TO INFORM EVERY TERRORIST ADDED TO THE NEW YORK STATE TERRORIST REGISTRY OF SUCH TERRORIST'S DUTY AND OBLIGATION TO REGISTER AS REQUIRED BY THIS ARTICLE, AND TO COLLECT THE NECESSARY INFORMATION FROM SUCH TERRORIST AS REQUIRED BY THIS ARTICLE.

12. MAILING OF REGISTRATION PACKET. THE NON-FORWARDABLE REGISTRATION PACKET, AS DEFINED IN SUBDIVISION ONE OF THIS SECTION, SHALL BE MAILED BY THE DIVISION, BY FIRST CLASS MAIL, TO THE LAST KNOWN ADDRESS OF SUCH TERRORIST, IN ACCORDANCE WITH THE TIMELINES ESTABLISHED BY SUBDIVISION FIFTEEN OF THIS SECTION.

13. PURPOSE OF THE VERIFICATION PACKET. THE PURPOSE OF THE NON-FORWARDABLE VERIFICATION PACKET, CREATED IN ACCORDANCE WITH SUBDIVISION FIVE OF THIS SECTION, SHALL BE TO INFORM EVERY REGISTRANT ADDED TO THE

NEW YORK STATE TERRORIST REGISTRY OF SUCH REGISTRANT'S DUTY AND OBLIGATION TO PROVIDE VERIFICATION AS REQUIRED BY THIS ARTICLE, AND TO COLLECT THE NECESSARY VERIFICATION INFORMATION FROM SUCH REGISTRANT AS REQUIRED BY THIS ARTICLE.

14. MAILING OF VERIFICATION PACKET. THE NON-FORWARDABLE VERIFICATION PACKET, AS DEFINED IN SUBDIVISION FIVE OF THIS SECTION, SHALL BE MAILED BY THE DIVISION, BY FIRST CLASS MAIL, TO THE LAST KNOWN ADDRESS OF SUCH REGISTRANT, IN ACCORDANCE WITH THE TIMELINES ESTABLISHED BY SUBDIVISION FIFTEEN OF THIS SECTION.

15. TIMELINES. WITH RESPECT TO THE REQUIREMENTS OF THIS ARTICLE, THE FOLLOWING TIMELINES SHALL APPLY:

(A) THE MAILING REQUIRED IN ACCORDANCE WITH THE PROVISIONS OF SUBDIVISION TWELVE OF THIS SECTION SHALL BE COMPLETED BY THE DIVISION WITHIN TEN CALENDAR DAYS OF THE DATE ON WHICH THE DIVISION ADDS THE TERRORIST TO WHOM THE MAILING IS DIRECTED TO THE NEW YORK STATE TERRORIST REGISTRY;

(B) THE MAILING REQUIRED IN ACCORDANCE WITH SUBDIVISION FOURTEEN OF THIS SECTION SHALL BE COMPLETED BY THE DIVISION WITHIN SEVENTY-FIVE CALENDAR DAYS OF THE DATE ON WHICH THE REGISTRANT TO WHOM THE MAILING IS DIRECTED PROVIDES THE DIVISION WITH ALL THE INFORMATION REQUIRED IN THE STANDARDIZED REGISTRATION FORM, AND THEN AGAIN, EVERY NINETY DAYS THEREAFTER;

(C) THE REGISTRANT, WITHIN TEN CALENDAR DAYS OF THE RECEIPT OF THE REGISTRATION PACKET FROM THE DIVISION, OR WITHIN THIRTY CALENDAR DAYS OF THE MAILING OF REGISTRATION PACKET BY THE DIVISION, OR WITHIN FIVE CALENDAR DAYS OF DOWNLOADING THE STANDARDIZED REGISTRATION FORM FROM THE DIVISION'S WEBSITE, OR WITHIN FIVE DAYS OF BEING PERSONALLY NOTIFIED BY THE DIVISION OR ITS REPRESENTATIVE, WHICHEVER IS EARLIER, SHALL RETURN A FULLY EXECUTED, SIGNED AND COMPLETED COPY OF THE STANDARDIZED REGISTRATION FORM TO THE DIVISION, EITHER BY MEANS OF UNITED STATES FIRST CLASS MAIL, OR BY MEANS OF PERSONAL DELIVERY TO THE LAW ENFORCEMENT AGENCY HAVING JURISDICTION;

(D) THE REGISTRANT, WITHIN TEN CALENDAR DAYS OF THE RECEIPT OF THE VERIFICATION PACKET FROM THE DIVISION, OR WITHIN FIFTEEN CALENDAR DAYS OF THE MAILING OF VERIFICATION PACKET BY THE DIVISION, OR WITHIN FIVE CALENDAR DAYS OF DOWNLOADING THE STANDARDIZED VERIFICATION FORM FROM THE DIVISION'S WEBSITE, OR WITHIN FIVE CALENDAR DAYS OF BEING PERSONALLY NOTIFIED BY THE DIVISION OR ITS REPRESENTATIVE, WHICHEVER IS EARLIER, SHALL RETURN A FULLY EXECUTED, SIGNED AND COMPLETED COPY OF THE STANDARDIZED VERIFICATION FORM TO THE DIVISION, EITHER BY MEANS OF UNITED STATES FIRST CLASS MAIL, OR BY MEANS OF PERSONAL DELIVERY TO THE LAW ENFORCEMENT AGENCY HAVING JURISDICTION;

(E) THE REGISTRANT, WITHIN FIFTEEN CALENDAR DAYS OF THE RECEIPT OF THE REGISTRATION PACKET FROM THE DIVISION, OR WITHIN THIRTY-FIVE CALENDAR DAYS OF THE MAILING OF REGISTRATION PACKET BY THE DIVISION, OR WITHIN TEN CALENDAR DAYS OF DOWNLOADING THE STANDARDIZED REGISTRATION FORM FROM THE DIVISION'S WEBSITE, OR WITHIN FIVE CALENDAR DAYS OF BEING PERSONALLY NOTIFIED BY THE DIVISION OR ITS REPRESENTATIVE, WHICHEVER IS EARLIER, SHALL APPEAR BEFORE THE LAW ENFORCEMENT AGENCY HAVING JURISDICTION, TO PROVIDE FINGERPRINTS, AN INITIAL PHOTOGRAPH AND A DNA SAMPLE, UNLESS SUCH REGISTRANT HAS PREVIOUSLY HAD THEIR INITIAL PHOTOGRAPH PREVIOUSLY TAKEN, AND THEIR FINGERPRINTS AND DNA SAMPLE PREVIOUSLY COLLECTED, IN ACCORDANCE WITH SUBDIVISIONS THREE AND FIVE OF SECTION ONE HUNDRED SIXTY-NINE-J OF THIS ARTICLE, OR IN ACCORDANCE WITH SUBDIVISIONS THREE AND FIVE OF SECTION ONE HUNDRED SIXTY-NINE-K OF THIS ARTICLE; AND

(F) THE REGISTRANT SHALL ANNUALLY APPEAR BEFORE THE LAW ENFORCEMENT AGENCY HAVING JURISDICTION, NOT LATER THAN ONE YEAR AFTER, AND NOT PRIOR TO THREE HUNDRED THIRTY DAYS BEFORE, THE ANNIVERSARY DATE OF THE TAKING OR HIS OR HER INITIAL PHOTOGRAPH IN ORDER TO PROVIDE THE DIVISION WITHIN AN UPDATED PHOTOGRAPH.

16. DUTY AND OBLIGATION TO REGISTER AND PROVIDE VERIFICATION ABSOLUTE. IN NO EVENT SHALL THE FAILURE OF A TERRORIST TO RECEIVE ANY NOTICE, REGISTRATION PACKET OR VERIFICATION PACKET, OR OF THE DIVISION TO FAIL TO PROVIDE SUCH NOTICE, REGISTRATION PACKET OR VERIFICATION PACKET, OR OF THE FAILURE OF THE DIVISION TO PROVIDE SUCH NOTICE, REGISTRATION PACKET OR VERIFICATION PACKET WITHIN THE TIME REQUIRED PURSUANT TO THIS SECTION, RELIEVE ANY SUCH TERRORIST FROM ANY DUTY OR OBLIGATION REQUIRED BY THIS ARTICLE.

17. VIOLATIONS. IN THE EVENT THAT A COMPLETED STANDARDIZED REGISTRATION FORM OR A COMPLETED STANDARDIZED VERIFICATION FORM IS NOT RETURNED TO THE DIVISION BY A REGISTRANT WITHIN THE TIMELINES REQUIRED PURSUANT TO SUBDIVISION FIFTEEN OF THIS SECTION, THE DIVISION SHALL IMMEDIATELY NOTIFY THE DIVISION OF STATE POLICE, THE STATE DIVISION OF HOMELAND SECURITY AND EMERGENCY SERVICES, AND THE UNITED STATES DEPARTMENT OF HOMELAND SECURITY, WHEREUPON THE DIVISION OF STATE POLICE SHALL IMMEDIATELY CAUSE SUCH TERRORIST TO BE ARRESTED AND CHARGED WITH A FAILURE TO REGISTER IN ACCORDANCE WITH THIS ARTICLE, AND PURSUANT TO SECTION 490.23 OF THE PENAL LAW.

18. LATE FILINGS. THE DIVISION MAY BY REGULATION IDENTIFY CERTAIN CIRCUMSTANCES WHEN THE COMMISSIONER MAY AUTHORIZE THE LATE SUBMISSION OF A STANDARDIZED REGISTRATION FORM, A STANDARDIZED VERIFICATION FORM, OR THE LATE COLLECTION OF FINGERPRINTS, DNA SAMPLE, INITIAL PHOTOGRAPH OR UPDATED PHOTOGRAPH, BUT IN NO EVENT SHALL A LATE SUBMISSION OR LATE COLLECTION BE AUTHORIZED MORE THAN NINETY DAYS AFTER THE REGISTRANT, IF OF LEGAL CAPACITY, RECEIVED ACTUAL NOTICE, OF THEIR DUTY AND OBLIGATION TO SUBMIT OR HAVE COLLECTED SUCH STANDARDIZED REGISTRATION FORM, STANDARDIZED VERIFICATION FORM, FINGERPRINTS, DNA SAMPLE, INITIAL PHOTOGRAPH OR UPDATED PHOTOGRAPH.

19. REGULATIONS. THE DIVISION SHALL PROMULGATE RULES AND REGULATIONS TO IMPLEMENT THE PROVISIONS OF THIS SECTION.

S 169-F. EXAMINATION OF POTENTIAL REGISTRANTS. 1. GENERALLY. THE DIVISION SHALL MAKE REGULAR EXAMINATIONS TO DETERMINE WHETHER TERRORISTS SHALL BE ADDED TO THE REGISTRY, AND UPON ANY SUCH EXAMINATION AND DETERMINATION THAT A TERRORIST SHALL BE ADDED TO THE REGISTRY, IN ACCORDANCE WITH THE PROVISIONS OF THIS SECTION, THE DIVISION SHALL ADD SUCH TERRORIST TO THE REGISTRY, AND SHALL NOTIFY SUCH TERRORIST PURSUANT TO SECTION ONE HUNDRED SIXTY-NINE-E OF THIS ARTICLE.

2. RELEASE NOTIFICATION. IN THE CASE OF ANY TERRORIST, IT SHALL BE THE DUTY OF THE CONFINEMENT ENTITY IN WHOSE CUSTODY SUCH TERRORIST IS HELD, AT LEAST SIXTY CALENDAR DAYS PRIOR TO THE RELEASE OF SUCH TERRORIST FROM SUCH CUSTODY, TO NOTIFY THE DIVISION, IN A FORM AND MANNER PROVIDED BY THE DIVISION, OF THE CONTEMPLATED RELEASE OR DISCHARGE OF SUCH TERRORIST. THE NOTIFICATION PROVIDED SHALL INCLUDE THE ADDRESS AT WHICH SUCH TERRORIST PROPOSES TO RESIDE. IF SUCH TERRORIST CHANGES HIS OR HER PLACE OF RESIDENCE WHILE ON PAROLE, SUCH NOTIFICATION OF THE CHANGE OF RESIDENCE SHALL BE SENT BY THE TERRORIST'S PAROLE OFFICER WITHIN FORTY-EIGHT HOURS TO THE DIVISION, ON A FORM AND IN A MANNER PROVIDED BY THE DIVISION. IN THE EVENT THAT THE CONFINEMENT ENTITY IS UNABLE TO NOTIFY THE DIVISION OF THE CONTEMPLATED RELEASE OR DISCHARGE OF SUCH TERRORIST AT LEAST SIXTY DAYS PRIOR TO SUCH RELEASE, THE CONFINEMENT ENTITY MUST

1 PROVIDE AN EMERGENCY NOTIFICATION TO THE DIVISION, IN A FORM AND MANNER
2 PROVIDED BY THE DIVISION.

3 3. PROBATION NOTIFICATION. IN THE CASE OF ANY TERRORIST ON PROBATION,
4 IT SHALL BE THE DUTY OF THE TERRORIST'S PROBATION OFFICER TO NOTIFY THE
5 DIVISION, WITHIN FORTY-EIGHT HOURS, OF ANY INITIAL OR CHANGED PLACE OF
6 RESIDENCE OF SUCH TERRORIST, IN THE FORM AND MANNER PROVIDED BY THE
7 DIVISION.

8 4. ESCAPE NOTIFICATION. IN THE EVENT THAT ANY TERRORIST ESCAPES FROM
9 THE CUSTODY OF ANY CONFINEMENT ENTITY, THE DESIGNATED OFFICIAL OF THE
10 CONFINEMENT ENTITY, SHALL IMMEDIATELY NOTIFY, BY TELEPHONE AND/OR EMAIL,
11 THE DIVISION OF SUCH ESCAPE. WITHIN TWENTY-FOUR HOURS, THE CONFINEMENT
12 ENTITY SHALL FURTHER PROVIDE THE DIVISION AND THE LAW ENFORCEMENT AGENCY
13 HAVING JURISDICTION AT, AND IMMEDIATELY PRIOR TO, THE TIME OF THE
14 TERRORIST'S CONFINEMENT, WITH:

15 (A) THE NAME AND ALIASES OF THE TERRORIST;

16 (B) THE ADDRESS AT WHICH THE TERRORIST RESIDED AT THE TIME OF HIS OR
17 HER CONFINEMENT;

18 (C) THE AMOUNT OF TIME REMAINING ON THE TERRORIST'S CONFINEMENT TO BE
19 SERVED, IF ANY;

20 (D) THE NATURE OF THE OFFENSE FOR WHICH THE TERRORIST WAS CONFINED;

21 (E) A RECENT PHOTOGRAPH OF THE TERRORIST; AND

22 (F) THE FINGERPRINTS OF THE TERRORIST.

23 5. PURPOSE. IT SHALL BE THE PURPOSE OF THE DIVISION'S EXAMINATIONS
24 UNDER THIS SECTION TO DETERMINE WHAT TERRORISTS ARE OR WILL BE RESIDING,
25 WORKING, OR ATTENDING EDUCATIONAL INSTITUTIONS, IN NEW YORK STATE, AND
26 WHETHER, PURSUANT TO THE PROVISIONS OF THIS ARTICLE, SUCH TERRORISTS
27 SHOULD BE ADDED TO THE NEW YORK STATE TERRORIST REGISTRY.

28 6. COMMUNICATION WITH OTHER ENTITIES. (A) IN CONDUCTING ITS EXAMINA-
29 TIONS, PURSUANT TO THIS SECTION, TO DETERMINE WHAT TERRORISTS ARE OR
30 WILL BE RESIDING, WORKING, OR ATTENDING EDUCATIONAL INSTITUTIONS IN NEW
31 YORK STATE, THE DIVISION SHALL COMMUNICATE WITH THE FOLLOWING STATE
32 ENTITIES:

36 (IV) THE DEPARTMENT OF HEALTH;

38 (VI) THE OFFICE OF COURT ADMINISTRATION, AND ANY COURT OF THE UNIFIED
39 COURT SYSTEM;

40 (VII) THE DIVISION OF STATE POLICE;

41 (VIII) THE DIVISION OF HOMELAND SECURITY AND EMERGENCY SERVICES;
42 AND/OR

43 (IX) ANY OTHER STATE OR LOCAL ENTITY THE DIVISION DEEMS APPROPRIATE.

44 (B) IN FURTHER CONDUCTING ITS EXAMINATIONS, PURSUANT TO THIS SECTION,
45 TO DETERMINE WHAT TERRORISTS ARE OR WILL BE RESIDING, WORKING, OR
46 ATTENDING EDUCATIONAL INSTITUTIONS, IN NEW YORK STATE, THE DIVISION
47 SHALL ALSO COMMUNICATE WITH THE FOLLOWING FEDERAL, INTERSTATE OR INTER-
48 NATIONAL ENTITIES:

49 (I) THE FEDERAL BUREAU OF PRISONS;

50 (II) THE UNITED STATE DEPARTMENT OF DEFENSE, AND ITS ARMED SERVICES
51 BRANCHES;

52 (III) THE UNITED STATE DEPARTMENT OF STATE;

53 (IV) THE UNITED STATES DEPARTMENT OF JUSTICE;

54 (V) THE UNITED STATES DEPARTMENT OF HOMELAND SECURITY;

55 (VI) THE CENTRAL INTELLIGENCE AGENCY;

56 (VII) THE OFFICE OF THE DIRECTOR OF NATIONAL INTELLIGENCE;

1 (VIII) THE INTERNATIONAL CRIMINAL POLICE ORGANIZATION (INTERPOL); AND
2 (IX) ANY OTHER FEDERAL, INTERSTATE, OR INTERNATIONAL ENTITY THE DIVI-
3 SION DEEMS APPROPRIATE.

4 7. GROUNDS TO ADD A TERRORIST TO THE REGISTRY. UPON EXAMINATION IN
5 ACCORDANCE WITH THIS SECTION, THE DIVISION SHALL ADD A TERRORIST, AS
6 DEFINED BY SUBDIVISION ONE OF SECTION ONE HUNDRED SIXTY-NINE-B OF THIS
7 ARTICLE, TO THE NEW YORK STATE TERRORIST REGISTRY, AND PROVIDE SUCH
8 TERRORIST WITH NOTIFICATION THAT THEY HAVE BEEN SO ADDED TO THE REGISTRY
9 IN ACCORDANCE WITH SECTION ONE HUNDRED SIXTY-NINE-E OF THIS ARTICLE, IF
10 THE DIVISION DETERMINES THAT SUCH TERRORIST IS:

11 (A) NOT PRESENTLY SUBJECT TO CONFINEMENT BUT IS CURRENTLY, HAS BEEN,
12 OR WILL BE WITHIN THE NEXT NINETY DAYS, LIVING, WORKING OR ATTENDING AN
13 EDUCATIONAL INSTITUTION WITHIN NEW YORK STATE, OR

14 (B) IS PRESENTLY IN THE CUSTODY OF A CONFINEMENT ENTITY, OR IS SUBJECT
15 TO COMMUNITY SUPERVISION OR PROBATION, AND IS SCHEDULED FOR A CONDI-
16 TIONAL RELEASE OR ANY OTHER DISCHARGE IN NEW YORK STATE, OR

17 (C) IS PRESENTLY IN THE CUSTODY OF A CONFINEMENT ENTITY, OR IS SUBJECT
18 TO COMMUNITY SUPERVISION OR PROBATION, AND IS SCHEDULED FOR A CONDI-
19 TIONAL RELEASE OR ANY OTHER DISCHARGE OUTSIDE OF NEW YORK STATE AND SUCH
20 TERRORIST HAS EVIDENCED ANY INTENTION TO RESIDE, WORK OR ATTEND AN
21 EDUCATIONAL INSTITUTION IN NEW YORK STATE.

22 8. COURT APPLICATION TO ADD A PERSON TO THE REGISTRY. UPON EXAMINATION
23 IN ACCORDANCE WITH THIS SECTION, AND UPON A FINDING THAT THE PERSON
24 EXAMINED MAY NOT HAVE COMMITTED A TERRORIST OFFENSE AS DEFINED IN SUBDI-
25 VISION TWO OF SECTION ONE HUNDRED SIXTY-NINE-B OF THIS ARTICLE, OR A
26 VERIFIABLE ACT OF TERRORISM, AS DEFINED IN SUBDIVISION THREE OF SECTION

36 REGISTRY, AND PROVIDE SUCH PERSON WITH NOTIFICATION IN ACCORDANCE WITH

50 ORDER OF THE SUPREME COURT IN THE COUNTY WHERE SUCH REGISTRANT RESIDES,
51 OR THE SUPREME COURT OF THE COUNTY OF ALBANY IF SUCH REGISTRANT DOES NOT
52 RESIDE IN THE STATE OF NEW YORK, TO HAVE THEIR NAME AND INFORMATION
53 REMOVED FROM THE REGISTRY AS FOLLOWS:

54 (A) GROUNDS FOR ORDER OF REMOVAL. THAT IN ORDER TO ISSUE AN ORDER TO
55 REMOVE THE REGISTRANT AND THEIR INFORMATION FROM THE NEW YORK STATE
56 TERRORIST REGISTRY, THE COURT MUST FIND CONSIDERABLE GROUNDS THAT:

7 IN AN ARBITRARY AND CAPRICIOUS MANNER, FAILED TO COMPLY WITH THE
8 PROVISIONS OF THIS ARTICLE AND/OR THE PAST ACTIONS AND CURRENT BEHAVIOR
9 OF THE REGISTRANT DOES NOT MERIT HIS OR HER REGISTRATION FOR ANY REASON;
10 AND

11 (IV) THE COURT IS OF THE OPINION THAT SUCH REGISTRATION WOULD BE UNDU-
12 LY HARSH AND INAPPROPRIATE.

13 (B) REMOVAL OF PERSON FROM THE REGISTRY. THAT WHERE THE SUPREME COURT
14 FINDS THE CONSIDERABLE GROUNDS REQUIRED IN PARAGRAPH (A) OF THIS SUBDI-
15 VISION, AND ISSUES AN ORDER TO REMOVE A PERSON FROM THE NEW YORK STATE
16 TERRORIST REGISTRY, THE DIVISION SHALL, IN ACCORDANCE WITH THIS PARA-
17 GRAPH AND PARAGRAPH (C) OF THIS SUBDIVISION, REMOVE SUCH PERSON FROM THE
18 REGISTRY, AND PROVIDE SUCH PERSON WITH NOTIFICATION OF THEIR REMOVAL
19 FROM THE REGISTRY.

20 (C) APPEALS. THE DIVISION MAY APPEAL ANY DECISION AND/OR ORDER WHERE
21 THE COURT DIRECTS THE DIVISION TO REMOVE A PERSON FROM THE NEW YORK
22 STATE TERRORIST REGISTRY. AN APPEAL OF SUCH DECISION AND/OR ORDER SHALL
23 GO, AS OF RIGHT, TO THE COURT OF APPEALS WHICH SHALL HEAR SUCH APPEAL
24 WITHIN NINETY DAYS OF THE ISSUANCE OF THE DECISION OR THE ENTRY OF THE
25 ORDER DIRECTING THE DIVISION TO REMOVE SUCH PERSON FROM THE REGISTRY,
26 WHICHEVER IS EARLIER. WHERE THE DIVISION APPEALS AN ORDER TO REMOVE A
27 PERSON FROM THE NEW YORK STATE TERRORIST REGISTRY, SUCH REMOVAL SHALL
28 NOT BE PERFORMED BY THE DIVISION UNTIL THE FINAL APPEAL IS DECIDED IN
29 FAVOR OF THE PERSON SEEKING SUCH REMOVAL. ANY PERSON TO WHOM THE COURT
30 DENIES A PETITION TO HAVE THEIR NAME REMOVED FROM THE NEW YORK STATE

36 STATE, TO THE APPELLATE DIVISION OF THE THIRD DEPARTMENT, WHICH SUCH
37 APPELLATE DIVISION SHALL HEAR SUCH APPEAL WITHIN NINETY DAYS OF THE
38 ISSUANCE OF THE DECISION OR ENTRY OF THE ORDER DENYING THE PETITION

37 THE DIVISION OF HOMELAND SECURITY AND EMERGENCY SERVICES, THE FEDERAL
38 BUREAU OF INVESTIGATION, AND THE UNITED STATE DEPARTMENT OF HOMELAND
39 SECURITY.

40 S 169-L. DURATION OF REGISTRATION AND VERIFICATION. THE DURATION OF
41 REGISTRATION OF A TERRORIST ADDED TO THE NEW YORK STATE TERRORIST REGIS-
42 TRY SHALL BE FOR LIFE, AND THE DUTY AND OBLIGATION TO PROVIDE VERIFICA-
43 TION BY SUCH TERRORIST SHALL BE QUARTERLY FOR LIFE.

44 S 169-M. NOTIFICATION OF CHANGE OF ADDRESS. 1. DUTY AND OBLIGATION TO
45 NOTIFY DIVISION OF CHANGE OF ADDRESS. IN ACCORDANCE WITH SUBDIVISION
46 FIVE OF SECTION ONE HUNDRED SIXTY-NINE-H OF THIS ARTICLE, ANY TERRORIST
47 ADDED TO THE NEW YORK STATE TERRORIST REGISTRY WHO IS A RESIDENT OF NEW
48 YORK STATE SHALL, IN ADDITION TO ANY OTHER INFORMATION REQUIRED BY THIS
49 ARTICLE, REGISTER HIS OR HER CURRENT RESIDENTIAL ADDRESS AND THE ADDRESS

17 IS AUTHORIZED TO SHARE THE NEW YORK STATE TERRORIST REGISTRY, AND ALL OF
18 ITS INFORMATION CONTAINED THEREIN, WITH THE DIVISION OF HOMELAND SECURI-
19 TY AND EMERGENCY SERVICES, THE DIVISION OF STATE POLICE, THE DEPARTMENT,
20 ANY COURT OF THE UNIFIED COURT SYSTEM, THE NEW YORK CITY POLICE DEPART-

22 COLLECTION. THE DIVISION, PURSUANT TO THIS SECTION, SHALL PROVIDE FOR
23 THE SECURE CUSTODIAL COLLECTION OF THE DNA SAMPLE AND FINGERPRINTS TAKEN
24 FROM THE TERRORIST BY THE LAW ENFORCEMENT AGENCY HAVING JURISDICTION,
25 THE CONFINEMENT ENTITY, OR THE DEPARTMENT OR OFFICE OF PROBATION AND
26 CORRECTIONAL ALTERNATIVES, IN ACCORDANCE WITH THE PROVISIONS OF THIS

25 IN THIS SECTION, THE DIVISION SHALL:

26 (A) ASK THE CALLER FOR A NAME OF AN INDIVIDUAL ON WHICH THE CALLER
27 WOULD LIKE TO OBTAIN INFORMATION.

28 (B) ASCERTAIN WHETHER SUCH NAMED INDIVIDUAL REASONABLY APPEARS TO BE A
29 PERSON LISTED ON THE REGISTRY, AND IN DECIDING WHETHER SUCH NAMED INDI-
30 VIDUAL REASONABLY APPEARS TO BE A PERSON LISTED ON THE REGISTRY, THE
31 DIVISION SHALL REQUIRE THE CALLER TO PROVIDE INFORMATION ON ANY THREE OF
32 THE FOLLOWING:

33 (I) AN EXACT STREET ADDRESS, INCLUDING APARTMENT NUMBER, IF ANY, OF
34 THE TERRORIST;

35 (II) THE DRIVER'S LICENSE NUMBER OR NON-DRIVER'S IDENTIFICATION CARD
36 NUMBER OF THE TERRORIST;

37 (III) THE DATE OF BIRTH OF THE TERRORIST;

38 (IV) THE SOCIAL SECURITY NUMBER OR TAXPAYER IDENTIFICATION NUMBER OF
39 THE TERRORIST;

40 (V) THE COUNTRY OF ORIGIN OF THE TERRORIST;

41 (VI) THE CRIME OF TERRORISM OR VERIFIABLE TERRORIST ACT COMMITTED BY
42 THE TERRORIST;

43 (VII) THE HAIR COLOR OR EYE COLOR OF THE TERRORIST;

44 (VIII) THE HEIGHT, WEIGHT, OR BUILD OF THE TERRORIST;

45 (IX) ANY DISTINCTIVE MARKINGS OR THE ETHNICITY OF THE TERRORIST;
46 AND/OR

47 (X) THE NAME AND STREET ADDRESS OF THE TERRORIST'S EMPLOYER.

48 (C) UPON ASCERTAINING THAT THE NAMED INDIVIDUAL REASONABLY APPEARS TO
49 BE A PERSON LISTED ON THE NEW YORK STATE TERRORIST REGISTRY BASED UPON
50 THE INFORMATION PROVIDED FROM THE CALLER IN ACCORDANCE WITH PARAGRAPH
51 (B) OF THIS SUBDIVISION, PROVIDE THE CALLER WITH THE FOLLOWING INFORMA-
52 TION:

53 (I) THE NAME OF THE TERRORIST;

54 (II) THE AGE, PHYSICAL DESCRIPTION AND ANY DISTINCTIVE MARKINGS OF THE
55 TERRORIST;

56 (III) THE EXACT RESIDENTIAL ADDRESS OF THE TERRORIST;

(IV) IF THE TERRORIST IS EMPLOYED, THE EXACT ADDRESS OF THE TERRORIST'S PLACE OF EMPLOYMENT;

(V) IF THE TERRORIST IS A STUDENT, THE EXACT ADDRESS OF THE EDUCATIONAL INSTITUTION THE TERRORIST IS ATTENDING; AND

(VI) BACKGROUND INFORMATION ON THE TERRORIST, INCLUDING FOR EACH AND EVERY TERRORIST INCIDENT INVOLVING THE TERRORIST, THE TERRORIST'S CRIME OF CONVICTION, VERIFIABLE ACT OF TERRORISM, MODUS OF OPERATION, AND ANY OTHER INFORMATION THE DIVISION DEEMS RELEVANT TO PROVIDE.

(D) PLAY, BEFORE A LIVE OPERATOR SPEAKS WITH THE CALLER, A RECORDED PREAMBLE WHICH SHALL PROVIDE THE FOLLOWING NOTICES:

(I) THAT THE CALLER'S TELEPHONE NUMBER WILL BE RECORDED;

(II) THAT THERE WILL BE NO CHARGE TO THE CALLER FOR USE OF THE SPECIAL TELEPHONE NUMBER;

(III) THAT THE CALLER SHALL BE REQUIRED TO PROVIDE THEIR NAME AND ADDRESS TO THE OPERATOR AND THAT SUCH SHALL BE MAINTAINED IN A WRITTEN RECORD;

(IV) THAT THE CALLER IS REQUIRED TO BE NOT LESS THAN EIGHTEEN YEARS OF AGE;

(VII) THAT THE SPECIAL TELEPHONE NUMBER IS NOT A CRIME HOTLINE AND THAT ANY SUSPECTED CRIMINAL OR TERRORIST ACTIVITY SHOULD BE REPORTED TO THE LOCAL, STATE OR FEDERAL AUTHORITIES; AND

(VIII) THAT AN INFORMATION PACKAGE, WHICH WILL INCLUDE A DESCRIPTION OF THE LAW PERTAINING TO THE NEW YORK STATE TERRORIST REGISTRY, IS AVAILABLE ONLINE ON THE DIVISION'S OFFICIAL WEBSITE, AND IN WRITING, BY MAIL, UPON REQUEST FROM THE DIVISION.

WHENEVER THERE IS REASONABLE CAUSE TO BELIEVE THAT ANY PERSON OR GROUP OF PERSONS IS ENGAGED IN A PATTERN OR PRACTICE OF MISUSE OF THE SPECIAL TELEPHONE NUMBER, THE ATTORNEY GENERAL, ANY DISTRICT ATTORNEY OR ANY PERSON AGGRIEVED BY THE MISUSE OF THE NUMBER IS AUTHORIZED TO BRING A CIVIL ACTION IN THE APPROPRIATE COURT REQUESTING PREVENTIVE RELIEF, INCLUDING AN APPLICATION FOR A PERMANENT OR TEMPORARY INJUNCTION, RESTRAINING ORDER OR OTHER ORDER AGAINST THE PERSON OR GROUP OF PERSONS RESPONSIBLE FOR THE PATTERN OR PRACTICE OF MISUSE, AND THE FOREGOING REMEDIES SHALL BE INDEPENDENT OF ANY OTHER REMEDIES OR PROCEDURES THAT MAY BE AVAILABLE TO AN AGGRIEVED PARTY UNDER OTHER PROVISIONS OF LAW, AND SUCH PERSON OR GROUP OF PERSONS SHALL BE SUBJECT TO A FINE OF NOT LESS THAN FIVE HUNDRED DOLLARS AND NOT MORE THAN ONE THOUSAND DOLLARS.

4. REPORT OF CALL ACTIVITY. THE DIVISION SHALL, ON OR BEFORE THE FIRST OF SEPTEMBER IN EACH YEAR, FILE A REPORT WITH THE GOVERNOR, THE TEMPORARY PRESIDENT OF THE SENATE, THE SPEAKER OF THE STATE ASSEMBLY, THE CHAIR OF THE SENATE STANDING COMMITTEE ON VETERANS, HOMELAND SECURITY AND MILITARY AFFAIRS, AND THE CHAIR OF THE ASSEMBLY STANDING COMMITTEE ON GOVERNMENTAL OPERATIONS, ON THE OPERATION OF THE TELEPHONE NUMBER, AND SUCH ANNUAL REPORT SHALL INCLUDE, BUT NOT BE LIMITED TO, ALL OF THE FOLLOWING:

(A) THE NUMBER OF CALLS RECEIVED;

1 (B) A DETAILED OUTLINE OF THE AMOUNT OF MONEY EXPENDED AND THE MANNER
2 IN WHICH IT WAS EXPENDED FOR PURPOSES OF THIS SECTION;

3 (C) THE NUMBER OF CALLS THAT RESULTED IN AN AFFIRMATIVE RESPONSE AND
4 THE NUMBER OF CALLS THAT RESULTED IN A NEGATIVE RESPONSE WITH REGARD TO
5 WHETHER A NAMED INDIVIDUAL WAS LISTED;

6 (D) A SUMMARY OF THE SUCCESS OF THE SPECIAL TELEPHONE NUMBER PROGRAM
7 BASED UPON THE ABOVE OR ANY OTHER SELECTED FACTORS THE DIVISION SHALL
8 DEEM RELEVANT;

9 (E) A COMPARISON BETWEEN THE EFFICACY OF THE SPECIAL TELEPHONE NUMBER,
10 OPERATED PURSUANT TO THIS SECTION, AND THE INTERNET DIRECTORY, OPERATED
11 PURSUANT TO SECTION ONE HUNDRED SIXTY-NINE-R OF THIS ARTICLE; AND

12 (F) RECOMMENDATIONS AS TO HOW THE DIVISION MIGHT IMPROVE THE SPECIAL
13 TELEPHONE NUMBER AND/OR THE NEW YORK STATE TERRORIST REGISTRY.

14 5. SECURE INFORMATION. THE OPERATORS OF THE SPECIAL TELEPHONE NUMBER
15 SHALL NOT PROVIDE ANY CALLER WITH ANY INFORMATION FROM THE NEW YORK
16 STATE TERRORIST REGISTRY THAT THE DIVISION HAS DEEMED SECURE IN ACCORD-
17 ANCE WITH SUBDIVISION THREE OF SECTION ONE HUNDRED SIXTY-NINE-N OF THIS
18 ARTICLE.

19 6. ADVERTISEMENT OF SPECIAL TELEPHONE NUMBER. THE DIVISION SHALL

33 (III) THE MOST RECENT PHOTOGRAPH OF THE TERRORIST TAKEN OF THE TERROR-
34 IST FOR THE REGISTRY;

35 (IV) THE EXACT RESIDENTIAL ADDRESS OF THE TERRORIST;

36 (V) IF THE TERRORIST IS EMPLOYED, THE EXACT ADDRESS OF THE TERRORIST'S
37 PLACE OF EMPLOYMENT;

38 (VI) IF THE TERRORIST IS A STUDENT, THE EXACT ADDRESS OF THE EDUCA-
39 TIONAL INSTITUTION THE TERRORIST IS ATTENDING; AND

40 (VII) BACKGROUND INFORMATION ON THE TERRORIST, INCLUDING EACH AND
41 EVERY TERRORIST INCIDENT INVOLVING THE TERRORIST, THE TERRORIST'S CRIME
42 OF CONVICTION, VERIFIABLE ACT OF TERRORISM, MODUS OF OPERATION, AND ANY
43 OTHER INFORMATION THE DIVISION DEEMS RELEVANT TO PROVIDE;

44 (B) HAVE TERRORIST LISTINGS CATEGORIZED BY COUNTY AND ZIP CODE; AND

45 (C) BE MADE AVAILABLE AT ALL TIMES ON THE INTERNET VIA THE DIVISION'S
46 OFFICIAL HOMEPAGE, WITH A LINK TO CONNECT TO SUCH DIRECTORY ALSO APPEAR-
47 ING ON THE OFFICIAL HOMEPAGE OF THE DIVISION OF HOMELAND SECURITY AND

49 2. AUTOMATED E-MAIL NOTIFICATIONS. ANY PERSON MAY APPLY TO THE DIVI-

25 (C) ALL OTHER MONIES, FEES, FINES, GRANTS, BEQUESTS OR OTHER MONIES

46 THOUSAND SIXTEEN, AND THEN EVERY FIVE YEARS THEREAFTER, WHICH PROVIDES A
47 COMPREHENSIVE REVIEW OF ALL CYBER SECURITY SERVICES PERFORMED BY, AND ON
48 BEHALF OF, THE STATE OF NEW YORK.

49 2. THE REPORT REQUIRED PURSUANT TO SUBDIVISION ONE OF THIS SECTION,
50 SHALL INCLUDE A DETAILED ASSESSMENT OF EACH AND EVERY CYBER SECURITY
51 NEED OF THE STATE OF NEW YORK, INCLUDING BUT NOT LIMITED TO, ITS STATE
52 AGENCIES AND ITS PUBLIC AUTHORITIES, AND FOR EACH AND EVERY SUCH CYBER
53 SECURITY NEED SO IDENTIFIED, SHALL FURTHER INCLUDE A DETAILED
54 DESCRIPTION OF:

(A) THE TYPE OF CYBER SECURITY SERVICE USED TO ADDRESS SUCH NEED;

(B) THE SCOPE OF THE NEED SO ADDRESSED, AS WELL AS THE SCOPE OF THE SERVICE USED TO ADDRESS SUCH NEED;

(C) THE COST OF THE SERVICE USED TO ADDRESS SUCH NEED;

(D) THE EFFECTIVENESS OF THE CYBER SECURITY SERVICE USED TO ADDRESS SUCH NEED;

(E) THE ENTITY PROVIDING SUCH CYBER SECURITY SERVICE USED TO ADDRESS SUCH NEED;

(F) THE GOVERNMENT, INDUSTRY AND/OR ACADEMICALLY ACCEPTED BEST CYBER SECURITY PRACTICE FOR ADDRESSING SUCH NEED;

(G) HOW OTHER STATES, AND THE FEDERAL GOVERNMENT HAVE ADDRESSED SUCH NEED; AND

(H) HOW PRIVATE SECTOR ENTITIES ADDRESSED SUCH NEED.

3. DURING THE PREPARATION OF THE REPORT REQUIRED BY SUBDIVISION ONE OF THIS SECTION, AND AFTER ITS DELIVERY TO THE PERSONS IDENTIFIED TO RECEIVE SUCH REPORT, THE COMMISSIONER, THE SUPERINTENDENT OF THE STATE POLICE, THE CHIEF INFORMATION OFFICER, AND THE PRESIDENT OF THE CENTER FOR INTERNET SECURITY, AS WELL AS THE DIVISIONS, OFFICES AND CORPORATIONS UNDER THEIR DIRECTION, SHALL PROVIDE TO SUCH PERSONS ENTITLED TO RECEIVE SUCH REPORT, ANY AND ALL ADDITIONAL INFORMATION SUCH PERSONS MAY REQUEST, WITH RESPECT TO ANY CYBER SECURITY ISSUE CONCERNING:

(A) THE STATE OF NEW YORK, INCLUDING BUT NOT LIMITED TO, ANY AGENCY, BOARD, BUREAU, COMMISSION, DEPARTMENT, DIVISION, INSTITUTION, OFFICE, OR PUBLIC AUTHORITY OF THE STATE;

(B) ANY LOCAL GOVERNMENT ENTITY, INCLUDING BUT NOT LIMITED TO, ANY COUNTY, TOWN, CITY, VILLAGE, SCHOOL DISTRICT, SPECIAL DISTRICT, AND ANY AGENCY, BOARD, BUREAU, COMMISSION, DEPARTMENT, DIVISION, INSTITUTION, OFFICE, OR PUBLIC AUTHORITY OF SUCH LOCAL GOVERNMENT ENTITY;

(C) ANY REGULATED ENTITY OF THE STATE OF NEW YORK OR LOCAL GOVERNMENT ENTITY;

(D) ANY NOT-FOR-PROFIT CORPORATION IN THE STATE OF NEW YORK;

(E) ANY PRIVATE SECTOR BUSINESS IN THE STATE OF NEW YORK, INCLUDING BUT NOT LIMITED TO, A SOLE PROPRIETOR, PARTNERSHIP, LIMITED LIABILITY COMPANY OR BUSINESS CORPORATION; AND/OR

(F) ANY CITIZEN OF THE STATE OF NEW YORK.

4. WHERE COMPLIANCE WITH THIS SECTION SHALL REQUIRE THE DISCLOSURE OF CONFIDENTIAL INFORMATION, OR THE DISCLOSURE OF SENSITIVE INFORMATION WHICH IN THE JUDGMENT OF THE COMMISSIONER WOULD JEOPARDIZE THE CYBER SECURITY OF THE STATE:

(A) SUCH CONFIDENTIAL OR SENSITIVE INFORMATION SHALL BE PROVIDED TO THE PERSONS ENTITLED TO RECEIVE THE REPORT AS PROVIDED BY SUBDIVISION ONE OF THIS SECTION, AS FOLLOWS:

(I) IN THE CASE OF THE REPORT REQUIRED BY SUBDIVISION ONE OF THIS SECTION, IN THE FORM OF A SUPPLEMENTAL APPENDIX TO THE REPORT; AND

(II) IN THE CASE OF A RESPONSE TO A REQUEST FOR INFORMATION MADE IN ACCORDANCE WITH SUBDIVISION THREE OF THIS SECTION, IN A SECURE MANNER AS DETERMINED BY THE COMMISSIONER;

(B) NEITHER A SUPPLEMENTAL APPENDIX TO THE REPORT, NOR ANY CONFIDENTIAL OR SENSITIVE INFORMATION PROVIDED IN ACCORDANCE WITH SUBDIVISION THREE OF THIS SECTION, SHALL BE POSTED ON THE DIVISION'S WEBSITE AS REQUIRED BY SUBDIVISION FIVE OF THIS SECTION;

(C) NEITHER A SUPPLEMENTAL APPENDIX TO THE REPORT, NOR ANY CONFIDENTIAL OR SENSITIVE INFORMATION PROVIDED IN ACCORDANCE WITH SUBDIVISION THREE OF THIS SECTION, SHALL BE SUBJECT TO THE PROVISIONS OF THE FREEDOM OF INFORMATION LAW PURSUANT TO ARTICLE SIX OF THE PUBLIC OFFICERS LAW; AND

(D) THE PERSONS ENTITLED TO RECEIVE THE REPORT AS PROVIDED BY SUBDIVISION ONE OF THIS SECTION, MAY DISCLOSE THE SUPPLEMENTAL APPENDIX TO THE REPORT, AND ANY CONFIDENTIAL OR SENSITIVE INFORMATION PROVIDED IN ACCORDANCE WITH SUBDIVISION THREE OF THIS SECTION, TO THEIR PROFESSIONAL STAFF, BUT SHALL NOT OTHERWISE PUBLICLY DISCLOSE SUCH CONFIDENTIAL OR SECURE INFORMATION.

5. EXCEPT WITH RESPECT TO ANY CONFIDENTIAL OR SENSITIVE INFORMATION AS DESCRIBED IN SUBDIVISION FOUR OF THIS SECTION, THE DIVISION SHALL POST A COPY OF THE REPORT PREPARED IN ACCORDANCE WITH SUBDIVISION ONE OF THIS SECTION, ON ITS WEBSITE, NOT MORE THAN FIFTEEN DAYS AFTER SUCH REPORT IS DELIVERED TO THE PERSONS ENTITLED TO RECEIVE SUCH REPORT. THE DIVISION MAY FURTHER POST ANY AND ALL FURTHER INFORMATION IT MAY DEEM APPROPRIATE, ON ITS WEBSITE, REGARDING CYBER SECURITY, AND THE PROTECTION OF PUBLIC AND PRIVATE COMPUTER SYSTEMS, NETWORKS, HARDWARE AND SOFTWARE.

S 2. This act shall take effect immediately.

SUBPART E

Section 1. The executive law is amended by adding a new section 721 to read as follows:

S 721. NEW YORK STATE CYBER SECURITY INITIATIVE. 1. LEGISLATIVE FINDINGS. THE LEGISLATURE FINDS AND DECLARES THAT REPEATED CYBER INTRUSIONS INTO CRITICAL INFRASTRUCTURE, EFFECTING GOVERNMENT, PRIVATE SECTOR BUSINESS, AND CITIZENS OF THE STATE OF NEW YORK, HAVE DEMONSTRATED THE NEED FOR IMPROVED CYBER SECURITY.

THE LEGISLATURE FURTHER FINDS AND DECLARES THAT THIS CYBER THREAT CONTINUES TO GROW AND REPRESENTS ONE OF THE MOST SERIOUS PUBLIC SECURITY CHALLENGES THAT NEW YORK MUST CONFRONT. MOREOVER, THE SECURITY OF THE STATE OF NEW YORK DEPENDS ON THE RELIABLE FUNCTIONING OF NEW YORK STATE'S CRITICAL INFRASTRUCTURE, AND PRIVATE SECTOR BUSINESS INTERESTS, AS WELL AS THE PROTECTION OF THE FINANCES AND INDIVIDUAL LIBERTIES OF EVERY CITIZEN, IN THE FACE OF SUCH THREATS.

THE LEGISLATURE ADDITIONALLY FINDS AND DECLARES THAT TO ENHANCE THE SECURITY, PROTECTION AND RESILIENCE OF NEW YORK STATE'S CRITICAL INFRASTRUCTURE, AND PRIVATE SECTOR BUSINESS INTERESTS, AS WELL AS THE PROTECTION OF THE FINANCES AND INDIVIDUAL LIBERTIES OF EVERY CITIZEN, THE STATE OF NEW YORK MUST PROMOTE A CYBER ENVIRONMENT THAT ENCOURAGES EFFICIENCY, INNOVATION, AND ECONOMIC PROSPERITY, AND THAT CAN OPERATE WITH SAFETY, SECURITY, BUSINESS CONFIDENTIALITY, PRIVACY, AND CIVIL LIBERTY.

THE LEGISLATURE FURTHER FINDS AND DECLARES THAT TO CREATE SUCH A SAFE AND SECURE CYBER ENVIRONMENT FOR GOVERNMENT, PRIVATE SECTOR BUSINESS AND INDIVIDUAL CITIZENS, NEW YORK MUST ADVANCE, IN ADDITION TO ITS CURRENT EFFORTS IN THIS FIELD, A NEW YORK STATE CYBER SECURITY INITIATIVE, THAT ESTABLISHES A NEW YORK STATE CYBER SECURITY ADVISORY BOARD; A NEW YORK STATE CYBER SECURITY PARTNERSHIP PROGRAM WITH THE OWNERS AND OPERATORS OF CRITICAL INFRASTRUCTURE, PRIVATE SECTOR BUSINESS, ACADEMIA, AND INDIVIDUAL CITIZENS TO IMPROVE, DEVELOP AND IMPLEMENT RISK-BASED STANDARDS FOR GOVERNMENT, PRIVATE SECTOR BUSINESSES AND INDIVIDUAL CITIZENS; AND A NEW YORK STATE CYBER SECURITY INFORMATION SHARING PROGRAM.

2. CRITICAL INFRASTRUCTURE AND INFORMATION SYSTEMS. AS USED IN THIS SECTION, THE TERM "CRITICAL INFRASTRUCTURE AND INFORMATION SYSTEMS" SHALL MEAN ALL SYSTEMS AND ASSETS, WHETHER PHYSICAL OR VIRTUAL, SO VITAL TO THE GOVERNMENT, PRIVATE SECTOR BUSINESSES AND INDIVIDUAL CITIZENS OF THE STATE OF NEW YORK THAT THE INCAPACITY OR DESTRUCTION OF SUCH SYSTEMS AND ASSETS WOULD HAVE A DEBILITATING IMPACT TO THE SECURITY, ECONOMY, OR

1 PUBLIC HEALTH OF THE INDIVIDUAL CITIZENS, GOVERNMENT, OR PRIVATE SECTOR
2 BUSINESSES OF THE STATE OF NEW YORK.

3 3. NEW YORK STATE CYBER SECURITY ADVISORY BOARD. (A) THERE SHALL BE
4 WITHIN THE DIVISION OF HOMELAND SECURITY AND EMERGENCY SERVICES, A NEW
5 YORK STATE CYBER SECURITY ADVISORY BOARD, WHICH SHALL ADVISE THE GOVER-
6 NOR AND THE LEGISLATURE ON DEVELOPMENTS IN CYBER SECURITY AND MAKE
7 RECOMMENDATIONS FOR PROTECTING THE STATE'S CRITICAL INFRASTRUCTURE AND
8 INFORMATION SYSTEMS.

9 (B) THE BOARD MEMBERS SHALL CONSIST OF ELEVEN MEMBERS APPOINTED BY THE
10 GOVERNOR, WITH THREE MEMBERS APPOINTED UPON RECOMMENDATION OF THE TEMPO-
11 RARY PRESIDENT OF THE SENATE, AND THREE MEMBERS APPOINTED AT THE RECOM-
12 MENDATION OF THE SPEAKER OF THE ASSEMBLY. ALL MEMBERS SO APPOINTED SHALL
13 HAVE EXPERTISE IN CYBER SECURITY, TELECOMMUNICATIONS, INTERNET SERVICE
14 DELIVERY, PUBLIC PROTECTION, COMPUTER SYSTEMS AND/OR COMPUTER NETWORKS.

15 (C) THE BOARD SHALL INVESTIGATE, DISCUSS AND MAKE RECOMMENDATIONS
16 CONCERNING CYBER SECURITY ISSUES INVOLVING BOTH THE PUBLIC AND PRIVATE
17 SECTORS AND WHAT STEPS CAN BE TAKEN BY NEW YORK STATE TO PROTECT CRIT-
18 ICAL CYBER INFRASTRUCTURE, FINANCIAL SYSTEMS, TELECOMMUNICATIONS
19 NETWORKS, ELECTRICAL GRIDS, SECURITY SYSTEMS, FIRST RESPONDER SYSTEMS
20 AND INFRASTRUCTURE, PHYSICAL INFRASTRUCTURE SYSTEMS, TRANSPORTATION
21 SYSTEMS, AND SUCH OTHER AND FURTHER SECTORS OF STATE GOVERNMENT AND THE
22 PRIVATE SECTOR AS THE ADVISORY BOARD SHALL DEEM PRUDENT.

23 (D) THE PURPOSE OF THE ADVISORY BOARD SHALL BE TO PROMOTE THE DEVELOP-
24 MENT OF INNOVATIVE, ACTIONABLE POLICIES TO ENSURE THAT NEW YORK STATE IS
25 IN THE FOREFRONT OF PUBLIC CYBER SECURITY DEFENSE.

26 (E) THE MEMBERS OF THE ADVISORY BOARD SHALL RECEIVE NO COMPENSATION
27 FOR THEIR SERVICES, BUT MAY RECEIVE ACTUAL AND NECESSARY EXPENSES, AND
28 SHALL NOT BE DISQUALIFIED FOR HOLDING ANY OTHER PUBLIC OFFICE OR EMPLOY-
29 MENT BY MEANS OF THEIR SERVICE AS A MEMBER OF THE ADVISORY BOARD.

30 (F) THE ADVISORY BOARD SHALL BE ENTITLED TO REQUEST AND RECEIVE, AND
31 SHALL BE PROVIDED WITH, SUCH FACILITIES, RESOURCES AND DATA OF ANY AGEN-
32 CY, DEPARTMENT, DIVISION, BOARD, BUREAU, COMMISSION, OR PUBLIC AUTHORITY
33 OF THE STATE, AS THEY MAY REASONABLY REQUEST, TO CARRY OUT PROPERLY
34 THEIR POWERS, DUTIES AND PURPOSE.

35 4. NEW YORK STATE CYBER SECURITY INFORMATION SHARING AND ANALYSIS
36 PROGRAM. (A) THE DIVISION OF HOMELAND SECURITY AND EMERGENCY SERVICES,
37 IN CONSULTATION WITH THE DIVISION OF THE STATE POLICE, THE STATE OFFICE
38 OF INFORMATION TECHNOLOGY SERVICES, AND THE CENTER FOR INTERNET SECURI-
39 TY, SHALL ESTABLISH, WITHIN SIXTY DAYS OF THE EFFECTIVE DATE OF THIS
40 SECTION, A VOLUNTARY NEW YORK STATE CYBER SECURITY INFORMATION SHARING
41 AND ANALYSIS PROGRAM.

42 (B) IT SHALL BE THE PURPOSE OF THE NEW YORK STATE CYBER SECURITY
43 INFORMATION SHARING AND ANALYSIS PROGRAM TO INCREASE THE VOLUME, TIMELI-
44 NESS, AND QUALITY OF CYBER THREAT INFORMATION SHARED WITH NEW YORK STATE
45 PUBLIC AND PRIVATE SECTOR ENTITIES SO THAT THESE ENTITIES MAY BETTER
46 PROTECT AND DEFEND THEMSELVES AGAINST CYBER THREATS AND TO PROMOTE THE
47 DEVELOPMENT OF EFFECTIVE DEFENSES AND STRATEGIES TO COMBAT, AND PROTECT
48 AGAINST, CYBER THREATS AND ATTACKS.

49 (C) TO FACILITATE THE PURPOSES OF THE NEW YORK STATE CYBER SECURITY
50 INFORMATION SHARING AND ANALYSIS PROGRAM, THE DIVISION OF HOMELAND SECU-
51 RITY AND EMERGENCY SERVICES, SHALL PROMULGATE REGULATIONS, IN ACCORDANCE
52 WITH THE PROVISIONS OF THIS SUBDIVISION.

53 (D) THE REGULATIONS SHALL PROVIDE FOR THE TIMELY PRODUCTION OF UNCLAS-
54 SIFIED REPORTS OF CYBER THREATS TO NEW YORK STATE AND ITS PUBLIC AND
55 PRIVATE SECTOR ENTITIES, INCLUDING THREATS THAT IDENTIFY A SPECIFIC
56 TARGETED ENTITY.

1 (E) THE REGULATIONS SHALL ADDRESS THE NEED TO PROTECT INTELLIGENCE AND
2 LAW ENFORCEMENT SOURCES, METHODS, OPERATIONS, AND INVESTIGATIONS, AND
3 SHALL FURTHER ESTABLISH A PROCESS THAT RAPIDLY DISSEMINATES THE REPORTS
4 PRODUCED PURSUANT TO PARAGRAPH (D) OF THIS SUBDIVISION, TO BOTH ANY
5 TARGETED ENTITY AS WELL AS SUCH OTHER AND FURTHER PUBLIC AND PRIVATE
6 ENTITIES AS THE DIVISION SHALL DEEM NECESSARY TO ADVANCE THE PURPOSES OF
7 THIS SUBDIVISION.

8 (F) THE REGULATIONS SHALL PROVIDE FOR PROTECTIONS FROM LIABILITY FOR
9 ENTITIES SHARING AND RECEIVING INFORMATION WITH THE NEW YORK STATE CYBER
10 SECURITY INFORMATION AND ANALYSIS PROGRAM, SO LONG AS THE ENTITY ACTED
11 IN GOOD FAITH.

12 (G) THE REGULATIONS SHALL FURTHER ESTABLISH A SYSTEM FOR TRACKING THE
13 PRODUCTION, DISSEMINATION, AND DISPOSITION OF THE REPORTS PRODUCED IN
14 ACCORDANCE WITH THE PROVISIONS OF THIS SUBDIVISION.

15 (H) THE REGULATIONS SHALL ALSO ESTABLISH AN ENHANCED CYBER SECURITY
16 SERVICES PROGRAM, WITHIN NEW YORK STATE, TO PROVIDE FOR PROCEDURES,
17 METHODS AND DIRECTIVES, FOR A VOLUNTARY INFORMATION SHARING PROGRAM,
18 THAT WILL PROVIDE CYBER THREAT AND TECHNICAL INFORMATION COLLECTED FROM
19 BOTH PUBLIC AND PRIVATE SECTOR ENTITIES, TO SUCH PRIVATE AND PUBLIC
20 SECTOR ENTITIES AS THE DIVISION DEEMS PRUDENT, TO ADVISE ELIGIBLE CRIT-
21 ICAL INFRASTRUCTURE COMPANIES OR COMMERCIAL SERVICE PROVIDERS THAT OFFER
22 SECURITY SERVICES TO CRITICAL INFRASTRUCTURE ON CYBER SECURITY THREATS
23 AND DEFENSE MEASURES.

24 (I) THE REGULATIONS SHALL ALSO SEEK TO DEVELOP STRATEGIES TO MAXIMIZE
25 THE UTILITY OF CYBER THREAT INFORMATION SHARING BETWEEN AND ACROSS THE
26 PRIVATE AND PUBLIC SECTORS, AND SHALL FURTHER SEEK TO PROMOTE THE USE OF
27 PRIVATE AND PUBLIC SECTOR SUBJECT MATTER EXPERTS TO ADDRESS CYBER SECU-
28 RITY NEEDS IN NEW YORK STATE, WITH THESE SUBJECT MATTER EXPERTS PROVID-
29 ING ADVICE REGARDING THE CONTENT, STRUCTURE, AND TYPES OF INFORMATION
30 MOST USEFUL TO CRITICAL INFRASTRUCTURE OWNERS AND OPERATORS IN REDUCING
31 AND MITIGATING CYBER RISKS.

32 (J) THE REGULATIONS SHALL FURTHER SEEK TO ESTABLISH A CONSULTATIVE
33 PROCESS TO COORDINATE IMPROVEMENTS TO THE CYBER SECURITY OF CRITICAL
34 INFRASTRUCTURE, WHERE AS PART OF THE CONSULTATIVE PROCESS, THE PUBLIC
35 AND PRIVATE ENTITIES OF THE STATE OF NEW YORK SHALL ENGAGE AND CONSIDER
36 THE ADVICE OF THE DIVISION OF HOMELAND SECURITY AND EMERGENCY SERVICES,
37 THE DIVISION OF THE STATE POLICE, THE STATE OFFICE OF INFORMATION TECH-
38 NOLOGY SERVICES, THE CENTER FOR INTERNET SECURITY, THE NEW YORK STATE
39 CYBER SECURITY ADVISORY BOARD, THE PROGRAMS ESTABLISHED BY THIS SUBDIVI-
40 SION, AND SUCH OTHER AND FURTHER PRIVATE AND PUBLIC SECTOR ENTITIES,
41 UNIVERSITIES, AND CYBER SECURITY EXPERTS AS THE DIVISION OF HOMELAND
42 SECURITY AND EMERGENCY SERVICES MAY DEEM PRUDENT.

43 (K) THE REGULATIONS SHALL FURTHER SEEK TO ESTABLISH A BASELINE FRAME-
44 WORK TO REDUCE CYBER RISK TO CRITICAL INFRASTRUCTURE, AND SHALL SEEK TO
45 HAVE THE DIVISION OF HOMELAND SECURITY AND EMERGENCY SERVICES, IN
46 CONSULTATION WITH THE DIVISION OF STATE POLICE, THE STATE OFFICE OF
47 INFORMATION TECHNOLOGY SERVICES, AND THE CENTER FOR INTERNET SECURITY,
48 LEAD THE DEVELOPMENT OF A VOLUNTARY FRAMEWORK TO REDUCE CYBER RISKS TO
49 CRITICAL INFRASTRUCTURE, TO BE KNOWN AS THE CYBER SECURITY FRAMEWORK,
50 WHICH SHALL:

51 (I) INCLUDE A SET OF STANDARDS, METHODOLOGIES, PROCEDURES, AND PROC-
52 ESSES THAT ALIGN POLICY, BUSINESS, AND TECHNOLOGICAL APPROACHES TO
53 ADDRESS CYBER RISKS;

54 (II) INCORPORATE VOLUNTARY CONSENSUS STANDARDS AND INDUSTRY BEST PRAC-
55 TICES TO THE FULLEST EXTENT POSSIBLE;

(III) PROVIDE A PRIORITIZED, FLEXIBLE, REPEATABLE, PERFORMANCE-BASED, AND COST-EFFECTIVE APPROACH, INCLUDING INFORMATION SECURITY MEASURES AND CONTROLS, TO HELP OWNERS AND OPERATORS OF CRITICAL INFRASTRUCTURE IDENTIFY, ASSESS, AND MANAGE CYBER RISK;

(IV) FOCUS ON IDENTIFYING CROSS-SECTOR SECURITY STANDARDS AND GUIDELINES APPLICABLE TO CRITICAL INFRASTRUCTURE;

(V) IDENTIFY AREAS FOR IMPROVEMENT THAT SHOULD BE ADDRESSED THROUGH FUTURE COLLABORATION WITH PARTICULAR SECTORS AND STANDARDS-DEVELOPING ORGANIZATIONS;

(VI) ENABLE TECHNICAL INNOVATION AND ACCOUNT FOR ORGANIZATIONAL DIFFERENCES, TO PROVIDE GUIDANCE THAT IS TECHNOLOGY NEUTRAL AND THAT ENABLES CRITICAL INFRASTRUCTURE SECTORS TO BENEFIT FROM A COMPETITIVE MARKET FOR PRODUCTS AND SERVICES THAT MEET THE STANDARDS, METHODOLOGIES, PROCEDURES, AND PROCESSES DEVELOPED TO ADDRESS CYBER RISKS;

(VII) INCLUDE GUIDANCE FOR MEASURING THE PERFORMANCE OF AN ENTITY IN IMPLEMENTING THE CYBER SECURITY FRAMEWORK;

(VIII) INCLUDE METHODOLOGIES TO IDENTIFY AND MITIGATE IMPACTS OF THE CYBER SECURITY FRAMEWORK AND ASSOCIATED INFORMATION SECURITY MEASURES OR CONTROLS ON BUSINESS CONFIDENTIALITY, AND TO PROTECT INDIVIDUAL PRIVACY AND CIVIL LIBERTIES; AND

(IX) ENGAGE IN THE REVIEW OF THREAT AND VULNERABILITY INFORMATION AND TECHNICAL EXPERTISE.

(L) THE REGULATIONS SHALL ADDITIONALLY ESTABLISH A VOLUNTARY CRITICAL INFRASTRUCTURE CYBER SECURITY PROGRAM TO SUPPORT THE ADOPTION OF THE CYBER SECURITY FRAMEWORK BY OWNERS AND OPERATORS OF CRITICAL INFRASTRUCTURE AND ANY OTHER INTERESTED ENTITIES, WHERE UNDER THIS PROGRAM IMPLEMENTATION GUIDANCE OR SUPPLEMENTAL MATERIALS WOULD BE DEVELOPED TO ADDRESS SECTOR-SPECIFIC RISKS AND OPERATING ENVIRONMENTS, AND RECOMMEND LEGISLATION FOR ENACTMENT TO ADDRESS CYBER SECURITY ISSUES.

(M) IN DEVELOPING THE NEW YORK STATE CYBER SECURITY INFORMATION SHARING AND ANALYSIS PROGRAM IN ACCORDANCE WITH THE PROVISIONS OF THIS SUBDIVISION, THE DIVISION OF HOMELAND SECURITY AND EMERGENCY SERVICES, IN CONSULTATION WITH THE DIVISION OF STATE POLICE, THE STATE OFFICE OF INFORMATION TECHNOLOGY SERVICES, AND THE CENTER FOR INTERNET SECURITY, SHALL PRODUCE AND SUBMIT A REPORT, TO THE GOVERNOR, THE TEMPORARY PRESIDENT OF THE SENATE, AND THE SPEAKER OF THE ASSEMBLY, MAKING RECOMMENDATIONS ON THE FEASIBILITY, SECURITY BENEFITS, AND RELATIVE MERITS OF INCORPORATING SECURITY STANDARDS INTO ACQUISITION PLANNING AND CONTRACT ADMINISTRATION. SUCH REPORT SHALL FURTHER ADDRESS WHAT STEPS CAN BE TAKEN TO HARMONIZE AND MAKE CONSISTENT EXISTING PROCUREMENT REQUIREMENTS RELATED TO CYBER SECURITY AND THE FEASIBILITY OF INCLUDING RISK-BASED SECURITY STANDARDS INTO PROCUREMENT AND CONTRACT ADMINISTRATION.

5. NEW YORK STATE CYBER SECURITY CRITICAL INFRASTRUCTURE RISK ASSESSMENT REPORT. (A) THE DIVISION OF HOMELAND SECURITY AND EMERGENCY SERVICES, IN CONSULTATION WITH THE DIVISION OF STATE POLICE, THE STATE OFFICE OF INFORMATION TECHNOLOGY SERVICES, AND THE CENTER FOR INTERNET SECURITY, WITHIN ONE HUNDRED TWENTY DAYS OF THE EFFECTIVE DATE OF THIS SECTION, SHALL PRODUCE A NEW YORK STATE CYBER SECURITY CRITICAL INFRASTRUCTURE RISK ASSESSMENT REPORT.

(B) THE PRODUCTION OF THE NEW YORK STATE CYBER SECURITY CRITICAL INFRASTRUCTURE RISK ASSESSMENT REPORT SHALL USE A RISK-BASED APPROACH TO IDENTIFY CRITICAL INFRASTRUCTURE WHERE A CYBER SECURITY INCIDENT COULD REASONABLY RESULT IN CATASTROPHIC REGIONAL OR STATE-WIDE EFFECTS ON PUBLIC HEALTH OR SAFETY, ECONOMIC DISTRESS, AND/OR THREATEN PUBLIC PROTECTION OF THE PEOPLE AND/OR PROPERTY OF NEW YORK STATE.

(C) THE PRODUCTION OF THE REPORT SHALL FURTHER USE THE CONSULTATIVE PROCESS AND DRAW UPON THE EXPERTISE OF AND ADVICE OF THE DIVISION OF HOMELAND SECURITY AND EMERGENCY SERVICES, THE DIVISION OF STATE POLICE, THE STATE OFFICE OF INFORMATION TECHNOLOGY SERVICES, THE CENTER FOR INTERNET SECURITY, THE NEW YORK STATE CYBER SECURITY ADVISORY BOARD, THE PROGRAMS ESTABLISHED BY THIS SECTION, AND SUCH OTHER AND FURTHER PRIVATE AND PUBLIC SECTOR ENTITIES, UNIVERSITIES, AND CYBER SECURITY EXPERTS AS THE DIVISION OF HOMELAND SECURITY AND EMERGENCY SERVICES MAY DEEM PRUDENT.

(D) THE NEW YORK STATE CYBER SECURITY CRITICAL INFRASTRUCTURE RISK ASSESSMENT REPORT SHALL BE DELIVERED TO THE GOVERNOR, THE TEMPORARY PRESIDENT OF THE SENATE, THE SPEAKER OF THE ASSEMBLY, THE CHAIR OF THE SENATE STANDING COMMITTEE ON VETERANS, HOMELAND SECURITY AND MILITARY AFFAIRS, AND THE CHAIR OF THE ASSEMBLY STANDING COMMITTEE ON GOVERNMENTAL OPERATIONS.

(E) WHERE COMPLIANCE WITH THIS SECTION SHALL REQUIRE THE DISCLOSURE OF CONFIDENTIAL INFORMATION, OR THE DISCLOSURE OF SENSITIVE INFORMATION WHICH IN THE JUDGMENT OF THE COMMISSIONER OF THE DIVISION OF HOMELAND SECURITY AND EMERGENCY SERVICES WOULD JEOPARDIZE THE CYBER SECURITY OF THE STATE:

(I) SUCH CONFIDENTIAL OR SENSITIVE INFORMATION SHALL BE PROVIDED TO THE PERSONS ENTITLED TO RECEIVE THE REPORT, IN THE FORM OF A SUPPLEMENTAL APPENDIX TO THE REPORT; AND

(II) SUCH SUPPLEMENTAL APPENDIX TO THE REPORT SHALL NOT BE SUBJECT TO THE PROVISIONS OF THE FREEDOM OF INFORMATION LAW PURSUANT TO ARTICLE SIX OF THE PUBLIC OFFICERS LAW; AND

(III) THE PERSONS ENTITLED TO RECEIVE THE REPORT MAY DISCLOSE THE SUPPLEMENTAL APPENDIX TO THE REPORT TO THEIR PROFESSIONAL STAFF, BUT SHALL NOT OTHERWISE PUBLICLY DISCLOSE SUCH CONFIDENTIAL OR SECURE INFORMATION.

S 2. This act shall take effect immediately.

SUBPART F

Section 1. This act shall be known and may be cited as the "personal information protection act".

S 2. Legislative findings and determinations. The legislature finds and determines that the unauthorized access to, theft and misappropriation of personal information can cause serious and significant harm.

The legislature further finds and determines that in an attempt to provide some level of protection against the unauthorized access to, and theft and misappropriation of such personal information, all persons or entities who collect and maintain such personal information should be required to follow certain minimum protocols and standards.

The legislature additionally finds and determines that the minimum protocols and standards established by this act seek to promote the safeguarding of personal information contained in both paper and electronic records, and that the objectives of this act are to promote the security and confidentiality of personal information in a manner fully consistent with customarily accepted standards and protocols; protect against unauthorized access, threats or hazards to the security or integrity of such information as best as can be anticipated; and protect against unauthorized access to, or the unauthorized use of, such information that may result in serious, significant or substantial harm or inconvenience.

22 COMPREHENSIVE INFORMATION SECURITY PROGRAM, THEN THE COURT MAY ALSO
23 AWARD PUNITIVE DAMAGES TO THE PLAINTIFF OF AN ACTION BROUGHT UNDER THIS
24 SUBDIVISION IN THE AMOUNT NOT TO EXCEED ONE HUNDRED THOUSAND DOLLARS.

25 (III) PERSONAL INFORMATION HOLDERS AND THIRD PARTY INFORMATION HOLDERS
26 WITH ANNUAL REVENUES OF LESS THAN ONE MILLION DOLLARS. ANY PERSONAL
27 INFORMATION HOLDER OR A THIRD PARTY PERSONAL INFORMATION HOLDER, THAT
28 HAS ANNUAL GROSS REVENUES OF LESS THAN ONE MILLION DOLLARS, AND THAT
29 FAILS TO MAINTAIN THE STANDARDS FOR THE PROTECTION OF PERSONAL INFORMA-
30 TION AS ESTABLISHED IN ITS COMPREHENSIVE INFORMATION SECURITY PROGRAM,
31 OR THAT FAILS TO MAINTAIN A COMPREHENSIVE SECURITY PROGRAM AS REQUIRED
32 BY THIS ARTICLE, AND THAT EXPERIENCES A BREACH OF SECURITY INVOLVING
33 SUCH PERSONAL INFORMATION, SHALL BE LIABLE IN A CIVIL ACTION FOR DAMAGES
34 BROUGHT IN ACCORDANCE WITH THIS SECTION, IN THE AMOUNT OF SUCH DAMAGES
35 SO SUSTAINED, OR AN AMOUNT OF UP TO ONE THOUSAND DOLLARS, WHICHEVER IS
36 GREATER, TOGETHER WITH COSTS, DISBURSEMENTS AND ATTORNEYS FEES OF THE
37 ACTION, OR IN THE EVENT THAT ANY PERSONAL INFORMATION SUBJECT INVOLVED
38 IN THE BREACH OF SECURITY SUSTAINS A PUBLIC DISCLOSURE OF THEIR MEDICAL
39 INFORMATION, AS DEFINED IN SUBPARAGRAPH (V) OF PARAGRAPH (A) OF SUBDIVI-
40 SION SIX OF SECTION FOUR HUNDRED ONE OF THIS ARTICLE, THEN SUCH PERSONAL
41 INFORMATION SUBJECT MAY BE AWARDED A RECOVERY IN THE AMOUNT OF ANY
42 DAMAGES SUSTAINED AS A RESULT OF THE DISCLOSURE OF SUCH MEDICAL INFORMA-
43 TION, OR AN AMOUNT OF UP TO TWO THOUSAND FIVE HUNDRED DOLLARS, WHICHEVER
44 IS GREATER, TOGETHER WITH COSTS, DISBURSEMENTS AND ATTORNEYS FEES OF THE
45 ACTION.

46 (IV) PERSONAL INFORMATION COLLECTORS. ANY PERSONAL INFORMATION COLLEC-
47 TOR, THAT FAILS TO MAINTAIN THE STANDARDS FOR THE PROTECTION OF PERSONAL
48 INFORMATION AS ESTABLISHED IN ITS COMPREHENSIVE INFORMATION SECURITY
49 PROGRAM, OR THAT FAILS TO MAINTAIN A COMPREHENSIVE SECURITY PROGRAM AS
50 REQUIRED BY THIS ARTICLE, AND THAT EXPERIENCES A BREACH OF SECURITY
51 INVOLVING SUCH PERSONAL INFORMATION, SHALL BE LIABLE IN A CIVIL ACTION
52 FOR DAMAGES BROUGHT IN ACCORDANCE WITH THIS SECTION, IN THE AMOUNT OF
53 SUCH DAMAGES SO SUSTAINED, OR AN AMOUNT OF UP TO ONE THOUSAND DOLLARS,
54 WHICHEVER IS GREATER, TOGETHER WITH COSTS, DISBURSEMENTS AND ATTORNEYS
55 FEES OF THE ACTION, OR IN THE EVENT THAT ANY PERSONAL INFORMATION
56 SUBJECT INVOLVED IN THE BREACH OF SECURITY SUSTAINS A PUBLIC DISCLOSURE

1 OF THEIR MEDICAL INFORMATION, AS DEFINED IN SUBPARAGRAPH (V) OF PARA-
2 GRAPH (A) OF SUBDIVISION SIX OF SECTION FOUR HUNDRED ONE OF THIS ARTI-
3 CLE, THEN SUCH PERSONAL INFORMATION SUBJECT MAY BE AWARDED A RECOVERY IN
4 THE AMOUNT OF ANY DAMAGES SUSTAINED AS A RESULT OF THE DISCLOSURE OF
5 SUCH MEDICAL INFORMATION, OR AN AMOUNT OF UP TO TWO THOUSAND FIVE
6 HUNDRED DOLLARS, WHICHEVER IS GREATER, TOGETHER WITH COSTS, DISBURSE-
7 MENTS AND ATTORNEYS FEES OF THE ACTION.

8 S 408. LIABILITY PROTECTION. 1. LIABILITY PROTECTION IT SHALL BE A
9 COMPLETE DEFENSE TO ANY CIVIL ACTION BROUGHT IN ACCORDANCE WITH SECTION

19 SECTION FOUR HUNDRED FOUR OF THIS ARTICLE, AT THE TIME OF THE BREACH OF

21 2. ANY CIVIL ACTION BROUGHT BY A PERSONAL INFORMATION SUBJECT AGAINST
22 A PERSONAL INFORMATION RECIPIENT, IN ANY COURT OF COMPETENT JURISDIC-
23 TION, INVOLVING DAMAGES ARISING FROM A BREACH OF SECURITY, AS DEFINED IN

29 PROVISIONS OF SECTION FOUR HUNDRED SIX OF THIS ARTICLE.

30 S 5. This act shall take effect on the first of November next succeed-
31 ing the date on which it shall have become a law.

32 SUBPART G

33 Section 1. This act shall be known and may be cited as the New York
34 state Iran divestment act.

35 S 2. Section 2 of chapter 1 of the laws 2012 amending the state
36 finance law and other laws enacting the Iran divestment act of 2012 is
37 amended to read as follows:

38 S 2. The legislature hereby finds and declares all of the following:

39 [(a) Congress and the President have determined that the illicit
40 nuclear activities of the Government of Iran, combined with its develop-
41 ment of unconventional weapons and ballistic missiles, and its support
42 of international terrorism, represent a serious threat to the security
43 of the United States, Israel, and other United States allies in Europe,
44 the Middle East, and around the world.

45 (b) The International Atomic Energy Agency has repeatedly called
46 attention to Iran's unlawful nuclear activities, and, as a result, the
47 United Nations Security Council has adopted a range of sanctions
48 designed to encourage the government of Iran to cease those activities
49 and comply with its obligations under the Treaty on the Non-Prolifera-
50 tion of Nuclear Weapons (commonly known as the "Nuclear Non-Prolifera-
51 tion Treaty").

52 (c) On July 1, 2010, President Barack Obama signed into law H.R.
53 2194, the "Comprehensive Iran Sanctions, Accountability, and Divestment
54 Act of 2010" (Public Law 111-195), which expressly authorizes states and

1 local governments to prevent investment in, including prohibiting entry
2 into or renewing contracts with, companies operating in Iran's energy
3 sector with investments that have the result of directly or indirectly
4 supporting the efforts of the government of Iran to achieve nuclear
5 weapons capability.

6 (d) The serious and urgent nature of the threat from Iran demands that
7 states, local governments, and private institutions work together with
8 the federal government and American allies to do everything possible
9 diplomatically, politically, and economically to prevent Iran from
10 acquiring a nuclear weapons capability.

11 (e) Respect for human rights in Iran has steadily deteriorated as
12 demonstrated by transparently fraudulent elections and the brutal
13 repression and murder, arbitrary arrests, and show trials of peaceful
14 dissidents.

15 (f) The concerns of the state of New York regarding Iran are strictly
16 the result of the actions of the government of Iran and should not be
17 construed as enmity towards the Iranian people.

18 (g) In order to effectively address the need for the governments of
19 this state to respond to the policies of Iran in a uniform fashion,
20 prohibiting contracts with persons engaged in investment activities in
21 the energy sector of Iran must be accomplished on a statewide basis.

22 (h) It is the intent of the legislature to fully implement the author-
23 ity granted under Section 202 of the Comprehensive Iran Sanctions,
24 Accountability, and Divestment Act of 2010 (Public Law 111-195).]

25 (A) THAT THE ILLICIT NUCLEAR ACTIVITIES OF THE GOVERNMENT OF IRAN,
26 COMBINED WITH ITS DEVELOPMENT OF UNCONVENTIONAL WEAPONS AND BALLISTIC
27 MISSILES, AND ITS SUPPORT OF INTERNATIONAL TERRORISM, REPRESENT A SERI-
28 OUS THREAT TO THE SECURITY OF THE STATE OF NEW YORK, ITS CITIZENS AND
29 THEIR PROPERTY;

30 (B) THAT IRAN AND OTHER TERRORIST STATES AND ORGANIZATIONS HAVE
31 REPEATEDLY IDENTIFIED NEW YORK STATE AND ITS CITIZENS AS A PRIMARY
32 TARGET FOR TERRORIST ACTIVITIES AND ATTACKS, AND UNDER THE STATE'S
33 CONSTITUTIONAL POWERS TO PROVIDE FOR THE PUBLIC HEALTH, SAFETY, SECURITY
34 AND PUBLIC PROTECTION OF ITS CITIZENS AND THEIR PROPERTY, AND UNDER THE
35 STATE'S CONSTITUTIONAL POWERS TO PROVIDE FOR THE PROTECTION AND REGU-
36 LATION OF ITS FINANCIAL, BANKING AND INSURANCE SECTORS, AND UNDER THE
37 STATE'S CONSTITUTIONAL POWERS TO PROVIDE FOR THE PROTECTION AND REGU-
38 LATION OF ITS ENVIRONMENT AND NATURAL RESOURCES, NEW YORK STATE HAS THE
39 LEGAL AUTHORITY TO PREVENT INVESTMENT IN, INCLUDING PROHIBITING ENTRY
40 INTO OR RENEWING CONTRACTS WITH, COMPANIES OPERATING IN IRAN'S ENERGY
41 AND FINANCIAL SECTORS WITH INVESTMENTS THAT HAVE THE RESULT OF DIRECTLY
42 OR INDIRECTLY SUPPORTING THE EFFORTS OF THE GOVERNMENT OF IRAN TO
43 ACHIEVE NUCLEAR WEAPONS CAPABILITY OR TO OTHERWISE PROMOTE OR ADVANCE
44 TERRORIST ACTIVITIES THAT WILL TARGET OR AFFECT NEW YORK STATE, ITS
45 CITIZENS OR THEIR PROPERTY;

46 (C) THAT THE SERIOUS AND URGENT NATURE OF THE THREAT FROM IRAN DEMANDS
47 THAT STATES, LOCAL GOVERNMENTS, AND PRIVATE INSTITUTIONS WORK TOGETHER
48 WITH THE FEDERAL GOVERNMENT AND AMERICAN ALLIES TO DO EVERYTHING POSSI-
49 BLE DIPLOMATICALLY, POLITICALLY, AND ECONOMICALLY TO PREVENT IRAN FROM
50 ACQUIRING A NUCLEAR WEAPONS CAPABILITY OR TO OTHERWISE PROMOTE OR
51 ADVANCE TERRORIST ACTIVITIES THAT WILL TARGET OR AFFECT NEW YORK STATE,
52 ITS CITIZENS OR THEIR PROPERTY;

53 (D) THAT IRAN HAS REPEATEDLY DEMONSTRATED AN INTENT TO PURSUE AND USE
54 NUCLEAR WEAPONS, WEAPONS OF MASS DESTRUCTION, AND TO PROMOTE OR ADVANCE
55 TERRORIST ACTIVITIES ACROSS THE WORLD;

(E) THAT RESPECT FOR HUMAN RIGHTS IN IRAN HAS STEADILY DETERIORATED AS DEMONSTRATED BY TRANSPARENTLY FRAUDULENT ELECTIONS AND THE BRUTAL REPRESSION AND MURDER, ARBITRARY ARRESTS, AND SHOW TRIALS OF PEACEFUL DISSIDENTS;

(F) THAT THE CONCERNS OF THE STATE OF NEW YORK REGARDING IRAN ARE STRICTLY THE RESULT OF THE ACTIONS OF THE GOVERNMENT OF IRAN AND SHOULD NOT BE CONSTRUED AS ENMITY TOWARDS THE IRANIAN PEOPLE;

(G) THAT IN ORDER TO EFFECTIVELY ADDRESS THE NEED FOR THE GOVERNMENTS OF THIS STATE TO RESPOND TO THE POLICIES OF IRAN IN A UNIFORM FASHION, PROHIBITING CONTRACTS WITH PERSONS ENGAGED IN INVESTMENT ACTIVITIES IN THE ENERGY AND FINANCIAL SECTORS OF IRAN MUST BE ACCOMPLISHED ON A STATEWIDE BASIS;

(H) THAT TERRORISTS HAVE CONTINUED TO USE IRAN AS THEIR SAFE HARBOR, THAT THE IRANIAN GOVERNMENT HAS FAILED TO ADDRESS THE SPREAD OF TERRORIST ACTIVITIES, AND THAT HUMAN RIGHTS VIOLATIONS ARE IN IRAN ARE, AND CONTINUE TO BE RAMPANT; AND

(I) THAT THE SERIOUS AND URGENT NATURE OF THE CONTINUED THREAT FROM IRAN, FOR THE STATE OF NEW YORK, ITS CITIZENS AND THEIR PROPERTY, DEMANDS THAT OUR STATE, LOCAL GOVERNMENTS AND PRIVATE INSTITUTIONS WORK TOGETHER TO CONTINUE TO DO ALL WITHIN ITS LEGAL POWER TO ENSURE THAT IRAN DOES NOT HAVE THE RESOURCES TO ACQUIRE NUCLEAR WEAPONS CAPABILITY AND THAT IT CEASE ITS PROMOTION AND ADVANCEMENT OF TERRORIST ACTIVITIES.

S 3. Paragraph (b) of subdivision 1 of section 165-a of the state finance law, as added by chapter 1 of the laws of 2012, is amended to read as follows:

(b) "Financial institution" means [the term as used in Section 14 of the Iran Sanctions Act of 1996 (Public Law 104-172; 50 U.S.C. 1701 note).]:

(1) A BANKING ORGANIZATION AS DEFINED IN SUBDIVISION ELEVEN OF SECTION TWO OF THE BANKING LAW;

(2) A SECURITIES FIRM, INCLUDING A BROKER OR DEALER;

(3) ANY INSURANCE COMPANY, INCLUDING ANY COMPANY, AGENT, BROKER, OR UNDERWRITER, LICENSED OR REGULATED BY THE DEPARTMENT OF FINANCIAL SERVICES PURSUANT TO THE INSURANCE LAW; AND/OR

(4) ANY OTHER COMPANY THAT PROVIDES A FINANCIAL PRODUCT OR SERVICE AS DEFINED IN SUBDIVISION TWO OF SECTION ONE HUNDRED FOUR OF THE FINANCIAL SERVICES LAW.

S 4. Subparagraph 2 of paragraph (e) of subdivision 1 of section 165-a of the state finance law, as added by chapter 1 of the laws of 2012, is amended to read as follows:

(2) Any governmental entity or instrumentality of a government, including [a multilateral development institution, as defined in Section 1701(c)(3) of the International Financial Institutions Act (22 U.S.C. 262r(c)(3))] THE INTERNATIONAL BANK FOR RECONSTRUCTION AND DEVELOPMENT, THE EUROPEAN BANK FOR RECONSTRUCTION AND DEVELOPMENT, THE INTERNATIONAL DEVELOPMENT ASSOCIATION, THE INTERNATIONAL FINANCE CORPORATION, THE MULTILATERAL INVESTMENT GUARANTEE AGENCY, THE AFRICAN DEVELOPMENT BANK, THE AFRICAN DEVELOPMENT FUND, THE ASIAN DEVELOPMENT BANK, THE INTER-AMERICAN DEVELOPMENT BANK, THE BANK FOR ECONOMIC COOPERATION AND DEVELOPMENT IN THE MIDDLE EAST AND NORTH AFRICA, AND THE INTER-AMERICAN INVESTMENT CORPORATION.

S 5. Subdivision 6 of section 165-a of the state finance law, as added by chapter 1 of the laws of 2012, is amended to read as follows:

6. The commissioner shall report to the governor and the legislature annually on or before October first, on the status of the [federal "Comprehensive Iran Sanctions, Accountability, and Divestment Act of

2010" (Public Law 111-195), "the Iran divestment act of 2012",] PROVISIONS OF THE NEW YORK STATE IRAN DIVESTMENT ACT and any rules or regulations adopted thereunder.

S 6. Section 1 of chapter 481 of the laws of 2013 amending the insurance law relating to investments in foreign states sponsoring terrorism, is amended to read as follows:

Section 1. The legislature finds and declares all of the following:

[(1) The Federal Securities and Exchange Commission has determined that investments in foreign states sponsoring terrorism, such as Iran, that are subject to sanctions by the United States, may materially harm the share value of foreign companies. Shares in these foreign companies may be held in the portfolio of insurance companies issuing policies to New York consumers.

(2) Publicly traded companies in the United States are substantially restricted in doing business in or with foreign states, such as Iran, that the United States Department of State has identified as sponsoring terrorism.

(3) Identifying persons with investments in foreign states, such as Iran, that sponsor terrorism and ensuring that those investments are financially sound is an important public policy priority.

(4) It is the government of Iran, and not the people of Iran, that is responsible for Iran's support of terrorism and that commits egregious violations of human rights under which its own citizens are required to live.]

(A) THAT THE ILLICIT NUCLEAR ACTIVITIES OF THE GOVERNMENT OF IRAN, COMBINED WITH ITS DEVELOPMENT OF UNCONVENTIONAL WEAPONS AND BALLISTIC MISSILES, AND ITS SUPPORT OF INTERNATIONAL TERRORISM, REPRESENT A SERIOUS THREAT TO THE SECURITY OF THE STATE OF NEW YORK, ITS CITIZENS AND THEIR PROPERTY;

(B) THAT IRAN AND OTHER TERRORIST STATES AND ORGANIZATIONS HAVE REPEATEDLY IDENTIFIED NEW YORK STATE AND ITS CITIZENS AS A PRIMARY TARGET FOR TERRORIST ACTIVITIES AND ATTACKS, AND UNDER THE STATE'S CONSTITUTIONAL POWERS TO PROVIDE FOR THE PUBLIC HEALTH, SAFETY, SECURITY AND PUBLIC PROTECTION OF ITS CITIZENS AND THEIR PROPERTY, AND UNDER THE STATE'S CONSTITUTIONAL POWERS TO PROVIDE FOR THE PROTECTION AND REGULATION OF ITS FINANCIAL, BANKING AND INSURANCE SECTORS, AND UNDER THE STATE'S CONSTITUTIONAL POWERS TO PROVIDE FOR THE PROTECTION AND REGULATION OF ITS ENVIRONMENT AND NATURAL RESOURCES, NEW YORK STATE HAS THE LEGAL AUTHORITY TO PREVENT INVESTMENT IN, INCLUDING PROHIBITING ENTRY INTO OR RENEWING CONTRACTS WITH, COMPANIES OPERATING IN IRAN'S ENERGY AND FINANCIAL SECTORS WITH INVESTMENTS THAT HAVE THE RESULT OF DIRECTLY OR INDIRECTLY SUPPORTING THE EFFORTS OF THE GOVERNMENT OF IRAN TO ACHIEVE NUCLEAR WEAPONS CAPABILITY OR TO OTHERWISE PROMOTE OR ADVANCE TERRORIST ACTIVITIES THAT WILL TARGET OR AFFECT NEW YORK STATE, ITS CITIZENS OR THEIR PROPERTY;

(C) THAT THE SERIOUS AND URGENT NATURE OF THE THREAT FROM IRAN DEMANDS THAT STATES, LOCAL GOVERNMENTS, AND PRIVATE INSTITUTIONS WORK TOGETHER WITH THE FEDERAL GOVERNMENT AND AMERICAN ALLIES TO DO EVERYTHING POSSIBLE DIPLOMATICALLY, POLITICALLY, AND ECONOMICALLY TO PREVENT IRAN FROM ACQUIRING A NUCLEAR WEAPONS CAPABILITY OR TO OTHERWISE PROMOTE OR ADVANCE TERRORIST ACTIVITIES THAT WILL TARGET OR AFFECT NEW YORK STATE, ITS CITIZENS OR THEIR PROPERTY;

(D) THAT IRAN HAS REPEATEDLY DEMONSTRATED AN INTENT TO PURSUE AND USE NUCLEAR WEAPONS, WEAPONS OF MASS DESTRUCTION, AND TO PROMOTE OR ADVANCE TERRORIST ACTIVITIES ACROSS THE WORLD;

(E) THAT RESPECT FOR HUMAN RIGHTS IN IRAN HAS STEADILY DETERIORATED AS DEMONSTRATED BY TRANSPARENTLY FRAUDULENT ELECTIONS AND THE BRUTAL REPRESSION AND MURDER, ARBITRARY ARRESTS, AND SHOW TRIALS OF PEACEFUL DISSIDENTS;

(F) THAT THE CONCERNS OF THE STATE OF NEW YORK REGARDING IRAN ARE STRICTLY THE RESULT OF THE ACTIONS OF THE GOVERNMENT OF IRAN AND SHOULD NOT BE CONSTRUED AS ENMITY TOWARDS THE IRANIAN PEOPLE;

(G) THAT IN ORDER TO EFFECTIVELY ADDRESS THE NEED FOR THE GOVERNMENTS OF THIS STATE TO RESPOND TO THE POLICIES OF IRAN IN A UNIFORM FASHION, PROHIBITING CONTRACTS WITH PERSONS ENGAGED IN INVESTMENT ACTIVITIES IN THE ENERGY AND FINANCIAL SECTORS OF IRAN MUST BE ACCOMPLISHED ON A STATEWIDE BASIS;

(H) THAT TERRORISTS HAVE CONTINUED TO USE IRAN AS THEIR SAFE HARBOR, THAT THE IRANIAN GOVERNMENT HAS FAILED TO ADDRESS THE SPREAD OF TERRORIST ACTIVITIES, AND THAT HUMAN RIGHTS VIOLATIONS ARE IN IRAN ARE, AND CONTINUE TO BE RAMPANT; AND

(I) THAT THE SERIOUS AND URGENT NATURE OF THE CONTINUED THREAT FROM IRAN, FOR THE STATE OF NEW YORK, ITS CITIZENS AND THEIR PROPERTY, DEMANDS THAT OUR STATE, LOCAL GOVERNMENTS AND PRIVATE INSTITUTIONS WORK TOGETHER TO CONTINUE TO DO ALL WITHIN ITS LEGAL POWER TO ENSURE THAT IRAN DOES NOT HAVE THE RESOURCES TO ACQUIRE NUCLEAR WEAPONS CAPABILITY AND THAT IT CEASE ITS PROMOTION AND ADVANCEMENT OF TERRORIST ACTIVITIES.

S 7. Subsection 5 of section 1415 of the insurance law is REPEALED.

S 8. This act shall take effect immediately, and shall not be deemed repealed as the result of any executive action taken by the president of the United States, or the department of state, unless such action is a duly executed treaty approved by two-thirds of the United States Senate; provided that the commissioner of general services shall notify the legislative bill drafting commission upon the occurrence of such duly executed treaty in order that the commission may maintain an accurate and timely effective data base of the official text of the laws of the state of New York in furtherance of effectuating the provisions of section 44 of the legislative law and section 70-b of the public officers law; and provided further that the addition, amendment and/or repeal of any rule or regulation necessary for the implementation of this act is authorized to be made on and after such effective date.

2 ENFORCEMENT OF CERTAIN FEDERAL LAWS. 1. IN ACCORDANCE WITH ARTICLES NINE

7 ADOPT ANY RULE, ORDER, ORDINANCE, LOCAL LAW OR POLICY, EITHER FORMALLY
8 OR INFORMALLY, PROHIBITING OR INHIBITING ONE OR MORE OF THE FOLLOWING:

9 (A) THE ENFORCEMENT OF LAWS OF THIS STATE OR FEDERAL LAWS RELATING TO
10 PERSONS ILLEGALLY IN THE COUNTRY;

11 (B) THE ABILITY OF LAW ENFORCEMENT OFFICERS TO ASSIST OR COOPERATE
12 WITH FEDERAL OFFICIALS IN THE COURSE OF CARRYING OUT THEIR ROUTINE LAW
13 ENFORCEMENT DUTIES;

14 (C) THE USE OF LOCAL RESOURCES TO AID IN THE COMPLIANCE WITH DETAINER
15 REQUESTS ISSUED BY THE DEPARTMENT OF HOMELAND SECURITY;

16 (D) A LAW ENFORCEMENT OFFICER FROM MAKING AN INQUIRY CONCERNING THE
17 LAWFULNESS OF AN INDIVIDUAL'S PRESENCE IN THE COUNTRY IF THE INDIVIDUAL
18 IS LAWFULLY DETAINED OR LAWFULLY ARRESTED, AND/OR VERIFYING SUCH INDI-
19 VIDUAL IS LEGALLY IN THE COUNTRY;

20 (E) THE SHARING OF INFORMATION PERTAINING TO WHETHER THE LAWFULNESS OF
21 AN INDIVIDUAL'S PRESENCE IN THE COUNTRY WITH FEDERAL HOMELAND SECURITY
22 OFFICIALS; OR

23 (F) THE ABILITY OF FEDERAL HOMELAND SECURITY OFFICIALS TO ENTER AND
24 CONDUCT ENFORCEMENT ACTIVITIES AT A MUNICIPAL OR COUNTY JAIL IN FURTHER-
25 ANCE OF THEIR DUTY TO ENFORCE FEDERAL LAWS.

26 2. FOR PURPOSES OF THIS SECTION, A PERSON SHALL NOT BE CONSIDERED TO
27 BE LAWFULLY DETAINED IF SUCH PERSON IS: (A) THE VICTIM OF A CRIME; (B) A
28 COOPERATING WITNESS RELATING TO A CRIME; OR (C) REPORTING A CRIME, CRIM-
29 INAL ACTIVITY, OR A PLANNED OR ACTUAL ACT OF TERRORISM.

35 (B) THE COMPTROLLER SHALL, PRIOR TO THE DISBURSEMENT OR DELIVERY OF
36 ANY STATE OR FEDERAL FUNDS, TO A COUNTY, CITY, TOWN OR VILLAGE, OR ANY
37 AGENCY, OFFICE, DEPARTMENT OR AUTHORITY THEREOF, REQUIRE THAT THE CHIEF
38 ELECTED OFFICER OF SUCH COUNTY, CITY, TOWN OR VILLAGE PROVIDE VERIFICA-
39 TION, SIGNED UNDER PENALTIES OF PERJURY BY SUCH CHIEF ELECTED OFFICER,
40 THAT SUCH COUNTY, CITY, TOWN OR VILLAGE IS IN COMPLIANCE WITH THIS
41 SECTION.

42 4. THIS SECTION SHALL NOT BE DEEMED TO APPLY TO ANY SCHOOL DISTRICT,
43 CHARTER SCHOOL, OR MUNICIPAL HEALTH SERVICE FACILITY.

44 S 4. Severability clause. If any clause, sentence, paragraph, subdivi-
45 sion, section or part of this act shall be adjudged by any court of
46 competent jurisdiction to be invalid, such judgment shall not affect,
47 impair or invalidate the remainder thereof, but shall be confined in its
48 operation to the clause, sentence, paragraph, subdivision, section or

S 200. Short title. This article shall be known and may be cited as the "disability benefits law AND THE PAID FAMILY LEAVE BENEFITS LAW."

S 2. Subdivision 14 of section 201 of the workers' compensation law, as added by chapter 600 of the laws of 1949 and as renumbered by chapter 438 of the laws of 1964, is amended and eleven new subdivisions 15, 16, 17, 18, 19, 20, 21, 22, 23, 24 and 25 are added to read as follows:

14. "A day of disability" means any day on which the employee was prevented from performing work because of disability, INCLUDING ANY DAY WHICH THE EMPLOYEE USES FOR FAMILY CARE, and for which [he] THE EMPLOYEE has not received his OR HER regular remuneration.

15. "FAMILY LEAVE" SHALL MEAN ANY LEAVE TAKEN BY AN EMPLOYEE FROM WORK TO PARTICIPATE IN PROVIDING CARE, INCLUDING PHYSICAL OR PSYCHOLOGICAL CARE, FOR A FAMILY MEMBER OF THE EMPLOYEE MADE NECESSARY BY A SERIOUS HEALTH CONDITION OF THE FAMILY MEMBER; OR TO BOND WITH THE EMPLOYEE'S CHILD DURING THE FIRST TWELVE MONTHS AFTER THE CHILD'S BIRTH, OR THE FIRST TWELVE MONTHS AFTER THE PLACEMENT OF THE CHILD FOR ADOPTION OR FOSTER CARE WITH THE EMPLOYEE; OR BECAUSE OF ANY QUALIFYING EXIGENCY AS INTERPRETED UNDER THE FAMILY AND MEDICAL LEAVE ACT, 29 U.S.C.S S 2612(A)(1)(E) AND 29 C.F.R. S.825.126(A)(1)-(8), ARISING OUT OF THE FACT THAT THE SPOUSE, DOMESTIC PARTNER, CHILD, OR PARENT OF THE EMPLOYEE IS ON ACTIVE DUTY (OR HAS BEEN NOTIFIED OF AN IMPENDING CALL OR ORDER TO ACTIVE DUTY) IN THE ARMED FORCES OF THE UNITED STATES.

16. "CHILD" MEANS A BIOLOGICAL, ADOPTED, OR FOSTER SON OR DAUGHTER, A STEPSON OR STEPDAUGHTER, A LEGAL WARD, A SON OR DAUGHTER OF A DOMESTIC PARTNER, OR THE PERSON TO WHOM THE EMPLOYEE STANDS IN LOCO PARENTIS.

17. "DOMESTIC PARTNER" HAS THE SAME MEANING AS SET FORTH IN SECTION FOUR OF THIS CHAPTER.

18. "SERIOUS HEALTH CONDITION" MEANS AN ILLNESS, INJURY, IMPAIRMENT, OR PHYSICAL OR MENTAL CONDITION THAT INVOLVES INPATIENT CARE IN A HOSPITAL, HOSPICE, OR RESIDENTIAL HEALTH CARE FACILITY, OR CONTINUING TREATMENT OR CONTINUING SUPERVISION BY A HEALTH CARE PROVIDER AND REQUIRING ASSISTANCE TO PERFORM THE ACTIVITIES OF DAILY LIVING.

19. "PARENT" MEANS A BIOLOGICAL, FOSTER, OR ADOPTIVE PARENT, A PARENT-IN-LAW, A STEPPARENT, A LEGAL GUARDIAN, OR OTHER PERSON WHO STOOD IN LOCO PARENTIS TO THE EMPLOYEE WHEN THE EMPLOYEE WAS A CHILD.

20. "FAMILY MEMBER" MEANS A CHILD, PARENT, GRANDPARENT, GRANDCHILD, SIBLING, SPOUSE, OR DOMESTIC PARTNER AS DEFINED IN THIS SECTION.

21. "GRANDCHILD" MEANS A CHILD OF THE EMPLOYEE'S CHILD.

22. "HEALTH CARE PROVIDER" SHALL MEAN A PERSON LICENSED UNDER ARTICLE ONE HUNDRED THIRTY-ONE, ONE HUNDRED THIRTY-ONE-B, ONE HUNDRED THIRTY-TWO, ONE HUNDRED THIRTY-THREE, ONE HUNDRED THIRTY-SIX, ONE HUNDRED THIRTY-NINE, ONE HUNDRED FORTY-ONE, ONE HUNDRED FORTY-THREE, ONE HUNDRED FORTY-FOUR, ONE HUNDRED FIFTY-THREE, ONE HUNDRED FIFTY-FOUR, ONE HUNDRED FIFTY-SIX OR ONE HUNDRED FIFTY-NINE OF THE EDUCATION LAW OR A PERSON LICENSED UNDER THE PUBLIC HEALTH LAW, ARTICLE ONE HUNDRED FORTY OF THE EDUCATION LAW OR ARTICLE ONE HUNDRED SIXTY-THREE OF THE EDUCATION LAW.

23. "GRANDPARENT" MEANS A PARENT OF THE EMPLOYEE'S PARENT.

1 24. "SIBLING" MEANS A PERSON RELATED TO ANOTHER PERSON BY BLOOD,
2 ADOPTION, OR AFFINITY THROUGH A COMMON LEGAL OR BIOLOGICAL PARENT.

3 25. "FAMILY CARE" SHALL MEAN ANY LEAVE TAKEN BY AN EMPLOYEE FROM WORK:

4 (A) TO PARTICIPATE IN PROVIDING CARE, INCLUDING PHYSICAL OR PSYCHOLOG-
5 ICAL CARE, FOR A FAMILY MEMBER OF THE EMPLOYEE MADE NECESSARY BY A SERI-
6 OUS HEALTH CONDITION OF THE FAMILY MEMBER; OR

7 (B) TO BOND WITH THE EMPLOYEE'S CHILD DURING THE FIRST TWELVE MONTHS
8 AFTER THE CHILD'S BIRTH, OR THE FIRST TWELVE MONTHS AFTER THE PLACEMENT
9 OF THE CHILD FOR ADOPTION OR FOSTER CARE WITH THE EMPLOYEE; OR

10 (C) BECAUSE OF ANY QUALIFYING EXIGENCY AS INTERPRETED UNDER THE FAMILY
11 AND MEDICAL LEAVE ACT, 29 U.S.C. S 2612(A)(1)(E) AND 29 C.F.R. S
12 825.126(A)(1)-(8), ARISING OUT OF THE FACT THAT THE SPOUSE, DOMESTIC
13 PARTNER, CHILD, OR PARENT OF THE EMPLOYEE IS ON ACTIVE DUTY OR HAS BEEN
14 NOTIFIED OF AN IMPENDING CALL OR ORDER TO ACTIVE DUTY IN THE ARMED FORC-
15 ES OF THE UNITED STATES.

16 S 3. Section 203 of the workers' compensation law, as amended by chap-
17 ter 436 of the laws of 1986, is amended to read as follows:

18 S 203. Employees eligible for benefits under section two hundred four
19 OF THIS ARTICLE. Employees in employment of a covered employer for four
20 or more consecutive weeks and employees in employment during the work
21 period usual to and available during such four or more consecutive weeks
22 in any trade or business in which they are regularly employed and in
23 which hiring from day to day of such employees is the usual employment
24 practice shall be eligible for disability AND FAMILY LEAVE benefits as
25 provided in section two hundred four OF THIS ARTICLE. EVERY SUCH
26 EMPLOYEE SHALL CONTINUE TO BE ELIGIBLE FOR FAMILY LEAVE BENEFITS ONLY
27 DURING EMPLOYMENT WITH A COVERED EMPLOYER. Every such employee shall
28 continue to be eligible FOR DISABILITY BENEFITS during such employment
29 and for a period of four weeks after such employment terminates regard-

31 profit in non-covered employment. If during such four week period the
32 employee performs any work for remuneration or profit for another
33 covered employer the employee shall become eligible for DISABILITY bene-
34 fits immediately with respect to that employment. In addition every such

11 TLED, ON RETURN FROM SUCH LEAVE, TO BE RESTORED BY THE EMPLOYER TO THE
12 POSITION OF EMPLOYMENT HELD BY THE EMPLOYEE WHEN THE LEAVE COMMENCED, OR
13 TO BE RESTORED TO A COMPARABLE POSITION WITH COMPARABLE EMPLOYMENT BENE-
14 FITS, PAY AND OTHER TERMS AND CONDITIONS OF EMPLOYMENT. THE TAKING OF
15 FAMILY LEAVE SHALL NOT RESULT IN THE LOSS OF ANY EMPLOYMENT BENEFIT
16 ACCRUED PRIOR TO THE DATE ON WHICH THE LEAVE COMMENCED. NOTHING IN THIS
17 SECTION SHALL BE CONSTRUED TO ENTITLE ANY RESTORED EMPLOYEE TO THE
18 ACCRUAL OF ANY SENIORITY OR EMPLOYMENT BENEFITS DURING ANY PERIOD OF
19 LEAVE, OR ANY RIGHT, BENEFIT OR POSITION TO WHICH THE EMPLOYEE WOULD
20 HAVE BEEN ENTITLED HAD THE EMPLOYEE NOT TAKEN THE LEAVE.

21 S 203-C HEALTH INSURANCE DURING FAMILY LEAVE.

22 IN ACCORDANCE WITH THE FAMILY AND MEDICAL LEAVE ACT (29 U.S.C. SS
23 2601-2654), DURING ANY PERIOD OF FAMILY LEAVE THE EMPLOYER SHALL MAIN-
24 TAIN ANY EXISTING HEALTH BENEFITS OF THE EMPLOYEE IN FORCE FOR THE DURA-
25 TION OF SUCH LEAVE AS IF THE EMPLOYEE HAD CONTINUED TO WORK FROM THE
26 DATE HE OR SHE COMMENCED FAMILY LEAVE UNTIL THE DATE HE OR SHE RETURNS
27 TO EMPLOYMENT.

28 S 5. Section 204 of the workers' compensation law, as added by chapter
29 600 of the laws of 1949, subdivision 2 as amended by chapter 38 of the
30 laws of 1989, is amended to read as follows:

31 S 204. Disability AND FAMILY LEAVE during employment. 1. Disability
32 benefits shall be payable to an eligible employee for disabilities
33 [commencing after June thirtieth, nineteen hundred fifty], beginning
34 with the eighth [consecutive] day of disability and thereafter during
35 the continuance of disability, subject to the limitations as to maximum
36 and minimum amounts and duration and other conditions and limitations in
37 this section and in sections two hundred five and two hundred six OF
38 THIS ARTICLE. FAMILY LEAVE BENEFITS SHALL BE PAYABLE TO AN ELIGIBLE
39 EMPLOYEE FOR THE FIRST FULL DAY WHEN FAMILY LEAVE IS REQUIRED AND THERE-
40 AFTER DURING THE CONTINUANCE OF THE NEED FOR FAMILY LEAVE, SUBJECT TO
41 THE LIMITATIONS AS TO MAXIMUM AND MINIMUM AMOUNTS AND DURATION AND OTHER
42 CONDITIONS AND LIMITATIONS IN THIS SECTION AND IN SECTIONS TWO HUNDRED
43 FIVE AND TWO HUNDRED SIX OF THIS ARTICLE. Successive periods of disabil-
44 ity OR FAMILY LEAVE caused by the same or related injury or sickness
45 shall be deemed a single period of disability OR FAMILY LEAVE only if
46 separated by less than three months.

47 2. (A) THE WEEKLY BENEFIT FOR FAMILY LEAVE THAT OCCURS (I) ON OR AFTER
48 JANUARY FIRST, TWO THOUSAND EIGHTEEN SHALL BE FIFTY PERCENT OF THE
49 EMPLOYEE'S AVERAGE WEEKLY WAGE BUT SHALL NOT EXCEED FIFTY PERCENT OF THE
50 STATE AVERAGE WEEKLY WAGE, (II) ON OR AFTER JANUARY FIRST, TWO THOUSAND
51 NINETEEN SHALL BE FIFTY-FIVE PERCENT OF THE EMPLOYEE'S AVERAGE WEEKLY
52 WAGE BUT SHALL NOT EXCEED FIFTY-FIVE PERCENT OF THE STATE AVERAGE WEEKLY
53 WAGE, (III) ON OR AFTER JANUARY FIRST, TWO THOUSAND TWENTY SHALL BE
54 SIXTY PERCENT OF THE EMPLOYEE'S AVERAGE WEEKLY WAGE BUT SHALL NOT EXCEED
55 SIXTY PERCENT OF THE STATE AVERAGE WEEKLY WAGE, AND (IV) ON OR AFTER
56 JANUARY FIRST OF EACH SUCCEEDING YEAR, SHALL BE SIXTY-SEVEN PERCENT OF

1 THE EMPLOYEE'S AVERAGE WEEKLY WAGE BUT SHALL NOT EXCEED SIXTY-SEVEN
2 PERCENT OF THE NEW YORK STATE AVERAGE WEEKLY WAGE IN EFFECT. THE WEEKLY
3 BENEFITS FOR FAMILY LEAVE THAT OCCURS ON OR AFTER JANUARY FIRST, TWO
4 THOUSAND EIGHTEEN SHALL NOT BE LESS THAN ONE HUNDRED DOLLARS PER WEEK
5 EXCEPT THAT IF THE EMPLOYEE'S WAGES AT THE TIME OF FAMILY LEAVE ARE LESS
6 THAN ONE HUNDRED DOLLARS PER WEEK, THE EMPLOYEE SHALL RECEIVE HIS OR HER
7 FULL WAGES. BENEFITS MAY BE PAYABLE TO EMPLOYEES FOR PAID FAMILY LEAVE
8 TAKEN INTERMITTENTLY OR FOR LESS THAN A FULL WORK WEEK IN INCREMENTS OF
9 ONE FULL DAY OR ONE FIFTH OF THE WEEKLY BENEFIT.

10 (B) The weekly benefit which the disabled employee is entitled to
11 receive for disability commencing on or after May first, nineteen
12 hundred eighty-nine shall be one-half of the employee's weekly wage, but
13 in no case shall such benefit exceed one hundred seventy dollars; except
14 that if the employee's average weekly wage is less than twenty dollars,
15 the benefit shall be such average weekly wage. The weekly benefit which
16 the disabled employee is entitled to receive for disability commencing
17 on or after July first, nineteen hundred eighty-four shall be one-half
18 of the employee's weekly wage, but in no case shall such benefit exceed
19 one hundred forty-five dollars; except that if the employee's average
20 weekly wage is less than twenty dollars, the benefit shall be such aver-
21 age weekly wage. The weekly benefit which the disabled employee is enti-
22 tled to receive for disability commencing on or after July first, nine-
23 teen hundred eighty-three and prior to July first, nineteen hundred
24 eighty-four shall be one-half of the employee's average weekly wage, but
25 in no case shall such benefit exceed one hundred thirty-five dollars nor
26 be less than twenty dollars; except that if the employee's average week-
27 ly wage is less than twenty dollars the benefit shall be such average
28 weekly wage. The weekly benefit which the disabled employee is entitled
29 to receive for disability commencing on or after July first, nineteen
30 hundred seventy-four, and prior to July first, nineteen hundred eighty-
31 three, shall be one-half of the employee's average weekly wage, but in
32 no case shall such benefit exceed ninety-five dollars nor be less than
33 twenty dollars; except that if the employee's average weekly wage is
34 less than twenty dollars, the benefit shall be such average weekly wage.
35 The weekly benefit which the disabled employee is entitled to receive
36 for disability commencing on or after July first, nineteen hundred
37 seventy and prior to July first, nineteen hundred seventy-four shall be
38 one-half of the employee's average weekly wage, but in no case shall
39 such benefit exceed seventy-five dollars nor be less than twenty
40 dollars; except that if the employee's average weekly wage is less than
41 twenty dollars the benefit shall be such average weekly wage. For any
42 period of disability less than a full week, the benefits payable shall
43 be calculated by dividing the weekly benefit by the number of the
44 employee's normal work days per week and multiplying the quotient by the
45 number of normal work days in such period of disability. The weekly
46 benefit for a disabled employee who is concurrently eligible for bene-
47 fits in the employment of more than one covered employer shall, within
48 the maximum and minimum herein provided, be one-half of the total of the
49 employee's average weekly wages received from all such covered employ-
50 ers, and shall be allocated in the proportion of their respective aver-
51 age weekly wage payments.

52 S 6. Section 205 of the workers' compensation law, as added by chapter
53 600 of the laws of 1949, subdivision 1 as amended by chapter 651 of the
54 laws of 1958, subdivision 2 as amended by chapter 270 of the laws of
55 1990, subdivision 5 as amended by chapter 288 of the laws of 1970, and

1 subdivisions 3, 4, 5, 6, 7 and 8 as renumbered by chapter 352 of the
2 laws of 1981, is amended to read as follows:

3 S 205. Disabilities, FAMILY LEAVE and [disability] periods for which
4 benefits are not payable. 1. No employee shall be entitled to DISABILITY
5 benefits under this article:

6 [1.] (A) For more than twenty-six weeks MINUS ANY DAYS TAKEN FOR FAMI-
7 LY LEAVE DURING ANY FIFTY-TWO CONSECUTIVE CALENDAR WEEKS during a period
8 of fifty-two consecutive calendar weeks or during any one period of
9 disability, OR FOR MORE THAN TWENTY-SIX WEEKS;

10 [2.] (B) for any period of disability during which an employee is not
11 under the care of a duly licensed [physician or with respect to disabil-
12 ity resulting from a condition of the foot which may lawfully be treated
13 by a duly registered and licensed podiatrist of the state of New York or
14 with respect to a disability resulting from a condition which may
15 lawfully be treated by a duly registered and licensed chiropractor of
16 the state of New York or with respect to a disability resulting from a
17 condition which may lawfully be treated by a duly licensed dentist of
18 the state of New York or with respect to a disability resulting from a
19 condition which may lawfully be treated by a duly registered and
20 licensed psychologist of the state of New York or with respect to a
21 disability resulting from a condition which may lawfully be treated by a
22 duly certified nurse midwife, for any period of such disability during
23 which an employee is neither under the care of a physician nor a podia-
24 trist, nor a chiropractor, nor a dentist, nor a psychologist, nor a
25 certified nurse midwife] HEALTH CARE PROVIDER; and for any period of
26 disability during which an employee who adheres to the faith or teach-
27 ings of any church or denomination and who in accordance with its creed,
28 tenets or principles depends for healing upon prayer through spiritual
29 means alone in the practice of religion, is not under the care of a
30 practitioner duly accredited by the church or denomination, and provided
31 such employee shall submit to all physical examinations as required by
32 this chapter.

33 2. NO EMPLOYEE SHALL BE ENTITLED TO FAMILY LEAVE BENEFITS UNDER THIS
34 ARTICLE:

35 (A) FOR MORE THAN TWELVE WEEKS DURING A PERIOD OF FIFTY-TWO CONSEC-
36 UTIVE CALENDAR WEEKS, OR FOR ANY PERIOD IN WHICH THE FAMILY LEAVE
37 COMBINED WITH THE DISABILITY BENEFITS PREVIOUSLY PAID EXCEEDS TWENTY-SIX
38 WEEKS DURING THE SAME FIFTY-TWO CONSECUTIVE CALENDAR WEEKS;

39 (B) FOR ANY PERIOD OF FAMILY LEAVE WHEREIN THE NOTICE AND MEDICAL
40 CERTIFICATION AS PRESCRIBED BY THE CHAIR HAS NOT BEEN FILED. AT THE
41 DISCRETION OF THE CHAIR OR CHAIR'S DESIGNEE, THE FAMILY MEMBER WHO IS
42 THE RECIPIENT OF CARE MAY BE REQUIRED TO SUBMIT TO A PHYSICAL EXAMINA-
43 TION BY A QUALIFIED HEALTH CARE PROVIDER. SUCH EXAMINATION SHALL BE PAID
44 FOR BY THE CARRIER.

45 (C) AS A CONDITION OF AN EMPLOYEE'S INITIAL RECEIPT OF FAMILY LEAVE
46 BENEFITS DURING ANY FIFTY-TWO CONSECUTIVE CALENDAR WEEKS IN WHICH AN
47 EMPLOYEE IS ELIGIBLE FOR THESE BENEFITS, AN EMPLOYER MAY OFFER AN
48 EMPLOYEE WHO HAS ACCRUED BUT UNUSED VACATION TIME OR PERSONAL LEAVE
49 AVAILABLE AT THE TIME OF USE OF AVAILABLE FAMILY LEAVE TO CHOOSE WHETHER
50 TO CHARGE ALL OR PART OF THE FAMILY LEAVE TIME TO ACCRUED BUT UNUSED
51 VACATION OR PERSONAL LEAVE, AND RECEIVE FULL SALARY, OR TO NOT CHARGE
52 TIME TO ACCRUED BUT UNUSED VACATION OR PERSONAL LEAVE, AND RECEIVE THE
53 BENEFIT AS SET FORTH IN SECTION TWO HUNDRED FOUR OF THIS ARTICLE. AN
54 EMPLOYER THAT PAYS FULL SALARY DURING A PERIOD OF FAMILY LEAVE MAY
55 REQUEST REIMBURSEMENT IN ACCORDANCE WITH SECTION TWO HUNDRED THIRTY-SEV-
56 EN OF THIS ARTICLE. WITH THE ELECTION OF EITHER OPTION, THE EMPLOYEE

1 SHALL RECEIVE THE FULL PROTECTION OF THE REINSTATEMENT PROVISION SET
2 FORTH IN SECTION TWO HUNDRED THREE-B OF THIS ARTICLE, AND SHALL CONCUR-
3 RENTLY USE AVAILABLE FAMILY MEDICAL LEAVE ACT AND PAID FAMILY LEAVE
4 CREDITS. IN NO EVENT CAN AN EMPLOYEE UTILIZE FAMILY LEAVE BEYOND THE
5 TWELVE WEEKS PER ANY FIFTY-TWO WEEK PERIOD SET FORTH IN THIS ARTICLE.
6 THIS PARAGRAPH MAY NOT BE CONSTRUED IN A MANNER THAT RELIEVES AN EMPLOY-
7 ER OF ANY DUTY OF COLLECTIVE BARGAINING THE EMPLOYER MAY HAVE WITH
8 RESPECT TO THE SUBJECT MATTER OF THIS PARAGRAPH.

9 3. NO EMPLOYEE SHALL BE ENTITLED TO DISABILITY OR FAMILY LEAVE BENE-
10 FITS UNDER THIS ARTICLE:

11 (A) for any disability occasioned by the wilful intention of the
12 employee to bring about injury to or the sickness of himself or another,
13 or resulting from any injury or sickness sustained in the perpetration
14 by the employee of an illegal act;

15 [4.] (B) for any day of disability OR FAMILY LEAVE during which the
16 employee performed work for remuneration or profit;

17 [5.] (C) for any day of disability OR FAMILY LEAVE for which the
18 employee is entitled to receive from his OR HER employer, or from a fund
19 to which the employer has contributed, remuneration or maintenance in an
20 amount equal to or greater than that to which he OR SHE would be enti-
21 tled under this article; but any voluntary contribution or aid which an
22 employer may make to an employee or any supplementary benefit paid to an
23 employee pursuant to the provisions of a collective bargaining agreement
24 or from a trust fund to which contributions are made pursuant to the
25 provisions of a collective bargaining agreement shall not be considered
26 as continued remuneration or maintenance for this purpose;

27 [6.] (D) for any period in respect to which such employee is subject
28 to suspension or disqualification of the accumulation of unemployment
29 insurance benefit rights, or would be subject if he OR SHE were eligible
30 for such benefit rights, except for ineligibility resulting from the
31 employee's disability;

32 [7.] (E) for any disability due to any act of war, declared or unde-
33 clared[, if such act shall occur after June thirtieth, nineteen hundred
34 fifty];

35 [8.] (F) for any disability OR FAMILY LEAVE commencing before the
36 employee becomes eligible to benefits [hereunder or commencing prior to
37 July first, nineteen hundred fifty, but this shall not preclude benefits
38 for recurrence after July first, nineteen hundred fifty, of a disability
39 commencing prior thereto] UNDER THIS SECTION.

40 4. AN EMPLOYEE WHO HAS GIVEN BIRTH MAY USE NO MORE THAN A COMBINED
41 TWELVE WEEKS PURSUANT TO SUBDIVISION ONE FOR RECOVERY FROM CHILDBIRTH
42 AND SUBDIVISION TWO FOR BONDING WITH THE CHILD AS PERMITTED UNDER SUBDI-
43 VISION FIFTEEN OF SECTION 201, DURING ANY FIFTY-TWO CONSECUTIVE CALENDAR
44 WEEKS. AN EMPLOYEE MAY NOT SEEK BENEFITS CONCURRENTLY UNDER BOTH SUBDI-
45 VISIONS ONE AND TWO OF THIS SECTION.

46 S 7. Section 206 of the workers' compensation law, as amended by chap-
47 ter 699 of the laws of 1956, paragraph (a) of subdivision 1 as separate-
48 ly amended by chapters 699 and 929 of the laws of 1956 and subdivision 2
49 as amended by chapter 24 of the laws of 1988, is amended to read as
50 follows:

51 S 206. Non-duplication of benefits. 1. No DISABILITY benefits shall be
52 payable under section two hundred four or two hundred seven OF THIS
53 ARTICLE:

54 (a) in a weekly benefit amount which, together with any amount that
55 the employee receives or is entitled to receive for the same period or
56 any part thereof as a permanent disability benefit or annuity under any

1 governmental system or program, except under a veteran's disability
2 program, or under any permanent disability policy or program of an
3 employer for whom he OR SHE has performed services, would, if appor-
4 tioned to weekly periods, exceed his OR HER weekly benefit amount [here-
5 under] UNDER THIS SECTION, provided however, that there shall be no
6 offset against the benefits set forth in this article if the claim for
7 disability benefits is based on a disability other than the permanent
8 disability for which the aforesaid permanent disability benefit or annu-
9 ity was granted;

10 (b) with respect to any week for which payments are received under the
11 unemployment insurance law or similar law of this state or of any other
12 state or of the United States;

13 (c) subject to the provisions of subdivision two of this section, for
14 any period with respect to which benefits, compensation or other allow-
15 ances (other than [workmen's] WORKERS' compensation benefits for a
16 permanent partial disability occurring prior to the disability for which
17 benefits are claimed hereunder) are paid or payable under this chapter,
18 the volunteer [firemen's] FIREFIGHTERS' benefit law, or any other [work-
19 men's] WORKERS' compensation act, occupational disease act or similar
20 law, or under any employers' liability act or similar law; under any
21 other temporary disability or cash sickness benefits act or similar law;
22 under section six hundred eighty-eight, title forty-six, United States
23 code; under the federal employers' liability act; or under the maritime
24 doctrine of maintenance, wages and cure.

25 2. If an employee who is eligible for DISABILITY benefits under
26 section two hundred three or two hundred seven OF THIS ARTICLE is disa-
27 bled and has claimed or subsequently claims workers' compensation bene-
28 fits under this chapter or benefits under the volunteer firefighters'
29 benefit law or the volunteer ambulance workers' benefit law, and such
30 claim is controverted on the ground that the employee's disability was
31 not caused by an accident that arose out of and in the course of his
32 employment or by an occupational disease, or by an injury in line of
33 duty as a volunteer firefighter or volunteer ambulance worker, the
34 employee shall be entitled in the first instance to receive benefits
35 under this article for his OR HER disability. If benefits have been paid
36 under this article in respect to a disability alleged to have arisen out
37 of and in the course of the employment or by reason of an occupational
38 disease, or in line of duty as a volunteer firefighter or a volunteer
39 ambulance worker, the employer or carrier or the chairman making such
40 payment may, at any time before award of workers' compensation benefits,
41 or volunteer firefighters' benefits or volunteer ambulance workers'
42 benefits, is made, file with the board a claim for reimbursement out of
43 the proceeds of such award to the employee for the period for which
44 disability benefits were paid to the employee under this article, and
45 shall have a lien against the award for reimbursement, notwithstanding
46 the provisions of section thirty-three of this chapter or section twenty-
47 three of the volunteer firefighters' benefit law or section twenty-
48 three of the volunteer ambulance workers' benefit law provided the
49 insurance carrier liable for payment of the award receives, before such
50 award is made, a copy of the claim for reimbursement from the employer,
51 carrier or [chairman] CHAIR who paid disability benefits, or provided
52 the board's decision and award directs such reimbursement therefrom.

53 3. NO FAMILY LEAVE BENEFITS SHALL BE PAYABLE UNDER SECTION TWO HUNDRED
54 FOUR OF THIS ARTICLE:

55 (A) DURING PERIODS WHEN THE EMPLOYEE IS RECEIVING WORKERS' COMPEN-
56 SATION LOST WAGE BENEFITS, OR BENEFITS UNDER THE VOLUNTEER FIREFIGHTERS'

1 BENEFIT LAW OR THE VOLUNTEER AMBULANCE WORKERS' BENEFIT LAW OR UNDER ANY
2 STATE'S LAW;

3 (B) TO AN EMPLOYEE WHO IS NOT EMPLOYED OR IS ON ADMINISTRATIVE LEAVE
4 FROM HIS OR HER EMPLOYMENT;

5 (C) TO AN EMPLOYEE DURING PERIODS WHERE THE EMPLOYEE IS COLLECTING
6 SICK PAY OR PAID TIME OFF FROM THE EMPLOYER; AND

7 (D) FOR ANY DAY IN WHICH CLAIMANT WORKS AT LEAST PART OF THAT DAY FOR
8 RENUMERATION OR PROFIT.

9 4. UNLESS OTHERWISE EXPRESSLY PERMITTED BY THE EMPLOYER, BENEFITS
10 AVAILABLE UNDER 29 U.S. CODE CHAPTER 28 (THE FAMILY AND MEDICAL LEAVE
11 ACT) MUST BE USED CONCURRENTLY WITH FAMILY LEAVE BENEFITS. AN EMPLOYER
12 SHALL NOT BE REQUIRED TO PERMIT TWELVE ADDITIONAL WEEKS OF BENEFITS
13 FOLLOWING EXHAUSTION OF THE TWELVE WEEKS OF PAID FAMILY LEAVE BENEFITS.

14 5. A COVERED EMPLOYER IS NOT REQUIRED TO PERMIT MORE THAN ONE EMPLOYEE
15 TO USE THE SAME PERIOD OF FAMILY LEAVE TO CARE FOR THE SAME FAMILY
16 MEMBER.

17 S 8. Section 207 of the workers' compensation law is amended by adding
18 a new subdivision 5 to read as follows:

19 5. THE FOREGOING PROVISIONS OF THIS SECTION SHALL NOT APPLY TO FAMILY
20 LEAVE BENEFITS, AS FAMILY LEAVE BENEFITS ARE NOT AVAILABLE TO EMPLOYEES
21 THAT ARE NOT EMPLOYED AT THE TIME FAMILY LEAVE IS REQUESTED BY FILING
22 THE NOTICE AND MEDICAL CERTIFICATION REQUIRED BY THE CHAIR.

23 S 9. Section 208 of the workers' compensation law, as added by chapter
24 600 of the laws of 1949, subdivision 1 as amended by chapter 314 of the
25 laws of 2010, is amended to read as follows:

26 S 208. Payment of disability AND FAMILY LEAVE benefits. 1. Benefits
27 provided under this article shall be paid periodically and promptly and,
28 except as to a contested period of disability OR FAMILY LEAVE, without
29 any decision by the board, OR DESIGNEE OF THE CHAIR. The first payment
30 of benefits shall be due on the fourteenth day of disability OR FAMILY
31 LEAVE and benefits for that period shall be paid directly to the employ-
32 ee within four business days thereafter or within four business days
33 after the filing of required proof of claim, whichever is the later.
34 Thereafter benefits shall be due and payable bi-weekly in like manner.
35 The [chairman] CHAIR OR CHAIR'S DESIGNEE may determine that benefits may
36 be paid monthly or semi-monthly if wages were so paid, and may authorize
37 deviation from the foregoing requirements to facilitate prompt payment
38 of benefits. Any inquiry which requires the employee's response in order
39 to continue benefits uninterrupted or unmodified shall provide a reason-
40 able time period in which to respond and include a clear and prominent
41 statement of the deadline for responding and consequences of failing to
42 respond.

43 2. The [chairman] CHAIR AND SUPERINTENDENT OF FINANCIAL SERVICES may,
44 whenever such information is deemed necessary, require any carrier to
45 file in form prescribed by the [chairman] CHAIR a report or reports as
46 to any claim or claims, including (but without limitation) dates of
47 commencement and termination of benefit payments and amount of benefits
48 paid under this article. The [chairman] CHAIR AND SUPERINTENDENT OF
49 FINANCIAL SERVICES may also require annually information in respect to
50 the aggregate of benefits paid, the number of claims allowed and disal-
51 lowed, the average benefits and duration of benefit periods, the amount
52 of payrolls covered and such other information as the [chairman] CHAIR
53 may deem necessary for the purposes of administering this article. If
54 the carrier is providing benefits in respect to more than one employer,
55 the [chairman] CHAIR AND SUPERINTENDENT OF FINANCIAL SERVICES may
56 require that such information be shown separately as to those employers

1 who are providing only benefits that are substantially the same as the
2 benefits required in this article. THE CHAIR AND SUPERINTENDENT OF
3 FINANCIAL SERVICES MAY PRESCRIBE THE FORMAT OF SUCH REPORT AND MAY
4 PROMULGATE REGULATIONS TO EFFECTUATE THIS ARTICLE.

5 S 10. Section 209 of the workers' compensation law, as added by chap-
6 ter 600 of the laws of 1949, subdivision 3 as amended by chapter 415 of
7 the laws of 1983 and subdivision 4 as amended by chapter 134 of the laws
8 of 1952, is amended to read as follows:

9 S 209. Contribution of employees for disability AND FAMILY LEAVE bene-
10 fits. 1. Every employee in the employment of a covered employer shall[,
11 on and after January first, nineteen hundred fifty,] contribute to the
12 cost of providing disability AND AFTER JANUARY FIRST, TWO THOUSAND EIGH-
13 TEEN, FAMILY LEAVE benefits under this article, to the extent and in the
14 manner herein provided.

15 2. The special contribution of each such employee to the accumulation
16 of funds to provide benefits for disabled unemployed shall be as
17 provided in subdivision one of section two hundred fourteen OF THIS
18 ARTICLE.

19 3. (A) DISABILITY BENEFITS. The contribution of each such employee to
20 the cost of disability benefits provided by this article shall be one-
21 half of one per centum of the employee's wages paid to him OR HER on and
22 after July first, nineteen hundred fifty, but not in excess of sixty
23 cents per week.

24 (B) FAMILY LEAVE BENEFITS. ON SEPTEMBER FIRST, TWO THOUSAND SEVENTEEN
25 AND ANNUALLY THEREAFTER THE SUPERINTENDENT OF FINANCIAL SERVICES SHALL
26 SET THE MAXIMUM EMPLOYEE CONTRIBUTION, USING THE REPORTS PROVIDED IN
27 SECTION TWO HUNDRED EIGHT OF THIS ARTICLE, AND CONSISTENT WITH THE PRIN-
28 CIPLE THAT THE COSTS OF FAMILY LEAVE SHOULD BE FUNDED ONE HUNDRED
29 PERCENT BY EMPLOYEE PAYROLL CONTRIBUTION.

30 4. Notwithstanding any other provision of law, the employer is author-
31 ized to collect from his OR HER employees, except as otherwise provided
32 in any plan or agreement under the provisions of subdivisions four or
33 five of section two hundred eleven OF THIS ARTICLE, the contribution
34 provided under subdivisions two and three OF THIS SECTION, through
35 payroll deductions. If the employer shall not make deduction for any
36 payroll period he OR SHE may thereafter, but not later than one month
37 after payment of wages, collect such contribution through payroll
38 deduction.

39 5. In collecting employee contributions through payroll deductions,
40 the employer shall act as the agent of his OR HER employees and shall
41 use the contributions only to provide disability AND FAMILY LEAVE bene-
42 fits as required by this article. IN NO EVENT MAY THE EMPLOYEE'S ANNUAL
43 CONTRIBUTION FOR FAMILY LEAVE EXCEED HIS OR HER PRO RATA SHARE OF THE
44 ACTUAL ANNUAL PREMIUM CHARGED FOR THE SAME YEAR AND MUST BE DETERMINED
45 CONSISTENT WITH THE PRINCIPLE THAT EMPLOYEES SHOULD PAY THE TOTAL COSTS
46 OF FAMILY LEAVE PREMIUM. IN NO EVENT MAY THE EMPLOYEE'S WEEKLY CONTRIB-
47 UTION FOR DISABILITY PREMIUM EXCEED ONE-HALF OF ONE PER CENTUM OF THE
48 EMPLOYEE'S WAGES PAID TO HIM OR HER, BUT NOT IN EXCESS OF SIXTY CENTS
49 PER WEEK. After June thirtieth, nineteen hundred fifty, if the employer
50 is not providing, or to the extent that he OR SHE is not then providing,
51 for the payment of disability benefits to his OR HER employees by insur-
52 ing with the state fund or with another insurance carrier, he OR SHE
53 shall keep the contributions of his OR HER employees as trust funds
54 separate and apart from all other funds of the employer. The payment of
55 such contributions by the employer to a carrier providing for the

1 payment of such benefits shall discharge the employer from responsibil-
2 ity with respect to such contributions.

3 S 11. Section 210 of the workers' compensation law, as added by chap-
4 ter 600 of the laws of 1949, is amended to read as follows:

5 S 210. Employer contributions. 1. Every covered employer shall, on and
6 after January first, nineteen hundred fifty, contribute the cost of
7 providing disability AND FAMILY LEAVE benefits in excess of the contrib-
8 utions collected from his OR HER employees, to the extent and in the
9 manner provided in this article.

10 2. The special contribution of each covered employer to the accumu-
11 lation of funds to provide benefits for disabled unemployed shall be as
12 provided in subdivision one of section two hundred fourteen OF THIS
13 ARTICLE.

14 3. The contribution of every covered employer to the cost of providing
15 disability benefits after June thirtieth, nineteen hundred fifty, AND
16 PROVIDING DISABILITY AND FAMILY LEAVE BENEFITS AFTER JANUARY FIRST, TWO
17 THOUSAND EIGHTEEN, shall be the excess of such cost over the amount of
18 the contributions of his OR HER employees.

19 4. No profit shall be derived by any employer or association of
20 employers or of employees from providing payment of disability AND FAMI-
21 LY LEAVE benefits under this article. All funds representing contrib-
22 utions of employers and employees, and increments thereon, held by
23 employers or associations of employers or of employees authorized or
24 permitted to pay benefits under the provisions of this article, and by
25 trustees paying benefits under plans or agreements meeting the require-
26 ments of section two hundred eleven OF THIS ARTICLE, shall be trust
27 funds and shall be expended only to provide for the payment of benefits
28 to employees and for the costs of administering this article and for the
29 support of the fund established under section two hundred fourteen OF
30 THIS ARTICLE.

31 S 12. The opening paragraph and subdivisions 3, 4 and 5 of section 211
32 of the workers' compensation law, the opening paragraph as added by
33 chapter 600 of the laws of 1949, subdivision 3 as amended by chapter 207
34 of the laws of 1992, and subdivisions 4 and 5 as amended by chapter 197
35 of the laws of 1960, are amended, and new subdivisions 7 and 8 are added
36 to read as follows:

37 A covered employer shall, with his OR HER own contributions and the
38 contributions of his employees, provide disability AND AFTER JANUARY
39 FIRST, TWO THOUSAND EIGHTEEN, FAMILY LEAVE benefits to his OR HER
40 employees in one or more of the following ways:

41 3. by furnishing satisfactory proof to the chair of the employers
42 financial ability to pay such benefits, in which case the chair shall
43 require the deposit of such securities as the chair may deem necessary
44 [of the kind prescribed in subdivisions one, two, three, four and five
45 and paragraph a of subdivision seven of section two hundred thirty-five
46 of the banking law or the deposit of cash or the filing of irrevocable
47 letters of credit issued by a qualified banking institution as defined
48 by rules promulgated by the chair or the filing of the bond of a surety
49 company authorized to do business in this state, conditioned on the
50 payment by the employer of its obligations under this article and in
51 form approved by the chair, or the posting and filing of a combination
52 of such securities, cash, irrevocable letters of credit and surety bonds
53 in an amount to be determined by the chair, to secure his or her liabil-
54 ity to pay the compensation provided in this chapter. The amount of
55 deposit or of the penal sum of the bond shall be determined by the chair
56 and shall not be less than one-half the estimated contributions of the

1 employees of the employer for the ensuing year or one-half of the
2 contributions of the employees which would have been paid by the employ-
3 ees during the preceding year, whichever is the greater, or if such
4 amount is more than fifty thousand dollars an amount not less than fifty
5 thousand dollars. The chair shall have authority to deny an application
6 to provide benefits pursuant to this subdivision or to revoke approval
7 at any time for good cause shown. In the case of an employer who main-
8 tains a deposit of securities, irrevocable letters of credit or cash in
9 accordance with subdivision three of section fifty of this chapter, the
10 chair may reduce the amount of the deposit or of the penal sum of the
11 bond, provided the securities, irrevocable letters of credit or cash
12 deposited by or for such employer under subdivision three of section
13 fifty of this chapter are, by agreement satisfactory to the chair, made
14 available for the payment of unpaid benefits under this article with
15 respect to obligations incurred for disabilities commencing prior to the
16 effective date of such revocation] CONSISTENT WITH THE PROVISIONS OF
17 SUBDIVISION THREE OF SECTION FIFTY OF THIS CHAPTER. An association of
18 employers or employees authorized to pay benefits under this article or
19 the trustee or trustees paying benefits under a plan or agreement
20 authorized under subdivisions four and five of this section, may with
21 the approval of the chair furnish such proof and otherwise comply with
22 the provisions of this section to provide disability AND FAMILY LEAVE
23 benefits to employees under such plan or agreement.

24 4. by a plan in existence on the effective date of this article. If on
25 the effective date of this article the employees of a covered employer
26 or any class or classes of such employees are entitled to receive disa-
27 bility AND FAMILY LEAVE benefits under a plan or agreement which remains
28 in effect on July first, nineteen hundred fifty, the employer, subject
29 to the requirements of this section, shall be relieved of responsibility
30 for making provision for benefit payments required under this article
31 until the earliest date, determined by the [chairman] CHAIR for the
32 purposes of this article, upon which the employer shall have the right
33 to discontinue the provisions thereof or to discontinue his contrib-
34 utions towards the cost. Any such plan or agreement may be extended,
35 with or without modification, by agreement or collective bargaining
36 between an employer or employers or association of employers and an
37 association of employees, in which event the period for which the
38 employer is relieved of such responsibility shall include such period of
39 extension. Any other plan or agreement in existence on the effective
40 date of this article which the employer may, by his OR HER sole act,
41 terminate at any time, or with respect to which he OR SHE is not obli-
42 gated to continue for any period to make contributions, may be accepted
43 by the [chairman] CHAIR as satisfying the obligation to provide for the
44 payment of benefits under this article if such plan or agreement
45 provides benefits at least as favorable as the disability AND FAMILY
46 LEAVE benefits provided by this article and does not require contrib-
47 utions of any employee or of any class or classes of employees in excess
48 of the statutory amount provided in SUBDIVISION THREE OF section two
49 hundred nine OF THIS ARTICLE, subdivision three, except by agreement and
50 provided the contribution is reasonably related to the value of the
51 benefits as determined by the CHAIR [chairman]. The [chairman] CHAIR may
52 require that the employer shall enter into an agreement in writing with
53 the [chairman] CHAIR that he OR SHE will pay the assessments set forth
54 in sections two hundred fourteen and two hundred twenty-eight and that
55 until he OR SHE shall have filed written notice with the CHAIR [chair-
56 man] of his OR HER election to terminate such plan or agreement or to

1 discontinue making necessary contributions to its cost, he OR SHE will
2 continue to provide for the payment of the disability AND FAMILY LEAVE
3 benefits under such plan or agreement.

4 During any period in which any plan or agreement or extension thereof
5 authorized under this subdivision provides for payment of benefits under
6 this article, the responsibility of the employer and the obligations and
7 benefits of the employees shall be as provided in said plan or agreement
8 rather than as provided under this article, other than the benefits
9 provided in section two hundred seven, and provided the employer or
10 carrier has agreed to pay the assessments described in sections two
11 hundred fourteen and two hundred twenty-eight.

12 Any such plan or agreement may be extended with or without modifica-
13 tion, provided the benefits under such plan or agreement, as extended or
14 modified, shall be found by the [chairman] CHAIR to be at least as
15 favorable as the benefits provided by this article.

16 5. by a new plan or agreement. After the effective date of this arti-
17 cle, a new plan or agreement with a carrier may be accepted by the CHAIR
18 [chairman] as satisfying the obligation to provide for the payment of
19 benefits under this article if such plan or agreement shall provide
20 benefits at least as favorable as the disability AND FAMILY LEAVE bene-
21 fits provided by this article and does not require contributions of any
22 employee or of any class or classes of employees in excess of the statu-
23 tory amount provided in section two hundred nine, subdivision three,
24 except by agreement and provided the contribution is reasonably related
25 to the value of the benefits as determined by the [chairman] CHAIR. Any
26 such plan or agreement shall continue until written notice filed with
27 the [chairman] CHAIR of intention to terminate such plan or agreement,
28 and any modification of such plan or agreement shall be subject to the
29 written approval of the [chairman] CHAIR.

30 During any period in which any plan or agreement or extension thereof
31 authorized under this subdivision provides for payment of benefits under
32 this article, the responsibility of the employer and the obligations and
33 benefits of the employees shall be as provided in said plan or agreement
34 rather than as provided under this article, other than the benefits
35 provided in section two hundred seven, and provided the employer or
36 carrier has agreed to pay the assessments described in sections two
37 hundred fourteen and two hundred twenty-eight.

38 7. PREMIUMS FOR POLICIES PROVIDING DISABILITY OR FAMILY LEAVE BENEFITS
39 IN ACCORDANCE WITH THIS ARTICLE SHALL BE CALCULATED IN ACCORDANCE WITH
40 APPLICABLE PROVISIONS OF THE INSURANCE LAW, INCLUDING SUBSECTION (N) OF
41 SECTION FOUR THOUSAND TWO HUNDRED AND THIRTY-FIVE OF SUCH LAW.

42 8. AN EMPLOYER PROVIDING DISABILITY BENEFITS COVERAGE PURSUANT TO
43 SUBDIVISION THREE OF THIS SECTION MAY OBTAIN COVERAGE FOR FAMILY LEAVE
44 BENEFITS SEPARATELY PURSUANT TO SUBDIVISION ONE OR SUBDIVISION TWO OF
45 THIS SECTION.

46 S 13. Subdivisions 1, 2, 4 and 5 of section 212 of the workers'
47 compensation law, subdivision 1 as amended by chapter 740 of the laws of
48 1960, subdivision 2 as amended by chapter 120 of the laws of 1969,
49 subdivision 4 as amended by chapter 205 of the laws of 1993, and subdi-
50 vision 5 as added by chapter 593 of the laws of 1992, are amended to
51 read as follows:

52 1. Any employer not required by this article to provide for the
53 payment of disability OR FAMILY LEAVE benefits to his employees, or to
54 any class or classes thereof, may become a covered employer or bring
55 within the provisions of this article such employees or class or classes
56 thereof by voluntarily electing to provide for payment of such benefits

1 in one or more of the ways set forth in section two hundred eleven OF
2 THIS ARTICLE; but such election shall be subject to the approval of the
3 [chairman] CHAIR, and if the employees are required to contribute to the
4 cost of such benefits the assent within thirty days before such approval
5 is granted, of more than one-half of such employees shall be evidenced
6 to the satisfaction of the [chairman] CHAIR. On approval by the [chair-
7 man] CHAIR of such election to provide benefits, all the provisions of
8 this article shall become and continue applicable as if the employer
9 were a covered employer as defined in this article. The obligation to
10 continue as a covered employer with respect to employees for whom
11 provision of benefits is not required under this article, may be discon-
12 tinued by such employer on ninety days notice to the [chairman] CHAIR in
13 writing and to his OR HER employees, after he OR SHE has provided for
14 payment of benefits for not less than one year and with such provision
15 for payment of obligations incurred on and prior to the termination date
16 as the [chairman] CHAIR may approve.

17 2. Notwithstanding the definition of "employer" and "employment" in
18 section two hundred one of this article, a public authority, a municipal
19 corporation or a fire district or other political subdivision may become
20 a covered employer FOR THE PURPOSE OF PROVIDING DISABILITY BENEFITS
21 under this article by complying with the provisions of subdivision one
22 of this section and may discontinue such status only as provided in that
23 subdivision.

24 4. (A) An executive officer of a corporation who at all times during
25 the period involved owns all of the issued and outstanding stock of the
26 corporation and holds all of the offices pursuant to paragraph (e) of
27 section seven hundred fifteen of the business corporation law or two
28 executive officers of a corporation who at all times during the period
29 involved between them own all of the issued and outstanding stock of
30 such corporation and hold all such offices provided, however, that each
31 officer must own at least one share of stock and who is the executive
32 officer or who are the executive officers of a corporation having other
33 persons who are employees required to be covered under this article,
34 shall be deemed to be included in the corporation's disability AND FAMI-
35 LY LEAVE benefits insurance contract or covered by a certificate of
36 self-insurance or a plan under section two hundred eleven of this arti-
37 cle, unless the officer or officers elect to be excluded from the cover-
38 age of this article. Such election shall be made by any such corporation
39 filing with the insurance carrier, or the chair of the workers' compen-
40 sation board in the case of self-insurance, upon a form prescribed by
41 the [chairman] CHAIR, a notice that the corporation elects to exclude
42 the executive officer or officers of such corporation named in the
43 notice from the coverage of this article. Such election shall be effec-
44 tive with respect to all policies issued to such corporation by such
45 insurance carrier as long as it shall continuously insure the corpo-
46 ration. Such election shall be final and binding upon the executive
47 officer or officers named in the notice until revoked by the corpo-
48 ration.

49 (B) NOTWITHSTANDING THE DEFINITION OF "EMPLOYER" IN SECTION TWO
50 HUNDRED ONE OF THIS ARTICLE, A SOLE PROPRIETOR, MEMBER OF A LIMITED
51 LIABILITY COMPANY OR LIMITED LIABILITY PARTNERSHIP, OR OTHER SELF-EM-
52 PLOYED PERSON MAY BECOME A COVERED EMPLOYER UNDER THIS ARTICLE BY
53 COMPLYING WITH THE PROVISIONS OF SUBDIVISION ONE OF THIS SECTION.

54 5. A spouse who is an employee of a covered employer shall be deemed
55 to be included in the employer's disability AND FAMILY LEAVE benefits
56 insurance contract or covered by a certificate of self-insurance or a

1 plan under section two hundred eleven of this article, unless the
2 employer elects to exclude such spouse from the coverage of this arti-
3 cle. Such election shall be made by any such employer filing with the
4 insurance carrier, or the chair of the workers' compensation board in
5 the case of self-insurance, upon a form prescribed by the chair, a
6 notice that the employer elects to exclude such spouse named in the
7 notice from the coverage of this article. Such election shall be effec-
8 tive with respect to all policies issued to such employer by such insur-
9 ance carrier as long as it shall continuously insure the employer. Such
10 election shall be final and binding upon the spouse named in the notice
11 until revoked by the employer.

12 S 14. The workers' compensation law is amended by adding new sections
13 212-a and 212-b to read as follows:

14 S 212-A. NOTWITHSTANDING THE DEFINITION OF "EMPLOYER" AND "EMPLOYMENT"
15 SET FORTH IN SECTION TWO HUNDRED ONE OF THIS ARTICLE AND THE REQUIREMENT
16 FOR INSURANCE POLICIES TO OFFER BOTH DISABILITY AND FAMILY LEAVE COVER-
17 AGE SET FORTH IN TWO HUNDRED TWENTY SIX OF THIS ARTICLE, THE STATE, ANY
18 POLITICAL SUBDIVISION OF THE STATE, A PUBLIC AUTHORITY OR ANY OTHER
19 GOVERNMENTAL AGENCY OR INSTRUMENTALITY, MAY ELECT TO BECOME A COVERED
20 EMPLOYER SOLELY FOR THE PURPOSE OF FAMILY LEAVE BENEFITS. COVERAGE FOR
21 FAMILY LEAVE BENEFITS MAY BE SECURED BY A PUBLIC EMPLOYER, AS THAT TERM
22 IS DEFINED IN SUBDIVISION ONE OF SECTION TWO HUNDRED TWELVE-B OF THIS
23 ARTICLE, AS PERMITTED BY THIS ARTICLE, INCLUDING AS APPLICABLE SECTION
24 TWO HUNDRED ELEVEN, SUBDIVISION FOUR OF SECTION FIFTY, OR SECTION EIGHT-
25 Y-EIGHT-C. THE PROVIDER OF FAMILY LEAVE COVERAGE FOR SUCH PUBLIC EMPLOY-
26 EES SHALL BE EXEMPT FROM THE REQUIREMENT THAT INSURANCE POLICIES OFFER
27 BOTH DISABILITY AND FAMILY LEAVE BENEFITS IN SECTION TWO HUNDRED TWEN-
28 TY-SIX OF THIS ARTICLE.

29 S 212-B. PUBLIC EMPLOYEES; PUBLIC EMPLOYEES REPRESENTED BY AN EMPLOYEE
30 ORGANIZATION; EMPLOYEE OPT IN.

31 1. FOR PURPOSES OF THIS SECTION, "PUBLIC EMPLOYEE" MEANS ANY EMPLOYEE
32 OF THE STATE, ANY POLITICAL SUBDIVISION OF THE STATE, A PUBLIC AUTHORITY
33 OR ANY OTHER GOVERNMENTAL AGENCY OR INSTRUMENTALITY. "PUBLIC EMPLOYER"
34 MEANS THE STATE, ANY POLITICAL SUBDIVISION OF THE STATE, A PUBLIC
35 AUTHORITY OR ANY OTHER GOVERNMENTAL AGENCY OR INSTRUMENTALITY THEREOF.
36 "EMPLOYEE ORGANIZATION" SHALL HAVE THE SAME MEANING SET FORTH IN SECTION
37 TWO HUNDRED ONE OF THE CIVIL SERVICE LAW.

38 2. PUBLIC EMPLOYERS SHALL PROVIDE BENEFITS FOR FAMILY LEAVE TO PUBLIC
39 EMPLOYEES IN ACCORDANCE WITH THE PROCEDURES AND TERMS SET FORTH IN
40 SUBDIVISION THREE OF THIS SECTION.

41 3. (A) AN EMPLOYEE ORGANIZATION MAY, PURSUANT TO COLLECTIVE BARGAIN-
42 ING, OPT IN TO PAID FAMILY LEAVE BENEFITS ON BEHALF OF THOSE PUBLIC
43 EMPLOYEES IT IS EITHER CERTIFIED OR RECOGNIZED, WITHIN THE MEANING OF
44 ARTICLE 14 OF THE CIVIL SERVICE LAW, TO REPRESENT AT ANY TIME THAT IS
45 MUTUALLY AGREED UPON BETWEEN THE EMPLOYEE ORGANIZATION AND ANY PUBLIC
46 EMPLOYER. AN EMPLOYEE ORGANIZATION THAT HAS OPTED IN TO PAID FAMILY
47 LEAVE BENEFITS MAY, PURSUANT TO COLLECTIVE BARGAINING, OPT OUT OF IT AS
48 IS MUTUALLY AGREED UPON BETWEEN THE EMPLOYEE ORGANIZATION AND ANY PUBLIC
49 EMPLOYER.

50 B. FOR PUBLIC EMPLOYEES WHO ARE NOT REPRESENTED BY AN EMPLOYEE ORGAN-
51 IZATION, THE PUBLIC EMPLOYER MAY OPT-IN TO PAID FAMILY LEAVE BENEFITS
52 WITHIN NINETY DAYS NOTICE TO SUCH PUBLIC EMPLOYEES. FOLLOWING OPT-IN BY
53 A PUBLIC EMPLOYER FOR PUBLIC EMPLOYEES NOT REPRESENTED BY AN EMPLOYEE
54 ORGANIZATION, THE PUBLIC EMPLOYER MAY OPT-OUT OF PAID FAMILY LEAVE BENE-
55 FITS WITH TWELVE MONTHS NOTICE TO THOSE PUBLIC EMPLOYEES.

1 4. IN THE ABSENCE OF ANY CONTRARY STATEMENT IN A COLLECTIVELY NEGOTI-
2 ATED AGREEMENT UNDER ARTICLE FOURTEEN OF THE CIVIL SERVICE LAW, A PUBLIC
3 EMPLOYER MAY REQUIRE PUBLIC EMPLOYEES WHO OPT IN UNDER THIS SECTION TO
4 PROVIDE THE MAXIMUM EMPLOYEE CONTRIBUTION, AS DEFINED IN PARAGRAPH (B)
5 OF SUBDIVISION THREE OF SECTION TWO HUNDRED NINE OF THIS ARTICLE.

6 S 15. Subdivision 1 of section 213 of the workers' compensation law,
7 as amended by chapter 784 of the laws of 1980, is amended and a new
8 subdivision 3 is added to read as follows:

9 1. Whenever a covered employer does not comply with this article by
10 providing for the payment of disability AND FAMILY LEAVE benefits to his
11 OR HER employees in one or more of the ways provided in section two
12 hundred eleven OF THIS ARTICLE or whenever a carrier fails to pay the
13 benefits required by this article to employees of a covered employer,
14 then such employer shall be fully and directly liable to each of his OR
15 HER employees for the payment of benefits provided by this article. The
16 amount of the benefits to which employees of such employers are entitled
17 under this article and attendance fees of [their] ANY attending [physi-
18 cians or attending podiatrists] HEALTH CARE PROVIDER fixed pursuant to
19 subdivision two of section two hundred thirty-two OF THIS ARTICLE shall,
20 on order of the [chairman] CHAIR, be paid out of the fund established
21 under section two hundred fourteen OF THIS ARTICLE. In case of non-com-
22 pliance of the employer, such employer shall forthwith pay to the
23 [chairman] CHAIR, for credit to the fund, the sum so expended or one
24 [per cent] PERCENT of his OR HER payroll for his OR HER employees in
25 employment during the period of non-compliance, whichever is greater;
26 provided, however, that if it shall appear to the satisfaction of the
27 [chairman] CHAIR that the default in payment of benefits or the non-com-
28 pliance of the employer otherwise with his OR HER obligation under this
29 article was inadvertent, the [chairman] CHAIR may fix the sum payable in
30 such case for non-compliance or default at the amount paid out of the
31 fund and a sum less than one [per cent] PERCENT of such payroll, and in
32 addition the penalties for non-compliance imposed under this article. In
33 case of failure of the carrier to pay benefits, the employer shall
34 forthwith pay to the [chairman] CHAIR, for credit to the fund, the sum
35 so expended.

36 3. THE PROVISIONS OF SECTION ONE HUNDRED FORTY-ONE-B OF THIS CHAPTER
37 SHALL NOT APPLY TO VIOLATIONS OF THIS SECTION AFTER JANUARY FIRST, TWO
38 THOUSAND EIGHTEEN AND BEFORE JANUARY FIRST, TWO THOUSAND TWENTY. THERE-
39 AFTER, IN THE EVENT AN EMPLOYER IS SUBJECT TO DEBARMENT SOLELY DUE TO A
40 PENALTY FOR VIOLATION OF THIS SECTION, THE CHAIR MAY, IN THE INTERESTS
41 OF JUSTICE, RESTORE THE EMPLOYER'S ELIGIBILITY TO SUBMIT A BID ON OR BE
42 AWARDED ANY PUBLIC WORK CONTRACT OR SUBCONTRACT. THE CHAIR MAY EXERCISE
43 THIS AUTHORITY ONLY IF IT IS THE EMPLOYER'S FIRST TIME VIOLATION OF
44 SECTION ONE HUNDRED FORTY-ONE-B OF THIS CHAPTER; THE EMPLOYER IS NOT
45 LIABLE FOR ANY OUTSTANDING WORKERS' COMPENSATION, DISABILITY OR FAMILY
46 LEAVE CLAIMS AS A RESULT OF THE LACK OF COVERAGE; AND THE EMPLOYER HAS
47 PAID ALL FINES, ASSESSMENTS, AND PENALTIES ASSOCIATED WITH THE LACK OF
48 COVERAGE.

49 S 16. Section 217 of the workers' compensation law, as added by chap-
50 ter 600 of the laws of 1949, subdivision 1 as amended by chapter 167 of
51 the laws of 1999, subdivisions 2 and 3 as amended by chapter 270 of the
52 laws of 1990, and subdivision 6 as amended by chapter 344 of the laws of
53 1994, is amended to read as follows:

54 S 217. Notice and proof of claim. 1. Written notice and proof of
55 disability OR PROOF OF NEED FOR FAMILY LEAVE shall be furnished to the
56 employer by or on behalf of the employee claiming benefits or, in the

1 case of a claimant under section two hundred seven of this article, to
2 the chair, within thirty days after commencement of the period of disa-
3 bility. Additional proof shall be furnished thereafter from time to time
4 as the employer or carrier or chair may require but not more often than
5 once each week. Such proof shall include a statement of disability by
6 the employee's [attending physician or attending podiatrist or attending
7 chiropractor or attending dentist or attending psychologist or attending
8 certified nurse midwife] OR FAMILY LEAVE CARE RECIPIENT'S HEALTH CARE
9 PROVIDER, or in the case of an employee who adheres to the faith or
10 teachings of any church or denomination, and who in accordance with its
11 creed, tenets or principles depends for healing upon prayer through
12 spiritual means alone in the practice of religion, by an accredited
13 practitioner, containing facts and opinions as to such disability in
14 compliance with regulations of the chair. Failure to furnish notice or
15 proof within the time and in the manner above provided shall not invali-
16 date the claim but no benefits shall be required to be paid for any
17 period more than two weeks prior to the date on which the required proof
18 is furnished unless it shall be shown to the satisfaction of the chair
19 not to have been reasonably possible to furnish such notice or proof and
20 that such notice or proof was furnished as soon as possible; provided,
21 however, that no benefits shall be paid unless the required proof of
22 disability is furnished within [twenty-six weeks after commencement of
23 the period of disability] THE PERIOD OF ACTUAL DISABILITY OR FAMILY
24 LEAVE THAT DOES NOT EXCEED THE STATUTORY MAXIMUM PERIOD PERMITTED UNDER
25 SECTION TWO HUNDRED FIVE OF THIS ARTICLE. No limitation of time
26 provided in this section shall run as against any [person] DISABLED
27 EMPLOYEE who is mentally incompetent, or physically incapable of provid-
28 ing such notice as a result of a serious medical condition, or a minor
29 so long as such person has no guardian of the person and/or property.

30 2. An employee claiming DISABILITY benefits shall, as requested by the
31 employer or carrier, submit himself or herself at intervals, but not
32 more than once a week, for examination by [a physician or podiatrist or
33 chiropractor or dentist or psychologist or certified nurse midwife] AN
34 ACCREDITED HEALTH CARE PROVIDER designated by the employer or carrier.
35 All such examinations shall be without cost to the employee and shall be
36 held at a reasonable time and place.

37 3. The chair OR CHAIR'S DESIGNEE may direct the claimant OR FAMILY
38 LEAVE CARE RECIPIENT to submit to examination by a [physician or podia-
39 trist or chiropractor or dentist or psychologist] HEALTH CARE PROVIDER
40 designated by him or her in any case in which the claim to disability OR
41 FAMILY LEAVE benefits is contested and in claims arising under section
42 two hundred seven OF THIS ARTICLE, and in other cases as the chair or
43 board may require.

44 4. Refusal of the claimant OR FAMILY LEAVE CARE RECIPIENT without good
45 cause to submit to any such examination shall disqualify [him] THE
46 CLAIMANT OR EMPLOYEE from all benefits hereunder for the period of such
47 refusal, except as to benefits already paid.

48 5. If benefits required to be paid by this article have been paid to
49 an employee, further payments for the same disability OR FAMILY LEAVE
50 shall not be barred solely because of failure to give notice or to file
51 proof of disability for the period or periods for which such benefits
52 have been paid.

53 6. In the event that a claim for benefits is rejected, the carrier or
54 employer shall send by first class mail written notice of rejection to
55 the [claimant] EMPLOYEE within forty-five days of receipt of proof of
56 disability. Failure to mail such written notice of rejection within the

1 time provided, shall bar the employer or carrier from contesting enti-
2 tlement to benefits for any period of disability prior to such notice
3 but such failure may be excused by the [chairman] CHAIR if it can be
4 shown to the satisfaction of the [chairman] CHAIR not to have been
5 reasonably possible to mail such notice and that such notice was mailed
6 as soon as possible. Such notice shall include a statement, in a form
7 prescribed by the [chairman] CHAIR, to the effect that the [claimant]
8 EMPLOYEE may, for the purpose of review [by the board], file [with the
9 chairman] notice that his or her claim has not been paid AS SET FORTH IN
10 SECTION TWO HUNDRED TWENTY-ONE OF THIS ARTICLE.

11 S 17. Section 219 of the workers' compensation law, as amended by
12 chapter 688 of the laws of 1953, is amended to read as follows:

13 S 219. Enforcement of payment in default. In case of a default in the
14 payment of any benefits, assessments or penalties payable under this
15 article by an employer who has failed to comply with the provisions of
16 section two hundred eleven of this [chapter] ARTICLE or refusal of such
17 employer to reimburse the fund under section two hundred fourteen OF
18 THIS ARTICLE for the expenditures made therefrom pursuant to section two
19 hundred thirteen OF THIS ARTICLE or to deposit within ten days after
20 demand the estimated value of benefits not presently payable, the
21 [chairman] CHAIR may file with the county clerk for the county in which
22 the employer has his principal place of business (1) a certified copy of
23 the decision of the board, OR ALTERNATIVE DISPUTE RESOLUTION ASSOCIATION
24 DESIGNATED BY THE CHAIR PURSUANT TO SECTION TWO HUNDRED TWENTY-ONE OF
25 THIS ARTICLE, or order of the [chairman] CHAIR, or (2) a certified copy
26 of the demand for deposit of security, and thereupon judgment must be
27 entered in the supreme court by the clerk of such county in conformity
28 therewith immediately upon such filing.

29 S 18. Section 220 of the workers' compensation law, as added by chap-
30 ter 600 of the laws of 1949, subdivision 1 as amended by chapter 387 of
31 the laws of 1984, subdivision 2 as amended by chapter 626 of the laws of
32 1979, subdivision 3 as amended by chapter 415 of the laws of 1983,
33 subdivision 4 as amended by chapter 645 of the laws of 1981, subdivision
34 5 as amended by chapter 940 of the laws of 1973, subdivision 7 as
35 amended by chapter 61 of the laws of 1989 and subdivision 8 as amended
36 by chapter 213 of the laws of 1993, is amended to read as follows:

37 S 220. Penalties. 1. Any employer who fails to make provision for
38 payment of disability OR FAMILY LEAVE benefits as required by section
39 two hundred eleven of this article within ten days following the date on
40 which such employer becomes a covered employer as defined in section two
41 hundred two OF THIS ARTICLE shall be guilty of a misdemeanor and upon
42 conviction be punishable by a fine of not less than one hundred nor more
43 than five hundred dollars or imprisonment for not more than one year or
44 both, except that where any person has previously been convicted of a
45 failure to make provisions for payment of disability OR FAMILY LEAVE
46 benefits within the preceding five years, upon conviction for a second
47 violation such person shall be fined not less than two hundred fifty nor
48 more than one thousand two hundred fifty dollars in addition to any
49 other penalties including fines otherwise provided by law, and upon
50 conviction for a third or subsequent violation such person may be fined
51 up to two thousand five hundred dollars in addition to any other penal-
52 ties including fines otherwise provided by law. Where the employer is a
53 corporation, the president, secretary, treasurer, or officers exercising
54 corresponding functions, shall each be liable under this section.

55 2. The [chairman] CHAIR or any officer of the board designated by him
56 OR HER, upon finding that an employer has failed to make provision for

1 the payment of disability OR FAMILY LEAVE benefits, shall impose upon
2 such employer a penalty not in excess of a sum equal to one-half of one
3 per centum of his OR HER weekly payroll for the period of such failure
4 and a further sum not in excess of five hundred dollars, which sums
5 shall be paid into the fund created under section two hundred fourteen
6 OF THIS ARTICLE.

7 3. If for the purpose of obtaining any benefit or payment under the
8 provisions of this article, or for the purpose of influencing any deter-
9 mination regarding any benefit payment, either for himself OR HERSELF or
10 any other person, any person, employee, employer or carrier wilfully
11 makes a false statement or representation or fails to disclose a materi-
12 al fact, he OR SHE shall be guilty of a misdemeanor.

13 4. Whenever a carrier shall fail to make prompt payment of disability
14 OR FAMILY LEAVE benefits payable under this article and after [hearing
15 before an officer designated by the chairman] A DETERMINATION BY THE
16 CHAIR'S DESIGNEE for that purpose, the [chairman] CHAIR OR DESIGNEE
17 shall determine that failure to make such prompt payment was without
18 just cause, the [chairman] CHAIR OR DESIGNEE shall collect from the
19 carrier a sum not in excess of twenty-five per centum of the amount of
20 the benefits as to which the carrier failed to make payment, which sum
21 shall be credited to the special fund for disability benefits. In addi-
22 tion, the [chairman] CHAIR OR DESIGNEE may collect and pay over to the
23 employee the sum of ten dollars in respect to each week, or fraction
24 thereof, for which benefits have not been promptly paid.

25 5. In addition to other penalties herein provided, the [chairman]
26 CHAIR OR DESIGNEE shall remove from the list of [physicians] HEALTH CARE
27 PROVIDERS authorized to render medical care under the provisions [of
28 articles one to eight, inclusive,] of this chapter [and from the list of
29 podiatrists authorized to render podiatric care under section thirteen-k
30 of this chapter, and from the list of chiropractors authorized to render
31 chiropractic care under section thirteen-l of this chapter the name of
32 any physician or podiatrist or chiropractor] whom [he] THE CHAIR OR
33 DESIGNEE shall find, after reasonable investigation, has submitted to
34 the employer or carrier or [chairman] CHAIR in connection with any claim
35 for disability benefits under this article, a statement of disability
36 that is not truthful and complete.

37 6. In addition to other penalties herein provided, any person who for
38 the purpose of obtaining any benefit or payment under this article or
39 for the purpose of influencing any determination regarding any benefit
40 payment, knowingly makes a false statement with regard to a material
41 fact, shall not be entitled to receive benefits with respect to the
42 disability claimed or any disability benefits during the period of
43 twelve calendar months thereafter; but this penalty shall not be applied
44 more than once with respect to each such offense.

45 7. All fines imposed under subdivisions one and three OF THIS SECTION,
46 except as herein otherwise provided, shall be paid directly and imme-
47 diately by the officer collecting the same to the chair, and be paid
48 into the state treasury, provided, however, that all such fines
49 collected by justices of the peace of towns and police justices of
50 villages shall be paid to the state comptroller in accordance with the
51 provisions of section twenty-seven of the town law [and section one
52 hundred eighty-five of the village law, respectively].

53 8. (a) The head of a state or municipal department, board, commission
54 or office authorized or required by law to issue any permit for or in
55 connection with any work involving the employment of employees in
56 employment as defined in this article, and notwithstanding any general

1 or special statute requiring or authorizing the issue of such permits,
2 shall not issue such permit unless proof duly subscribed by an insurance
3 carrier is produced in a form satisfactory to the chair, that the
4 payment of disability benefits AND AFTER JANUARY FIRST, TWO THOUSAND
5 TWENTY-ONE, THE PAYMENT OF FAMILY LEAVE BENEFITS for all employees has
6 been secured as provided by this article. Nothing herein, however,
7 shall be construed as creating any liability on the part of such state
8 or municipal department, board, commission or office to pay any disabili-
9 ty benefits to any such employee if so employed.

10 (b) The head of a state or municipal department, board, commission or
11 office authorized or required by law to enter into any contract for or
12 in connection with any work involving the employment of employees in
13 employment as defined in this article, and notwithstanding any general
14 or special statute requiring or authorizing any such contract, shall not
15 enter into any such contract unless proof duly subscribed by an insur-
16 ance carrier is produced in a form satisfactory to the chair, that the
17 payment of disability benefits AND AFTER JANUARY FIRST, TWO THOUSAND
18 EIGHTEEN, THE PAYMENT OF FAMILY LEAVE BENEFITS for all employees has
19 been secured as provided by this article.

20 S 19. Section 221 of the workers' compensation law, as separately
21 amended by chapters 425 and 500 of the laws of 1985, is amended to read
22 as follows:

23 S 221. Determination of contested claims for disability AND FAMILY
24 LEAVE benefits. [Within twenty-six weeks] IN ACCORDANCE WITH REGU-
25 LATIONS ADOPTED BY THE CHAIR, WITHIN TWENTY-SIX WEEKS of written notice
26 of rejection of claim, the employee may file with the [chairman] CHAIR a
27 notice that his or her claim for disability OR FAMILY LEAVE benefits has
28 not been paid, and the employee shall submit proof of disability OR
29 ENTITLEMENT TO FAMILY LEAVE and of his or her employment, wages and
30 other facts reasonably necessary for determination of the employee's
31 right to such benefits. Failure to file such notice within the time
32 provided, may be excused [by the chairman] if it can be shown [to the
33 satisfaction of the chairman] not to have been reasonably possible to
34 furnish such notice and that such notice was furnished as soon as possi-
35 ble. On demand [of the chairman] the employer or carrier shall forth-
36 with deliver to the [chairman] BOARD the original or a true copy of the
37 [attending physician's or attending podiatrist's or accredited practi-
38 tioner's statement] HEALTH CARE PROVIDER'S REPORT, wage and employment
39 data and all other papers in the possession of the employer or carrier
40 with respect to such claim.

41 The [board] CHAIR OR DESIGNEE shall have full power and authority to
42 determine all issues in relation to every such claim for disability OR
43 FAMILY LEAVE benefits required or provided under this article[, and
44 shall file its decision in the office of the chairman. Upon such filing,
45 the chairman shall send to the parties a copy of the decision. Either
46 party may present evidence and be represented by counsel at any hearing
47 on such claim. The decision of the board shall be final as to all ques-
48 tions of fact and, except as provided in section twenty-three of this
49 chapter, as to all questions of law]. Every decision [of the board]
50 shall be complied with in accordance with its terms within ten days
51 thereafter except [in case of appeal] AS PERMITTED BY LAW UPON THE
52 FILING OF A REQUEST FOR REVIEW, and any payments due under such decision
53 shall draw simple interest from thirty days after the making thereof at
54 the rate provided in section five thousand four of the civil practice
55 law and rules. THE CHAIR SHALL ADOPT RULES AND REGULATIONS TO CARRY OUT
56 THE PROVISIONS OF THIS ARTICLE INCLUDING BUT NOT LIMITED TO RESOLUTION

1 OF CONTESTED CLAIMS AND REQUESTS FOR REVIEW THEREOF, AND PAYMENT OF
2 COSTS FOR RESOLUTION OF DISPUTED CLAIMS BY CARRIERS. THE CHAIR SHALL
3 HAVE AUTHORITY TO PROVIDE FOR ALTERNATIVE DISPUTE RESOLUTION PROCEDURES
4 FOR CLAIMS ARISING UNDER THIS ARTICLE INCLUDING BUT NOT LIMITED TO
5 REFERRAL AND SUBMISSION OF DISPUTED CLAIMS TO MANDATORY ARBITRATION WITH
6 PRIVATE ARBITRATION ASSOCIATIONS, AND ANY DETERMINATION MADE BY ALTERNA-
7 TIVE DISPUTE RESOLUTION SHALL NOT BE REVIEWABLE BY THE BOARD AND THE
8 VENUE FOR ANY APPEAL SHALL BE TO A COURT OF COMPETENT JURISDICTION.

9 S 20. Section 222 of the workers' compensation law, as added by chap-
10 ter 600 of the laws of 1949, is amended to read as follows:

11 S 222. Technical rules of evidence or procedure not required. The
12 [chairman or] CHAIR, the board OR THE CHAIR'S DESIGNEE, in making an
13 investigation or inquiry or conducting a hearing shall not be bound by
14 common law or statutory rules of evidence or by technical or formal
15 rules of procedure, except as provided by this chapter; but may make
16 such investigation or inquiry or conduct such hearing in such manner as
17 to ascertain the substantial rights of the parties.

18 S 21. Sections 223 and 224 of the workers' compensation law are
19 REPEALED.

20 S 22. Section 225 of the workers' compensation law, as added by chap-
21 ter 600 of the laws of 1949, is amended to read as follows:

22 S 225. Fees for representing employees. Claims of attorneys and coun-
23 sellors-at-law for services in connection with any contested claim aris-
24 ing under this article shall not be enforceable unless approved by the
25 board. If so approved, such fee or fees shall become a lien upon the
26 benefits ordered, but shall be paid therefrom only in the manner fixed
27 by the board OR THE ALTERNATIVE DISPUTE RESOLUTION ASSOCIATION. Any
28 other person, firm, corporation, organization, or other association who
29 shall exact or receive any fee or gratuity for any services rendered on
30 behalf of an employee except in an amount SO determined [by the board]
31 shall be guilty of a misdemeanor. Any person, firm, corporation, organ-
32 ization, or association who shall solicit the business [of appearing
33 before the board on behalf] of an employee claiming benefits under this
34 article, or who shall make it a business to solicit employment for a
35 lawyer in connection with any claim for disability OR FAMILY LEAVE bene-
36 fits under this article, or who shall exact or receive any fee or gratu-
37 ity or other charge with respect to the collection of any uncontested
38 claim for disability OR FAMILY LEAVE benefits, shall be guilty of a
39 misdemeanor.

40 S 23. Subdivision 5 of section 226 of the workers' compensation law,
41 as amended by chapter 211 of the laws of 1983, is amended and three new
42 subdivisions 7, 8 and 9 are added to read as follows:

43 5. No contract of insurance issued by an insurance carrier providing
44 the benefits to be paid under this article shall be cancelled within the
45 time limited in such contract for its expiration unless notice is given
46 as required by this section. When cancellation is due to non-payment of
47 premiums such cancellation shall not be effective until at least ten
48 days after a notice of cancellation of such contract, on a date speci-
49 fied in such notice, shall be filed in the office of the [chairman]
50 CHAIR and also served on the employer. When cancellation is due to any
51 reason other than non-payment of premiums such cancellation shall not be
52 effective until at least thirty days after a notice of cancellation of
53 such contract, on a date specified in such notice, shall be filed in the
54 office of the [chairman] CHAIR and also served on the employer;
55 provided, however, in either case that if insurance with another insur-
56 ance carrier has been obtained which becomes effective prior to the

1 expiration of the time stated in such notice, the cancellation shall be
2 effective as of the date of such other coverage. Such notice shall be
3 served on the employer [by] AS PRESCRIBED BY THE CHAIR, INCLUDING deliv-
4 ering it to him [or by sending it by certified or registered mail,
5 return receipt requested, addressed to the employer at his or its last
6 known place of business] OR HER BY ELECTRONIC MEANS; provided that, if
7 the employer be a partnership, then such notice may be given to any one
8 of the partners, and if the employer be a corporation then the notice
9 may be given to any agent or officer of the corporation upon whom legal
10 process may be served, provided, however, the right to cancellation of a
11 policy of insurance in the state fund shall be exercised only for
12 nonpayment of premiums or as provided in section ninety-four of this
13 chapter.

14 7. THE CHAIR MAY REQUIRE BY REGULATION THAT EVERY POLICY OF INSURANCE
15 CONTAIN A PROVISION REQUIRING THAT ALL DISPUTES BE RESOLVED BY MANDATORY
16 ARBITRATION, IN ACCORDANCE WITH SUCH REGULATIONS.

17 8. PREMIUMS FOR POLICIES PROVIDING DISABILITY OR FAMILY LEAVE BENEFITS
18 IN ACCORDANCE WITH THIS ARTICLE SHALL BE CALCULATED IN ACCORDANCE WITH
19 APPLICABLE PROVISIONS OF THE INSURANCE LAW, INCLUDING SUBSECTION (N) OF
20 SECTION FOUR THOUSAND TWO HUNDRED THIRTY-FIVE OF SUCH LAW.

21 9. EXCEPT AS SET FORTH IN SUBDIVISION EIGHT OF SECTION TWO HUNDRED
22 ELEVEN OF THIS ARTICLE, EVERY POLICY OF INSURANCE ISSUED PURSUANT TO
23 THIS ARTICLE MUST OFFER COVERAGE FOR BOTH DISABILITY AND FAMILY LEAVE
24 BENEFITS.

25 S 24. The section heading of section 227 of the workers' compensation
26 law, as amended by chapter 805 of the laws of 1984, is amended to read
27 as follows:

28 Actionable injuries IN CLAIMS FOR DISABILITY BENEFITS; subrogation.

29 S 25. Subdivision 1 of section 228 of the workers' compensation law,
30 as added by section 27 of part GG of chapter 57 of the laws of 2013, is
31 amended to read as follows:

32 1. The estimated annual expenses necessary for the workers' compen-
33 sation board OR DEPARTMENT OF FINANCIAL SERVICES to administer the
34 provisions of the disability AND FAMILY LEAVE benefits law shall be
35 borne by all affected employers and included as part of the assessment
36 rate generated pursuant to subdivision two of section one hundred
37 fifty-one of this chapter.

38 S 26. Section 229 of the workers' compensation law, as amended by
39 chapter 271 of the laws of 1985, is amended to read as follows:

40 S 229. Posting of notice and providing of notice of rights. 1. Each
41 covered employer shall post and maintain in a conspicuous place or plac-
42 es in and about the employer's place or places of business typewritten
43 or printed notices in form prescribed by the [chairman] CHAIR, stating
44 that the employer has provided for the payment of disability AND FAMILY
45 LEAVE benefits as required by this article. The [chairman] CHAIR may
46 require any covered employer to furnish a written statement at any time
47 showing the carrier insuring the payment of benefits under this article
48 or the manner in which such employer has complied with section two
49 hundred eleven OF THIS ARTICLE or any other provision of this article.
50 Failure for a period of ten days to furnish such written statement shall
51 constitute presumptive evidence that such employer has neglected or
52 failed in respect of any of the matters so required.

53 2. Whenever an employee of a covered employer who is eligible for
54 benefits under section two hundred four of this article shall be absent
55 from work due to a disability OR TO PROVIDE FAMILY CARE as defined in
56 subdivision nine AND SUBDIVISION TWENTY-FIVE RESPECTIVELY, of section

1 two hundred one of this article for more than seven consecutive days,
2 the employer shall provide the employee with a written statement of the
3 employee's rights under this article in a form prescribed by the [chair-
4 man] CHAIR. The statement shall be provided to the employee within five
5 business days after the employee's seventh consecutive day of absence

FISCAL NOTE.-- Pursuant to Legislative Law, Section 50:

This bill would allow up to three (3) years of service credit for
military duty by removing all existing requirements that such military
service be performed during certain war periods, during certain hostil-
ities while in the theater of operations or upon receipt of an expedi-
tionary medal. However, the total service credit granted for active and
peacetime military service shall not exceed three (3) years. Members
must have at least five years of credited service (not including mili-
tary service). Tier 1-5 members would be required to make a payment of
three percent of their most recent compensation per year of additional
service credit granted by this bill. Tier 6 members would be required to
make a payment of six percent of their most recent compensation per year
of additional service credit.

If this bill is enacted, insofar as this proposal affects the New York
State and Local Employees' Retirement System (ERS), it is estimated that
the past service cost will average approximately 15% (12% for Tier 6) of
an affected members' compensation for each year of additional service
credit that is purchased.

Insofar as this proposal affects the New York State and Local Police
and Fire Retirement System (PFRS), it is estimated that the past service
cost will average approximately 19% (16% for Tier 6) of an affected
members' compensation for each year of additional service that is
purchased.

The exact number of current members as well as future members who
could be affected by this legislation cannot be readily determined.

ERS costs would be borne entirely by the State of New York. Since a member can apply for this service credit at any time prior to retirement, a precise cost can't be determined until each member, as well as future members, applies for the service credit. Every year a cost will be determined (and billed to the state) based on those benefiting from this provision.

PFRS costs would be shared by the State of New York and the participating employers in the PFRS.

Summary of relevant resources:

The membership data used in measuring the impact of the proposed change was the same as that used in the March 31, 2015 actuarial valuation. Distributions and other statistics can be found in the 2015 Report of the Actuary and the 2015 Comprehensive Annual Financial Report.

The actuarial assumptions and methods used are described in the 2015 Annual Report to the Comptroller on Actuarial Assumptions, and the Codes Rules and Regulations of the State of New York: Audit and Control.

The Market Assets and GASB Disclosures are found in the March 31, 2015 New York State and Local Retirement System Financial Statements and Supplementary Information.

I am a member of the American Academy of Actuaries and meet the Qualification Standards to render the actuarial opinion contained herein.

This estimate, dated January 14, 2016 and intended for use only during the 2016 Legislative Session, is Fiscal Note No. 2016-25, prepared by the Actuary for the New York State and Local Retirement System.

FISCAL NOTE.-- Pursuant to Legislative Law, Section 50:

With respect to certain New York City Retirement Systems (NYCRS), this proposed legislation would amend New York State Retirement and Social Security Law (RSSL) Section 1000 to provide certain members of the New York City Employees' Retirement System (NYCERS), the New York City Teachers' Retirement System (NYCTRS), the New York City Board of Education Retirement System (BERS), the New York City Police Pension Fund (POLICE) and the New York Fire Department Pension Fund (FIRE), collectively, the New York City Retirement Systems (NYCRS), the opportunity to obtain additional retirement service credits for certain Military Service.

This proposed legislation would permit any NYCRS member, prior to the effective date of retirement, to make application for these additional service credits.

To obtain such Military Service credits, members would be required to pay to the appropriate NYCRS, for each year of Military Service purchased, a sum equal to 3.0% (6.0% for members who first join on and after April 1, 2012) of such member's compensation earned during the twelve months of credited service immediately preceding the date that the member makes application for credit.

MEMBERS IMPACTED: Insofar as this proposed legislation relates to the NYCRS, the number of members who could potentially benefit from this proposed legislation cannot be readily determined.

IMPACT ON BENEFITS: With respect to the NYCRS, a member who served in the U.S. military and received an honorable discharge would be permitted, after completing five years of credited service (exclusive of the service credit that could be purchased under this proposed legislation), to purchase a maximum of three years of Military Service (inclusive of any prior purchases of Military Service credit).

In order to purchase the Military Service credits provided in this proposed legislation, a member must have been honorably discharged

following a period of "military duty" as defined in New York State Military Law Section 243.

If a member's Military Service meets these conditions, then that member would be permitted to purchase a maximum of three years of Military Service (inclusive of any previously-received Military Service credit) attributable to any period of the member's military career.

For purposes of the respective NYCERS, each year of Military Service credit purchased would apply toward providing the member with a year of benefit accrual under the particular benefit formula covering the member.

In certain circumstances, the member also may be entitled to utilize such Military Service as qualifying service for benefit eligibility purposes.

For purposes of this Fiscal Note, it has been assumed that members who purchase Military Service in accordance with this proposed legislation would generally be entitled to count such service for benefit accrual purposes and for the purpose of qualifying for benefits.

FINANCIAL IMPACT - OVERVIEW: With respect to an individual member, the additional cost of this proposed legislation would depend on the length of all New York City service, age, salary history and Plan in which the member participates, as well as the number of years of service credit purchased.

With respect to employers participating in the NYCERS, the ultimate employer cost of this proposed legislation would be determined by the increase in benefits to be paid, the impact of certain benefits commencing earlier and the reduction in certain future member contributions.

FINANCIAL IMPACT - ACTUARIAL PRESENT VALUES: The additional Actuarial Present Value (APV) of benefits would depend on the number, salaries, ages and lengths of Military Service purchased by members who would be affected by this proposed legislation.

With respect to the NYCERS and based on the census data and assumptions herein, the enactment of this proposed legislation would increase the Actuarial Present Value (APV) of benefits (APVB) by approximately \$147.1 million of June 30, 2016.

In addition, with respect to the NYCERS, the APV of future member contributions (primarily attributable to the payments by members of 3.0% (6.0% for members who first join on and after April 1, 2012) of salary per year of Military Service purchased) would increase by approximately \$22.2 million when measured as of June 30, 2016.

Consequently, with respect to the NYCERS, the APV of net future employer contributions would increase by approximately \$124.9 million as of June 30, 2016.

FINANCIAL IMPACT - ANNUAL EMPLOYER COSTS: The ultimate cost of a pension plan is the benefits it pays. With respect to the NYCERS, the financing of that ultimate cost depends upon the census data used and the actuarial assumptions and methods employed. Assuming that all eligible members were to purchase the eligible Military Service during Fiscal Year 2016 and based on the Actuary's actuarial assumptions and methods in effect as of June 30, 2015, the enactment of this proposed legislation would increase annual employer costs by approximately \$14.8 million per year.

FINANCIAL IMPACT - EMPLOYER CONTRIBUTIONS: The impact of the proposed legislation on employer contributions would be a function of the census data (i.e., age/service/salary, etc.) reported to the Actuary and of the timing of the members electing to buy back their Military Service.

With respect to the NYCERS, based on the Actuary's actuarial assumptions and methods in effect as of June 30, 2015, the enactment of this proposed legislation would ultimately increase employer contributions by approximately the estimated additional annual employer costs.

If applications for buying back Military Service were completed during Fiscal Year 2016 and the NYCERS census data were updated to reflect this information by June 30, 2016, then employer contributions would first be impacted for Fiscal Year 2018.

If the Military Service buybacks were completed after Fiscal Year 2016, then the increase in employer contributions would first occur after Fiscal Year 2018.

FINANCIAL IMPACT - SUMMARY: The following table summarizes the estimated financial impact of this proposed legislation on the NYCERS.

ADDITIONAL EMPLOYER COSTS - GENERAL: In general, the real cost of the enactment of this proposed legislation would be the additional benefits paid.

This Fiscal Note does not include analyses of the impact of this proposed legislation on the expected increases in administrative costs or costs for Other Post-Employment Benefits (OPEB).

CENSUS DATA: The census data used for estimates of APV of benefits and employer contributions presented herein are the active members included in the June 30, 2015 (Lag) actuarial valuations of NYCERS, NYCTRS, BERS, POLICE and FIRE used to determine the Preliminary Fiscal Year 2017 employer contributions.

ACTUARIAL ASSUMPTIONS AND METHODS: Additional APV of benefits, of member contributions and of employer contributions have been estimated as of June 30, 2017 using various approximating techniques and assumptions by the Actuary, including, but not limited to:

* A certain percentage of Veterans being honorably discharged.

* A certain percentage of honorably discharged Veterans being disabled.

* Different percentages of members by NYCERS having prior Military Service.

* Each eligible member purchasing an average of 2.5 years of the Military Service.

Changes in employer contributions have been estimated assuming the increase in the APV of Future Employer Contributions would be financed over a time period comparable to that used for actuarial losses under the Entry Age Actuarial Cost Method. Using this approach, the Additional APV of Future Employer Contributions would be amortized over a closed 15-year period (14 payments under One-Year Lag Methodology) using level dollar payments.

STATEMENT OF ACTUARIAL OPINION: I, Sherry S. Chan, am the Chief Actuary for the New York City Retirement Systems. I am an Associate of the Society of Actuaries, a Fellow of the Conference of Consulting Actuaries, and a Member of the American Academy of Actuaries. I meet the Qualification Standards of the American Academy of Actuaries to render the actuarial opinion contained herein.

FISCAL NOTE IDENTIFICATION: This estimate is intended for use only during the 2016 Legislative Session. It is Fiscal Note 2016-04, dated March 1, 2016, prepared by the Chief Actuary for the New York City Employees' Retirement System, the New York City Teachers' Retirement System, the New York City Board of Education Retirement System, the New York City Police Pension Fund and the New York Fire Department Pension Fund.

FISCAL NOTE. -- Pursuant to Legislative Law, Section 50:

This bill would amend Section 1000 of the Retirement and Social Security Law to allow active members of public retirement systems of New York State to claim service credit for up to three years of military service, regardless of when or where it was performed. Currently, active members can receive service credit for military service performed, but only during specified periods of war. A member must have at least five years of credited service to be eligible and make application for such credit before the effective date of retirement. To obtain such credit, a member must make payments as required in Section 1000 of the Retirement and Social Security Law. Tier 1, 2, 3, 4 and 5 members are required to pay three percent of salary earned during the twelve months of credited service immediately preceding the year in which a claim is made for each year of military service. Tier 6 members are required to pay six percent of salary earned during the twelve months of credited service immediately preceding the year in which a claim is made for each year of military service.

It is not possible to determine the total annual cost of this bill since the total amount of service credit which would be claimed under this bill cannot be estimated. Pursuant to Section 25 of the Retirement and Social Security Law, the cost to the New York State Teachers' Retirement System (NYSTRS) would be borne by the State of New York and would require an itemized appropriation adequate to pay the cost of this bill. The cost to the State of New York is estimated to be \$19,700 per year of service credited for Tier 1, 2, 3, 4 and 5 members and \$15,200 per year of service credited for Tier 6 members if this bill is enacted. Each year a cost will be computed and billed to the State of New York for those members of NYSTRS receiving a benefit under this bill.

Employee data is from the System's most recent actuarial valuation files, consisting of data provided by the employers to the Retirement System. Data distributions and statistics can be found in the System's Comprehensive Annual Financial Report (CAFR). System assets are as reported in the System's financial statements, and can also be found in the CAFR. Actuarial assumptions and methods are provided in the System's Actuarial Valuation Report.

The source of this estimate is Fiscal Note 2016-8 dated February 3, 2016 prepared by the Actuary of the New York State Teachers' Retirement System and is intended for use only during the 2016 Legislative Session. I, Richard A. Young, am the Actuary for the New York State Teachers' Retirement System. I am a member of the American Academy of Actuaries and I meet the Qualification Standards of the American Academy of Actuaries to render the actuarial opinion contained herein.

(xiii) the victim was killed in furtherance of an act of terrorism, as defined in paragraph (b) of subdivision one of section 490.05 of this chapter; [and] OR

(XIV) THE INTENDED VICTIM WAS A MEMBER OF THE NEW YORK GUARD OR THE NEW YORK NAVAL MILITIA WHO WAS AT THE TIME OF THE KILLING ENGAGED IN THE COURSE OF PERFORMING HIS OR HER OFFICIAL DUTIES, AND THE DEFENDANT KNEW OR REASONABLY SHOULD HAVE KNOWN THAT THE INTENDED VICTIM WAS A MEMBER OF THE NEW YORK GUARD OR THE NEW YORK NAVAL MILITIA; AND

(b) The defendant was more than eighteen years old at the time of the commission of the crime.

2. In any prosecution under subdivision one, it is an affirmative defense that:

(a) The defendant acted under the influence of extreme emotional disturbance for which there was a reasonable explanation or excuse, the reasonableness of which is to be determined from the viewpoint of a person in the defendant's situation under the circumstances as the defendant believed them to be. Nothing contained in this paragraph shall constitute a defense to a prosecution for, or preclude a conviction of, manslaughter in the first degree or any other crime except murder in the second degree; or

(b) The defendant's conduct consisted of causing or aiding, without the use of duress or deception, another person to commit suicide. Nothing contained in this paragraph shall constitute a defense to a prosecution for, or preclude a conviction of, manslaughter in the second degree or any other crime except murder in the second degree.

Murder in the first degree is a class A-I felony.

S 4. This act shall take effect immediately.

PART V

Section 1. This act shall be known and may be cited as "Brittany's law".

FAILURE TO REGISTER OR VERIFY AS A DOMESTIC VIOLENCE OFFENDER IN THE SECOND DEGREE IS A CLASS E FELONY.

S 195.04 FAILURE TO REGISTER OR VERIFY AS A DOMESTIC VIOLENCE OFFENDER IN THE FIRST DEGREE.

1 A PERSON IS GUILTY OF FAILURE TO REGISTER OR VERIFY AS A DOMESTIC
2 VIOLENCE OFFENDER IN THE FIRST DEGREE WHEN HE OR SHE COMMITS THE CRIME

47 STILL RESIDE IN THE SAME HOUSEHOLD;

48 (D) PERSONS WHO HAVE A CHILD IN COMMON REGARDLESS OF WHETHER SUCH
49 PERSONS ARE MARRIED OR HAVE LIVED TOGETHER AT ANY TIME; OR

50 (E) UNRELATED PERSONS WHO ARE CONTINUALLY OR AT REGULAR INTERVALS
51 LIVING IN THE SAME HOUSEHOLD OR WHO HAVE IN THE PAST CONTINUALLY OR AT
52 REGULAR INTERVALS LIVED IN THE SAME HOUSEHOLD.

53 4. "PARENT" MEANS A NATURAL OR ADOPTIVE PARENT OR ANY INDIVIDUAL

(III) IF THERE BE NO CHIEF ENFORCEMENT OFFICER IN SUCH VILLAGE, TOWN, CITY OR COUNTY, THE DIVISION OF STATE POLICE; AND

(B) IN THE CASE OF A DOMESTIC VIOLENCE OFFENDER WHO IS OR EXPECTS TO BE EMPLOYED BY, ENROLLED IN, ATTENDING OR EMPLOYED, WHETHER FOR COMPENSATION OR NOT, AT AN INSTITUTION OF HIGHER EDUCATION, (I) THE CHIEF LAW ENFORCEMENT OFFICER IN THE VILLAGE, TOWN OR CITY IN WHICH SUCH INSTITUTION IS LOCATED; OR (II) IF THERE BE NO CHIEF LAW ENFORCEMENT OFFICER IN SUCH VILLAGE, TOWN OR CITY, THE CHIEF LAW ENFORCEMENT OFFICER OF THE COUNTY IN WHICH SUCH INSTITUTION IS LOCATED; OR (III) IF THERE BE NO CHIEF LAW ENFORCEMENT OFFICER IN SUCH VILLAGE, TOWN, CITY OR COUNTY, THE DIVISION OF STATE POLICE; AND (IV) IF SUCH INSTITUTION OPERATES OR EMPLOYS A CAMPUS LAW ENFORCEMENT OR SECURITY AGENCY, THE CHIEF OF SUCH AGENCY; AND

(C) IN THE CASE OF A DOMESTIC VIOLENCE OFFENDER WHO EXPECTS TO RESIDE WITHIN A STATE PARK OR ON OTHER LAND UNDER THE JURISDICTION OF THE OFFICE OF PARKS, RECREATION AND HISTORIC PRESERVATION, THE STATE REGIONAL PARK POLICE.

S 165-A. DUTIES OF THE DIVISION; REGISTRATION INFORMATION. 1. THE DIVISION SHALL ESTABLISH AND MAINTAIN A FILE OF INDIVIDUALS REQUIRED TO REGISTER PURSUANT TO THE PROVISIONS OF THIS ARTICLE WHICH SHALL INCLUDE THE FOLLOWING INFORMATION OF EACH REGISTRANT:

(A) THE DOMESTIC VIOLENCE OFFENDER'S NAME, ALL ALIASES USED, DATE OF BIRTH, SEX, RACE, HEIGHT, WEIGHT, EYE COLOR, DRIVER'S LICENSE NUMBER, HOME ADDRESS AND/OR EXPECTED PLACE OF DOMICILE, ANY INTERNET ACCOUNTS WITH INTERNET ACCESS PROVIDERS BELONGING TO SUCH OFFENDER AND INTERNET IDENTIFIERS THAT SUCH OFFENDER USES.

(B) A PHOTOGRAPH AND SET OF FINGERPRINTS. THE DIVISION SHALL, DURING THE PERIOD OF REGISTRATION, UPDATE SUCH PHOTOGRAPH ONCE EVERY THREE YEARS. THE DIVISION SHALL NOTIFY THE DOMESTIC VIOLENCE OFFENDER BY MAIL OF THE DUTY TO APPEAR AND BE PHOTOGRAPHED AT THE SPECIFIED LAW ENFORCEMENT AGENCY HAVING JURISDICTION. SUCH NOTIFICATION SHALL BE MAILED AT LEAST THIRTY DAYS AND NOT MORE THAN SIXTY DAYS BEFORE THE PHOTOGRAPH IS REQUIRED TO BE TAKEN PURSUANT TO THIS ARTICLE.

(C) A DESCRIPTION OF THE OFFENSE FOR WHICH THE DOMESTIC VIOLENCE OFFENDER WAS CONVICTED, THE DATE OF CONVICTION AND THE SENTENCE IMPOSED.

(D) THE NAME AND ADDRESS OF ANY INSTITUTION OF HIGHER EDUCATION AT WHICH THE DOMESTIC VIOLENCE OFFENDER IS OR EXPECTS TO BE ENROLLED, ATTENDING OR EMPLOYED, WHETHER FOR COMPENSATION OR NOT, AND WHETHER SUCH OFFENDER RESIDES IN OR WILL RESIDE IN A FACILITY OWNED OR OPERATED BY SUCH INSTITUTION.

(E) THE EMPLOYMENT ADDRESS AND/OR EXPECTED PLACE OF EMPLOYMENT OF THE DOMESTIC VIOLENCE OFFENDER.

(F) ANY OTHER INFORMATION DEEMED PERTINENT BY THE DIVISION.

2. (A) THE DIVISION IS AUTHORIZED TO MAKE THE REGISTRY AVAILABLE TO ANY REGIONAL OR NATIONAL REGISTRY OF DOMESTIC VIOLENCE OFFENDERS FOR THE PURPOSE OF SHARING INFORMATION. THE DIVISION SHALL ACCEPT FILES FROM ANY REGIONAL OR NATIONAL REGISTRY OF DOMESTIC VIOLENCE OFFENDERS AND SHALL

1 MAKE SUCH FILES AVAILABLE WHEN REQUESTED PURSUANT TO THE PROVISIONS OF
2 THIS ARTICLE.

3 (B) NO OFFICIAL, AGENCY, AUTHORIZED PERSON OR ENTITY, WHETHER PUBLIC
4 OR PRIVATE, SHALL BE SUBJECT TO ANY CIVIL OR CRIMINAL LIABILITY FOR
5 DAMAGES FOR ANY DECISION OR ACTION MADE IN THE ORDINARY COURSE OF BUSI-
6 NESS OF THAT OFFICIAL, AGENCY, AUTHORIZED PERSON OR ENTITY PURSUANT TO
7 THIS ARTICLE, PROVIDED THAT SUCH OFFICIAL, AGENCY, AUTHORIZED PERSON OR

37 A PROSPECTIVE EMPLOYEE OF ANY SUCH PERSON OR ENTITY IN ACCORDANCE WITH

39 REGULATIONS RELATING TO PROCEDURES FOR THE RELEASE OF INFORMATION IN THE

45 ENFORCEMENT AND/OR OTHER GOVERNMENTAL ENTITIES OF POTENTIAL VIOLATIONS
46 OF LAW AND/OR THREATS TO PUBLIC SAFETY. BEFORE RELEASING ANY INFORMATION
47 THE DIVISION SHALL REQUIRE AN AUTHORIZED INTERNET ENTITY THAT REQUESTS
48 INFORMATION FROM THE REGISTRY TO SUBMIT TO THE DIVISION THE NAME,
49 ADDRESS AND TELEPHONE NUMBER OF SUCH ENTITY AND THE SPECIFIC LEGAL
50 NATURE AND CORPORATE STATUS OF SUCH ENTITY. EXCEPT FOR THE PURPOSES
51 SPECIFIED IN THIS SUBDIVISION, AN AUTHORIZED INTERNET ENTITY SHALL NOT
52 PUBLISH OR IN ANY WAY DISCLOSE OR REDISCLOSE ANY INFORMATION PROVIDED TO
53 IT BY THE DIVISION PURSUANT TO THIS SUBDIVISION. THE DIVISION MAY CHARGE
54 AN AUTHORIZED INTERNET ENTITY A FEE FOR ACCESS TO REGISTERED INTERNET
55 IDENTIFIERS REQUESTED BY SUCH ENTITY PURSUANT TO THIS SUBDIVISION. THE
56 DIVISION SHALL PROMULGATE RULES AND REGULATIONS RELATING TO PROCEDURES

FOR THE RELEASE OF INFORMATION IN THE REGISTRY, INCLUDING BUT NOT LIMITED TO, THE DISCLOSURE AND REDISCLOSURE OF SUCH INFORMATION, AND THE IMPOSITION OF ANY FEES.

S 165-B. DOMESTIC VIOLENCE OFFENDER; RELOCATION; NOTIFICATION. 1. IN THE CASE OF ANY DOMESTIC VIOLENCE OFFENDER, IT SHALL BE THE DUTY OF THE DEPARTMENT, HOSPITAL OR LOCAL CORRECTIONAL FACILITY AT LEAST TEN CALENDAR DAYS PRIOR TO THE RELEASE OR DISCHARGE OF ANY DOMESTIC VIOLENCE OFFENDER FROM A CORRECTIONAL FACILITY, HOSPITAL OR LOCAL CORRECTIONAL FACILITY TO NOTIFY THE DIVISION OF THE CONTEMPLATED RELEASE OR DISCHARGE OF SUCH DOMESTIC VIOLENCE OFFENDER, INFORMING THE DIVISION IN WRITING ON A FORM PROVIDED BY THE DIVISION INDICATING THE ADDRESS AT WHICH HE OR SHE PROPOSES TO RESIDE AND THE NAME AND ADDRESS OF ANY INSTITUTION OF HIGHER EDUCATION AT WHICH HE OR SHE EXPECTS TO BE ENROLLED, ATTENDING OR EMPLOYED, WHETHER FOR COMPENSATION OR NOT, AND WHETHER HE OR SHE RESIDES IN OR WILL RESIDE IN A FACILITY OWNED OR OPERATED BY SUCH INSTITUTION. IF SUCH DOMESTIC VIOLENCE OFFENDER CHANGES HIS OR HER PLACE OF RESIDENCE WHILE ON PAROLE, SUCH NOTIFICATION OF THE CHANGE OF RESIDENCE SHALL BE SENT BY THE DOMESTIC VIOLENCE OFFENDER'S PAROLE OFFICER WITHIN FORTY-EIGHT HOURS TO THE DIVISION ON A FORM PROVIDED BY THE DIVISION. IF SUCH DOMESTIC VIOLENCE OFFENDER CHANGES THE STATUS OF HIS OR HER ENROLLMENT, ATTENDANCE, EMPLOYMENT OR RESIDENCE AT ANY INSTITUTION OF HIGHER EDUCATION WHILE ON PAROLE, SUCH NOTIFICATION OF THE CHANGE OF STATUS SHALL BE SENT BY THE DOMESTIC VIOLENCE OFFENDER'S PAROLE OFFICER WITHIN FORTY-EIGHT HOURS TO THE DIVISION ON A FORM PROVIDED BY THE DIVISION.

2. IN THE CASE OF ANY DOMESTIC VIOLENCE OFFENDER ON PROBATION, IT SHALL BE THE DUTY OF THE DOMESTIC VIOLENCE OFFENDER'S PROBATION OFFICER TO NOTIFY THE DIVISION WITHIN FORTY-EIGHT HOURS OF THE NEW PLACE OF RESIDENCE ON A FORM PROVIDED BY THE DIVISION. IF SUCH DOMESTIC VIOLENCE OFFENDER CHANGES THE STATUS OF HIS OR HER ENROLLMENT, ATTENDANCE, EMPLOYMENT OR RESIDENCE AT ANY INSTITUTION OF HIGHER EDUCATION WHILE ON PROBATION, SUCH NOTIFICATION OF THE CHANGE OF STATUS SHALL BE SENT BY THE DOMESTIC VIOLENCE OFFENDER'S PROBATION OFFICER WITHIN FORTY-EIGHT HOURS TO THE DIVISION ON A FORM PROVIDED BY THE DIVISION.

3. IN THE CASE IN WHICH ANY DOMESTIC VIOLENCE OFFENDER ESCAPES FROM A STATE OR LOCAL CORRECTIONAL FACILITY OR HOSPITAL, THE DESIGNATED OFFICIAL OF THE FACILITY OR HOSPITAL WHERE THE PERSON WAS CONFINED SHALL NOTIFY WITHIN TWENTY-FOUR HOURS THE LAW ENFORCEMENT AGENCY HAVING HAD JURISDICTION AT THE TIME OF HIS OR HER CONVICTION, INFORMING SUCH LAW ENFORCEMENT AGENCY OF THE NAME AND ALIASES OF THE PERSON, AND THE ADDRESS AT WHICH HE OR SHE RESIDED AT THE TIME OF HIS OR HER CONVICTION, THE AMOUNT OF TIME REMAINING TO BE SERVED, IF ANY, ON THE FULL TERM FOR WHICH HE OR SHE WAS SENTENCED, AND THE NATURE OF THE CRIME FOR WHICH HE OR SHE WAS SENTENCED, TRANSMITTING AT THE SAME TIME A COPY OF SUCH DOMESTIC VIOLENCE OFFENDER'S FINGERPRINTS AND PHOTOGRAPH AND A SUMMARY OF HIS OR HER CRIMINAL RECORD.

4. THE DIVISION SHALL PROVIDE GENERAL INFORMATION, IN REGISTRATION MATERIALS AND ANNUAL CORRESPONDENCE, TO REGISTRANTS CONCERNING NOTIFICATION AND REGISTRATION PROCEDURES THAT MAY APPLY IF THE REGISTRANT IS AUTHORIZED TO RELOCATE AND RELOCATES TO ANOTHER STATE OR UNITED STATES POSSESSION, OR COMMENCES EMPLOYMENT OR ATTENDANCE AT AN EDUCATION INSTITUTION IN ANOTHER STATE OR UNITED STATES POSSESSION. SUCH INFORMATION SHALL INCLUDE ADDRESSES AND TELEPHONE NUMBERS FOR RELEVANT AGENCIES FROM WHICH ADDITIONAL INFORMATION MAY BE OBTAINED.

S 165-C. DUTIES OF THE COURT. 1. UPON CONVICTION OF ANY OF THE OFFENSES SET FORTH IN SUBDIVISION TWO OF SECTION ONE HUNDRED SIXTY-FIVE OF THIS ARTICLE THE COURT SHALL CERTIFY THAT THE PERSON IS A DOMESTIC

1 VIOLENCE OFFENDER AND SHALL INCLUDE THE CERTIFICATION IN THE ORDER OF
2 COMMITMENT, IF ANY, AND JUDGMENT OF CONVICTION. THE COURT SHALL ALSO
3 ADVISE THE DOMESTIC VIOLENCE OFFENDER OF HIS OR HER DUTIES UNDER THIS

7 2. ANY DOMESTIC VIOLENCE OFFENDER, WHO IS RELEASED ON PROBATION OR
8 DISCHARGED UPON PAYMENT OF A FINE, CONDITIONAL DISCHARGE OR UNCONDI-
9 TIONAL DISCHARGE SHALL, PRIOR TO SUCH RELEASE OR DISCHARGE, BE INFORMED

30 S 165-D. DISCHARGE OF DOMESTIC VIOLENCE OFFENDER FROM CORRECTIONAL
31 FACILITY; DUTIES OF OFFICIAL IN CHARGE. ANY DOMESTIC VIOLENCE OFFENDER,
32 TO BE DISCHARGED, PAROLED, RELEASED TO POST-RELEASE SUPERVISION OR
33 RELEASED FROM ANY STATE OR LOCAL CORRECTIONAL FACILITY, HOSPITAL OR

50 ER'S LICENSE NUMBER OR BIRTH DATE, ALONG WITH ADDITIONAL INFORMATION
51 THAT MAY INCLUDE SOCIAL SECURITY NUMBER, HAIR COLOR, EYE COLOR, HEIGHT,
52 WEIGHT, DISTINCTIVE MARKINGS, ETHNICITY; OR (B) ANY COMBINATION OF THE
53 ABOVE LISTED CHARACTERISTICS IF AN EXACT BIRTH DATE OR ADDRESS IS NOT
54 AVAILABLE. IF THREE OF THE CHARACTERISTICS PROVIDED INCLUDE ETHNICITY,
55 HAIR COLOR, AND EYE COLOR, OTHER IDENTIFYING CHARACTERISTICS SHALL BE
56 PROVIDED. ANY INFORMATION IDENTIFYING THE VICTIM BY NAME, BIRTH DATE,

12 (E) A WARNING THAT IT IS ILLEGAL TO USE INFORMATION OBTAINED THROUGH
13 THE TELEPHONE NUMBER TO COMMIT A CRIME AGAINST ANY PERSON LISTED OR TO
14 ENGAGE IN ILLEGAL DISCRIMINATION OR HARASSMENT AGAINST SUCH PERSON;

15 (F) NOTICE THAT THE CALLER IS REQUIRED TO HAVE THE BIRTH DATE, DRIV-
16 ER'S LICENSE OR IDENTIFICATION NUMBER, OR ADDRESS OR OTHER IDENTIFYING
17 INFORMATION REGARDING THE PERSON ABOUT WHOM INFORMATION IS SOUGHT IN
18 ORDER TO ACHIEVE A POSITIVE IDENTIFICATION OF THAT PERSON;

19 (G) A STATEMENT THAT THE NUMBER IS NOT A CRIME HOTLINE AND THAT ANY
20 SUSPECTED CRIMINAL ACTIVITY SHOULD BE REPORTED TO LOCAL AUTHORITIES;

21 (H) A STATEMENT THAT AN INFORMATION PACKAGE WHICH WILL INCLUDE A
22 DESCRIPTION OF THE LAW AND DOMESTIC VIOLENCE PREVENTION MATERIALS IS
23 AVAILABLE UPON REQUEST FROM THE DIVISION. SUCH INFORMATION PACKAGE SHALL
24 INCLUDE QUESTIONS AND ANSWERS REGARDING THE MOST COMMONLY ASKED QUES-
25 TIONS ABOUT THE DOMESTIC VIOLENCE OFFENDER REGISTRATION ACT, AND CURRENT

43 (C) FOR PURPOSES OF THIS SUBDIVISION, "YOUTH SERVICES ORGANIZATION"
44 SHALL MEAN A FORMALIZED PROGRAM OPERATED BY A CORPORATION PURSUANT TO
45 SUBPARAGRAPH FIVE OF PARAGRAPH (A) OF SECTION ONE HUNDRED TWO OF THE
46 NOT-FOR-PROFIT CORPORATION LAW THAT FUNCTIONS PRIMARILY TO: (I) PROVIDE

17 (E) A SUMMARY OF THE SUCCESS OF THE TELEPHONE NUMBER PROGRAM BASED
18 UPON SELECTED FACTORS.

19 S 165-L. IMMUNITY FROM LIABILITY. 1. NO OFFICIAL, EMPLOYEE OR AGENCY,
20 WHETHER PUBLIC OR PRIVATE, SHALL BE SUBJECT TO ANY CIVIL OR CRIMINAL
21 LIABILITY FOR DAMAGES FOR ANY DISCRETIONARY DECISION TO RELEASE RELEVANT

12 FIRST DEGREE, STALKING IN THE SECOND DEGREE, STALKING IN THE THIRD
13 DEGREE, STALKING IN THE FOURTH DEGREE, CRIMINAL MISCHIEF, MENACING IN
14 THE SECOND DEGREE, MENACING IN THE THIRD DEGREE, RECKLESS ENDANGERMENT,
15 ASSAULT IN THE SECOND DEGREE, ASSAULT IN THE THIRD DEGREE OR AN
16 ATTEMPTED ASSAULT BETWEEN SPOUSES OR FORMER SPOUSES, OR BETWEEN PARENT
17 AND CHILD OR BETWEEN MEMBERS OF THE SAME FAMILY OR HOUSEHOLD EXCEPT THAT

56 NO CHIEF LAW ENFORCEMENT OFFICER IN SUCH VILLAGE, TOWN OR CITY, THE

1 CHIEF LAW ENFORCEMENT OFFICER OF THE COUNTY IN WHICH THE OFFENDER
2 EXPECTS TO RESIDE; OR (III) IF THERE BE NO CHIEF ENFORCEMENT OFFICER IN
3 SUCH VILLAGE, TOWN, CITY OR COUNTY, THE DIVISION OF STATE POLICE; AND

4 (B) IN THE CASE OF A DOMESTIC ABUSE OFFENDER WHO IS OR EXPECTS TO BE
5 EMPLOYED BY, ENROLLED IN, ATTENDING OR EMPLOYED, WHETHER FOR COMPEN-
6 SATION OR NOT, AT AN INSTITUTION OF HIGHER EDUCATION: (I) THE CHIEF LAW
7 ENFORCEMENT OFFICER IN THE VILLAGE, TOWN OR CITY IN WHICH SUCH INSTITU-
8 TION IS LOCATED; OR (II) IF THERE BE NO CHIEF LAW ENFORCEMENT OFFICER IN
9 SUCH VILLAGE, TOWN OR CITY, THE CHIEF LAW ENFORCEMENT OFFICER OF THE
10 COUNTY IN WHICH SUCH INSTITUTION IS LOCATED; OR (III) IF THERE BE NO
11 CHIEF LAW ENFORCEMENT OFFICER IN SUCH VILLAGE, TOWN, CITY OR COUNTY, THE
12 DIVISION OF STATE POLICE; AND (IV) IF SUCH INSTITUTION OPERATES OR
13 EMPLOYS A CAMPUS LAW ENFORCEMENT OR SECURITY AGENCY, THE CHIEF OF SUCH
14 AGENCY.

15 5. "DIVISION" MEANS THE DIVISION OF CRIMINAL JUSTICE SERVICES AS
16 DEFINED BY SECTION EIGHT HUNDRED THIRTY-FIVE OF THE EXECUTIVE LAW.

17 6. "LOCAL CORRECTIONAL FACILITY" MEANS A LOCAL CORRECTIONAL FACILITY
18 AS THAT TERM IS DEFINED IN SUBDIVISION SIXTEEN OF SECTION TWO OF THIS
19 CHAPTER.

20 7. "PROBATION" MEANS A SENTENCE OF PROBATION IMPOSED PURSUANT TO ARTI-
21 CLE SIXTY-FIVE OF THE PENAL LAW AND SHALL INCLUDE A SENTENCE OF IMPRI-
22 SONMENT IMPOSED IN CONJUNCTION WITH A SENTENCE OF PROBATION.

23 8. "NONRESIDENT WORKER" MEANS ANY PERSON REQUIRED TO REGISTER AS A
24 DOMESTIC ABUSE OFFENDER IN ANOTHER JURISDICTION WHO IS EMPLOYED OR
25 CARRIES ON A VOCATION IN THIS STATE, ON EITHER A FULL-TIME OR A
26 PART-TIME BASIS, WITH OR WITHOUT COMPENSATION, FOR MORE THAN FOURTEEN
27 CONSECUTIVE DAYS, OR FOR AN AGGREGATE PERIOD EXCEEDING THIRTY DAYS IN A
28 CALENDAR YEAR.

29 9. "NONRESIDENT STUDENT" MEANS A PERSON REQUIRED TO REGISTER AS A
30 DOMESTIC ABUSE OFFENDER IN ANOTHER JURISDICTION WHO IS ENROLLED ON A
31 FULL-TIME OR PART-TIME BASIS IN ANY PUBLIC OR PRIVATE EDUCATIONAL INSTI-
32 TUTION IN THIS STATE INCLUDING ANY SECONDARY SCHOOL, TRADE OR PROFES-
33 SIONAL INSTITUTION OR INSTITUTION OF HIGHER EDUCATION.

34 S 169-B. DUTIES OF THE DIVISION; REGISTRATION INFORMATION. 1. THE
35 DIVISION SHALL ESTABLISH AND MAINTAIN A FILE OF INDIVIDUALS REQUIRED TO
36 REGISTER PURSUANT TO THE PROVISIONS OF THIS ARTICLE WHICH SHALL INCLUDE
37 THE FOLLOWING INFORMATION OF EACH REGISTRANT:

38 (A) THE DOMESTIC ABUSE OFFENDER'S NAME, ALL ALIASES USED, DATE OF
39 BIRTH, SEX, RACE, HEIGHT, WEIGHT, EYE COLOR, DRIVER'S LICENSE NUMBER,
40 AND HOME ADDRESS AND/OR EXPECTED PLACE OF DOMICILE.

41 (B) A PHOTOGRAPH AND SET OF FINGERPRINTS.

42 (C) A DESCRIPTION OF THE OFFENSE FOR WHICH THE DOMESTIC ABUSE OFFENDER
43 WAS CONVICTED, THE DATE OF CONVICTION AND THE SENTENCE IMPOSED.

44 (D) THE NAME AND ADDRESS OF ANY INSTITUTION OF HIGHER EDUCATION AT
45 WHICH THE DOMESTIC ABUSE OFFENDER IS OR EXPECTS TO BE ENROLLED, ATTEND-
46 ING OR EMPLOYED, WHETHER FOR COMPENSATION OR NOT, AND WHETHER SUCH
47 DOMESTIC ABUSE OFFENDER RESIDES IN OR WILL RESIDE IN A FACILITY OWNED OR
48 OPERATED BY SUCH INSTITUTION.

49 (E) ANY OTHER INFORMATION DEEMED PERTINENT BY THE DIVISION.

50 2. (A) THE DIVISION IS AUTHORIZED TO MAKE THE REGISTRY AVAILABLE TO
51 ANY REGIONAL OR NATIONAL REGISTRY OF DOMESTIC ABUSE OFFENDERS FOR THE
52 PURPOSE OF SHARING INFORMATION. THE DIVISION SHALL ACCEPT FILES FROM ANY
53 REGIONAL OR NATIONAL REGISTRY OF DOMESTIC ABUSE OFFENDERS AND SHALL MAKE
54 SUCH FILES AVAILABLE WHEN REQUESTED PURSUANT TO THE PROVISIONS OF THIS
55 ARTICLE.

1 (B) THE DIVISION SHALL REQUIRE THAT NO INFORMATION INCLUDED IN THE
2 REGISTRY SHALL BE MADE AVAILABLE EXCEPT IN THE FURTHERANCE OF THE
3 PROVISIONS OF THIS ARTICLE.

4 3. THE DIVISION SHALL DEVELOP A STANDARDIZED REGISTRATION FORM TO BE
5 MADE AVAILABLE TO THE APPROPRIATE AUTHORITIES AND PROMULGATE RULES AND
6 REGULATIONS TO IMPLEMENT THE PROVISIONS OF THIS SECTION. SUCH FORM SHALL
7 BE WRITTEN IN CLEAR AND CONCISE LANGUAGE AND SHALL ADVISE THE DOMESTIC
8 ABUSE OFFENDER OF HIS OR HER DUTIES AND OBLIGATIONS UNDER THIS ARTICLE.

9 4. THE DIVISION SHALL MAIL A NONFORWARDABLE VERIFICATION FORM TO THE
10 LAST REPORTED ADDRESS OF THE PERSON FOR ANNUAL VERIFICATION REQUIRE-
11 MENTS.

12 5. THE DIVISION SHALL ESTABLISH AND OPERATE A TELEPHONE NUMBER AS
13 PROVIDED FOR IN SECTION ONE HUNDRED SIXTY-NINE-M OF THIS ARTICLE.

14 6. THE DIVISION SHALL ESTABLISH A DIRECTORY PURSUANT TO SECTION ONE
15 HUNDRED SIXTY-NINE-N OF THIS ARTICLE.

16 7. THE DIVISION SHALL ESTABLISH A PUBLIC AWARENESS CAMPAIGN TO ADVISE
17 THE PUBLIC OF THE PROVISIONS OF THIS ARTICLE.

18 8. (A) THE DIVISION SHALL CHARGE AN ADMINISTRATIVE FEE TO A DOMESTIC
19 ABUSE OFFENDER TO COVER THE COST OF INCLUSION ON THE REGISTRY. SUCH FEE
20 SHALL BE SET AT A REASONABLE RATE TO BE DETERMINED PERIODICALLY BY THE
21 DIVISION.

22 (B) THE DIVISION SHALL CHARGE A FEE OF TEN DOLLARS EACH TIME A DOME-
23 STIC ABUSE OFFENDER REGISTERS ANY CHANGE OF ADDRESS OR ANY CHANGE OF HIS
24 OR HER STATUS OF ENROLLMENT, ATTENDANCE, EMPLOYMENT OR RESIDENCE AT ANY
25 INSTITUTION OF HIGHER EDUCATION AS REQUIRED BY SUBDIVISION THREE OF
26 SECTION ONE HUNDRED SIXTY-NINE-F OF THIS ARTICLE. THE FEE SHALL BE PAID
27 TO THE DIVISION BY THE DOMESTIC ABUSE OFFENDER. THE STATE COMPTROLLER IS
28 HEREBY AUTHORIZED TO DEPOSIT SUCH FEES INTO THE GENERAL FUND.

29 S 169-C. DOMESTIC ABUSE OFFENDER; RELOCATION; NOTIFICATION. 1. IN THE
30 CASE OF ANY DOMESTIC ABUSE OFFENDER, IT SHALL BE THE DUTY OF THE DEPART-
31 MENT OR LOCAL CORRECTIONAL FACILITY AT LEAST TEN CALENDAR DAYS PRIOR TO
32 THE RELEASE OR DISCHARGE OF ANY DOMESTIC ABUSE OFFENDER FROM A CORREC-
33 TIONAL FACILITY OR LOCAL CORRECTIONAL FACILITY TO NOTIFY THE DIVISION OF
34 THE CONTEMPLATED RELEASE OR DISCHARGE OF SUCH DOMESTIC ABUSE OFFENDER,
35 INFORMING THE DIVISION IN WRITING ON A FORM PROVIDED BY THE DIVISION
36 INDICATING THE ADDRESS AT WHICH HE OR SHE PROPOSES TO RESIDE AND THE
37 NAME AND ADDRESS OF ANY INSTITUTION OF HIGHER EDUCATION AT WHICH HE OR
38 SHE EXPECTS TO BE ENROLLED, ATTENDING OR EMPLOYED, WHETHER FOR COMPEN-
39 SATION OR NOT, AND WHETHER HE OR SHE RESIDES IN OR WILL RESIDE IN A
40 FACILITY OWNED OR OPERATED BY SUCH INSTITUTION. IF SUCH DOMESTIC ABUSE
41 OFFENDER CHANGES HIS OR HER PLACE OF RESIDENCE WHILE ON PAROLE, SUCH
42 NOTIFICATION OF THE CHANGE OF RESIDENCE SHALL BE SENT BY THE DOMESTIC
43 ABUSE OFFENDER'S PAROLE OFFICER WITHIN FORTY-EIGHT HOURS TO THE DIVISION
44 ON A FORM PROVIDED BY THE DIVISION. IF SUCH DOMESTIC ABUSE OFFENDER
45 CHANGES THE STATUS OF HIS OR HER ENROLLMENT, ATTENDANCE, EMPLOYMENT OR
46 RESIDENCE AT ANY INSTITUTION OF HIGHER EDUCATION WHILE ON PAROLE, SUCH
47 NOTIFICATION OF THE CHANGE OF STATUS SHALL BE SENT BY THE DOMESTIC ABUSE
48 OFFENDER'S PAROLE OFFICER WITHIN FORTY-EIGHT HOURS TO THE DIVISION ON A
49 FORM PROVIDED BY THE DIVISION.

50 2. IN THE CASE OF ANY DOMESTIC ABUSE OFFENDER ON PROBATION, IT SHALL
51 BE THE DUTY OF THE DOMESTIC ABUSE OFFENDER'S PROBATION OFFICER TO NOTIFY
52 THE DIVISION WITHIN FORTY-EIGHT HOURS OF THE NEW PLACE OF RESIDENCE ON A
53 FORM PROVIDED BY THE DIVISION. IF SUCH DOMESTIC ABUSE OFFENDER CHANGES
54 THE STATUS OF HIS OR HER ENROLLMENT, ATTENDANCE, EMPLOYMENT OR RESIDENCE
55 AT ANY INSTITUTION OF HIGHER EDUCATION WHILE ON PROBATION, SUCH NOTIFI-
56 CATION OF THE CHANGE OF STATUS SHALL BE SENT BY THE DOMESTIC ABUSE

1 OFFENDER'S PROBATION OFFICER WITHIN FORTY-EIGHT HOURS TO THE DIVISION ON
2 A FORM PROVIDED BY THE DIVISION.

3 3. IN THE CASE IN WHICH ANY DOMESTIC ABUSE OFFENDER ESCAPES FROM A
4 STATE OR LOCAL CORRECTIONAL FACILITY, THE DESIGNATED OFFICIAL OF THE
5 FACILITY WHERE THE DOMESTIC ABUSE OFFENDER WAS CONFINED SHALL NOTIFY
6 WITHIN TWENTY-FOUR HOURS THE LAW ENFORCEMENT AGENCY HAVING HAD JURISDIC-
7 TION AT THE TIME OF HIS OR HER CONVICTION, INFORMING SUCH LAW ENFORCE-
8 MENT AGENCY OF THE NAME AND ALIASES OF THE DOMESTIC ABUSE OFFENDER, AND
9 THE ADDRESS AT WHICH HE OR SHE RESIDED AT THE TIME OF HIS OR HER
10 CONVICTION, THE AMOUNT OF TIME REMAINING TO BE SERVED, IF ANY, ON THE
11 FULL TERM FOR WHICH HE OR SHE WAS SENTENCED, AND THE NATURE OF THE CRIME
12 FOR WHICH HE OR SHE WAS SENTENCED, TRANSMITTING AT THE SAME TIME A COPY
13 OF SUCH DOMESTIC ABUSE OFFENDER'S FINGERPRINTS AND PHOTOGRAPH AND A
14 SUMMARY OF HIS OR HER CRIMINAL RECORD.

15 4. THE DIVISION SHALL PROVIDE GENERAL INFORMATION, IN REGISTRATION
16 MATERIALS AND ANNUAL CORRESPONDENCE, TO REGISTRANTS CONCERNING NOTIFICA-
17 TION AND REGISTRATION PROCEDURES THAT MAY APPLY IF THE REGISTRANT IS
18 AUTHORIZED TO RELOCATE AND RELOCATES TO ANOTHER STATE OR UNITED STATES
19 POSSESSION, OR COMMENCES EMPLOYMENT OR ATTENDANCE AT AN EDUCATIONAL
20 INSTITUTION IN ANOTHER STATE OR UNITED STATES POSSESSION. SUCH INFORMA-
21 TION SHALL INCLUDE ADDRESSES AND TELEPHONE NUMBERS FOR RELEVANT AGENCIES
22 FROM WHICH ADDITIONAL INFORMATION MAY BE OBTAINED.

23 S 169-D. DUTIES OF THE COURT. 1. UPON CONVICTION OF ANY OF THE
24 OFFENSES SET FORTH IN SUBDIVISION TWO OF SECTION ONE HUNDRED
25 SIXTY-NINE-A OF THIS ARTICLE THE COURT SHALL CERTIFY THAT THE PERSON IS
26 A DOMESTIC ABUSE OFFENDER AND SHALL INCLUDE THE CERTIFICATION IN THE
27 JUDGMENT OF CONVICTION. THE COURT SHALL ALSO ADVISE THE DOMESTIC ABUSE
28 OFFENDER OF HIS OR HER DUTIES UNDER THIS ARTICLE. FAILURE TO INCLUDE THE
29 CERTIFICATION IN THE JUDGMENT OF CONVICTION SHALL NOT RELIEVE A DOMESTIC
30 ABUSE OFFENDER OF THE OBLIGATIONS IMPOSED BY THIS ARTICLE.

31 2. ANY DOMESTIC ABUSE OFFENDER WHO HAS BEEN CONVICTED OF A VIOLENT
32 FELONY OR TWO OR MORE MISDEMEANORS AGAINST A PERSON WHO IS A MEMBER OF
33 SUCH OFFENDER'S FAMILY OR HOUSEHOLD AS DEFINED IN SECTION 530.12 OF THE
34 CRIMINAL PROCEDURE LAW, WHO IS RELEASED ON PROBATION OR DISCHARGED UPON
35 PAYMENT OF A FINE, CONDITIONAL DISCHARGE OR UNCONDITIONAL DISCHARGE
36 SHALL, PRIOR TO SUCH RELEASE OR DISCHARGE, BE INFORMED OF HIS OR HER
37 DUTY TO REGISTER UNDER THIS ARTICLE BY THE COURT IN WHICH HE OR SHE WAS
38 CONVICTED. AT THE TIME SENTENCE IS IMPOSED, SUCH DOMESTIC ABUSE OFFENDER
39 SHALL REGISTER WITH THE DIVISION ON A FORM PREPARED BY THE DIVISION. THE
40 COURT SHALL REQUIRE THE DOMESTIC ABUSE OFFENDER TO READ AND SIGN SUCH
41 FORM AND TO COMPLETE THE REGISTRATION PORTION OF SUCH FORM. THE COURT
42 SHALL ON SUCH FORM OBTAIN THE ADDRESS WHERE THE DOMESTIC ABUSE OFFENDER
43 EXPECTS TO RESIDE UPON HIS OR HER RELEASE, AND THE NAME AND ADDRESS OF
44 ANY INSTITUTION OF HIGHER EDUCATION HE OR SHE EXPECTS TO BE EMPLOYED BY,
45 ENROLLED IN, ATTENDING OR EMPLOYED, WHETHER FOR COMPENSATION OR NOT, AND
46 WHETHER HE OR SHE EXPECTS TO RESIDE IN A FACILITY OWNED OR OPERATED BY
47 SUCH AN INSTITUTION, AND SHALL REPORT SUCH INFORMATION TO THE DIVISION.
48 THE COURT SHALL GIVE ONE COPY OF THE FORM TO THE DOMESTIC ABUSE OFFENDER
49 AND SHALL SEND TWO COPIES TO THE DIVISION WHICH SHALL FORWARD THE INFOR-
50 MATION TO THE LAW ENFORCEMENT AGENCIES HAVING JURISDICTION. WHERE THE
51 COURT ORDERS A DOMESTIC ABUSE OFFENDER RELEASED ON PROBATION, SUCH ORDER
52 MUST INCLUDE A PROVISION REQUIRING THAT HE OR SHE COMPLY WITH THE
53 REQUIREMENTS OF THIS ARTICLE. WHERE SUCH DOMESTIC ABUSE OFFENDER
54 VIOLATES SUCH PROVISION, PROBATION MAY BE IMMEDIATELY REVOKED IN THE
55 MANNER PROVIDED BY ARTICLE FOUR HUNDRED TEN OF THE CRIMINAL PROCEDURE
56 LAW.

1 3. NOTWITHSTANDING ANY OTHER PROVISION OF LAW TO THE CONTRARY, IT
2 SHALL BE IN THE COURTS DISCRETION TO REQUIRE AN OFFENDER TO REGISTER
3 PURSUANT TO THIS ARTICLE. IN DETERMINING WHETHER AN OFFENDER SHOULD BE
4 ON THE REGISTRY, A JUDGE SHALL CONSIDER, AMONG OTHER THINGS, WHETHER THE

9 SCREENING INSTRUMENT OR A KINGSTON SCREENING INSTRUMENT FOR DOMESTIC
10 VIOLENCE OR OTHER THREAT ASSESSMENT AS THE COURT MAY DEEM APPROPRIATE.

11 4. THE COURT SHALL PROVIDE REASONABLE OPPORTUNITY TO A VICTIM TO
12 OBJECT TO AN OFFENDER'S INCLUSION IN THE REGISTRY AND SHALL TAKE SUCH
13 INFORMATION INTO ACCOUNT WHILE DETERMINING THE OFFENDER'S INCLUSION
14 PURSUANT TO SUBDIVISION THREE OF THIS SECTION.

15 S 169-E. DISCHARGE OF DOMESTIC ABUSE OFFENDER FROM CORRECTIONAL FACIL-
16 ITY; DUTIES OF OFFICIAL IN CHARGE. 1. ANY DOMESTIC ABUSE OFFENDER, TO BE
17 DISCHARGED, PAROLED, RELEASED TO POST-RELEASE SUPERVISION OR RELEASED
18 FROM ANY STATE OR LOCAL CORRECTIONAL FACILITY, SHALL AT LEAST FIFTEEN
19 CALENDAR DAYS PRIOR TO DISCHARGE, PAROLE OR RELEASE, BE INFORMED OF HIS
20 OR HER DUTY TO REGISTER UNDER THIS ARTICLE, BY THE FACILITY IN WHICH HE
21 OR SHE WAS CONFINED. THE FACILITY SHALL REQUIRE THE DOMESTIC ABUSE
22 OFFENDER TO READ AND SIGN SUCH FORM AS MAY BE REQUIRED BY THE DIVISION
23 STATING THE DUTY TO REGISTER AND THE PROCEDURE FOR REGISTRATION HAS BEEN
24 EXPLAINED TO HIM OR HER AND TO COMPLETE THE REGISTRATION PORTION OF SUCH
25 FORM. THE FACILITY SHALL OBTAIN ON SUCH FORM THE ADDRESS WHERE THE
26 DOMESTIC ABUSE OFFENDER EXPECTS TO RESIDE UPON HIS OR HER DISCHARGE,
27 PAROLE OR RELEASE AND THE NAME AND ADDRESS OF ANY INSTITUTION OF HIGHER
28 EDUCATION HE OR SHE EXPECTS TO BE EMPLOYED BY, ENROLLED IN, ATTENDING OR
29 EMPLOYED, WHETHER FOR COMPENSATION OR NOT, AND WHETHER HE OR SHE EXPECTS
30 TO RESIDE IN A FACILITY OWNED OR OPERATED BY SUCH AN INSTITUTION, AND
31 SHALL REPORT SUCH INFORMATION TO THE DIVISION. THE FACILITY SHALL GIVE
32 ONE COPY OF THE FORM TO THE DOMESTIC ABUSE OFFENDER, RETAIN ONE COPY AND
33 SHALL SEND ONE COPY TO THE DIVISION WHICH SHALL PROVIDE THE INFORMATION
34 TO THE LAW ENFORCEMENT AGENCIES HAVING JURISDICTION. THE FACILITY SHALL
35 GIVE THE DOMESTIC ABUSE OFFENDER A FORM PREPARED BY THE DIVISION, TO
36 REGISTER WITH THE DIVISION AT LEAST FIFTEEN CALENDAR DAYS PRIOR TO
37 RELEASE AND SUCH FORM SHALL BE COMPLETED, SIGNED BY THE DOMESTIC ABUSE
38 OFFENDER AND SENT TO THE DIVISION BY THE FACILITY AT LEAST TEN DAYS
39 PRIOR TO THE DOMESTIC ABUSE OFFENDER'S RELEASE OR DISCHARGE.

40 2. THE DIVISION SHALL ALSO IMMEDIATELY TRANSMIT THE CONVICTION DATA
41 AND FINGERPRINTS TO THE FEDERAL BUREAU OF INVESTIGATION IF NOT ALREADY
42 OBTAINED.

43 S 169-F. DUTY TO REGISTER AND TO VERIFY. 1. ANY DOMESTIC ABUSE OFFEN-
44 DER SHALL (A) AT LEAST TEN CALENDAR DAYS PRIOR TO DISCHARGE, PAROLE,
45 RELEASE TO POST-RELEASE SUPERVISION OR RELEASE FROM ANY STATE OR LOCAL
46 CORRECTIONAL FACILITY WHERE HE OR SHE WAS CONFINED, OR (B) IF RELEASED
47 ON PROBATION OR DISCHARGED UPON PAYMENT OF A FINE, CONDITIONAL DISCHARGE
48 OR UNCONDITIONAL DISCHARGE, AT THE TIME SENTENCE IS IMPOSED, REGISTER
49 WITH THE DIVISION ON A FORM PREPARED BY THE DIVISION.

50 2. ANY DOMESTIC ABUSE OFFENDER REQUIRED TO REGISTER UNDER THIS ARTICLE
51 SHALL ON OR BEFORE EACH ANNIVERSARY OF THE DOMESTIC ABUSE OFFENDER'S

55 3. ANY DOMESTIC ABUSE OFFENDER SHALL REGISTER WITH THE DIVISION NO
56 LATER THAN TEN CALENDAR DAYS AFTER ANY CHANGE OF ADDRESS OR ANY CHANGE

1 OF HIS OR HER STATUS OF ENROLLMENT, ATTENDANCE, EMPLOYMENT OR RESIDENCE
2 AT ANY INSTITUTION OF HIGHER EDUCATION. A FEE OF TEN DOLLARS, AS AUTHOR-
3 IZED BY SUBDIVISION EIGHT OF SECTION ONE HUNDRED SIXTY-NINE-B OF THIS
4 ARTICLE, SHALL BE SUBMITTED BY THE DOMESTIC ABUSE OFFENDER EACH TIME
5 SUCH DOMESTIC ABUSE OFFENDER REGISTERS ANY CHANGE OF ADDRESS OR ANY
6 CHANGE OF HIS OR HER STATUS OF ENROLLMENT, ATTENDANCE, EMPLOYMENT OR

19 INSTITUTION IN THE STATE. ANY NONRESIDENT WORKER OR NONRESIDENT STUDENT
20 SHALL NOTIFY THE DIVISION OF ANY CHANGE OF RESIDENCE, EMPLOYMENT OR
21 EDUCATIONAL INSTITUTION ADDRESS NO LATER THAN TEN DAYS AFTER SUCH
22 CHANGE. THE DIVISION SHALL NOTIFY THE LAW ENFORCEMENT AGENCY WHERE THE
23 NONRESIDENT WORKER IS EMPLOYED OR THE EDUCATIONAL INSTITUTION IS LOCATED
24 THAT A NONRESIDENT WORKER OR NONRESIDENT STUDENT IS PRESENT IN THAT
25 AGENCY'S JURISDICTION.

26 S 169-G. PRIOR CONVICTIONS; DUTY TO INFORM AND REGISTER. 1. EVERY
27 DOMESTIC ABUSE OFFENDER WHO ON THE EFFECTIVE DATE OF THIS ARTICLE IS
28 THEN ON PAROLE OR PROBATION FOR AN OFFENSE PROVIDED FOR IN SUBDIVISION
29 TWO OF SECTION ONE HUNDRED SIXTY-NINE-A OF THIS ARTICLE SHALL WITHIN
30 THIRTY CALENDAR DAYS OF SUCH EFFECTIVE DATE REGISTER WITH HIS OR HER

31 AND WHO HAS BEEN REGISTERED FOR A MINIMUM PERIOD OF TEN YEARS MAY BE
32 RELIEVED OF ANY FURTHER DUTY TO REGISTER UPON THE GRANTING OF A PETITION

52 S 169-N. DIRECTORY; INTERNET POSTING. 1. THE DIVISION SHALL MAINTAIN A
53 DIRECTORY OF DOMESTIC ABUSE OFFENDERS. THE DIRECTORY SHALL INCLUDE THE
54 ADDRESS, ADDRESS OF THE OFFENDER'S PLACE OF EMPLOYMENT AND PHOTOGRAPH OF
55 THE DOMESTIC ABUSE OFFENDER ALONG WITH THE FOLLOWING INFORMATION, IF
56 AVAILABLE: NAME, PHYSICAL DESCRIPTION, AGE AND DISTINCTIVE MARKINGS. THE

1 DIRECTORY SHALL HAVE DOMESTIC ABUSE OFFENDER LISTINGS CATEGORIZED BY
2 COUNTY AND ZIP CODE. A COPY OF THE DIRECTORY SHALL ANNUALLY BE DISTRIB-
3 UTED TO THE OFFICES OF LOCAL, VILLAGE, TOWN, CITY, COUNTY OR STATE LAW
4 ENFORCEMENT AGENCIES FOR PURPOSES OF PUBLIC ACCESS. THE DIVISION SHALL

40 such report in conjunction with, and shall consider and include in such
41 report the recommendations of, the empire state development corporation,
42 the office of parks, recreation and historic preservation, the depart-
43 ment of environmental conservation, the mayor of the city of Buffalo,

37 the south and east by Ogdensburg Bridge and Port Authority lands, on the
38 north by Woods Road, and southwest of any St. Lawrence Psychiatric
39 Center Buildings.

40 Parcel 3: 25 acres for Co-generation development, bounded to the south
41 by Entrance Drive, on the east by Cottage Road, on the north by Office
42 of Mental Health long-term property.

43 S 3. The description of the lands set forth in section two of this act
44 to be conveyed is not intended to be a legal description, but is
45 intended only to identify the premises to be conveyed. As a condition of
46 purchase, the City of Ogdensburg shall submit to the commissioner of the
47 office of general services for said commissioner's approval an accurate
48 survey and description of the lands generally described, which may be
49 used in the conveyance thereof.

9 FIREFIGHTER SERVICE, WHICH EXAMINATION FAILED TO REVEAL ANY EVIDENCE OF
10 SUCH A MELANOMA OR CONDITION, SHALL BE PRESUMPTIVE EVIDENCE THAT IT WAS
11 INCURRED IN THE PERFORMANCE AND DISCHARGE OF DUTY UNLESS THE CONTRARY BE
12 PROVEN BY COMPETENT EVIDENCE.

13 S 2. This act shall take effect immediately and shall expire and be
14 deemed repealed June 30, 2020.

16 Section 1. Section 8 of the volunteer firefighters' benefit law, as
17 amended by chapter 574 of the laws of 1998, is amended to read as
18 follows:

19 S 8. Permanent total disability benefits. 1. In the case of total
20 disability adjudged to be permanent the volunteer firefighter shall be
21 paid four hundred dollars for each week [during the continuance there-
22 of]. Permanent total disability, within the meaning of this section,
23 shall exist only if the earning capacity of the volunteer firefighter
24 has been lost permanently and totally as the result of the injury. The
25 loss of both hands, or both arms, or both feet, or both legs, or both
26 eyes, or any two thereof, shall, in the absence of conclusive proof to
27 the contrary, constitute permanent total disability, but in all other
28 cases permanent total disability shall be determined in accordance with
29 the facts. Notwithstanding any other provisions of this chapter, an
30 injured volunteer firefighter disabled due to the loss or total loss of
31 use of both eyes, or both hands, or both arms, or both feet, or both
32 legs, or any two thereof shall not suffer any diminution of such weekly
33 benefit by engaging in business or employment provided his or her weekly
34 earnings or wages, when combined with his or her weekly benefit shall
35 not be in excess of [six] EIGHT hundred dollars; and further provided
36 that the application of this section shall not result in reduction of
37 benefits which an injured volunteer firefighter who is disabled due to
38 the loss or total loss of use of both eyes, or both hands, or both arms,
39 or both feet, or both legs, or any two thereof would otherwise be enti-
40 tled to under any other provisions of this article.

41 2. BENEFITS RECEIVED PURSUANT TO SUBDIVISION ONE OF THIS SECTION AFTER
42 JANUARY FIRST, TWO THOUSAND SIXTEEN SHALL BE ADJUSTED YEARLY ON FEBRUARY
43 FIRST BY A PERCENTAGE EQUAL TO THE PERCENT INCREASE IN THE PREVIOUS

45 S 2. Subdivision 5 of section 51 of the volunteer firefighters' bene-

Notwithstanding the provisions of subdivision one of this paragraph[,]: (A) bonds issued by a school district prior to December first two thousand one, or prior to thirty days after the effective date of this subdivision, whichever is later, for the purpose of financing facilities which were eligible for building aid pursuant to section thirty-six hundred two of the education law, and for which the aid apportionments payable in two thousand two--two thousand three and/or two thousand three--two thousand four school years for approved expenditures for debt service are subsequently reduced as a result of the application of assumed amortization to unpaid principal outstanding as of July first, two thousand two, may be refunded and the refunding bonds may be sold at either public or private sale in accordance with the provisions of section 90.10 of this title; provided, however, the school district need not comply with: (i) subparagraph (a) of subdivision two of paragraph b of section 90.10 of this title; and (ii) if the bonds to be refunded are to be redeemed or paid on the same date as the refunding bonds are issued, the school district need not comply with the provisions of section 90.10 of this title relating to the escrow of the proceeds of the sale of the refunding bonds; AND (B) BONDS ISSUED BY A MUNICIPALITY AUTHORIZED TO CREATE A COMMUNITY PRESERVATION FUND PURSUANT TO SUBDIVISION TWO OF SECTION SIXTY-FOUR-E OF THE TOWN LAW AND FOR THE PURPOSE OF FINANCING COMMUNITY PRESERVATION WHICH WERE ELIGIBLE FOR FUNDING PURSUANT TO SUBDIVISIONS THREE AND FOUR OF SECTION SIXTY-FOUR-E OF THE TOWN LAW MAY BE REFUNDED AND THE REFUNDING BONDS MAY BE SOLD AT EITHER PUBLIC OR PRIVATE SALE IN ACCORDANCE WITH THE PROVISIONS OF SECTION 90.10 OF THIS TITLE; PROVIDED, HOWEVER, THE MUNICIPALITY NEED NOT COMPLY WITH: (I) SUBPARAGRAPH (A) OF SUBDIVISION TWO OF PARAGRAPH B OF SECTION 90.10 OF THIS TITLE; AND (II) IF THE BONDS TO BE REFUNDED ARE TO BE REDEEMED OR PAID ON THE SAME DATE AS THE REFUNDING BONDS ARE ISSUED, THE MUNICIPALITY NEED NOT COMPLY WITH THE PROVISIONS OF SECTION 90.10 OF THIS TITLE RELATING TO THE ESCROW OF THE PROCEEDS OF THE SALE OF THE REFUNDING BONDS.

4. 44 receives pursuant to the compact shall be distributed in accordance with

48 facility shall collectively receive a minimum of twenty-five percent of

49 (iii) all other monies appropriated or received for distribution

11 GROUP PURCHASING PROGRAMS AND REAL ESTATE SETTLEMENT PROGRAMS;

12 (D) PROVIDING REAL ESTATE SERVICES INCLUDING BUT NOT LIMITED TO
13 BROKERAGE, APPRAISAL, INSPECTION, PROPERTY MANAGEMENT, AND LEASING OF
14 EXCESS PROPERTY;

15 (E) LEASING OF PERSONAL PROPERTY TO CUSTOMERS;

16 (F) PROVIDING LOAN SUPPORT SERVICES INCLUDING BUT NOT LIMITED TO DEBT
17 COLLECTION SERVICES, LOAN PROCESSING, SERVICE AND SALES, REAL ESTATE
18 SETTLEMENT SERVICES, PURCHASING AND SERVICING OF NON-PERFORMING LOANS
19 AND REFERRAL AND PROCESSING OF LOAN APPLICATIONS;

20 (G) RECORD RETENTION, SECURITY AND DISASTER RECOVERY SERVICES INCLUD-
21 ING BUT NOT LIMITED TO ALARM-MONITORING AND OTHER SECURITY SERVICES,
22 DISASTER RECOVERY SERVICES, MICROFILM, MICROFICHE, OPTICAL AND ELECTRON-
23 IC IMAGING, CD-ROM DATA STORAGE AND RETRIEVAL SERVICES, PROVISION OF
24 FORMS AND SUPPLIES AND RECORD RETENTION AND STORAGE;

25 (H) SECURITIES BROKERAGE SERVICES;

26 (I) SHARED COMMUNITY BANK BRANCH OPERATIONS;

27 (J) STUDENT LOAN ORIGATION, INCLUDING THE AUTHORITY TO BUY AND SELL
28 PARTICIPATION INTERESTS IN SUCH LOANS;

29 (K) TRAVEL AGENCY AND TAX PREPARATION SERVICES;

30 (L) PROVIDING COURIER SERVICES;

31 (M) TRUST AND TRUST RELATED SERVICES INCLUDING BUT NOT LIMITED TO
32 ACTING AS ADMINISTRATOR FOR PREPAID LEGAL SERVICE PLANS, ACTING AS TRUS-

39 (R) SPONSORING, ORGANIZING AND ADVISING OPEN-ENDED MUTUAL FUNDS;
40 PROVIDED THAT ALL OF THE STOCK OF SUCH SERVICE CORPORATIONS IS, OR IS TO
41 BE, OWNED BY ONE OR MORE COMMUNITY BANKS; AND PROVIDED FURTHER, THAT NO
42 COMMUNITY BANK MAY MAKE ANY INVESTMENT UNDER THIS SECTION IF ITS AGGRE-
43 GATE OUTSTANDING INVESTMENT THEREBY, DETERMINED AS PRESCRIBED BY THE
44 SUPERINTENDENT, WOULD EXCEED FIVE PER CENTUM OF ITS ASSETS.

17 EMPLOYEES' RETIREMENT SYSTEM, WHO RETIRE PURSUANT TO SECTION FIVE
18 HUNDRED SIX OR FIVE HUNDRED SEVEN OF THIS ARTICLE. THE ORDINARY OR ACCI-
19 DENTAL DISABILITY RETIREMENT BENEFIT OF MEMBERS OF THE NEW YORK FIRE
20 DEPARTMENT PENSION FUND, THE ORDINARY OR ACCIDENTAL DISABILITY RETIRE-
21 MENT BENEFIT OF SANITATION AND CORRECTION MEMBERS OF THE NEW YORK CITY
22 EMPLOYEES' RETIREMENT SYSTEM, OR THE ORDINARY OR ACCIDENTAL DISABILITY
23 RETIREMENT BENEFIT OF UNIFORMED COURT OFFICERS IN THE NEW YORK CITY
24 EMPLOYEES' RETIREMENT SYSTEM WHO RETIRE PURSUANT TO SECTION FIVE HUNDRED

3 S 2. Severability clause. If any clause, sentence, paragraph, subdivi-
4 sion, section or part of this act shall be adjudged by any court of
5 competent jurisdiction to be invalid, such judgment shall not affect,
6 impair, or invalidate the remainder thereof, but shall be confined in
7 its operation to the clause, sentence, paragraph, subdivision, section
