AN ACT to amend chapter 142 of the laws of 2014, amending the environmental conservation law relating to authorizing hunting in the county of Livingston, in relation to making the provisions thereof permanent; and to amend the environmental conservation law, in relation to making deer and bear hunting in the county of Livingston permanent

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Section 3 of chapter 142 of the laws of 2014, amending the environmental conservation law relating to authorizing hunting in the county of Livingston, is amended to read as follows:

S 3. This act shall take effect immediately, provided that[:

- b. nothing contained in this act shall be construed so as to extend the provisions of this act beyond October 1, 2016, when upon such date this act shall expire and the provisions contained herein shall be deemed repealed].
