- AN ACT to amend the insurance law, in relation to requiring health insurance coverage for drug and alcohol abuse and dependency treatment services

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Subsection (i) of section 3216 of the insurance law is amended by adding a new paragraph 33 to read as follows:

3 (33) (A) EVERY POLICY DELIVERED OR ISSUED FOR DELIVERY IN THIS STATE 4 WHICH PROVIDES MEDICAL, MAJOR MEDICAL OR SIMILAR COMPREHENSIVE-TYPE 5 COVERAGE SHALL INCLUDE SPECIFIC COVERAGE FOR DRUG AND ALCOHOL ABUSE AND 6 DEPENDENCY TREATMENT SERVICES THAT ARE CERTIFIED AS NECESSARY BY A QUAL-7 IFIED HEALTH PROFESSIONAL, AS DEFINED IN THE REGULATIONS OF THE COMMIS-8 SIONER OF ALCOHOLISM AND SUBSTANCE ABUSE SERVICES. AT A MINIMUM SUCH 9 COVERAGE SHALL INCLUDE:

10 (I) UP TO SEVEN DAYS OF DETOXIFICATION PER ADMISSION, SUCH DETOXIFICA-11 TION MAY OCCUR IN A HOSPITAL OR NON-HOSPITAL RESIDENTIAL FACILITY;

12 (II) THIRTY DAYS OF REHABILITATION PER EPISODE IN A HOSPITAL OR 13 NON-HOSPITAL RESIDENTIAL FACILITY;

14 (III) THIRTY SESSIONS OF OUTPATIENT OR PARTIAL HOSPITALIZATION PER 15 EPISODE OF CARE; AND

(IV) FAMILY COUNSELING AND INTERVENTION SERVICES.

(B) THE ONLY PREREQUISITE FOR THE COVERAGE OF HOSPITAL OR NON-HOSPITAL 17 18 BASED DETOXIFICATION, INCLUDING MEDICALLY MANAGED, MEDICALLY SUPERVISED 19 AND MEDICALLY MONITORED WITHDRAWAL, OR INPATIENT OR INTENSIVE RESIDEN-20 TIAL REHABILITATION, OR INTENSIVE OR ROUTINE OUTPATIENT TREATMENT, SHALL BE THAT A COVERED PERSON BE CERTIFIED AND REFERRED BY A OUALIFIED HEALTH 21 PROFESSIONAL. SUCH CERTIFICATION AND REFERRAL 22 SHALL CONTROL BOTH THE AND DURATION OF COVERED TREATMENT; PROVIDED, HOWEVER, THAT SUCH 23 NATURE 24 COVERAGE SHALL BE TERMINATED WHEN THE ADMITTING OR ATTENDING PHYSICIAN, 25 OR A PHYSICIAN ASSISTANT OR NURSE PRACTITIONER PROVIDING DETOXIFICATION, 26 REHABILITATION OR OUTPATIENT TREATMENT CERTIFIES THAT ADMISSION OF THE

7 S 2. Subsection (1) of section 3221 of the insurance law is amended by 8 adding a new paragraph 19 to read as follows:

9 (A) EVERY GROUP OR BLANKET POLICY DELIVERED OR ISSUED FOR DELIV-(19) 10 ERY IN THIS STATE WHICH PROVIDES MEDICAL, MAJOR MEDICAL OR SIMILAR COMPREHENSIVE-TYPE COVERAGE SHALL INCLUDE SPECIFIC COVERAGE FOR DRUG AND 11 ALCOHOL ABUSE AND DEPENDENCY TREATMENT SERVICES THAT ARE CERTIFIED AS 12 NECESSARY BY A QUALIFIED HEALTH PROFESSIONAL, AS DEFINED IN 13 THE REGU-14 LATIONS OF THE COMMISSIONER OF ALCOHOLISM AND SUBSTANCE ABUSE SERVICES. 15 AT A MINIMUM SUCH COVERAGE SHALL INCLUDE:

16 (I) UP TO SEVEN DAYS OF DETOXIFICATION PER ADMISSION, SUCH DETOXIFICA-17 TION MAY OCCUR IN A HOSPITAL OR NON-HOSPITAL RESIDENTIAL FACILITY;

(II) THIRTY DAYS OF REHABILITATION PER EPISODE IN A HOSPITAL 18 OR 19 NON-HOSPITAL RESIDENTIAL FACILITY;

20 THIRTY SESSIONS OF OUTPATIENT OR PARTIAL HOSPITALIZATION PER (III) 21 EPISODE; AND 22

(IV) FAMILY COUNSELING AND INTERVENTION SERVICES.

23 (B) THE ONLY PREREOUISITE FOR THE COVERAGE OF HOSPITAL OR NON-HOSPITAL 24 BASED DETOXIFICATION, INCLUDING MEDICALLY MANAGED, MEDICALLY SUPERVISED 25 AND MEDICALLY MONITORED WITHDRAWAL, OR INPATIENT OR INTENSIVE RESIDEN-26 TIAL REHABILITATION, OR INTENSIVE OR ROUTINE OUTPATIENT TREATMENT, SHALL 27 BE THAT A COVERED PERSON BE CERTIFIED AND REFERRED BY A QUALIFIED HEALTH 28 PROFESSIONAL. SUCH CERTIFICATION AND REFERRAL SHALL CONTROL BOTH THE NATURE AND DURATION OF COVERED TREATMENT; PROVIDED, HOWEVER, THAT SUCH 29 COVERAGE SHALL BE TERMINATED WHEN THE ADMITTING OR ATTENDING PHYSICIAN, 30 OR A PHYSICIAN ASSISTANT OR NURSE PRACTITIONER PROVIDING DETOXIFICATION, 31 32 REHABILITATION OR OUTPATIENT TREATMENT CERTIFIES THAT ADMISSION OF THE 33 COVERED PERSON IS NOT NECESSARY, EARLY DISCHARGE IS APPROPRIATE OR ADDI-34 TIONAL INPATIENT DAYS OR SESSIONS ARE NECESSARY.

39 S 3. Section 4303 of the insurance law is amended by adding а new 40 subsection (qq) to read as follows:

(QQ) (1) EVERY CONTRACT ISSUED BY A HOSPITAL SERVICE COMPANY OR HEALTH 41 42 SERVICE CORPORATION WHICH PROVIDES MEDICAL, MAJOR MEDICAL OR SIMILAR 43 COMPREHENSIVE-TYPE COVERAGE SHALL INCLUDE SPECIFIC COVERAGE FOR DRUG AND 44 ALCOHOL ABUSE AND DEPENDENCY TREATMENT SERVICES THAT ARE CERTIFIED AS 45 NECESSARY BY A OUALIFIED HEALTH PROFESSIONAL, AS DEFINED IN THE REGU-46 LATIONS OF THE COMMISSIONER OF ALCOHOLISM AND SUBSTANCE ABUSE SERVICES. 47 AT A MINIMUM SUCH COVERAGE SHALL INCLUDE:

48 (A) UP TO SEVEN DAYS OF DETOXIFICATION PER ADMISSION, SUCH DETOXIFICA-49 TION MAY OCCUR IN A HOSPITAL OR NON-HOSPITAL RESIDENTIAL FACILITY;

50 THIRTY DAYS OF REHABILITATION PER EPISODE IN A HOSPITAL OR (B) 51 NON-HOSPITAL RESIDENTIAL FACILITY;

(C) THIRTY SESSIONS OF OUTPATIENT OR PARTIAL HOSPITALIZATION PER 52 53 EPISODE; AND

54 (D) FAMILY COUNSELING AND INTERVENTION SERVICES.

55 (2) THE ONLY PREREQUISITE FOR THE COVERAGE OF HOSPITAL OR NON-HOSPITAL 56 BASED DETOXIFICATION, INCLUDING MEDICALLY MANAGED, MEDICALLY SUPERVISED

AND MEDICALLY MONITORED WITHDRAWAL, OR INPATIENT OR INTENSIVE RESIDEN-1 TIAL REHABILITATION, OR INTENSIVE OR ROUTINE OUTPATIENT TREATMENT, SHALL 2 3 BE THAT A COVERED PERSON BE CERTIFIED AND REFERRED BY A QUALIFIED HEALTH 4 PROFESSIONAL. SUCH CERTIFICATION AND REFERRAL SHALL CONTROL BOTH THE 5 NATURE AND DURATION OF COVERED TREATMENT, PROVIDED, HOWEVER, THAT SUCH COVERAGE SHALL BE TERMINATED WHEN THE ADMITTING OR ATTENDING PHYSICIAN, 6 7 OR A PHYSICIAN ASSISTANT OR NURSE PRACTITIONER PROVIDING DETOXIFICATION, REHABILITATION OR OUTPATIENT TREATMENT CERTIFIES THAT ADMISSION OF THE 8 COVERED PERSON IS NOT NECESSARY, EARLY DISCHARGE IS APPROPRIATE OR ADDI-9 10 TIONAL INPATIENT DAYS OR SESSIONS ARE NECESSARY.

11 (3) THE LOCATION OF COVERED TREATMENT PURSUANT TO THIS SUBSECTION 12 SHALL BE SUBJECT TO THE INSURER'S REQUIREMENTS RELATING TO THE USE OF 13 PARTICIPATING PROVIDERS, INCLUDING THOSE PROVIDERS LOCATED OUTSIDE OF 14 THE STATE.

15 S 4. This act shall take effect on the first of January next succeed-16 ing the date on which it shall have become a law and shall apply to 17 policies and contracts issued, renewed, modified, altered or amended on 18 or after such date.
