AN ACT to amend the environmental conservation law, in relation to establishing the marine mammal and sea turtle protection area; and providing for the repeal of such provisions upon expiration thereof

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Article 11 of the environmental conservation law is amended 2 by adding a new title 20-A to read as follows: 3 TITLE 20-A 4 MARINE MAMMAL AND SEA TURTLE PROTECTION AREA 5 SECTION 11-2050. ESTABLISHMENT OF THE MARINE MAMMAL AND SEA TURTLE б PROTECTION AREA. 7 MARINE MAMMAL AND SEA TURTLE PROTECTION AREA ADVI-11-2052. THE 8 SORY COMMITTEE. 9 S 11-2050. FOR PURPOSES OF THIS TITLETHE MARINE MAMMAL AND SEA TURTLE 22 PROTECTION AREA SHALL MEAN:

THE MARINE MAMMAL AND SEA TURTLE PROTECTION ADVISORY AREA 11 COMMITTEE. 12 THERE SHALL BE CREATED WITHIN THE DEPARTMENT THE MARINE MAMMAL AND SEA 13 TURTLE PROTECTION AREA ADVISORY COMMITTEE WHOSE NON-GOVERNMENTAL MEMBERS 14 SHALL SERVE WITHOUT PAY, MEET NOT LESS THAN TWICE EACH YEAR, AND WHOSE 15 SOLE PURPOSE SHALL BE TO ADVISE AS TO THE MANAGEMENT, EDUCATIONAL 16 RESEARCH AND UTILIZATION OF THE MARINE MAMMAL AND SEA TURTLE PROTECTION AREA. PROVIDED, HOWEVER, THE UTILIZATION OF SUCH AREA SHALL BE CONSIST-17 WITH THE MISSION OF THE DEPARTMENT PURSUANT TO SECTION 11-2050 OF 18 ENT19 THIS TITLE. IN ADDITION TO REPRESENTATIVES OF THE DEPARTMENT, THE ADVI-SORY COMMITTEE SHALL CONSIST OF, BUT NOT BE LIMITED TO ONE REPRESEN-20 21 TATIVE EACH FROM THE DEPARTMENT OF STATE, THE MARINE RESOURCES ADVISORY THE OFFICE OF PARKS, RECREATION AND HISTORIC PRESERVATION, THE 22 BOARD, STATE MUSEUM, AMERICAN MUSEUM OF NATURAL HISTORY, CORNELL LABORATORY OF 23 ORNITHOLOGY, ENVIRONMENTAL GROUPS, MARINE EDUCATION AND RESEARCH GROUPS, 24 25 MARINE SCIENCES RESEARCH CENTER AT STONY BROOK, THE THE DEAN OF THE 26 SUFFOLK COUNTY EXECUTIVE, AND THE TOWN SUPERVISORS OF SOUTHOLD AND 27 BROOKHAVEN.
