AN ACT to amend the executive law, in relation to establishing the municipal severe storm relief fund for Rockaway, Queens to be administered by the division of homeland security and emergency services

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. The executive law is amended by adding a new section 719 to 2 read as follows:

3 S 719. MUNICIPAL SEVERE STORM RELIEF FUND FOR ROCKAWAY, QUEENS. 1. 4 THERE IS HEREBY ESTABLISHED A MUNICIPAL SEVERE STORM ASSISTANCE RELIEF 5 PROGRAM FOR ROCKAWAY, QUEENS FOR DAMAGE RESULTING FROM A SEVERE STORM б AND FLOODING WHICH OCCURRED ON NOVEMBER THIRD, TWO THOUSAND TWELVE TO BE 7 ADMINISTERED BY THE DIVISION OF HOMELAND SECURITY AND EMERGENCY 8 SERVICES.

9 2. PROJECTS ELIGIBLE FOR PROGRAM GRANTS PURSUANT TO THIS SECTION SHALL 10 BE LIMITED TO PROJECTS TO REPAIR DAMAGE TO PUBLIC INFRASTRUCTURE, INCLUDING PUBLICLY OWNED ROADS, BRIDGES, BOARDWALKS, DRAINAGE AND FLOOD 11 MITIGATION SYSTEMS, AND ANY ANCILLARY INFRASTRUCTURE NECESSARY 12 FOR THE 13 SAFE OPERATION OF THE COMPONENTS THEREOF, WITHIN ROCKAWAY, QUEENS WHEN SUCH DAMAGE OCCURRED AS A RESULT OF A SEVERE 14 STORM EVENT ON OCTOBER TWO THOUSAND TWELVE THROUGH NOVEMBER THIRD, TWO THOUSAND 15 TWENTY-NINTH, TWELVE. IN NO EVENT SHALL FUNDING BE USED 16 FOR INFRASTRUCTURE REPAIRS THAT ARE REQUIRED DUE TO NORMAL WEAR AND TEAR. 17

18 3. THE COMMISSIONER OF THE DIVISION OF HOMELAND SECURITY AND EMERGENCY 19 SHALL ESTABLISH PROCEDURES FOR RECEIPT OF APPLICATION FROM SERVICES 20 MUNICIPALITIES AND FOR THE ISSUANCE OF GRANTS AUTHORIZED BY THIS SECTION WITHIN AVAILABLE APPROPRIATIONS. APPLICATIONS FOR SUCH GRANTS SHALL BE 21 THAN SEVEN YEARS AFTER NOVEMBER THIRD, TWO THOUSAND 22 SUBMITTED NO MORE TWELVE. A MUNICIPALITY SHALL RECEIVE FIFTY PERCENT OF THE COST OF OTHER-23 24 WISE UNREIMBURSED REPAIRS FROM DAMAGES INCURRED DUE ТΟ SUCH FLOODING, 25 PROVIDED THE APPROPRIATE MUNICIPAL AUTHORITY HAS SUBMITTED APPROPRIATE 26 DOCUMENTATION OF SUCH DAMAGE AND HAS FILED AN ATTESTATION WITH THE DIVI-SION INDICATING THAT THE DAMAGE FOR WHICH REPAIRS WERE MADE IS 27 DIRECTLY
