AN ACT to amend the education law, in relation to authorizing the board of trustees of the state university of New York to offer certain non-resident undergraduate students separate tuition rates for attendance at selected state-operated institutions; and providing for the repeal of such provisions upon the expiration thereof

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Paragraph h of subdivision 2 of section 355 of the educa-
2 tion law is amended by adding a new subparagraph 4-a to read as follows:
3 (4-A) COMMENCING WITH THE TWO THOUSAND SEVENTEEN--TWO THOUSAND EIGH-
4 TEEN ACADEMIC YEAR AND ENDING IN THE TWO THOUSAND TWENTY-ONE--TWO THOU-
5 SAND TWENTY-TWO ACADEMIC YEAR, THE BOARD OF TRUSTEES OF THE STATE
6 UNIVERSITY IS AUTHORIZED TO DESIGNATE SELECTED STATE-OPERATED INSTI-
7 TUTIONS OF THE STATE UNIVERSITY FOR PARTICIPATION IN A PROGRAM ALLOWING
8 ELIGIBLE NON-RESIDENT UNDERGRADUATE STUDENTS THAT RESIDE WITHIN TWO
9 HUNDRED MILES OF A SELECTED INSTITUTION TO PAY SEPARATE TUITION RATES
10 FOR ATTENDANCE AT THOSE SELECTED INSTITUTIONS. IN SELECTING INSTITUTIONS
11 FOR THIS PROGRAM, SUCH BOARD OF TRUSTEES SHALL CONSIDER OUT-OF-STATE
12 COMPETITION, CURRENT OR PROJECTED LEVELS OF HIGH SCHOOL GRADUATES WITHIN
13 AN INSTITUTION'S RECRUITMENT REGION, AND ENROLLMENT CAPACITY AND PHYS-
14 ICAL LOCATION OF THESE INSTITUTIONS. THE BOARD OF TRUSTEES OF THE STATE
15 UNIVERSITY IS FURTHER AUTHORIZED TO SET SUCH SEPARATE TUITION RATES,
16 WHICH SHALL NOT BE SET BELOW AN AMOUNT EQUAL TO ONE AND ONE-HALF TIMES
17 THE IN-STATE TUITION RATE AT THE DESIGNATED INSTITUTION. SUCH SEPARATE
18 TUITION RATES MAY BE OFFERED ONLY TO ELIGIBLE NON-RESIDENT STUDENTS, THE
19 TOTAL OF WHICH SHALL NOT EXCEED TEN PERCENT OF ENROLLMENT AT EACH DESIG-
20 NATED INSTITUTION. EACH STATE-OPERATED INSTITUTION THAT IS SELECTED FOR
21 PARTICIPATION IN THIS PROGRAM SHALL REPORT ANNUALLY TO THE BOARD OF
22 TRUSTEES OF THE STATE UNIVERSITY ON THE IMPACT OF THIS PROGRAM.
23 S 2. This act shall take effect immediately and shall expire and be
24 deemed repealed June 1, 2022.
