AN ACT to amend the administrative code of the city of New York, in relation to dividing the one hundred fifth and one hundred ninth precincts of the New York city police department into subdivisions

THE PEOPLE OF THE STATE OF NEW YORK, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 Section 1. Section 14-129 of the administrative code of the city of 2 New York is amended by adding two new subdivisions c and d to read as 3 follows:

4 THE ONE HUNDRED FIFTH PRECINCT SHALL BE DIVIDED INTO TWO SEPARATE С. 5 SUBDIVISIONS, ONE SUBDIVISION REPRESENTING THE NORTHERN PORTION OF SUCH PRECINCT AND ONE SUBDIVISION REPRESENTING THE SOUTHERN PORTION OF SUCH 6 PRECINCT. ALL 7 CORRESPONDING BOUNDARIES SHALL BE DETERMINED ΒY THE 8 COMMISSIONER, IN ACCORDANCE WITH THE REGULATIONS OF THE DEPARTMENT, SUCH RESOURCES NECESSARY TO 9 WHEREUPON, THE DEPARTMENT SHALL ALLOCATE ESTABLISH AND SUPPORT BOTH PRECINCT SUBDIVISIONS. 10

ONE HUNDRED NINTH PRECINCT SHALL BE DIVIDED INTO TWO SEPARATE 11 D. THE SUBDIVISIONS, ONE SUBDIVISION REPRESENTING "FLUSHING 12 SOUTH", AND THE 13 OTHER REPRESENTING THE "NORTH SHORE - COLLEGE POINT, WHITESTONE, CLEAR-VIEW AND BAY TERRACE". ALL CORRESPONDING BOUNDARIES SHALL BE DETERMINED 14 THE COMMISSIONER, IN ACCORDANCE WITH THE REGULATIONS OF THE DEPART-15 ΒY 16 MENT, WHEREUPON, THE DEPARTMENT SHALL ALLOCATE SUCH RESOURCES NECESSARY 17 TO ESTABLISH AND SUPPORT BOTH PRECINCT SUBDIVISIONS.

18 S 2. This act shall take effect on the one hundred twentieth day after 19 it shall have become a law.
