AN ACT to authorize the town of Brookhaven, county of Suffolk, to alienate certain parklands and to dedicate other lands as parklands

## The People of the State of New York, represented in Senate and Assembly, do enact as follows:

Section 1. Subject to the provisions of this act, the town of Brook-2 haven, county of Suffolk, acting by and through its governing body and 3 upon such terms and conditions as determined by such body, is hereby 4 authorized to discontinue as parklands and to alienate the lands described in section three of this act to DiPaolo Development, LLC to be 6 used for residential purposes.

- § 2. The authorization provided in section one of this act shall be 8 effective only upon the condition that the town of Brookhaven dedicate the lands described in section four of this act as parkland provided that the town of Brookhaven has never used such lands for public open space or park purposes.
- § 3. The parklands authorized by section one of this act to be alien-12 13 ated as parklands are described as follows:

In the event that the fair market value of the parklands described in section four of this act to be dedicated as parklands by the town of Brookhaven pursuant to this act are not equal to or greater than the fair market value of the parklands to be alienated as described section three of this act, the town of Brookhaven shall dedicate the difference of the fair market value of the lands to be alienated and the lands to be dedicated for the acquisition of additional parklands and/or capital improvements to existing park and recreational facilities.
- § 6. In the event that the town of Brookhaven received any funding 34 35 support or assistance from the federal government for the purchase, 36 maintenance or improvement of the parklands set forth in section three of this act, the discontinuance and alienation of such parkland author-37 ized by the provisions of this act shall not occur until the town of 38 39 Brookhaven has complied with any federal requirements pertaining to the alienation or conversion of parklands, including satisfying the secre-40 41 tary of the interior that the alienation or conversion complies with all conditions which the secretary of the interior deems necessary to assure the substitution of other lands shall be equivalent in fair market value 43 44 and usefulness to the lands being alienated or converted.
  - § 7. This act shall take effect immediately.
