AN ACT to amend the public health law, in relation to adding substances to the schedules of controlled substances

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

- Section 1. Subdivision (b) of schedule I of section 3306 of the public health law is amended by adding 10 new paragraphs 58, 59, 60, 61, 62, 63, 64, 65, 66 and 67 to read as follows:
- 4 (58) N-(1-phenethylpiperidin-4-yl)-N-phenylbutyramide (Butyryl Fenta-5 nyl).
- 6 (59) N-{1-{2-hydroxy-2-(thiophen-2-yl)ethyl}piperidin-4-yl}- N-phenyl-7 propionamide (Beta- Hydroxythiofentanyl).
  - (60) N-(1-phenethylpiperdin-4-yl)-N-phenylfuran-2-carboxamide (Furanyl Fentanyl).

- § 3. Subdivision (d) of schedule I of section 3306 of the public health law is amended by adding a new paragraph 39 to read as follows:
