Introduced by M. of A. GANTT -- read once and referred to the Committee on Transportation

AN ACT to amend the vehicle and traffic law, in relation to increasing the penalties for aggravated unlicensed operation of a motor vehicle in the second and first degrees in certain cases

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Paragraph (b) of subdivision 2 of section 511 of the vehicle and traffic law, as amended by chapter 607 of the laws of 1993, is amended to read as follows:

2 (b) Aggravated unlicensed operation of a motor vehicle in the second degree is a misdemeanor. When a person is convicted of this crime under
3 subparagraph (i) of paragraph (a) of this subdivision, the sentence of
4 the court must be: (i) a fine of not less than five hundred dollars; and
5 (ii) a term of imprisonment not to exceed one hundred eighty days; or
6 (iii) where appropriate a sentence of probation as provided in subdivision
7 six of this section; or (iv) a term of imprisonment as a condition
8 of a sentence of probation as provided in the penal law and consistent
9 with this section. When a person is convicted of this crime under
10 subparagraph (ii), (iii) or (iv) of paragraph (a) of this subdivision,
11 the sentence of the court must be: (i) a fine of not less than [~~five~~
12 ~~hundred~~] seven hundred fifty dollars nor more than one thousand dollars;
13 and (ii) a term of imprisonment of not less than seven days nor more
14 than one [~~hundred eighty days~~] year, or (iii) where appropriate a
15 sentence of probation as provided in subdivision six of this section; or
16 (iv) a term of imprisonment as a condition of a sentence of probation as
17 provided in the penal law and consistent with this section.

1 (b) Aggravated unlicensed operation of a motor vehicle in the first
2 degree is a class E felony. When a person is convicted of this crime,
3 the sentence of the court must be: (i) a fine in an amount not less than
4 [~~five~~] twenty-five hundred dollars nor more than five thousand dollars;
5 and (ii) a term of imprisonment as provided in the penal law, or (iii)
6 where appropriate and a term of imprisonment is not required by the
7 penal law, a sentence of probation as provided in subdivision six of
8 this section, or (iv) a term of imprisonment as a condition of a
9 sentence of probation as provided in the penal law.
10 § 3. This act shall take effect on the first of November next succeed-
11 ing the date on which it shall have become a law.
